PROPOSED AMENDMENTS TO HOUSE BILL 2871

- In line 2 of the printed bill, after the semicolon delete the rest of the line
- 2 and insert "amending ORS 320.013, 320.100, 418.205, 418.653, 418.657, 418.658,
- 3 418.660 and 418.663.".
- Delete lines 4 through 14 and insert:
- **"SECTION 1.** ORS 418.653 is amended to read:
- 6 "418.653. (1) Subject to the availability of funds [therefor], there is created
- 7 an Oregon Youth [Conservation] Corps that shall provide emergency services,
- 8 public conservation, rehabilitation and improvement programs. The corps
- 9 shall be headed by a program director, and shall be administered through the
- 10 [Office of Community Colleges and Workforce Development] Higher Educa-

tion Coordinating Commission.

- "(2) Upon implementation of subsection (1) of this section, there shall be
 - created an Oregon Youth [Conservation] Corps Advisory [Committee] Board
- 14 to consist of nine members, three to be appointed by the President of the
- 15 Senate, three to be appointed by the Speaker of the House of Representatives
- and three public members to be appointed by the Governor. No more than
 - one Senator and one Representative shall be appointed.
- "(3) [Committee] Board members may receive reimbursement of necessary
- and actual expenses under ORS 292.495 (2), but may not receive compensation
- under ORS 292.495 (1) or otherwise for participation as a [committee] board

- "(4) [Committee] **Board** members may be removed by the appointing au-
- 2 thority. Vacancies shall be filled by the appointing authority. [Committee]
- 3 Board members shall serve for a term of three years and may be reappointed
- 4 for an additional consecutive term.
- 5 "(5) The advisory [committee] board established under subsection (2) of
- 6 this section shall advise the program director on the implementation of ORS
- 7 418.650 to 418.663.
- 8 **"SECTION 2.** ORS 418.657 is amended to read:
- 9 "418.657. (1) In consultation with the Oregon Youth [Conservation] Corps
- 10 Advisory [Committee] Board and the executive director of the Higher Ed-
- 11 ucation Coordinating Commission [Office of Community Colleges and
- 12 Workforce Development], or the designee of the executive director, the
- program director of the Oregon Youth [Conservation] Corps shall:
- "(a) Establish eligibility criteria for participants. Such criteria shall not
- 15 render the program ineligible for federal funds. Participants shall be lawful
- 16 permanent residents of this state.
- 17 "(b) Establish criteria in order to make the required determination that
- 18 enrollment in the corps was not the reason that an individual ceased at-
- 19 tendance at a secondary school.
- 20 "(c) Assume that application of the eligibility and participation criteria
- 21 results in enrollment of at least 75 percent disadvantaged and at-risk youth
- 22 among the total number of participants.
- 23 "(2) The program director, in consultation with the **executive** director

- "(a) State Personnel Relations Law; and

- "418.658. (1) The program director of the Oregon Youth [Conservation]
- 14 Corps shall establish a separate program known as the Oregon Community
- 15 Stewardship Corps. In addition to the established purposes of the Oregon
- 16 Youth [Conservation] Corps, the purpose of the Oregon Community
- 17 Stewardship Corps is to promote community service activities throughout the
- 18 state for a broad cross section of Oregon disadvantaged and at-risk youth
- 19 through programs that also include appropriate educational and job training
- 20 opportunities for participants.
- "(2) In addition to projects submitted under ORS 418.660 (1), projects of
- 22 the Oregon Community Stewardship Corps may include, but shall not be
- 23 limited to:

- 24 "(a) Child care services.
- 25 "(b) Elderly and disabled care services.
- 26 "(c) Literacy education programs.
- 27 "(d) Recycling and other waste reduction services.
- 28 "(3) The Oregon Community Stewardship Corps shall offer employment
- 29 and educational opportunities of at least three but not more than 12 months'
- 30 duration for selected participants.

- "(4) Under rules adopted by the Higher Education Coordinating Commission, participants who successfully complete any [12-month] program under this section shall be eligible for **up to** \$1,500 in [tuition] **support** vouchers that can be used [at any career school or post-secondary educational institution that is qualified to receive assistance through the Director of the Office of Student Access and Completion] to pay for tuition, books or other items or services that enhance and support education or employment.
- "(5) All Oregonians who are at least 13 years of age and under 25 years of age are eligible to participate in the program. To ensure that Oregon Community Stewardship Corps participants represent a broad cross section of Oregonians, special emphasis shall be given to recruiting school dropouts and other disadvantaged and at-risk youth, according to criteria established by the Oregon Youth [Conservation] Corps Advisory [Committee] Board.
 - "(6) To the extent practicable, the program director shall enlist state and federal agencies, local government, nonprofit organizations and private businesses, and any combination of such entities, to act as sponsors for programs administered under this section. Selection of sponsors shall be based on criteria that include the following:
 - "(a) The availability of other resources on a matching basis, including contributions from private sources, other federal, state and local agencies, and moneys available through the federal Workforce Innovation and Opportunity Act;
- "(b) The provision of related educational and job training programs to participants, including but not limited to school and college coursework, training for approved high school equivalency tests such as the General Educational Development (GED), project-related education and professional training;
- 28 "(c) Assurances that proposed projects will not displace existing employ-29 ees or duplicate existing private or government programs; and
 - "(d) Assurances that proposed projects are devoted to the enhancement

- **"SECTION 4.** ORS 418.660 is amended to read:

- in or receives care or services from a child-caring agency.
- "(2)(a) 'Child-caring agency':
- "(A) Means any private school, private agency or private organization
- 20 providing:

- "(i) Day treatment for children with emotional disturbances;
- 22 "(ii) Adoption placement services;
- "(iii) Residential care, including but not limited to foster care or resi-
- 24 dential treatment for children;
- 25 "(iv) Residential care in combination with academic education and
- 26 therapeutic care, including but not limited to treatment for emotional, be-
- 27 havioral or mental health disturbances;
- 28 "(v) Outdoor youth programs; or

 child without compensation or reimbursement of expenses for the purpose
 of providing a parent in crisis with relief from the demands of ongoing care
 of the parent's child;
- "(C) A youth job development organization as defined in ORS 344.415;
- 18 "(D) A shelter-care home that is a foster home subject to ORS 418.625 to 418.645;
- 20 "(E) A foster home subject to ORS 418.625 to 418.645;
- 21 "(F) A facility that exclusively serves individuals 18 years of age and 22 older; or
- "(G) A facility that primarily serves both adults and children but requires that any child must be accompanied at all times by at least one custodial parent or guardian.
- 26 "(3) 'Child-caring facility' has the meaning given that term in ORS 418.950.
- "(4) 'Governmental agency' means an executive, legislative or judicial agency, department, board, commission, authority, institution or instrumentality of this state or of a county, municipality or other political

- "(5) 'Independent residence facility' means a facility established or certified under ORS 418.475.

- "(10) 'Provider of care or services for children' means a person, entity or organization that provides care or services to children, regardless of whether the child is in the custody of the Department of Human Services, and that does not otherwise meet the definition of, or requirements for, a child-caring

- 6 "(a) Result in an increase in employment opportunities for disadvantaged 7 and at-risk youth over those opportunities which would otherwise be avail-

- "(b) Not result in the displacement of currently employed workers, including partial displacement such as reduction in the hours of nonovertime work or wages or employment benefits;
- "(c) Not impair existing contracts for services or result in the substitution of state for other funds in connection with work that would otherwise be performed;
 - "(d) Not substitute jobs assisted under ORS 418.650 to 418.663 for existing federally assisted jobs;
- "(e) Not employ any person when any other person is on layoff by an employer from the same or any substantially equivalent job in the same area; and
 - "(f) Not be used to employ any person to fill a job opening created by the act of an employer in laying off or terminating employment of any regular employee, otherwise reducing the regular workforce not supported under ORS 418.650 to 418.663, in anticipation of filling the vacancy so created by hiring a person to be supported under ORS 418.650 to 418.663.
- "(2) Where a labor organization represents employees who are engaged in similar work or a workers' cooperative is engaged in work in the same area to that proposed to be performed under the program for which an application is being developed, the organization or cooperative shall be notified and shall be afforded a reasonable period of time prior to the submission of the application in which to make comments to the applicant and to the program di-
