PROPOSED AMENDMENTS TO HOUSE BILL 2074

- On page 2 of the printed bill, delete lines 6 through 13 and insert:
- 2 "(2)(a) For the purpose of preparing the tentative budget, the department
- 3 shall form a committee. The committee must include:
- 4 "(A) Representatives from the Department of Education, the Legislative
- 5 Fiscal Office, the Legislative Revenue Officer and the Governor's office;
- 6 "(B) Representatives of school districts, school budget committees, school

- 20 "(2) The budget and accounting information report required under
- 21 this section shall include uniform definitions for a chart of accounts

- and revenues that allows for comparison of expenditures and revenues
- 2 among public universities and community colleges in this state. The
- 3 commission shall develop the uniform definitions for the chart of ac-
- 4 counts and revenues in collaboration with the Oregon Department of
- 5 Administrative Services and other appropriate organizations that rep-
- 6 resent the interests of public universities and community colleges in
- 7 this state.
- 8 "(3) In addition to information required under subsection (2) of this
- 9 section, the commission may request financial information that in-

- "(a) Statements of net position;
- "(b) Audited financial statements;
- 13 "(c) Audit findings and credit analyst reports;
- 14 "(d) Accreditation sanctions or other related information; or
- 15 "(e) Cost data necessary to construct an expenditure study model.
- 16 "(4) Each even-numbered year, the department shall prepare a ten-
- 17 tative budget for funding public universities and the Community Col-
- 18 lege Support Fund established under ORS 341.620 for the next
- biennium. The tentative budget shall be based on information collected
- 20 by the commission under this section.
- 21 "(5)(a) For the purpose of preparing the tentative budget, the de-
- 22 partment shall form a committee. The committee must include:
- 23 "(A) Representatives from public universities listed in ORS 352.002
- 24 and community colleges in this state, the Legislative Fiscal Office, the
- 25 Legislative Revenue Officer and the Governor's office;
- 26 "(B) Representatives of community college districts and higher ed-
- 27 ucation labor unions; and
- 28 "(C) The cochairs of the Joint Committee on Ways and Means.
- 29 "(b) The representatives from the Legislative Fiscal Office and the
- 30 Legislative Revenue Officer and the cochairs of the Joint Committee

on Ways and Means shall serve as nonvoting members on the committee formed under this subsection.

- "(6) In preparing the tentative budget, the department shall review with the committee formed under subsection (5) of this section the components of the methodology that will be used to prepare the tentative budget and the calculations for the tentative budget. The department shall collaborate with the committee to refine the methodology by considering alternative approaches to the calculations and other factors the committee believes may be pertinent to the preparation of the tentative budget. The department shall collaborate with the committee prior to finalizing the tentative budget required under this section. The tentative budget shall include:
- "(a) Projected changes in the cost of personal services, other services, supplies and capital expenditures, based on anticipated expenses;
- "(b) Forecasted local property tax revenues as calculated by the Oregon Department of Administrative Services, the Legislative Fiscal Officer, the Legislative Revenue Officer and the Department of Revenue; and
- "(c) Projected cost factors that may arise from new laws and administrative rules.
- "(7) The Oregon Department of Administrative Services shall present the tentative budget prepared under this section to the Governor and to the Legislative Assembly in conjunction with submittal of the agency request budget of the commission.".
