## PROPOSED AMENDMENTS TO SENATE BILL 247

8 "(2) 'Beverage container' means a container described in ORS 459A.702.

9 "(3) 'Commission' means the Oregon Liquor Control Commission.

"(5) 'Dealer' means every person in this state who engages in the sale of

"(7) 'Importer' means any dealer or manufacturer who directly imports

20 "(8) 'In this state' means within the exterior limits of the State of Oregon 21 and includes all territory within these limits owned by or ceded to the 1 United States of America.

## "(9) 'Kombucha' means a fermented beverage that is made from tea and contains not more than 21 percent of alcohol by volume.

4 "[(9)] (10) 'Manufacturer' means every person bottling, canning or other-5 wise filling beverage containers for sale to distributors, importers or dealers.

"[(10)] (11) 'Place of business of a dealer' means the location at which a
dealer sells or offers for sale beverages in beverage containers to consumers.
"[(11)] (12) 'Use or consumption' includes the exercise of any right or
power over a beverage incident to the ownership thereof, other than the sale
or the keeping or retention of a beverage for the purposes of sale.

"[(12)] (13) 'Water and flavored water' means any beverage identified through the use of letters, words or symbols on its product label as a type of water.
