## PROPOSED AMENDMENTS TO HOUSE BILL 2600

1 On page 1 of the printed bill, line 3, after "441.406," delete the rest of the 2 line and insert "441.413, 443.382, 443.386, 443.415 and 443.735.".

3 Delete lines 5 through 25 and delete pages 2 through 10 and insert:

4 "SECTION 1. (1) As used in this section and section 2 of this 2019 5 Act:

"(a) 'Disease outbreak' has the meaning given that term in ORS
431A.005.

8 **"(b) 'Facility' means:** 

9 "(A) A long term care facility, as defined in ORS 442.015;

10 "(B) A conversion facility, as defined in ORS 443.400; and

"(C) A residential care facility, as defined in ORS 443.400, including
 a residential care facility with a memory care endorsement.

"(c) 'Medical resource' means a physician, nurse practitioner or
 other health professional that has prescribing privileges.

15 "(2) An administrator of a facility and the employees of the facility, 16 as specified by the Department of Human Services by rule, must re-17 ceive training in recognizing disease outbreaks and infection control 18 at the time of hiring, unless the administrator or the employees have 19 received the training at another facility no later than 18 months before 20 the time of hiring, and annually as part of the administrator or 21 employee's continuing education requirements. The department, in consultation with the Oregon Health Authority, shall prescribe by rule
the requirements for the training, which must include at least the
following:

4 "(a) How to properly prevent and contain disease outbreaks based
5 on the current best evidence in the field of infection and disease out6 break identification, prevention and control; and

7 "(b) The responsibility of staff members to report disease outbreaks
8 under ORS 433.004.

"(3) The training may be provided in person, in writing, by webinar
or by other electronic means. The department shall make the training
available online.

"(4)(a) A facility must establish and maintain infection prevention
 and control protocols designed to provide a safe, sanitary and com fortable environment and to prevent the development and trans mission of communicable diseases.

16 "(b) A facility must designate an individual to be responsible for 17 carrying out the infection prevention and control protocols and to 18 serve as the primary point of contact for the department regarding 19 disease outbreaks. The individual must:

20 "(A) Be qualified by education, training and experience or certi-21 fication; and

"(B) Complete specialized training in infection prevention and con trol within three months of being designated under this paragraph.

"(5) Upon hiring a new staff member, a facility shall provide to the staff member information about the rights and responsibility of facility staff members to report disease outbreaks under ORS 433.004 and the safeguards for staff members who report disease outbreaks.

"(a) Communicate regularly with facility administrators to recom mend best practices and protocols for preventing and responding to

disease outbreaks and provide contacts for local public health authorities; and

exposure to the disease outbreak.

"SECTION 2. (1) The Department of Human Services shall annually 6 inspect the kitchen of a facility and other areas where food is prepared 7 for residents. The inspection is in addition to other surveys or in-8 spections required by law, except that the inspection is not required 9 in a year in which a facility is scheduled for a survey required by the 10 Centers for Medicare and Medicaid Services under 42 C.F.R. part 488. 11 The inspection must be conducted by an individual who has training 12and expertise in food sanitation. The department may charge the fa-13 cility a fee for the inspection of up to \$200. 14

"[(m)] (n) Promote the development of organizations to advocate on behalf
 of residents of residential facilities.

"[(n)] (o) To the extent practicable, assist residents who move from a
 residential facility to a home care setting.

"[(o)] (**p**) Assist residents and individuals acting on their behalf in locating and accessing resources in the community and in connecting with local service providers.

"[(p)] (q) Engage the participation of residents in general studies, con ferences, inquiries or meetings related to residential care in this state.

"(2) The Residential Facilities Ombudsman shall prescribe the qualifica tions of designees by rule.

"(3) To be appointed as a designee, a person must complete an initial training prescribed by the Residential Facilities Ombudsman by rule and attend required continuing educational training sessions that are approved by the ombudsman. The training must include instruction on how to identify and report disease outbreaks.

"(4) Designees must sign a contract with the Residential Facilities Ombudsman that outlines the scope of their duties. Violation of the contract
