4 Delete lines 4 through 16 and insert:

5 **SECTION 1.** ORS 813.100 is amended to read:

813.100. (1) Any person who operates a motor vehicle upon premises open 6 to the public or the highways of this state shall be deemed to have given 7 consent, subject to the implied consent law, to a chemical test of the person's 8 breath, or of the person's blood if the person is receiving medical care in a 9 health care facility immediately after a motor vehicle accident, for the pur-10 pose of determining the alcoholic content of the person's blood if the person 11 is arrested for driving a motor vehicle while under the influence of 12 intoxicants in violation of ORS 813.010 or of a municipal ordinance. A test 13 shall be administered upon the request of a police officer having reasonable 14 grounds to believe the person arrested to have been driving while under the 15 influence of intoxicants in violation of ORS 813.010 or of a municipal ordi-16 nance. Before the test is administered the person requested to take the test 17 shall be informed of consequences and rights as described under ORS 813.130. 18 A person does not revoke the person's consent by refusing to provide 19 a sample. 20

21 [(2) No chemical test of the person's breath or blood shall be given, under

subsection (1) of this section, to a person under arrest for driving a motor vehicle while under the influence of intoxicants in violation of ORS 813.010 or
of a municipal ordinance, if the person refuses the request of a police officer
to submit to the chemical test after the person has been informed of conseguences and rights as described under ORS 813.130.]

6 [(3)] (2) If a person refuses to [*take*] submit to a test under this section 7 or if a breath test under this section discloses that the person, at the time 8 of the test, had a level of alcohol in the person's blood that constitutes being 9 under the influence of intoxicating liquor under ORS 813.300 and the person 10 has been informed of rights and consequences as provided under ORS 11 813.130, the person's driving privileges are subject to suspension under ORS 12 813.410 and the police officer shall do all of the following:

(a) Immediately take custody of any driver license or permit issued by this
 state to the person to grant driving privileges.

(b) Provide the person with a written notice of intent to suspend, on forms prepared and provided by the Department of Transportation. The written notice shall inform the person of consequences and rights as described under ORS 813.130.

(c) If the person qualifies under ORS 813.110, issue to the person, on be half of the department, a temporary driving permit described under ORS
 813.110.

(d) Within a period of time required by the department by rule, report action taken under this section to the department and prepare and cause to be delivered to the department a report as described in ORS 813.120, along with the confiscated license or permit and a copy of the notice of intent to suspend.

[(4)] (3) If a blood test under this section discloses that the person, at the time of the test, had a level of alcohol in the person's blood that constitutes being under the influence of intoxicating liquor under ORS 813.300, the person's driving privileges are subject to suspension under ORS 813.410 and the police officer shall report to the department within 45 days of the date
of arrest that the person failed the blood test.

[(5)] (4) Nothing in this section precludes a police officer from obtaining
a chemical test of the person's breath or blood through any lawful means for
use as evidence in a criminal or civil proceeding including, but not limited
to, obtaining a search warrant.

## 7 **SECTION 2.** ORS 813.130 is amended to read:

8 813.130. This section establishes the requirements for information about 9 rights and consequences for purposes of ORS 813.100 and 813.410. The fol-10 lowing apply to the information about rights and consequences:

(1) The information about rights and consequences shall be substantially
 in the form prepared by the Department of Transportation. The department
 may establish any form it determines appropriate and convenient.

(2) Except as provided in subsection (3) of this section, the informa tion about rights and consequences shall be substantially as follows:

(a) Driving under the influence of intoxicants is a crime in Oregon, and the person is subject to criminal penalties if a test under ORS 813.100 shows that the person is under the influence of intoxicants. If **after being asked if** the person [*refuses a test or*] **would consent to provide a breath or blood test, the person** fails **a test**, evidence of the [*refusal or*] failure may also be offered against the person.

(b) The person will fail a test under ORS 813.100 for purposes of criminal penalties if the test discloses a blood alcohol content of 0.08 percent or more by weight of alcohol in the blood of the person as shown by chemical analysis of the breath or blood. The person will fail a test for purposes of the Motorist Implied Consent Law if the test discloses a blood alcohol content of:

(A) 0.08 percent or more by weight of alcohol in the blood of the person as shown by chemical analysis of the breath or blood if the person
was not driving a commercial motor vehicle;

(B) 0.04 percent or more by weight of alcohol in the blood of the person
as shown by chemical analysis of the breath or blood if the person was
driving a commercial motor vehicle; or

4 (C) Any amount if the person was under 21 years of age.

(c) If the person [*refuses or*] fails a test under ORS 813.100, the person's
driving privileges will be suspended. The outcome of a criminal charge for
driving under the influence of intoxicants will not affect the suspension.
[*The suspension will be substantially longer if the person refuses a test.*]

9 (d) If the person [*refuses a test or*] fails a breath test under ORS 813.100 10 and has an Oregon driver license or permit, the license or permit will be 11 taken immediately and, unless the person does not currently have full valid 12 driving privileges, a temporary driving permit will be issued to the person.

[(e) If the person refuses a test under ORS 813.100, the person is not eligible for a hardship permit for at least 90 days, and possibly for three years, depending on the following factors set forth in ORS 813.430:]

[(A) Whether the person is presently participating in a driving while under the influence of intoxicants diversion program in this state or in any similar alcohol or drug rehabilitation program in this or another jurisdiction; or]

19 [(B) Whether within the five years preceding the date of arrest any of the 20 following occurred:]

[(i) A suspension of the person's driving privileges under ORS 813.410 or 482.540 (1981 Replacement Part) became effective;]

[(ii) The person was convicted of driving while under the influence of intoxicants in violation of ORS 813.010 or the statutory counterpart to ORS 813.010 in another jurisdiction, as described in ORS 813.430;]

[(iii) The person was convicted of driving while under the influence of intoxicants in violation of a municipal ordinance in this state or another jurisdiction, as described in ORS 813.430; or]

[(*iv*) The person commenced participating in a driving while under the influence of intoxicants diversion program in this state or in any similar alcohol or drug rehabilitation program in this or another jurisdiction, as described in
 ORS 813.430.]

[(f) If the person refuses a breath test under ORS 813.100, or refuses a urine
test under ORS 813.131 and 813.132, the person is subject to a fine of at least
\$500 and not more than \$1,000.]

6 [(g)] (e) After taking a test under ORS 813.100, the person will have a 7 reasonable opportunity, upon request, for an additional chemical test for 8 blood alcohol content to be performed at the person's own expense by a 9 qualified individual of the person's choosing.

[(*h*)] (**f**) The person has a right to a hearing to challenge the validity of the suspension before the suspension becomes effective. The person must make a written request to the department for such a hearing. If the person wins at the hearing, the person's driving privileges will not be suspended. If the person loses at the hearing, the suspension will remain in effect during any court review of the hearing.

[(*i*)] (**g**) If the person is issued a temporary driving permit under ORS 813.100, the information provided to the person shall include the number of hours before the driving permit will be effective and the number of days the permit will be effective.

[(j)] (h) The information provided to the person shall include the number of days within which a person must request a hearing under ORS 813.410.

[(k)] (i) The information provided to the person shall include the number
of days within which a hearing under ORS 813.410 will be held.

[(L)] (j) The person may possibly qualify for a hardship permit in 30 days if the person fails a test, depending on the person's driving record.

(3) A person who refuses to submit to a chemical test after being
informed of the rights and consequences in subsection (2) of this section, shall be provided additional information, substantially as follows:
(a) Driving under the influence of intoxicants is a crime in Oregon,
and the person is subject to criminal penalties if a test under ORS

1 813.100 shows that the person is under the influence of intoxicants. If 2 the person refuses to provide consent to a breath or blood test, and 3 after being given a request for only physical cooperation to submit to 4 a breath or blood test refuses to submit to a test, evidence of the re-5 fusal may also be offered against the person.

6 (b) If the person refuses to submit to a test under ORS 813.100, the 7 person's driving privileges will be suspended. The outcome of a crimi-8 nal charge for driving under the influence of intoxicants will not affect 9 the suspension. The suspension will be substantially longer if a person 10 refuses a test.

(c) If the person refuses to submit to a breath test under ORS 813.100 and has an Oregon driver license or permit, the license or permit will be taken immediately and, unless the person does not currently have full valid driving privileges, a temporary driving permit will be issued to the person.

(d) If the person refuses to submit to a test under ORS 813.100, the
person is not eligible for a hardship permit for at least 90 days, and
possibly for three years, depending on the following factors set forth
in ORS 813.430:

(A) Whether the person is presently participating in a driving while
 under the influence of intoxicants diversion program in this state or
 in any similar alcohol or drug rehabilitation program in this or an other jurisdiction; or

(B) Whether within the five years preceding the date of arrest any
 of the following occurred:

(i) A suspension of the person's driving privileges under ORS 813.410

The person must make a written request to the department for such a hearing. If the person wins at the hearing, the person's driving privileges will not be suspended. If the person loses at the hearing, the suspension will remain in effect during any court review of the hearing.

(g) If the person is issued a temporary driving permit under ORS
 813.100, the number of hours before the driving permit will be effective
 and the number of days the permit will be effective.

(h) The number of days within which a person must request a
 hearing under ORS 813.410.

(i) The number of days within which a hearing under ORS 813.410
will be held.

(j) The person may possibly qualify for a hardship permit in 30 days
 if the person fails a test, depending on the person's driving record.

[(3)] (4) If the person is driving a commercial motor vehicle, the information about rights and consequences shall include[, *in addition to the provisions of subsection (2) of this section*,] substantially the following:

30 (a) If the person [*refuses a*] takes a breath or blood test under ORS

1 813.100 [or submits to a breath or blood test and] after being informed of
2 the rights and consequences under subsection (2) of this section, the
3 following additional information shall be provided:

(A) If the level of alcohol in the person's blood is 0.04 percent or more by weight of alcohol in the blood of the person as shown by chemical analysis of the breath or blood, the person's commercial driving privileges or right to apply for commercial driving privileges will be suspended and no hardship permit authorizing the person to drive a commercial motor vehicle will be issued. [The suspension will be substantially longer if the person refuses a test.]

[(b)] (B) The suspension of the person's commercial driving privileges or right to apply for commercial driving privileges will be for the person's lifetime if the person [*refuses a test under ORS 813.100 or submits to*] **takes** a breath or blood test and the level of alcohol in the person's blood is 0.04 percent or more by weight of alcohol in the blood of the person as shown by chemical analysis of the breath or blood and:

17 [(A)] (i) The person previously has been convicted of failure to perform
18 the duties of a driver;

[(B)] (ii) The person previously has been convicted of a crime punishable as a felony and the person was driving a motor vehicle at the time the offense was committed;

[(C)] (iii) The person previously has been convicted of driving a commercial motor vehicle while the person's commercial driving privileges or right to apply for commercial driving privileges was suspended or revoked for offenses committed while operating a commercial motor vehicle;

[(D)] (iv) The person previously has been convicted of any degree of murder, manslaughter or criminally negligent homicide resulting from the operation of a commercial motor vehicle or assault in the first degree resulting from the operation of a commercial motor vehicle;

[(E)] (v) The person previously has been convicted of driving while under

1 the influence of intoxicants;

[(F)] (vi) The person's commercial driving privileges previously have been
suspended or revoked for refusal to submit to, or failure of, a breath or blood
test under ORS 813.100; or

5 [(G)] (vii) The person's right to apply for commercial driving privileges 6 previously has been suspended or revoked for refusal to submit to, or failure 7 of, a breath or blood test under ORS 813.100 resulting from the operation of 8 a commercial motor vehicle.

9 (b) If the person refuses to submit to a breath or blood test under 10 ORS 813.100 and has been informed of the rights and consequences 11 under subsection (3) of this section and paragraph (a) of this sub-12 section, the following additional information shall be provided:

(A) If the person refuses to submit to a test under ORS 813.100, the person's commercial driving privileges or right to apply for commercial driving privileges will be suspended and no hardship permit authorizing the person to drive a commercial motor vehicle will be issued. The suspension will be substantially longer if the person refuses the test.

(vii) The person's right to apply for commercial driving privileges
 previously has been suspended or revoked for refusal to submit to, or
 failure of, a breath or blood test under ORS 813.100 resulting from the
 operation of a commercial motor vehicle.

[(4)] (5) Nothing in this section prohibits the department from providing additional information concerning rights and consequences that the department considers convenient or appropriate.

813.131. (1) A person may be asked to provide a urine sample under
ORS 813.140 or subsection (2) of this section.

[(1)] (2) Any person who operates a motor vehicle upon premises open to 22the public or the highways of this state shall be deemed to have given con-23sent, subject to the Motorist Implied Consent Law, to a chemical test of the 24person's urine for the purpose of determining the presence of cannabis, a 25controlled substance or an inhalant in the person's body if the person is ar-26rested for driving while under the influence of intoxicants in violation of 27ORS 813.010 or of a municipal ordinance [and either:]. A person does not 28revoke the person's consent by refusing to provide a urine sample. The 29 implied consent applies when: 30

(a) The person takes the breath test described in ORS 813.100 and the test
discloses a blood alcohol content of less than 0.08 percent; or

(b) The person is involved in an accident resulting in injury or property
damage. A urine test may be requested under this paragraph regardless of
whether a breath test has been requested and regardless of the results of a
breath test, if one is taken.

7 [(2)] (3) A police officer may not request a urine test unless the officer 8 is certified by the Department of Public Safety Standards and Training as 9 having completed at least eight hours of training in recognition of drug im-10 paired driving and the officer has a reasonable suspicion that the person 11 arrested has been driving while under the influence of cannabis, a controlled 12 substance, an inhalant or any combination of cannabis, a controlled sub-13 stance, an inhalant and intoxicating liquor.

subject to consecutive suspensions, the length of time that must elapse before

135.815. (1) Except as otherwise provided in ORS 135.855 and 135.873, the
district attorney shall disclose to a represented defendant the following material and information within the possession or control of the district attorney:

7 (a) The names and addresses of persons whom the district attorney in-8 tends to call as witnesses at any stage of the trial, together with their rele-9 vant written or recorded statements or memoranda of any oral statements 10 of such persons.

(b) Any written or recorded statements or memoranda of any oral statements made by the defendant, or made by a codefendant if the trial is to be a joint one.

(c) Any reports or statements of experts, made in connection with the particular case, including results of physical or mental examinations and of scientific tests, experiments or comparisons which the district attorney intends to offer in evidence at the trial.

18 (d) Any books, papers, documents, photographs or tangible objects:

(A) Which the district attorney intends to offer in evidence at the trial;or

(B) Which were obtained from or belong to the defendant.

(e) If actually known to the district attorney, any record of prior criminal convictions of persons whom the district attorney intends to call as witnesses at the trial; and the district attorney shall make a good faith effort to determine if such convictions have occurred.

(f) All prior convictions of the defendant known to the state that would
affect the determination of the defendant's criminal history for sentencing
under rules of the Oregon Criminal Justice Commission.

(a) Any report prepared by a police officer relating to field tests, inter views, observations and other information relating to the charged offense;

(b) Any report relating to the test results;

(c) A copy of the form provided to the defendant under ORS 813.100
[(3)(b)] (2)(b); and

(d) Any checklist prepared by the operator of the instrument for the test.
(4)(a) If a defendant is not represented by a lawyer, the district attorney
shall disclose to the defendant all of the information described in subsections

(1) and (3) of this section except for the personal identifiers of the victim and
any witnesses.

(b) Notwithstanding paragraph (a) of this subsection, the district attorney
shall disclose the personal identifiers of the victim and any witnesses if the
trial court orders the disclosure. A trial court shall order the district attorney to disclose the personal identifiers of the victim and any witnesses
if the trial court finds that:

8 (A) The defendant has requested the information; and

9 (B)(i) The victim or witness is a business or institution and disclosure of 10 the information would not represent a risk of harm to the victim or witness; 11 or

(ii) The need for the information cannot reasonably be met by othermeans.

(5)(a) Unless authorized by the trial court to disclose the information, a
lawyer representing a defendant, or a representative of the lawyer, may not
disclose to the defendant personal identifiers of a victim or witness obtained
under subsections (1) and (3) of this section.

(b) The trial court shall order the lawyer, or representative of the lawyer,
to disclose to the defendant the personal identifiers of a victim or witness
if the court finds that:

(A) The defendant's lawyer has requested the district attorney to disclose

to a test, was under arrest for driving a motor vehicle while under the influence of intoxicants in violation of ORS 813.010 or of a municipal ordinance.

(b) Whether the police officer had reasonable grounds to believe, at the time the request was made, that the person arrested had been driving under the influence of intoxicants in violation of ORS 813.010 or of a municipal ordinance.

(c) Whether the person refused to submit to a test or if the person submitted to a breath or blood test whether the level of alcohol in the person's blood, as shown by the test, was sufficient to constitute being under the influence of intoxicating liquor under ORS 813.300.

(d) Whether the person was driving a commercial motor vehicle and refused to submit to a test or if the person submitted to a breath or blood test
whether the level of alcohol in the person's blood, as shown by the test, was

1 0.04 percent or more by weight.

2 (e) Whether the person was informed of consequences and rights as de3 scribed under ORS 813.130.

4 (f) Whether the person was given written notice of intent to suspend re-5 quired by ORS 813.100 [(3)(b)] (2)(b).

6 (g) If the arrested person took a test, a statement that the person con-7 ducting the test was appropriately qualified.

8 (h) If the arrested person took a test, a statement that any methods, pro9 cedures and equipment used in the test comply with any requirements under
10 ORS 813.160.

(2) A report required by ORS 813.100 may be made in one or more forms
 specified by the Department of Transportation.
