A certified copy must be sent to the Department of Corrections when the person has been in the custody of the Department of Corrections. Upon entry of the order, the conviction, arrest, citation, charge or other proceeding shall be deemed not to have occurred, and the applicant may answer accordingly any questions relating to its occurrence.
- "(5) The provisions of subsection (1)(a) of this section apply to a conviction for:
- "(a) A Class B felony, except for a violation of ORS 166.429 or any crime classified as a person felony as that term is defined in the rules of the Oregon Criminal Justice Commission, only if:

- "(7) 'Unlawful debt' means any money or other thing of value constituting
- principal or interest of a debt that is legally unenforceable in the state in
- whole or in part because the debt was incurred or contracted:
- 20 "(a) In violation of any one of the following:
- 21 "(A) ORS chapter 462, relating to racing;
- 22 "(B) ORS 167.108 to 167.164, relating to gambling; or

- **"SECTION 16.** ORS 30.198 is amended to read:
- 2 "30.198. (1) Irrespective of any criminal prosecution or the result thereof,

- 4 action to secure an injunction, damages or other appropriate relief against
- 5 any [and all persons] person whose actions are unlawful under ORS 166.155

- 7 "(2) Upon prevailing in such action, the plaintiff may recover:
- 8 "(a) Both special and general damages, including damages for emotional 9 distress; and
  - "(b) Punitive damages.
- "(3) The court shall award reasonable attorney fees to the prevailing plaintiff in an action under this section. The court may award reasonable attorney fees and expert witness fees incurred by a defendant who prevails in the action if the court determines that the plaintiff had no objectively reasonable basis for asserting a claim or no reasonable basis for appealing an adverse decision of a trial court.
  - "(4) The parent, parents or legal guardian of an unemancipated minor shall be liable for any judgment recovered against such minor under this section, in an amount not to exceed \$5,000.
    - **"SECTION 17.** ORS 30.200 is amended to read:
  - "30.200. If any district attorney has reasonable cause to believe that any person [or group of persons] is engaged in violation of ORS 166.155 or 166.165, the district attorney may bring a civil claim for relief in the appropriate court, setting forth facts pertaining to such violation, and request such relief as may be necessary to restrain or prevent such violation. Any claim for relief under this section does not prevent any person from seeking any other remedy otherwise available under law.
  - "SECTION 18. Section 4 of this 2019 Act and the amendments to ORS 30.198, 30.200, 90.396, 137.225, 137.712, 163.707, 166.155, 166.165 and 166.715 by sections 1, 2 and 11 to 17 of this 2019 Act apply to conduct

occurring on or after the effective date of this 2019 Act.

"SECTION 19. (1)(a) Sections 5, 8 and 9 of this 2019 Act become operative on January 1, 2020.

- (b) The Department of Justice and the Oregon Criminal Justice Commission may take any action before the operative date specified in paragraph (a) of this subsection that is necessary to enable the department or commission to exercise, on and after the operative date specified in paragraph (a) of this subsection, all of the duties, functions and powers conferred on the department or commission by sections 5, 8 and 9 of this 2019 Act.
- (2) The amendments to section 5 of this 2019 Act by section 6 of this 2019 Act become operative on January 2, 2023.

"SECTION 20. This 2019 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect on its passage."
