 - "(2) The purpose of a criminal background check is to preserve safety and prevent criminal acts by determining whether an individual is eligible to be employed as an ignition interlock device technician.

 - "(c) A felony in any jurisdiction within 10 years of the date of the criminal background check.

- "[(2)] (4) The department [of State Police] shall prescribe by rule the process for [conducting] obtaining a criminal background check by the department or, if the department is unable to conduct the check, by the service center requesting the criminal background check.

"[(3)] (5) If the criminal background check conducted by **the department**or a service center reveals that the individual who is the subject of the
criminal background check has been convicted of any of the crimes described
in subsection [(1)] (2) of this section, the service center may not employ the
individual as an ignition interlock device technician.".
