**PROPOSED AMENDMENTS TO
HOUSE BILL 3241**

1 On page 1 of the printed bill, delete lines 4 through 31 and delete page
2 2 and insert:

3 **“SECTION 1. (1) As used in this section, ‘secure vestibule’ means**
4 **an entry to a school building that is visually monitored by an em-**
5 **ployee of the school district or education service district.**

6 **“(2) The Department of Education shall develop and administer a**
7 **grant program under which the department distributes moneys from**
8 **the Secure Vestibule Grant Fund established in section 2 of this 2019**
9 **Act to school districts and education service districts to create secure**
10 **vestibules.**

11 **“(3) To be eligible to receive grants under the program, a school**
12 **district or education service district must:**

13 **“(a) Agree to finance at least one-half of the cost of the secure**
14 **vestibule project from proceeds of local general obligation bonds for**
15 **which the district has received voter approval; and**

16 **“(b) Agree that, in each school building in which a secure vestibule**
17 **is constructed using grant moneys, all other entry points will be con-**
18 **verted to exit-only points.**

19 **“(4) The State Board of Education shall adopt rules necessary to**
20 **ensure that proceeds of bonds issued under Article XI-P of the Oregon**
21 **Constitution are used for purposes permissible under Article XI-P of**

1 the Oregon Constitution. The board may adopt any other rules neces-
2 sary or convenient for the administration of the grant program.

3 **“SECTION 2. (1) The Secure Vestibule Grant Fund is established in**
4 **the State Treasury, separate and distinct from the General Fund. In-**
5 **terest earned on the moneys in the Secure Vestibule Grant Fund must**
6 **be deposited in the fund. The Secure Vestibule Grant Fund consists**
7 **of moneys deposited in the fund under sections 3 and 4 of this 2019 Act**
8 **and may include fees, revenues or other income deposited into the**
9 **fund by the Legislative Assembly.**

10 **“(2) Moneys in the fund are continuously appropriated to the De-**
11 **partment of Education for the purposes described in section 1 of this**
12 **2019 Act.**

13 **“SECTION 3. (1) In addition to and not in lieu of any authorization**
14 **to issue general obligation bonds under ORS 286A.035, in the biennium**
15 **beginning July 1, 2019, the State Treasurer is authorized to issue Ar-**
16 **ticle XI-P bonds in the manner provided by ORS 286A.796 to 286A.806**
17 **in an amount that produces \$___ in net proceeds for the purpose**
18 **specified in subsection (2) of this section, plus an additional amount**
19 **estimated by the State Treasurer to pay bond-related costs.**

20 **“(2) Net proceeds of bonds issued under this section must be trans-**
21 **ferred to the Department of Education for deposit in the Secure**
22 **Vestibule Grant Fund established under section 2 of this 2019 Act to**
23 **be used for the purposes set forth in section 1 of this 2019 Act.**

24 **“SECTION 4. In addition to and not in lieu of any other appropri-**
25 **ation, there is appropriated to the Department of Education, for the**
26 **biennium beginning July 1, 2019, out of the General Fund, the amount**
27 **of \$___ for deposit in the Secure Vestibule Grant Fund established**
28 **under section 2 of this 2019 Act.”.**
