**PROPOSED AMENDMENTS TO  
HOUSE BILL 3085**

1 On page 1 of the printed bill, line 8, delete “Oregon Business Development  
2 Department” and insert “State Department of Agriculture”.

3 In line 9, delete “State Department of Agriculture” and insert “Oregon  
4 Business Development Department”.

5 In line 22, delete “Oregon Business Development Department” and insert  
6 “State Department of Agriculture”.

7 On page 2, line 29, delete “Oregon Business Development Department”  
8 and insert “State Department of Agriculture”.

9 On page 3, delete lines 35 through 45.

10 On page 4, delete lines 1 through 7 and insert:

11 **“SECTION 4.** ORS 285A.435 is amended to read:

12 “285A.435. (1) There is created the [*Beginning and Expanding*] Farmer  
13 Loan Program Fund, separate and distinct from the General Fund. Interest  
14 earned by the [*Beginning and Expanding*] Farmer Loan Program Fund shall  
15 be credited to the fund.

16 **“(2)(a)** All moneys credited to the fund **for the purpose of implement-**  
17 **ing and operating the Beginning and Expanding Farmer Loan Program**  
18 **under ORS 285A.420 to 285A.435** are continuously appropriated to the  
19 Oregon Business Development Department for [*the purpose of implementing*  
20 *and operating the Beginning and Expanding Farmer Loan Program under*  
21 *ORS 285A.420 to 285A.435*] **that purpose.**

1       “(b) All moneys credited to the fund for the purpose of implement-  
2 ing and operating the Family Farmer Loan Program created under  
3 section 2 of this 2019 Act are continuously appropriated to the State  
4 Department of Agriculture for that purpose.

5       “[(2)] (3) The fund shall consist of all moneys credited to the fund, in-  
6 cluding:

7       “(a) Moneys appropriated to the fund by the Legislative Assembly; [or]

8       “(b) Moneys transferred to the fund by the Oregon Business Development  
9 Department and the State Department of Agriculture;

10       “[(b)] (c) Earnings on moneys in the fund;

11       “[(c)] (d) Fees paid to the [department by beginning] departments by  
12 farmers and lenders under the Beginning and Expanding Farmer Loan  
13 Program and the Family Farmer Loan Program; and

14       “[(d)] (e) Moneys from any other source, including but not limited to  
15 grants and gifts.

16       “[(3)] (4) Moneys in the fund may be invested as provided by ORS 293.701  
17 to 293.857 and the earnings from investments shall be credited to the fund.

18       “[(4)] (5) [The department] The Oregon Business Development De-  
19 partment and the State Department of Agriculture may establish ac-  
20 counts within the fund to carry out the provisions of the Beginning and  
21 Expanding Farmer Loan Program and the Family Farmer Loan Pro-  
22 gram, respectively, under ORS 285A.420 to 285A.435.”.

23       In line 10, delete “Oregon Business Development Department and the”.

24       In line 11, after “culture” insert “and the Oregon Business Development  
25 Department”.

26
