- "(c) The offering of special rates or services to persons 50 years of age or older[.];

- "(3) It is an unlawful practice for any person to deny full and equal accommodations, advantages, facilities and privileges of any place of public accommodation in violation of this section.
  - "(4) The definitions in section 1 of this 2019 Act apply to this section.
  - "SECTION 3. (1) Except as provided in subsection (2) of this section, the amendments to ORS 659A.403 by section 2 of this 2019 Act apply to all causes of action under ORS 659A.403, whether arising before, on or after the effective date of this 2019 Act.

- "(1) 'Authorized person' means a person authorized by the owner or possessor of a firearm to carry or control the firearm.

- "(b) 'Container' does not include a building, room or vehicle or a space within a vehicle.

(1)(a) A person who owns, possesses or controls a firearm shall report the loss or theft of the firearm to a law enforcement agency in the jurisdiction in which the loss or theft occurred as soon as practicable but not later than 72 hours of the time the person knew or reasonably should have known of the loss or theft.
- "(b) If a means of reporting a loss or theft of a firearm within 72 hours is not reasonably available, the person who owned, possessed or controlled the firearm that was lost or stolen must report the loss or theft within 24 hours of the means of reporting becoming available.

If a minor obtains access to a firearm and the owner failed to store the firearm in a safe manner, the owner may be guilty of a crime.'

  - "(3)(a) Upon receipt of a request of the gun dealer for a criminal history record check, the department shall immediately, during the gun dealer's telephone call or by return call:

I have been discharged from the jurisdiction of the juvenile court for more than four years if, while a minor, I was found to be within the jurisdiction of the juvenile court for having committed an act that, if committed by an adult, would constitute a felony or a misdemeanor involving violence, as defined in ORS 166.470. I have never been convicted of a felony or found guilty, except for insanity under ORS 161.295, of a felony in the State of Oregon or elsewhere. I have not, within the last four years, been convicted of a misdemeanor or found guilty, except for insanity under ORS

161.295, of a misdemeanor. Except as provided in ORS 166.291 (1)(L), I have 1 not been convicted of an offense involving controlled substances or com-2 pleted a court-supervised drug diversion program. There are no outstanding 3 warrants for my arrest and I am not free on any form of pretrial release. I 4 have not been committed to the Oregon Health Authority under ORS 426.130, 5 nor have I been found to be a person with mental illness and presently sub-6 ject to an order prohibiting me from purchasing or possessing a firearm be-7 cause of mental illness. I am not under a court order to participate in 8 assisted outpatient treatment that includes an order prohibiting me from 9 purchasing or possessing a firearm. - "(3) An entity that adopts an ordinance or policy under this section shall post a sign, visible to the public, identifying all locations where the affirmative defense described in ORS 166.370 (3)(g) is limited or precluded.

**"SECTION 29.** ORS 166.435 is amended to read:

- "166.435. (1) As used in this section:
- "(a) 'Transfer' means the delivery of a firearm from a transferor to a transferee, including, but not limited to, the sale, gift, loan or lease of the
- 24 firearm. 'Transfer' does not include the temporary provision of a firearm to
- 25 a transferee if the transferor has no reason to believe the transferee is pro-
- 26 hibited from possessing a firearm or intends to use the firearm in the com-
- 27 mission of a crime, and the provision occurs:
- "(A) At a shooting range, shooting gallery or other area designed for the purpose of target shooting, for use during target practice, a firearms safety
- or training course or class or a similar lawful activity;

- "(B) For the purpose of hunting, trapping or target shooting, during the time in which the transferee is engaged in activities related to hunting, trapping or target shooting;
- "(C) Under circumstances in which the transferee and the firearm are in the presence of the transferor;
- 6 "(D) To a transferee who is in the business of repairing firearms, for the 7 time during which the firearm is being repaired;
- 8 "(E) To a transferee who is in the business of making or repairing custom 9 accessories for firearms, for the time during which the accessories are being 10 made or repaired; or
- "(F) For the purpose of preventing imminent death or serious physical injury, and the provision lasts only as long as is necessary to prevent the death or serious physical injury.
- "(b) 'Transferee' means a person who is not a gun dealer or licensed as a manufacturer or importer under 18 U.S.C. 923 and who intends to receive a firearm from a transferor.
- "(c) 'Transferor' means a person who is not a gun dealer or licensed as a manufacturer or importer under 18 U.S.C. 923 and who intends to deliver a firearm to a transferee.
- "(2) Except as provided in ORS 166.436 and 166.438 and subsection (4) of this section, a transferor may not transfer a firearm to a transferee unless the transfer is completed through a gun dealer as described in subsection (3) of this section.
- "(3)(a) A transferor may transfer a firearm to a transferee only as provided in this section. Except as provided in paragraph (b) of this subsection, prior to the transfer both the transferor and the transferee must appear in person before a gun dealer, with the firearm, and request that the gun dealer perform a criminal background check on the transferee.
- 29 "(b) If the transferor and the transferee reside over 40 miles from each 30 other, the transferor may ship or deliver the firearm to a gun dealer located

- near the transferee or a gun dealer designated by the transferee, and the transferor need not appear before the gun dealer in person.
- "(c) A gun dealer who agrees to complete a transfer of a firearm under this section shall request a criminal history record check on the transferee as described in ORS 166.412 and shall comply with all requirements of federal law.
- 7 "(d) If, upon completion of a criminal background check, the gun dealer:
- "(A) Receives a unique approval number from the Department of State
  Police indicating that the transferee is qualified to complete the transfer, the
  gun dealer shall notify the transferor, enter the firearm into the gun dealer's
  inventory and transfer the firearm to the transferee.
- "(B) Receives notification that the transferee is prohibited by state or federal law from possessing or receiving the firearm, the gun dealer shall notify the transferor and neither the transferor nor the gun dealer shall transfer the firearm to the transferee. If the transferor shipped or delivered the firearm to the gun dealer pursuant to paragraph (b) of this subsection, the gun dealer shall comply with federal law when returning the firearm to the transferor.
- 19 "(e) A gun dealer may charge a reasonable fee for facilitating a firearm 20 transfer pursuant to this section.
- "(4) The requirements of subsections (2) and (3) of this section do not apply to:
- "(a) The transfer of a firearm by or to a law enforcement agency, or by or to a law enforcement officer, private security professional or member of the Armed Forces of the United States, while that person is acting within the scope of official duties.
- "(b) The transfer of a firearm as part of a firearm turn-in or buyback event, in which a law enforcement agency receives or purchases firearms from members of the public.

- 8 "(H) A transferor's first cousin;
- 9 "(I) A transferor's niece or nephew; or
- "(J) The spouse or domestic partner of a person specified in subparagraphs (B) to (I) of this paragraph.
