- "[(3)] (4) 'Low income' means income that is more than 50 percent and
- not more than 80 percent of the **area** median [family] income [for the area,
- 18 subject to adjustment for areas with unusually high or low incomes or housing
- 19 costs, all as determined by the council based on information from the United
- 20 States Department of Housing and Urban Development].
- "[(4)] (5) 'Minority' means an individual:

- "(a) Who has origins in one of the black racial groups of Africa but who is not Hispanic;
- 3 "(b) Who is of Hispanic culture or origin;
- 4 "(c) Who has origins in any of the original peoples of the Far East,
- 5 Southeast Asia, the Indian subcontinent or the Pacific Islands; or
- 6 "(d) Who is an American Indian or Alaskan Native having origins in one 7 of the original peoples of North America.
- "[(5)] (6) 'Moderate income' means income that is more than 80 percent and not more than 120 percent of the area median [family] income [for the area, subject to adjustment for areas with unusually high or low incomes or housing costs, all as determined by the council based on information from the United States Department of Housing and Urban Development].
- "[(6)] (7) 'Organization' means a:

- "(a) Nonprofit corporation established under ORS chapter 65;
- 15 "(b) Housing authority established under ORS 456.055 to 456.235; or
- "(c) Local government as defined in ORS 197.015.
- "[(7)] (8) 'Persons with disabilities' means persons with handicaps described in 42 U.S.C. 3602(h).
 - "[(8)] (9) 'Very low income' means income that is 50 percent or less of the area median [family] income [for the area, subject to adjustment for areas with unusually high or low incomes or housing costs, all as determined by the council based on information from the United States Department of Housing and Urban Development].
 - "[(9)] (10) 'Veteran' has the meaning given that term in ORS 408.225.".
