**PROPOSED AMENDMENTS TO  
HOUSE BILL 2006**

1 In line 2 of the printed bill, after “housing” insert “; creating new pro-  
2 visions; amending ORS 147.453”.

3 Delete lines 4 through 9 and insert:

4 **“SECTION 1. (1) The Housing and Community Services Department**  
5 **shall award grants to private or public entities to support or develop**  
6 **programs that build on successful strategies that help individuals ob-**  
7 **tain and retain housing, including through:**

8 **“(a) Tenant education services for low-income tenants, including**  
9 **Rent Guarantee Program education under ORS 456.608 (3);**

10 **“(b) Fair housing training for tenants and landlords;**

11 **“(c) Technological innovations that help low-income individuals**  
12 **find and access available rental housing; and**

13 **“(d) Other education, services or resources for low-income tenants**  
14 **and prospective tenants and landlords who serve low-income tenants.**

15 **“(2) The department shall develop a competitive process by which**  
16 **proposals and applications for grants awarded under this section are**  
17 **evaluated.**

18 **“(3) In addition to any criteria adopted under subsection (2) of this**  
19 **section, before a grant may be awarded, a grant application must be**  
20 **approved by the Oregon Housing Stability Council.**

21 **“SECTION 2. (1) The State Court Administrator shall award grants**

1 to private or public entities for providing no-charge legal services re-  
2 lated to housing to low-income individuals.

3 “(2) Grants awarded under this section to the Oregon State Bar or  
4 for any entity funded through the Legal Services Program established  
5 under ORS 9.572 are in addition to and not in lieu of any distribution  
6 made from the Legal Aid Account under ORS 9.577.

7 “SECTION 3. ORS 147.453 is amended to read:

8 “147.453. There is established in the State Treasury, separate and distinct  
9 from the General Fund, the Oregon Domestic and Sexual Violence Services  
10 Fund. All moneys in the fund are continuously appropriated to the Depart-  
11 ment of Justice and shall be used by the department to carry out a program  
12 of domestic and sexual violence services that:

13 “(1) Provides safety for and assists victims of domestic violence and sex-  
14 ual assault, promotes effective intervention and reduces the incidence of do-  
15 mestic violence and sexual assault;

16 “(2) Advocates for victims and for domestic violence and sexual assault  
17 services;

18 “(3) Promotes and facilitates interagency and interdepartmental cooper-  
19 ation among state agencies, including the Department of Human Services,  
20 and among different levels of government in this state in the delivery and  
21 funding of services; *[and]*

22 “(4) **Assists victims of domestic violence and sexual assault with**  
23 **housing needs, including through homelessness prevention, housing**  
24 **search assistance, tenant education and funding for rent, utilities,**  
25 **moving costs, deposits, application fees or safe emergency housing;**  
26 **and**

27 “[~~(4)~~] (5) Encourages and supports services, programs and curricula to  
28 educate and inform students in grades 7 through 12 about teen dating vi-  
29 olence and domestic violence, to provide assistance to victims of teen dating  
30 violence and domestic violence, and to prevent and reduce the incidence of

1 teen dating violence and domestic violence.

2 **“SECTION 4. Sections 1 and 2 of this 2019 Act are repealed on Jan-**  
3 **uary 2, 2022.**

4 **“SECTION 5. In addition to and not in lieu of any other appropri-**  
5 **ation, there is appropriated to the Housing and Community Services**  
6 **Department, for the biennium beginning July 1, 2019, out of the Gen-**  
7 **eral Fund, the amount of \$15,000,000, to administer and award grants**  
8 **under section 1 of this 2019 Act.**

9 **“SECTION 6. In addition to and not in lieu of any other appropri-**  
10 **ation, there is appropriated to the State Court Administrator, for the**  
11 **biennium beginning July 1, 2019, out of the General Fund, the amount**  
12 **of \$2,000,000, to administer and award grants under section 2 of this**  
13 **2019 Act.**

14 **“SECTION 7. In addition to and not in lieu of any other appropri-**  
15 **ation, there is appropriated to the Department of Justice, for the**  
16 **biennium beginning July 1, 2019, out of the General Fund, the amount**  
17 **of \$3,000,000 for deposit into the Oregon Domestic and Sexual Violence**  
18 **Services Fund established under ORS 147.453, for housing for victims**  
19 **under ORS 147.453 (4).”.**

20 In line 10, delete “2” and insert “8”.
