**PROPOSED AMENDMENTS TO  
HOUSE BILL 2512**

1 On page 1 of the printed bill, line 2, after the first semicolon delete the  
2 rest of the line and line 3 and insert “creating new provisions; and amending  
3 ORS 326.021.”.

4 Delete lines 5 through 31 and delete page 2 and insert:

5 **“SECTION 1.** ORS 326.021 is amended to read:

6 “326.021. (1) The State Board of Education shall consist of:

7 “(a) The State Treasurer, or the designee of the State Treasurer;

8 “(b) The Secretary of State, or the designee of the Secretary of State; and

9 “(c) Seven members, appointed by the Governor for a term of four years  
10 beginning July 1 of the year of appointment, subject to confirmation by the  
11 Senate in the manner provided in ORS 171.562 and 171.565. A person ap-  
12 pointed under this paragraph may not be appointed to serve consecutively  
13 more than two full terms as a board member.

14 “(2) In making appointments under subsection (1) of this section, the  
15 Governor shall select from residents of Oregon one member from each con-  
16 gressional district and two members from the state at large. [*An*] **One** ap-  
17 pointed member [*may not*] **from the state at large must** be engaged in  
18 teaching [*or participate in the administration or operation of any school*] **as**  
19 **a licensed teacher in this state.**

20 “(3) The Governor may remove appointed members of the State Board of  
21 Education for cause at any time after notice and public hearing.

1 “(4) The State Treasurer and the Secretary of State, or the designee of the  
2 State Treasurer or Secretary of State, are nonvoting, ex officio members of  
3 the board.

4 “(5) The board shall coordinate and collaborate with the Chief Education  
5 Office as provided by section 1, chapter 519, Oregon Laws 2011.

6 **“SECTION 2.** ORS 326.021, as amended by section 42, chapter 774, Oregon  
7 Laws 2015, is amended to read:

8 “326.021. (1) The State Board of Education shall consist of:

9 “(a) The State Treasurer, or the designee of the State Treasurer;

10 “(b) The Secretary of State, or the designee of the Secretary of State; and

11 “(c) Seven members, appointed by the Governor for a term of four years  
12 beginning July 1 of the year of appointment, subject to confirmation by the  
13 Senate in the manner provided in ORS 171.562 and 171.565. A person ap-  
14 pointed under this paragraph may not be appointed to serve consecutively

27 **“SECTION 3. The amendments to ORS 326.021 by sections 1 and 2**  
28 **of this 2019 Act apply to appointments to the State Board of Education**  
29 **made on or after the effective date of this 2019 Act.”.**
