ORS 238A.330 is amended to read: 12 "238A.330. (1) A member of the individual account program must make 13 employee contributions to the individual account program of six percent of 14 the member's salary. 15 "(2) Employee contributions made by a member of the individual account 16 program under this section shall be credited by the **Public Employees Re**-17 **tirement** Board [to the employee account established for the member under 18 ORS 238A.350 (2).] as follows: 19 "(a) Except as provided in paragraph (c) of this subsection, for a 20member who established membership in the Public Employees Retire1 ment System before August 29, 2003, as described in ORS 238A.025:

"(A) If the member's salary does not exceed \$2,500 in a calendar
month, the board shall credit all employee contributions made by the
member under this section to the employee account established for the
member under ORS 238A.350 (2).

6 "(B) If the member's salary exceeds \$2,500 in a calendar month, the
7 board shall credit:

"(i) 3.5 percent of the member's salary to the employee account
established for the member under ORS 238A.350 (2); and

"(ii) 2.5 percent of the member's salary to the employee pension

 2019 Act.

"(b) Except as provided in paragraph (c) of this subsection, for a
 member who established membership in the system on or after August
 29, 2003, as described in ORS 238A.025:

"(A) If the member's salary does not exceed \$2,500 in a calendar
 month, the board shall credit all employee contributions made by the
 member under this section to the employee account established for the
 member under ORS 238A.350 (2).

"(B) If the member's salary exceeds \$2,500 in a calendar month, the

"(i) 5.25 percent of the member's salary to the employee account

"(5) On January 1 of each year, the board shall adjust the dollar amounts provided in subsection (2) of this section to reflect any percentage increase in the cost of living for the previous calendar year, based on changes in the Consumer Price Index for All Urban Consumers, West Region (All Items), as published by the Bureau of Labor Statistics of the United States Department of Labor.

"SECTION 3. Employee pension stability accounts established. (1)
 The Public Employees Retirement Board shall establish an employee

"(2) Each account established under this section shall be adjusted 1 at least annually in accordance with rules adopted by the board to  $\mathbf{2}$ reflect any net earnings or losses on the amounts in the account. 6 "(3) In the event that a beneficiary has not been named as provided in 7 subsection (1) of this section and ORS 238.390 (1), the death benefit referred 8 to in subsection (1) of this section shall be paid in the manner provided for 9 payment of money credited to the member account of the member in ORS 10 238.390 (2).

"(4) The beneficiary designated under subsection (1) of this section and ORS 238.390 (1) may elect to receive the amount payable in actuarially determined monthly payments for the life of such beneficiary as long as such monthly payments, plus the monthly amount if elected under ORS 238.390 (3), are at least \$200.

"(5) Interest upon the death benefit provided by this section shall accrue until the date that the benefit is distributed. The board shall establish procedures for computing interest to be credited on the benefit for the period between the date of death and date of distribution.

"(6) Payment by the Public Employees Retirement Board of additional death benefits in the manner provided by this section completely discharges the board and system on account of the death, and shall hold the board and system harmless from any claim for wrongful payment.

"(b) Seasonal, emergency or casual workers whose periods of employment

## **"REVIEW BY SUPREME COURT**

"SECTION 65. (1) Jurisdiction is conferred upon the Supreme Court 20to determine in the manner provided by this section whether this 2019 21Act breaches any contract between members of the Public Employees 22Retirement System and their employers or violates any provision of 23the Oregon Constitution or of the United States Constitution, includ-24ing but not limited to impairment of contract rights of members of the 25Public Employees Retirement System under Article I, section 21, of the 26Oregon Constitution, or Article I, section 10, clause 1, of the United 27**States Constitution.** 28

"(2) A person who is adversely affected by this 2019 Act or who will
 be adversely affected by this 2019 Act may institute a proceeding for

review by filing with the Supreme Court a petition that meets the
 following requirements:

"(a) The petition must be filed within 60 days after the effective
date of this 2019 Act.

5 **"(b)** The petition must include the following:

6 "(A) A statement of the basis of the challenge; and

7 "(B) A statement and supporting affidavit showing how the
8 petitioner is adversely affected.

"(3) The petitioner shall serve a copy of the petition by registered
or certified mail upon the Public Employees Retirement Board, the
Attorney General and the Governor.

"(4) Proceedings for review under this section shall be given priority
 over all other matters before the Supreme Court.

"(5) The Supreme Court shall allow public employers participating
 in the Public Employees Retirement System to intervene in any pro ceeding under this section.

17 "(6)(a) The Supreme Court shall allow members of the Legislative 18 Assembly to intervene in any proceeding relating to this 2019 Act. Af-19 ter a member intervenes in a proceeding relating to this 2019 Act, the 20 member has standing to participate in the proceeding even if the 21 member ceases to be a member of the Legislative Assembly.

"(b) A member of the Senate or the House of Representatives who
