 - "(A) To a practitioner or pharmacist, or, if a practitioner or pharmacist authorizes the authority to disclose the information to a member of the practitioner's or pharmacist's staff, to a member of the practitioner's or pharmacist's staff. If a practitioner or pharmacist authorizes disclosing the information to a member of the practitioner's or pharmacist's staff under this subparagraph, the practitioner or pharmacist remains responsible for the use or misuse of the information by the staff member. To receive information under this subparagraph, or to authorize the receipt of information by a staff member under this subparagraph, a practitioner or pharmacist must certify that the requested information is for the purpose of evaluating the need for or providing medical or pharmaceutical treatment for a patient to whom the

practitioner or pharmacist anticipates providing, is providing or has provided care.

- "(B) To a medical director or pharmacy director, or, if a medical director 3 or pharmacy director authorizes the authority to disclose the information to 4 a member of the medical director's or pharmacy director's staff, to a member 5 of the medical director's or pharmacy director's staff. If a medical director 6 or pharmacy director authorizes disclosing the information to a member of 7 the medical director's or pharmacy director's staff under this subparagraph, 8 the medical director or pharmacy director remains responsible for the use 9 or misuse of the information by the staff member. An agreement entered into under this section must adhere to the disclosure limitations listed under ORS 431A.865 [(2)] (3). An agreement entered into under this section may:
