**PROPOSED AMENDMENTS TO  
SENATE BILL 224**

1 On page 1 of the printed bill, line 2, after “ORS” delete the rest of the  
2 line and delete lines 3 through 5 and insert “171.062, 246.021, 247.013, 247.940,  
3 247.945, 247.965, 248.015, 248.017, 248.023, 248.024, 248.026, 248.029, 248.033,  
4 248.035, 248.043, 249.013, 249.035, 249.037, 249.068, 249.072, 249.078, 249.865,  
5 253.540, 253.565, 254.155, 255.012 and 260.993; repealing ORS 248.010 and  
6 sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15 and 16, chapter 70, Oregon  
7 Laws 2019 (Enrolled House Bill 2491); and prescribing an effective date.”.

8 Delete lines 7 through 18 and delete pages 2 through 25 and insert:

9 **“SECTION 1.** ORS 247.013 is amended to read:

10 “247.013. (1) A qualified person shall be considered registered to vote in  
11 a county when the person’s first registration in the county occurs as de-  
12 scribed in ORS 247.012.

13 “(2) An elector who changes residence address from the county in which  
14 the elector is registered to a different county within the state, in order to  
15 vote in an election, must be an elector registered in the county in which the  
16 new residence address of the elector is located.

17 “(3) If there is a change in any information required for registration un-  
18 der this chapter, and the elector has not changed residence address to an-  
19 other county, the registration of the elector may be updated as provided in  
20 this chapter.

21 “(4) Notwithstanding subsections (2) and (3) of this section, if an elector

1 changes residence address from the county in which the elector is registered  
2 to a different county within the state, the elector need not register again if  
3 the registration of the elector is updated.

4 “(5) If the county clerk does not have evidence of a change in any infor-  
5 mation required for registration under this chapter for an elector, the regis-  
6 tration of the elector shall be considered active.

7 “(6) The registration of an elector shall be considered inactive if:

8 “(a) The county clerk has received evidence that there has been a change  
9 in the information required for registration under this chapter [*or the elector*  
10 *has neither voted nor updated the registration for a period of not less than five*  
11 *years*]; and

12 “(b) The county clerk has mailed the notice described in ORS 247.563.

13 “[~~(7)~~ *The registration of an elector shall not be moved to an inactive file*  
14 *during the 60-day period prior to any election because the elector has neither*  
15 *voted nor updated the registration for a period of not less than five years.*]

16 “[~~(8)~~ (7) The inactive registration of an elector must be updated before  
17 the elector may vote in an election.

18 “**SECTION 2.** ORS 253.540 is amended to read:

19 “253.540. (1) Any military or overseas elector may secure a ballot by  
20 submitting an application as specified in subsection (2) of this section to the  
21 clerk of the county of the military or overseas elector’s residence, or to the  
22 Secretary of State. If the application is addressed to the Secretary of State,  
23 the secretary shall forward it to the appropriate county clerk.

24 “(2) An application for a ballot by a military or overseas elector shall be  
25 made in the form of a written request **and may be submitted by mail,**  
26 **electronic mail, a facsimile machine or other means identified by the**  
27 **Secretary of State by rule.** The application shall be valid for every subse-  
28 quent election until the elector otherwise notifies the clerk or is no longer  
29 an elector of the county. The application shall be signed by the applicant  
30 and contain:

- 1       “(a) The name and current mailing address of the applicant;
- 2       “(b) A statement that the applicant is a citizen of the United States;
- 3       “(c) A statement that the applicant will be 18 years of age or older on the  
4 date of the election;
- 5       “(d) A statement that for more than 20 days preceding the election the  
6 applicant’s home residence has been in this state, and giving the address of  
7 the last home residence;
- 8       “(e) A statement of the facts that qualify the applicant as a military or  
9 overseas elector or as the spouse or a dependent of a military or overseas  
10 elector;
- 11       “(f) A statement that the applicant is not requesting a ballot from any  
12 other state and is not voting in any other manner in the election except by  
13 the requested ballot; and
- 14       “(g) If the applicant desires to vote in a primary election, a designation  
15 of the applicant’s political party affiliation or a statement that the applicant  
16 is not affiliated with any political party. An applicant not affiliated with any  
17 political party may request a ballot for a major political party. The applicant  
18 shall be sent the ballot for the political party that the applicant requested  
19 if that political party has provided under ORS 254.365 for a primary election  
20 that admits electors not affiliated with any political party.
- 21       “SECTION 3. ORS 253.565 is amended to read:
- 22       “253.565. (1) Any military or overseas elector may secure a special ballot  
23 for a primary election or general election by making an application under  
24 this section if the elector believes that:
- 25       “(a) The elector will be residing, stationed or working outside the terri-  
26 torial limits of the United States and the District of Columbia; and
- 27       “(b) The elector will be unable to vote and return a regular ballot by  
28 normal mail delivery within the period provided for regular absent electors.
- 29       “(2) A military or overseas elector shall make the application for a special  
30 ballot in the form of a written request, **which may be submitted by mail,**

1 **electronic mail, a facsimile machine or other means identified by the**  
2 **Secretary of State by rule.** The elector shall submit the application before  
3 the date of the applicable election to the clerk of the county of the military  
4 or overseas elector’s residence or to the Secretary of State. If the application  
5 is addressed to the Secretary of State, the secretary shall forward it to the  
6 appropriate county clerk. The application shall be signed by the applicant  
7 and contain:

8 “(a) The name and current mailing address of the applicant;

9 “(b) A designation of the election for which the applicant requests a  
10 special ballot;

11 “(c) A statement that the applicant is a citizen of the United States;

12 “(d) A statement that the applicant will be 18 years of age or older on the  
13 date of the election;

14 “(e) A statement that for more than 20 days preceding the election the  
15 applicant’s home residence has been in this state, and giving the address of  
16 the last home residence;

17 “(f) A statement of the facts that qualify the applicant as a military or  
18 overseas elector or as the spouse or a dependent of a military or overseas  
19 elector;

20 “(g) A statement of the facts that qualify the applicant to vote by means  
21 of a special ballot;

22 “(h) A statement that the applicant is not requesting a ballot from any  
23 other state and is not voting in any other manner in the election except by  
24 the requested special ballot; and

25 “(i) If the applicant requests a ballot for a primary election, a designation  
26 of the applicant’s political party affiliation or a statement that the applicant  
27 is not affiliated with any political party. An applicant not affiliated with any  
28 political party may request a ballot for a major political party. The appli-  
29 cant shall be sent the ballot for the political party that the applicant re-  
30 quested if that political party has provided under ORS 254.365 for a primary

1 election that admits electors not affiliated with any political party.

2 “(3) An application for a special ballot shall be valid only for the election  
3 specified in the application.

4 “(4) The county clerk shall list on the special ballot the offices and  
5 measures scheduled to appear on the regular ballot, if known when the ballot  
6 is prepared, and provide space in which the elector may write in the elector’s  
7 preference.

8 “(5) The elector may write in the name of any eligible candidate for each  
9 office to be filled or for which nominations will be made at the election, and  
10 may vote on any measure submitted at the election.

11 **“SECTION 4.** ORS 246.021 is amended to read:

12 “246.021. (1) Except as provided in ORS 247.012 and subsection (2) of this  
13 section, an election document and an accompanying payment of fees required  
14 to be filed with the Secretary of State, county clerk or other filing officer  
15 must be delivered to and actually received at the office of the designated  
16 officer not later than 5 p.m. of the day the document or fee is due or, if the  
17 day due is a Saturday, Sunday or holiday, on the next business day.

18 “(2) If, at 5 p.m. of the day an election document is due, an individual is  
19 physically present in the office of the secretary, county clerk or other filing  
20 officer and in line waiting to deliver the document, the individual is con-  
21 sidered to have begun the act of delivering the document and is permitted  
22 to file it.

23 “(3) Except as provided in ORS **253.540, 253.565 and** 253.690, any election  
24 document required to be filed with the filing officer other than ballots, voter  
25 registration cards or petitions requiring signatures of electors may also be  
26 filed by means of an electronic facsimile transmission machine or electronic  
27 mail. If an election document is required to be filed by a specified time, the  
28 entire document must be received at the office of the filing officer not later  
29 than 5 p.m. of the day the document is due or, if the day due is a Saturday,  
30 Sunday or holiday, on the next business day.

1 “(4) Notwithstanding any provision of subsections (1) to (3) of this sec-  
2 tion, if a statement is required to be filed electronically under ORS 260.057:

3 “(a) The statement must be received electronically at the office of the  
4 Secretary of State not later than 11:59 p.m. of the day the statement is due  
5 or, if the day due is a Saturday, Sunday or holiday, on the next business day;  
6 and

7 “(b) The Secretary of State may not accept the filing of the statement in  
8 any form other than an electronic format.

9 “(5) As used in this section, ‘election document’ includes, but is not lim-  
10 ited to, a declaration of candidacy for nomination for public or political  
11 party office, completed nominating petitions, statements and portraits for  
12 voters’ pamphlets, statements of election campaign contributions and ex-  
13 penditures, and initiative, referendum or recall petitions.

14 **“SECTION 5.** ORS 247.940 is amended to read:

15 “247.940. (1) *[Not later than the 21st day before any primary election, gen-*  
16 *eral election or special congressional election,]* A major political party quali-  
17 fied under ORS 248.006 *[or its affiliate within the county]* or a minor political  
18 party qualified under ORS 248.008 may request from the *[county clerk]* **Sec-**  
19 **retary of State** a **statewide** list of *[active]* electors, as described in ORS  
20 **247.945 (4)** *[247.013, of the county. Except as provided in this section, the list*  
21 *shall contain the name, party affiliation, residence or mailing address and*  
22 *precinct name or number of each active elector and shall be arranged in groups*  
23 *by election precinct].* The list may not contain any information about partic-  
24 ipants in the Address Confidentiality Program established under ORS 192.820  
25 to 192.868 **or any information that may not be publicly disclosed under**  
26 **section 21, chapter 70, Oregon Laws 2018.** A major political party *[or its*  
27 *affiliate within the county]* or a minor political party may make no more than  
28 two separate requests under this subsection **per primary election, general**  
29 **election or special election.**

30 “(2) **A request for a list under subsection (1) of this section must**

1 **be made:**

2 “(a) Not earlier than six months before the primary election, gen-  
3 eral election or special election; and

4 “(b) Not later than the 15th day before the primary election, general  
5 election or special election.

6 “[~~(2)~~] (3) If the [*county clerk*] **Secretary of State** receives a request under  
7 subsection (1) of this section, the [*clerk*] **secretary** shall deliver the list not  
8 later than[:]

9 “[*(a) Ten*] **10** days after receiving the request.[: or]

10 “[*(b) The date requested, provided that the date requested is more than 10*  
11 *days after the request was made and at least 10 days before the date of any*  
12 *primary election, general election or special congressional election.*]

13 “[~~(3)~~] (4) The [*county clerk*] **Secretary of State** may not charge for  
14 preparation or delivery of the list supplied under this section.

15 “**SECTION 6.** ORS 247.945 is amended to read:

16 “247.945. (1) The county clerk, upon request before the 45th day before a  
17 primary, general or special election, shall deliver to any person a list of  
18 electors. The list may not contain any information about participants in the  
19 Address Confidentiality Program established under ORS 192.820 to 192.868  
20 **or any information that may not be publicly disclosed under section**  
21 **21, chapter 70, Oregon Laws 2018.** The lists shall be prepared in the man-  
22 ner requested, limited only to the capabilities of the Secretary of State or  
23 the county clerk.

24 “(2) The county clerk shall collect and pay into the county treasury a  
25 charge for the actual cost of supplying lists under subsection (1) of this  
26 section.

27 “(3) The county clerk shall keep a record of all persons to whom a list  
28 of electors is delivered under this section.

29 “(4) Upon request, the Secretary of State shall deliver to any person a  
30 statewide list of electors. **Except as provided in ORS 247.940 (4),** the sec-

1 retary shall charge a fee of \$500 for delivering a list under this subsection.  
2 The list may not contain any information about participants in the Address  
3 Confidentiality Program established under ORS 192.820 to 192.868 **or any**  
4 **information that may not be publicly disclosed under section 21,**  
5 **chapter 70, Oregon Laws 2018.**

6 **“SECTION 7.** ORS 247.965 is amended to read:

7 “247.965. (1) Any elector may request the county clerk to keep the resi-  
8 dence address of the elector exempt from disclosure as a public record under  
9 ORS 192.311 to 192.478.

10 “(2) The county clerk shall keep the residence address of an elector ex-  
11 empt from disclosure as a public record under ORS 192.311 to 192.478 if the  
12 elector making the request demonstrates to the satisfaction of the county  
13 clerk that the elector’s personal safety or the safety of any family member  
14 residing with the elector is in danger if the elector’s address remains avail-  
15 able for public inspection.

16 “(3) The county clerk shall automatically mail a ballot to an elector  
17 whose residence address is exempt from disclosure under this section.

18 “(4) An exemption from disclosure granted under this section shall remain  
19 in effect until the elector requests termination of the exemption or the  
20 elector is required to update the elector’s registration. If the elector is re-  
21 quired to update the elector’s registration, the elector may apply for another  
22 exemption from disclosure.

23 “(5) An exemption from disclosure granted under this section includes an  
24 exemption from disclosure of the residence address of an elector under ORS  
25 247.940 or 247.945.

26 “(6) A county clerk **or the Secretary of State** shall not be held liable  
27 for:

28 “(a) Granting or denying an exemption from disclosure under this section;  
29 or

30 “(b) Any unauthorized release of a residence address granted an ex-



1 exemption from disclosure under this section.

2 **“SECTION 8.** ORS 254.155, as amended by section 11, chapter 70, Oregon  
3 Laws 2018, is amended to read:

4 “254.155. (1) Not later than the 69th day before the date of any election  
5 the Secretary of State shall complete a random ordering of the letters of the  
6 alphabet.

7 “(2) Not later than the 68th day before the date of any election the Sec-  
8 retary of State shall mail or deliver to each county clerk a copy of the ran-  
9 dom ordering of the letters of the alphabet.

10 “(3) The county clerk shall arrange by surname the names of the candi-  
11 dates on the ballot in the random order of the letters of the alphabet com-  
12 pleted by the Secretary of State under subsection (1) of this section.

13 “(4) The requirements of this section **apply only if at least one con-**  
14 **tested candidate race** *[do not apply to any election in which only one can-*  
15 *didate]* will be on the ballot.

16 **“SECTION 9.** ORS 171.062 is amended to read:

17 “171.062. (1) When a legislative district in which a vacancy occurs en-  
18 compasses two or more counties, each county shall be entitled to one vote  
19 for each 1,000 of its electors or major fraction thereof residing within the  
20 legislative district at the time **when either the office becomes vacant, or**  
21 **a resignation becomes binding under ORS 236.325, whichever occurs**  
22 **first** *[vacancy occurs]*. However, any county having electors in the district  
23 shall be entitled to at least one vote.

24 “(2) A major fraction of electors shall be a number greater than 500 but  
25 less than 1,000.

26 **“SECTION 10.** ORS 255.012 is amended to read:

27 “255.012. As used in this chapter, ‘district’ means:

28 “(1) A domestic water supply district organized under ORS chapter 264.

29 “(2) A cemetery maintenance district organized under ORS chapter 265.

30 “(3) A park and recreation district organized under ORS chapter 266.

- 1 “(4) A mass transit district organized under ORS 267.010 to 267.390.

8 “**SECTION 11.** ORS 260.993 is amended to read:

9 “260.993. (1) The penalty for violation of ORS 260.532 is limited to that  
10 provided in ORS 260.532 (6) and (8).

11 “(2) Violation of ORS 247.125 (1), 247.171 (5), 247.420 (2), 253.710, 260.402,  
12 260.555, 260.558, 260.575, 260.645 or 260.665 (2) or (3) involving any action  
13 described in ORS 260.665 (2)(d) to (f) or 260.715 is a Class C felony.

14 “(3) Violation of ORS 260.695 [(4)] **(3)** is a Class A misdemeanor.

15 “(4) Violation of ORS 247.171 (6) is a Class C misdemeanor.

16 “**SECTION 12.** ORS 249.068, as amended by section 13, chapter 70, Oregon  
17 Laws 2018, is amended to read:

18 “249.068. (1) Except as otherwise provided for a candidate for nonpartisan  
19 office in ORS 249.072:

20 “(a) A nominating petition for an office to be voted for in the state at  
21 large or for a candidate for Representative in Congress shall contain signa-  
22 tures of members of the same major political party as the candidate. Except  
23 as provided in this subsection, there shall be at least 1,000 signatures or the  
24 number of signatures at least equal to two percent of the vote cast in the  
25 state or congressional district, as the case may be, for the candidates of that  
26 major political party for presidential electors at the last presidential  
27 election, whichever is less;

28 “(b) For an election next following any change in the boundaries of a  
29 congressional district, there shall be at least 1,000 signatures or the number  
30 of signatures at least equal to two percent of the average number of votes

1 cast in all congressional districts in this state, as the case may be, for the  
2 candidates of that major political party for presidential electors at the last  
3 presidential election, whichever is less;

4 “(c) In the case of a candidate nominated by a major political party that  
5 did not nominate presidential electors at the last presidential election, there  
6 shall be at least 1,000 signatures; and

7 “(d) If the office is one to be voted for in the state at large, the signatures  
8 shall include those of **at least 100** electors registered in **each congressional**  
9 **district** [*at least five percent of the precincts in each of at least seven counties.*  
10 *If the office is one to be voted for in a congressional district the signatures*  
11 *shall include those of electors registered in at least five percent of the precincts*  
12 *in each of at least one-fourth of the counties in the congressional district*].

13 “(2) Except as otherwise provided in this section or for a candidate for  
14 nonpartisan office in ORS 249.072:

15 “(a) A nominating petition for an office not provided for in subsection (1)  
16 of this section shall contain the signatures of electors who are members of  
17 the same major political party as the candidate. There shall be at least 500  
18 signatures or the number of signatures at least equal to two percent of the  
19 vote in the electoral district for the candidates of that major political party  
20 for presidential electors at the last presidential election, whichever is less;

21 “(b) In the case of major political party candidates for the office of state  
22 Senator or state Representative, for an election next following any change  
23 in the boundaries of the districts of state Senators or state Representatives  
24 under Article IV, section 6, of the Oregon Constitution, there shall be at  
25 least 500 signatures or the number of signatures at least equal to two percent  
26 of the average number of votes cast in all state senatorial or state repre-  
27 sentative districts in this state, as the case may be, for the candidates of that  
28 major political party for presidential electors at the last presidential  
29 election, whichever is less; **and**

30 “(c) In the case of a candidate nominated by a major political party that

1 did not nominate presidential electors at the last presidential election, there  
2 shall be at least 500 signatures[;].

3 “[(d) *If the office under this subsection is to be voted for in more than one*  
4 *county, the signatures shall include those of electors registered in at least two*  
5 *counties encompassed by the electoral district, and the signatures from each*  
6 *such county shall include those of electors registered in at least six percent of*  
7 *the precincts of the electoral district that are located within that county. If six*  
8 *percent of the precincts of the electoral district in one of the counties or portion*  
9 *thereof does not constitute a whole precinct, the nominating petition shall*  
10 *contain signatures from at least one precinct in that county; and]*

11 “[(e) *If the office is to be voted for in only one county or in a city, the sig-*  
12 *natures shall include those of electors registered in at least 10 percent of the*  
13 *precincts in the electoral district.]*

14 “**SECTION 13.** ORS 249.072, as amended by section 12, chapter 70, Oregon  
15 Laws 2018, is amended to read:

16 “249.072. (1) If the nonpartisan office is to be voted for in the state at  
17 large, the nominating petition shall contain at least 1,000 signatures of  
18 electors, or a number of signatures of electors equal to at least one percent  
19 of the vote cast in the state for all candidates for Governor at the most re-  
20 cent election at which a candidate for Governor was elected to a full term,  
21 whichever is less. The signatures shall include those of **at least 100** electors  
22 registered in each **congressional district** [*of at least five percent of the pre-*  
23 *cincts in each of at least seven counties].*

24 “(2) The nominating petition for a nonpartisan office not provided for in  
25 subsection (1) of this section shall contain at least 500 signatures of electors  
26 in the electoral district, or a number of signatures of electors equal to at  
27 least one percent of the vote cast in the electoral district for all candidates  
28 for Governor at the most recent election at which a candidate for Governor  
29 was elected to a full term, whichever is less. [*In addition:*]

30 “[(a) *If an office under this subsection is to be voted for in more than one*

1 county, the signatures shall include those of electors registered in at least two  
2 counties encompassed by the electoral district, and the signatures from each  
3 such county shall include those of electors registered in at least six percent of  
4 the precincts of the electoral district that are located within that county. If six  
5 percent of the precincts of the electoral district in one of the counties or portion  
6 thereof does not constitute a whole precinct, the nominating petition shall  
7 contain signatures from at least one precinct in that county.]

8 “[b) If the office is to be voted for in only one county or in a city, the  
9 signatures shall include those of electors registered in at least 10 percent of the  
10 precincts in the electoral district.]

11 **“SECTION 14.** ORS 249.078 is amended to read:

12 “249.078. (1) The name of a candidate for a major political party nomi-  
13 nation for President of the United States shall be printed on the ballot only:

14 “(a) By direction of the Secretary of State who in the secretary’s sole  
15 discretion has determined that the candidate’s candidacy is generally advo-  
16 cated or is recognized in national news media; or

17 “(b) By nominating petition described in this section and filed with the  
18 Secretary of State.

19 “(2) A petition nominating a candidate under this section shall contain  
20 from each congressional district the signatures of at least 1,000 electors who  
21 are registered in the district and who are members of the major political  
22 party of the candidate. [*The electors in each congressional district shall in-*  
23 *clude electors registered in at least five percent of the precincts in each of at*  
24 *least one-fourth of the counties in the congressional district.*] The petition  
25 shall contain the printed name, residence or mailing address and name or  
26 number of the precinct, if known, of each elector whose signature appears  
27 on the petition. The signatures shall be certified for genuineness by the  
28 county clerks or the Secretary of State under ORS 249.008.

29 “(3) Before circulating the nominating petition, the chief sponsor shall  
30 file with the Secretary of State a signed copy of the prospective petition. The

1 chief sponsor shall include with the prospective petition a statement declar-  
2 ing whether one or more persons will be paid money or other valuable con-  
3 sideration for obtaining signatures of electors on the petition. After the  
4 prospective petition is filed, the chief sponsor shall notify the Secretary of  
5 State not later than the 10th day after the chief sponsor first has knowledge  
6 or should have had knowledge that:

7 “(a) Any person is being paid for obtaining signatures, when the state-  
8 ment included with the prospective petition declared that no such person  
9 would be paid.

10 “(b) No person is being paid for obtaining signatures, when the statement  
11 included with the prospective petition declared that one or more such per-  
12 sons would be paid.

13 **“SECTION 15.** ORS 249.865 is amended to read:

14 “249.865. (1) Pursuant to [*section 18,*] Article II, **section 18**, of the Oregon  
15 Constitution, an elector of the electoral district from which the public officer  
16 is elected may file a petition demanding the recall of the public officer. **The**  
17 **production and circulation of the petition must conform to the re-**  
18 **quirements governing recall petitions set forth in ORS 250.048 and**  
19 **250.052.** Before the petition is circulated for signatures, the chief petitioner  
20 of the petition shall file with the officer authorized to order the recall  
21 election a copy of the prospective petition signed by the chief petitioner.

22 “(2) The chief petitioner shall include with the prospective petition a  
23 statement declaring whether one or more persons will be paid money or other

29 ment included with the prospective petition declared that no such person  
30 would be paid.

1 “(b) No person is being paid for obtaining signatures, when the statement  
2 included with the prospective petition declared that one or more such per-  
3 sons would be paid.

4 “(3) Each sheet of the recall petition must contain:

5 “(a) The words ‘Petition for recall of,’ (name and title of officer) and the  
6 date of the filing under subsection (1) of this section; and

7 “(b) The name and address of [*the treasurer or*] the chief petitioner listed  
8 on the statement of organization filed under ORS 260.118.

9 “(4) Not more than 20 signatures on each sheet of the recall petition shall  
10 be counted. The circulator shall certify on each signature sheet that the  
11 circulator:

12 “(a) Witnessed the signing of the signature sheet by each individual  
13 whose signature appears on the signature sheet; and

14 “(b) Believes each individual is an elector.

15 “(5) Any intentional or willful violation of subsection (1) or (2) of this  
16 section by a chief petitioner of the recall petition [*or by the treasurer*] listed  
17 on the statement of organization filed under ORS 260.118 invalidates the  
18 prospective petition before it is circulated for signatures.

19 **“SECTION 16. Sections 17 and 18 of this 2019 Act are added to and  
20 made a part of ORS chapter 248.**

21 **“SECTION 17. (1) Subject to ORS 248.015 (4), a person may partic-  
22 ipate as a write-in candidate for precinct committeeperson by filing  
23 with the county elections official a declaration of write-in candidacy.

23 **“(b) Request that the county elections official count any write-in  
24 votes received by the write-in candidate.**

25 **“(2) An elector who is nominated as a write-in candidate under this  
26 section is not eligible for election to the office of precinct committee-  
27 person unless:**

28 **“(a) The write-in candidate meets the qualifications set forth in  
29 ORS 248.015 (4); and**

30 **“(b) The write-in candidate receives three or more votes.**

1        **“SECTION 19.** ORS 249.035 is amended to read:

2        “249.035. A nominating petition, **write-in form prepared under section**  
3 **17 or 18 of this 2019 Act** or declaration of candidacy relating to a candidate  
4 for:

5        “(1) State office, United States Senator or Representative in Congress  
6 shall be filed with the Secretary of State.

7        “(2) County office or precinct committeeperson shall be filed with the  
8 county [*clerk*] **elections official**.

9        “(3) City office shall be filed with the chief city elections officer.

10       “(4) Any elected office of a metropolitan service district under ORS  
11 chapter 268 shall be filed with the county [*clerk*] **elections official** of the  
12 county in which the administrative office of the district is located.

13       “(5) Any other office shall be filed under ORS chapter 255.

14        **“SECTION 20.** ORS 248.023 is amended to read:

15        “248.023. (1) Not later than the 20th day after a primary election, the  
16 county [*clerk*] **elections official** shall mail a certificate of election to each  
17 newly elected precinct committeeperson within the county. The [*clerk*]

30 “[b] (B) Declare that office vacant.

1       **“SECTION 22.** ORS 248.026 is amended to read:

2       “248.026. (1) The members of a county central committee may **fill a va-**  
3 **cancy in the office of precinct committeeperson by selecting** *[select]* a  
4 member of the major political party who is registered in:

5       **“(a)** The precinct in which the vacancy exists[,]; *[or registered in a pre-*  
6 *inct within the same county adjoining that precinct, to fill a vacancy in the*  
7 *office of precinct committeeperson.]*

8       **“(b) A precinct adjoining the precinct in which the vacancy exists**  
9 **that is within the same county; or**

10       **“(c) A precinct that is both within the same county and state Rep-**  
11 **resentative district as the precinct in which the vacancy exists.**

22        “(3) The cost of the election shall be paid by the county central committee  
23 of the party of the **precinct** committeeperson.

24        **“SECTION 24.** ORS 248.033 is amended to read:

25        “248.033. (1) The organizational meeting of a county central committee  
26 shall be held no less frequently than every 25 months.

27        “(2) The retiring county central committee shall prepare a written notice  
28 designating the time, date and place of the meeting and file a copy of the  
29 notice with the county [*clerk*] **elections official** not later than the 40th day  
30 before the date of the meeting. The retiring county central committee also

1 shall mail a copy of the notice to the state central committee.

5 a member of the major political party not later than **180 days before** the
