  - "SECTION 8. Notwithstanding any other law limiting expenditures, the limitation on expenditures established by chapter 372, section 2 (2), Oregon Laws 2017, for the biennium ending June 30, 2019, as the maximum limit for payment of expenses by the Department of Consumer and Business Services from the Health Insurance Exchange Fund established by ORS 741.102, for the Central Services Division, is increased by \$803,245.
- "SECTION 9. This 2019 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is
