**PROPOSED AMENDMENTS TO
HOUSE BILL 2015**

1 On page 1 of the printed bill, line 3, after “97.953,” insert “247.017,”.

2 On page 2, lines 11 and 12, delete the boldfaced material.

3 In line 45, delete the boldfaced material.

4 On page 3, line 1, delete “section”.

5 On page 4, line 5, delete “proof, as defined by the department by rule,
6 of”.

7 On page 5, line 13, delete “proof, as defined by the department by rule,
8 of”.

9 On page 10, delete lines 20 through 45.

10 On page 11, delete lines 1 through 16 and insert:

11 **“SECTION 7.** ORS 807.730, as amended by section 19, chapter 568, Oregon
12 Laws 2017, is amended to read:

13 “807.730. (1) The Department of Transportation may issue or replace a
14 **Real ID** limited term driver license, **Real ID** limited term commercial driver
15 license, **Real ID** limited term driver permit, limited term commercial learner
16 driver permit, **limited term commercial driver license that is not a Real**
17 **ID** or **Real ID** limited term identification card only for a person who pro-
18 vides proof, as determined by the department by rule, that the person [*is le-*
19 *gally present*] **has lawful status** in the United States on a temporary basis.

20 “(2) A **Real ID** limited term driver license, **Real ID** limited term com-
21 mercial driver license, **limited term commercial driver license that is**

1 **not a Real ID** or **Real ID** limited term identification card is valid:

2 “(a) During the applicant’s authorized stay in the United States, but no
3 longer than eight years from the date of issuance; or

4 “(b) If there is no definite end to the authorized stay, for a period of one
5 year.

6 “(3) A **Real ID** limited term driver permit or a limited term commercial
7 learner driver permit is valid:

8 “(a) During the applicant’s authorized stay in the United States, but no
9 longer than the period of time for which a driver permit of the same type is
10 issued by the department.

11 “(b) If there is no definite end to the authorized stay, for a period of one
12 year but no longer than the period of time for which a driver permit of the
13 same type is issued by the department.

14 “(4) A **Real ID** limited term driver license, **Real ID** limited term com-
15 mercial driver license, **limited term commercial driver license that is**
16 **not a Real ID, Real ID** limited term driver permit[, *limited term commercial*
17 *learner driver permit*] or **Real ID** limited term identification card may be
18 renewed only upon presentation of valid documentation, as determined by the
19 department by rule, that the status by which the applicant qualified for the
20 **Real ID** limited term driver license, **Real ID** limited term commercial driver
21 license, **limited term commercial driver license that is not a Real ID,**
22 **Real ID** limited term driver permit[, *limited term commercial learner driver*
23 *permit*] or **Real ID** limited term identification card has been extended or is
24 still in effect.

25 “(5) A **Real ID** limited term driver license or **Real ID** limited term driver
26 permit grants the same **driving** privileges as a driver license or driver per-
27 mit.

28 “(6) A **Real ID** limited term identification card shall bear a statement to
29 the effect that the **Real ID** limited term identification card is not a license
30 or any other grant of driving privileges to operate a motor vehicle and is to

1 be used for identification purposes only.

2 “(7) A limited term commercial driver license, a **Real ID limited term**
3 **commercial driver license** or limited term commercial learner driver per-
4 mit grants the same privileges as a commercial driver license or commercial
5 learner driver permit.

6 “(8) The department may issue a **Real ID limited term commercial**
7 **driver license**, limited term commercial driver license **that is not a Real**
8 **ID** or limited term commercial learner driver permit if the applicant is oth-
9 erwise eligible for commercial driving privileges. The department may adopt
10 rules describing eligibility requirements for **Real ID** limited term commercial
11 driver licenses, **limited term commercial driver licenses that are not**
12 **Real ID** and limited term commercial learner driver permits.

13 “(9) A **Real ID** limited term driver license, **Real ID** limited term com-
14 mercial driver license, **limited term commercial driver license that is**
15 **not a Real ID, Real ID limited term driver permit, limited term com-**
16 **mmercial learner driver permit** or **Real ID** limited term identification card
17 shall clearly indicate **on the face of the card and in the machine read-**
18 **able zone** that it is a **Real ID** limited term driver license, **Real ID** limited
19 term commercial driver license, **limited term commercial driver license**
20 **that is not a Real ID, Real ID limited term driver permit, limited term**
21 **commercial learner driver permit** or **Real ID** limited term identification
22 card and indicate the date on which it expires.”.

23 On page 25, after line 39, insert:

“OUTREACH

27 “SECTION 23a. (1) **The Department of Transportation shall conduct**
28 **an outreach program to educate driver license and driver permit ap-**
29 **plicants and the general public about the operation of sections 9 and**
30 **11 of this 2019 Act, the amendments to ORS 97.953, 659A.885, 802.195,**

1 802.200, 807.021, 807.040, 807.130, 807.173, 807.285, 807.310, 807.400, 807.405
2 and 807.730 by sections 1 to 7 and 12 to 22 of this 2019 Act and the re-
3 peal of ORS 807.735 by section 24 of this 2019 Act as of the operative
4 date specified in section 26 of this 2019 Act. The program must:

5 “(a) In collaboration with impacted communities, develop a com-
6 munication strategy for dissemination of information using a variety
7 of media sources, state agencies, associations and organizations.

8 “(b) Effectively communicate with specific populations in a manner
9 that is culturally and linguistically appropriate.

10 “(c) Provide communications, including educational materials, in
11 English and in languages other than English that are most commonly
12 spoken by the residents of this state.

13 “(2) To carry out the provisions of this section, the department may
14 enter into a contract with a business or an organization.

15 “SECTION 23b. Section 23a of this 2019 Act is repealed on January
16 2, 2023.

18 **“VOTER REGISTRATION**

19

20 “SECTION 23c. ORS 247.017 is amended to read:

21 “247.017. (1) The Secretary of State shall by rule establish a schedule by
22 which the Department of Transportation shall provide to the secretary elec-
23 tronic records containing the legal name, age, residence and citizenship in-
24 formation for, and the electronic signature of, each person who meets
25 qualifications identified by the secretary by rule.

26 “(2) Upon receiving the electronic record for, and electronic signature of,
27 a person described in subsection (1) of this section, the Secretary of State
28 shall provide the information to the county clerk of the county in which the
29 person may be registered as an elector. The secretary or county clerk shall
30 notify each person of the process to:

1 “(a) Decline being registered as an elector.

2 “(b) Adopt a political party affiliation.

3 “(3) If a person notified under subsection (2) of this section does not de-
4 cline to be registered as an elector within 21 calendar days after the Secre-
5 tary of State or county clerk issues the notification, the person’s electronic
6 record and electronic signature submitted under subsection (1) of this section
7 will constitute a completed registration card for the person for purposes of
8 this chapter. The person shall be registered to vote if the county clerk de-
9 termines that the person is qualified to vote under Article II, section 2, of
10 the Oregon Constitution, and the person is not already registered to vote.

11 “(4) A county clerk may not send a ballot to, or add to an elector regis-
12 tration list, a person who meets eligibility requirements until at least 21
13 calendar days after the Secretary of State or county clerk provided notifica-
14 tion to the person as described in subsection (2) of this section.

15 **“(5) In addition to providing electronic records to the Secretary of**
16 **State under subsection (1) of this section, the Department of Trans-**
17 **portation may by rule develop, and require the availability or use of,**
18 **any form or application the department determines is necessary to**
19 **ensure compliance with the voter registration provisions of the Na-**
20 **tional Voter Registration Act of 1993 (P.L. 103-31).**

21 “[(5)] (6) The Secretary of State shall adopt rules required to implement
22 **subsections (1) to (4) of this section.”.**

23 On page 26, line 6, after “97.953,” insert “247.017,”.

24 In line 8, delete the first “and” and insert a comma and after “22” insert
25 “and 23c”.

26 In line 14, after “97.953,” insert “247.017,”.

27 In line 15, delete the second “and” and insert a comma and after “22”
28 insert “and 23c”.

29 After line 36, insert:

1 **“EXPENDITURE LIMITATIONS**

2

3 **“SECTION 29. Notwithstanding any other law limiting expenditures,**
4 **the limitation on expenditures established by section 2 (9), chapter __,**
5 **Oregon Laws 2019 (Enrolled House Bill 5039), for the biennium begin-**
6 **ning July 1, 2019, as the maximum limit for payment of expenses from**
7 **fees, moneys or other revenues, including Miscellaneous Receipts and**
8 **federal funds received as reimbursement from the United States De-**
9 **partment of Transportation, but excluding lottery funds and federal**
10 **funds not described in this section, collected or received by the De-**
11 **partment of Transportation, for the administration of driver and mo-**
12 **tor vehicle services, is increased by \$4,264,589.”.**
