29 **grams, is increased by \$29,146,011.**

30 **"SECTION 8. Notwithstanding any other law limiting expenditures,**

1 the limitation on expenditures established by section 4 (8), chapter 604,
2 Oregon Laws 2017, for the biennium ending June 30, 2019, as the max-
3 imum limit for payment of expenses from fees, moneys or other reve-
4 nues, including Miscellaneous Receipts and federal funds received as
5 reimbursement from the United States Department of Transportation,
6 but excluding lottery funds and federal funds not described in section
7 4, chapter 604, Oregon Laws 2017, collected or received by the Depart-
8 ment of Transportation, for the local government program, is de-
9 creased by \$29,146,011.

10 SECTION 9. This 2019 Act being necessary for the immediate
11 preservation of the public peace, health and safety, an emergency is
12 declared to exist, and this 2019 Act takes effect on its passage.”.
