**PROPOSED AMENDMENTS TO

(INCLUDING AMENDMENTS TO RESOLVE CONFLICTS)**

2 section 32, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill 1008)”.

3 On page 4, after line 31, insert:

4 **“SECTION 9.** If Senate Bill 1008 becomes law and Senate Bill 1013 does  
5 not become law, section 32, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled  
6 Senate Bill 1008), is amended to read:

12 420.011, 420.081 and 420A.203 by sections 1 to 23 and 26 to 29 [*of this 2019*  
13 *Act*], **chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill 1008),** apply  
14 to sentences imposed on or after January 1, 2020.

1 **26 to 29, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill 1008),**  
2 **do not apply to persons who were originally sentenced before January**  
3 **1, 2020, and who are subsequently resentenced on or after January 1,**  
4 **2020, as the result of an appellate decision or a post-conviction relief**  
5 **proceeding or for any other reason.**

6 **“SECTION 10.** If both Senate Bill 1008 and Senate Bill 1013 become law,  
7 section 32, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill 1008), as  
8 amended by section 3c, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate  
9 Bill 1013), is amended to read:

16 **Senate Bill 1013)**, by sections 1 to 23 and 26 to 29, chapter \_\_\_\_\_, Oregon  
17 Laws 2019 (Enrolled Senate Bill 1008), and section 3a [*of this 2019 Act*],  
18 **chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill 1013)**, apply to  
19 sentences imposed on or after January 1, 2020.

27 **23 and 26 to 29, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill**  
28 **1008), and section 3a, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Sen-**  
29 **ate Bill 1013), do not apply to persons who were originally sentenced**  
30 **before January 1, 2020, and who are subsequently resentenced on or**

1 **after January 1, 2020, as the result of an appellate decision or a post-**  
2 **conviction relief proceeding or for any other reason.”.**

3 In line 32, delete “9” and insert “11”.
