13 to sentences imposed on or after January 1, 2020.

18 **339.319, 339.321, 419C.005, 419C.050, 419C.346, 419C.349, 419C.352, 419C.355,**
19 **419C.358, 419C.361, 420.011, 420.081 and 420A.203 by sections 1 to 23 and**
20 **26 to 29, chapter _____, Oregon Laws 2019 (Enrolled Senate Bill 1008),**
21 **do not apply to persons who were originally sentenced before January**

1 **1, 2020, and who are subsequently resentenced on or after January 1,**
2 **2020, as the result of an appellate decision or a post-conviction relief**
3 **proceeding or for any other reason.”.**
