**PROPOSED AMENDMENTS TO
HOUSE BILL 2164**

1 In line 2 of the printed bill, after “taxation;” insert “creating new pro-
2 visions; amending ORS 307.455, 307.459, 307.517, 307.518, 307.523, 307.529,
3 307.535, 314.752, 315.266, 315.675, 318.031 and 358.499 and section 19, chapter
4 954, Oregon Laws 2001, section 7, chapter 637, Oregon Laws 2005, sections 7
5 and 10, chapter 826, Oregon Laws 2005, section 66, chapter 832, Oregon Laws
6 2005, section 6, chapter 880, Oregon Laws 2007, sections 2b, 7b, 17 and 18,
7 chapter 906, Oregon Laws 2007, sections 5, 24, 28, 34 and 36, chapter 913,
8 Oregon Laws 2009, and sections 58, 61, 63, 64, 66, 67 and 70, chapter 122,
9 Oregon Laws 2019 (Enrolled House Bill 3427); repealing ORS 825.475;”.

12 **“TAX CREDIT FOR HIGHER EDUCATION SAVINGS OR**
13 **ABLE ACCOUNT CONTRIBUTIONS**
14

15 **“SECTION 1. Sections 2 and 3 of this 2019 Act are added to and**
16 **made a part of ORS chapter 315.**

17 **“SECTION 2. (1) A credit against taxes otherwise imposed under**
18 **ORS chapter 316 shall be allowed for amounts contributed by the tax-**
19 **payer during the tax year to a savings network account for higher**
20 **education established under ORS 178.300 to 178.355 or an ABLE account**
21 **established under ORS 178.380. A taxpayer who makes contributions**

1 to both types of account may claim the credit for the amounts listed
2 in subsection (2) of this section for each type of account.

3 “(2) The amount of the credit allowed under this section shall be
4 limited based on the taxpayer’s adjusted gross income and shall be the
5 lesser of \$300, if reported on a joint return, or \$150, if reported on any
6 other type of return, or the following:

7 “(a) The amount contributed, if the taxpayer’s adjusted gross in-
8 come does not exceed \$30,000;

9 “(b) 50 percent of the amount contributed, if the taxpayer’s adjusted
10 gross income exceeds \$30,000 but does not exceed \$70,000;

11 “(c) 25 percent of the amount contributed, if the taxpayer’s adjusted
12 gross income exceeds \$70,000 but does not exceed \$100,000;

13 “(d) 10 percent of the amount contributed, if the taxpayer’s adjusted
14 gross income exceeds \$100,000 but does not exceed \$250,000; or

15 “(e) 5 percent of the amount contributed, if the taxpayer’s adjusted
16 gross income exceeds \$250,000.

17 “(3)(a) The Department of Revenue shall annually adjust the maxi-
18 mum credit amounts allowable under this section according to the
19 cost-of-living adjustment for the calendar year. The department shall
20 first make this adjustment for a joint return by multiplying the maxi-
21 mum credit amount in subsection (2) of this section by the percentage
22 (if any) by which the monthly averaged U.S. City Average Consumer
23 Price Index for the 12 consecutive months ending August 31 of the
24 prior calendar year exceeds the monthly averaged U.S. City Average
25 Consumer Price Index for the 12 consecutive months ending August
26 31, 2018.

27 “(b) As used in this subsection, ‘U.S. City Average Consumer Price
28 Index’ means the U.S. City Average Consumer Price Index for All Ur-
29 ban Consumers (All Items) as published by the Bureau of Labor Sta-
30 tistics of the United States Department of Labor.

1 “(c) If any adjustment to the maximum credit amount for a joint
2 return, as determined under paragraph (a) of this subsection, is not a
3 multiple of \$20, the adjustment shall be rounded to the next lower
4 multiple of \$20. The department shall then adjust the maximum credit
5 amount for all other types of returns so that it is half the maximum
6 credit amount for a joint return.

7 “(4) A credit under this section is allowed for a preceding tax year
8 for amounts contributed to a savings network account for higher ed-
9 ucation or to an ABLE account if the contribution is made before the
10 taxpayer files a return or before the 15th day of the fourth month
11 following the closing of the taxpayer’s tax year, whichever is earlier.

12 “(5) A credit is not allowed under this section for any amount that
13 has been transferred into a savings network account for higher edu-
14 cation from an individual development account, through a rollover,
15 as provided in ORS 458.685 (4)(a)(A).

16 “(6) If the amount allowable as a credit under this section, when
17 added to the sum of the amounts allowable as payment of tax under
18 ORS 316.187 (withholding), ORS 316.583 (estimated tax), other tax pre-
19 payment amounts and other refundable credit amounts, exceeds the
20 taxes imposed by ORS chapters 314 and 316 for the tax year (reduced
21 by any nonrefundable credits allowable for purposes of ORS chapter
22 316 for the tax year), the amount of the excess shall be refunded to the
23 taxpayer as provided in ORS 316.502.

24 “(7) The credit shall be claimed on a form prescribed by the De-
25 partment of Revenue that contains the information required by the
26 department.

27 “(8) Spouses in a marriage who file separate returns for a taxable
28 year may each claim a share of the tax credit that would have been
29 allowed on a joint return in proportion to the adjusted gross income
30 of each.

1 **“(9) In the case of a credit allowed under this section:**

2 **“(a) A nonresident shall be allowed the credit in the proportion**
3 **provided in ORS 316.117.**

4 **“(b) If a change in the status of the taxpayer from resident to**
5 **nonresident or from nonresident to resident occurs, the credit shall**
6 **be determined in a manner consistent with ORS 316.117.**

7 **“(c) If a change in the taxable year of the taxpayer occurs as de-**
8 **scribed in ORS 314.085, or if the department terminates the taxpayer’s**
9 **taxable year under ORS 314.440, the credit shall be prorated or com-**
10 **puted in a manner consistent with ORS 314.085.**

11 **“SECTION 3. (1) As provided in subsection (2) of this section, prior**
12 **tax relief afforded a taxpayer by virtue of the credit allowed under**
13 **section 2 of this 2019 Act shall be forfeited if any of the following are**
14 **taken:**

15 **“(a) A nonqualified withdrawal from an account, as defined in ORS**
16 **178.300;**

17 **“(b) A withdrawal from a savings network account for higher edu-**
18 **cation established under ORS 178.300 to 178.355 to pay expenses in**
19 **connection with enrollment or attendance at an elementary or sec-**
20 **ondary school; or**

21 **“(c) A distribution from an ABLE account that is not a qualified**
22 **disability expense of the designated beneficiary as provided in ORS**
23 **178.375 and 178.380 and rules adopted by the Oregon 529 Savings Board.**

24 **“(2) A taxpayer shall report the amount of a disallowed withdrawal**
25 **or distribution in the tax year in which it is taken, and shall remit the**
26 **taxes due as a result of the forfeited credit. The Department of Rev-**
27 **enue shall by rule determine the calculation of forfeited credit**
28 **amounts.**

29 **“(3) If a taxpayer does not report a disallowed withdrawal or dis-**
30 **tribution in the tax year that it is taken, and notwithstanding ORS**

1 314.410, the department shall proceed to collect those taxes, including
2 penalties and interest, not paid by the taxpayer as a result of the tax
3 credit allowed the taxpayer.

4 **“SECTION 4. Except as provided in ORS 316.699 (4), a taxpayer:**

5 **“(1) May use a subtraction under ORS 316.699 only for contributions**
6 **made in tax years beginning before January 1, 2020; and**

7 **“(2) May carry forward and use a subtraction under ORS 316.699 (4)**
8 **only in tax years beginning before January 1, 2025.**

9 **“SECTION 5. Sections 2 and 3 of this 2019 Act apply to tax years**
10 **beginning on or after January 1, 2020, and before January 1, 2026.**

11
12 **“TAX CREDIT FOR SHORT LINE RAILROAD REHABILITATION**

13
14 **“SECTION 6. Sections 7 to 14 of this 2019 Act are added to and made**
15 **a part of ORS chapter 315.**

16 **“SECTION 7. As used in sections 7 to 14 of this 2019 Act:**

17 **“(1) ‘Infrastructure’ includes tracks, switches, sidings, roadbeds,**
18 **railroad bridges and industrial leads owned by a short line railroad.**

19 **“(2) ‘Short line railroad’ means a class II or class III railroad as**
20 **defined in 49 C.F.R. 1201.**

21 **“(3) ‘Short line railroad rehabilitation project’ means a project that**
22 **involves the maintenance, reconstruction or replacement of**
23 **infrastructure.**

24 **“(4) ‘Short line railroad rehabilitation project costs’ means costs**
25 **that are directly related to the work necessary to maintain, recon-**
26 **struct or replace infrastructure. ‘Short line railroad rehabilitation**
27 **project costs’ does not include costs that are funded by or used to**
28 **qualify for any state or federal grants, or costs that are used to claim**
29 **a federal tax credit.**

30 **“(5) ‘Tier I short line railroad’ means a short line railroad owned**

1 or leased by a person for whom the total length of short line railroad
2 track owned or leased in Oregon is equal to or greater than 200 miles.
3 The total amount of short line railroad track in Oregon calculated
4 under this subsection includes any short line railroad track owned or
5 leased by the person, or if the person is a corporation, by the person's
6 parent corporation or subsidiaries, regardless of whether the track is
7 owned or leased by one or more railroads.

8 “(6) ‘Tier II short line railroad’ means a short line railroad that is
9 not a tier I short line railroad or is a short line railroad owned or
10 leased by the state, a city, a county, a port or any other public or
11 municipal corporation.

12 “SECTION 8. (1) A credit against taxes imposed by ORS chapter 316
13 (or, if the taxpayer is a corporation, under ORS chapter 317 or 318) is
14 allowed to a taxpayer, based upon short line railroad rehabilitation
15 project costs actually paid or incurred by the taxpayer during the tax
16 year for which the credit is claimed.

17 “(2) The credit allowed under this section shall be the least of:

18 “(a) In the case of a tier I short line railroad, \$1,000 multiplied by
19 the number of miles of short line railroad track the taxpayer owns or
20 leases in this state on the day the short line railroad rehabilitation
21 project is completed;

22 “(b) In the case of a tier II short line railroad, \$3,500 multiplied by
23 the number of miles of short line railroad track the taxpayer owns or
24 leases in this state on the day the short line railroad rehabilitation
25 project is completed; or

26 “(c) Fifty percent of the short line railroad rehabilitation project
27 costs paid or incurred by the taxpayer during the tax year in which
28 the credit is claimed.

29 “(3) For the credit to be allowed under this section:

30 “(a) The infrastructure must be located in Oregon; and

1 **“(b) The taxpayer must:**
2 **“(A) Own or lease the infrastructure;**
3 **“(B) Be a short line railroad; and**
4 **“(C) Receive a final written certification from the Department of**
5 **Transportation before claiming the credit.**
6 **“(4) The amount of the credit claimed under this section for any**
7 **one tax year may not exceed the tax liability of the taxpayer.**
8 **“(5) Any tax credit otherwise allowable under this section that is**
9 **not used by the taxpayer in a particular tax year may be carried for-**
10 **ward and offset against the taxpayer’s tax liability for the next suc-**
11 **ceeding tax year. Any credit remaining unused in that next succeeding**
12 **tax year may be carried forward and used in the second succeeding tax**
13 **year, and likewise, any credit not used in that second succeeding tax**
14 **year may be carried forward and used in the third succeeding tax year,**
15 **and likewise, any credit not used in that third succeeding tax year**
16 **may be carried forward and used in the fourth succeeding tax year,**
17 **and likewise, any credit not used in that fourth succeeding tax year**
18 **may be carried forward and used in the fifth succeeding tax year but**
19 **may not be carried forward for any tax year thereafter.**
20 **“(6) The credit allowed under this section is not in lieu of any de-**
21 **preciation or amortization deduction for the short line railroad reha-**
22 **bilitation project to which the taxpayer otherwise may be entitled for**
23 **purposes of ORS chapter 316, 317 or 318 for the tax year.**
24 **“(7) The taxpayer’s adjusted basis for determining gain or loss may**
25 **not be decreased by any tax credit allowed under this section.**
26 **“(8)(a) The Department of Revenue may by rule require that the**
27 **Department of Transportation provide information about a certifica-**
28 **tion issued under section 9 of this 2019 Act, including the name and**
29 **taxpayer identification number of the taxpayer or other person re-**
30 **ceiving certification, the date the certification was issued in its final**

1 form, the approved amount of credit and the first tax year for which
2 the credit may be claimed.

3 “(b) A taxpayer that is a pass-through entity that has received
4 certification under section 9 of this 2019 Act shall provide to the De-
5 partment of Revenue, within two months after the close of the tax
6 year in which the certification was issued, the name, taxpayer iden-
7 tification number and any other information required by the depart-
8 ment of each owner receiving a distributive share of the credit, in a
9 manner prescribed by the department.

10 “(9) The Department of Revenue shall prescribe by rule the manner
11 and the timing of submission of the information described in sub-
12 section (8) of this section to the department.

13 “(10) The credit shall be claimed on a form prescribed by the De-
14 partment of Revenue that contains the information required by the
15 department.

16 “(11) In the case of a credit allowed under this section:

17 “(a) A nonresident shall be allowed the credit under this section in
18 the proportion provided in ORS 316.117.

19 “(b) If a change in the status of a taxpayer from resident to non-
20 resident or from nonresident to resident occurs, the credit allowed by
21 this section shall be determined in a manner consistent with ORS
22 316.117.

23 “(c) If a change in the taxable year of a taxpayer occurs as de-
24 scribed in ORS 314.085, or if the Department of Revenue terminates a
25 taxpayer’s taxable year under ORS 314.440, the credit allowed under
26 this section shall be prorated or computed in a manner consistent with
27 ORS 314.085.

28 “SECTION 9. (1) Prior to construction of a short line railroad re-
29 habilitation project, a taxpayer may apply to the Department of
30 Transportation for preliminary certification of the project in the

1 manner prescribed by rules adopted under this section, which must
2 include:

3 “(a) Timelines and deadlines for submission of application materi-
4 als;

5 “(b) A description of the information required by the department
6 to determine that the taxpayer qualifies for the credit allowed under
7 section 8 of this 2019 Act;

8 “(c) Criteria for determining the amount of the tax credit allowed
9 under section 8 of this 2019 Act, including standards for what consti-
10 tutes completion of a short line railroad rehabilitation project;

11 “(d) The process by which an applicant will be notified of an in-
12 complete application and the time allowed for the applicant to provide
13 the missing information; and

14 “(e) The month and date by which the department must notify an
15 applicant of the preliminary certification decision and the potential
16 amount of the tax credit for which the applicant has received prelim-
17 inary certification.

18 “(2) If the total amount of potential tax credits allowed under sec-
19 tion 8 of this 2019 Act for all taxpayers that have applied for prelimi-
20 nary certification exceeds the limit in section 8 of this 2019 Act, the
21 department shall allocate the tax credits allowed under section 8 of
22 this 2019 Act as follows:

23 “(a) By giving first priority to all tier II short line railroads that
24 own or lease less than 75 miles of short line railroad track in this
25 state; and

26 “(b) By giving second priority to all tier II short line railroads not
27 described in paragraph (a) of this subsection.

28 “(3) If the department must allocate tax credits to a group of tax-
29 payers in an amount that is less than the amount the taxpayers would
30 otherwise receive under section 8 of this 2019 Act, the department shall

1 divide the available tax credits among the group proportionally, based
2 on the amount each taxpayer would have otherwise received under
3 section 8 of this 2019 Act.

4 **“SECTION 10. (1) A taxpayer may apply to the Department of**
5 **Transportation for final certification of a short line railroad rehabili-**
6 **tation project if:**

7 **“(a) The taxpayer received preliminary certification for the project**
8 **under section 9 of this 2019 Act; and**

9 **“(b) The project is completed.**

10 **“(2) After approving the application, the department shall certify**
11 **the project, including the amount of the tax credit for which the tax-**
12 **payer has received final certification. The department may not certify**
13 **an amount that is more than the amount approved in the preliminary**
14 **certification for the project.**

15 **“(3) The department may establish by rule a process for accepting**
16 **applications and issuing final certifications under this section.**

17 **“SECTION 11. (1) The Department of Transportation may charge**
18 **and collect a fee from taxpayers for preliminary or final certification**
19 **of short line rehabilitation projects under sections 9 and 10 of this 2019**
20 **Act. The fee may not exceed the cost to the department of issuing**
21 **certifications.**

22 **“(2) All fees collected under this section shall be deposited in the**
23 **State Treasury to the credit of the Railroad Fund established under**
24 **ORS 824.014. Moneys deposited under this section are continuously**
25 **appropriated to the Department of Transportation for the purpose of**
26 **administering and enforcing the provisions of sections 7 to 14 of this**
27 **2019 Act.**

28 **“SECTION 12. (1) A person that has obtained a tax credit under**
29 **section 8 of this 2019 Act may transfer the credit to a taxpayer under**
30 **ORS chapter 316, 317 or 318. A transfer that occurs on or after January**

1 1, 2020, is conditioned upon compliance with this section and ORS
2 315.052 and 315.053.

3 “(2) The Department of Revenue may require that the person that
4 has earned the credit and the taxpayer that intends to claim the credit
5 jointly file a notice of tax credit transfer with the department on or
6 before the earliest of the following dates:

7 “(a) A date 30 days after the transfer of the credit;

8 “(b) The date on which the transferee files a return; or

9 “(c) The due date, including extensions, of the transferee’s return.

10 “(3) The notice shall be given on a form prescribed by the depart-
11 ment that contains:

12 “(a) The name and address of the transferor and of the transferee;

13 “(b) The taxpayer identification number of the transferor and of the
14 transferee;

15 “(c) The dates on which the person earning the credit received
16 certifications for the credit;

17 “(d) The amount of the credit that is certified, the amount that is
18 being transferred and the amount that is being retained by the
19 transferor; and

20 “(e) Any other information required by the department.

21 “(4)(a) A transferor may separately transfer the entirety of that
22 portion corresponding to the tax year to one or more transferees,
23 subject to subsection (5) of this section.

24 “(b) Any amount of credit that would be allowed due only to a
25 carryforward provision may not be transferred.

26 “(5) Any transfer of a tax credit or a portion of a tax credit must
27 be completed no later than the earliest of the following dates in re-
28 lation to the tax return on which the credit is claimed:

29 “(a) The original due date, including extensions, of the transferor’s
30 return;

1 **“(b) The date on which the transferor’s return is actually filed;**

2 **“(c) The original due date, including extensions, of the transferee’s**
3 **return; or**

4 **“(d) The date on which the transferee’s return is actually filed.**

5 **“(6) Notwithstanding subsection (5) of this section, if the transferor**
6 **is a tax-exempt entity, the transfer must be completed on or before a**
7 **date one year after the close of the tax year for which the credit was**
8 **certified. As used in this subsection, ‘tax-exempt entity’ means a**
9 **government agency or an organization that is recognized as exempt**
10 **under section 501(c)(3) of the Internal Revenue Code.**

11 **“(7) The transferee shall claim the credit in accordance with the**
12 **credit provisions for the tax years in which the credit is allowed.**

13 **“(8) The department by rule may establish policies and procedures**
14 **for the implementation of this section.**

15 **“SECTION 13. The total amount of potential tax credits allowed**
16 **under section 8 of this 2019 Act at the time of preliminary certification**
17 **under section 9 of this 2019 Act may not exceed \$4 million for any**
18 **biennium.**

19 **“SECTION 14. (1) Under the procedures for a contested case under**
20 **ORS chapter 183, the Director of Transportation may order the sus-**
21 **pension, revocation or forfeiture of a tax credit certification under**
22 **section 9 or 10 of this 2019 Act, or of a portion thereof, if the director**
23 **finds that:**

24 **“(a) The certification was obtained by fraud or misrepresentation;**

25 **“(b) The certification was obtained by mistake or miscalculation;**
26 **or**

27 **“(c) The taxpayer otherwise violates or has violated a condition or**
28 **requirement for eligibility for the tax credit.**

29 **“(2) As soon as an order of revocation under this section becomes**
30 **final, the director shall notify the Department of Revenue and the**

1 person that received the tax credit certification of the order of revo-
2 cation. Upon notification, the Department of Revenue immediately
3 shall proceed to collect:

4 “(a) If no portion of a credit has been transferred, those taxes not
5 paid by the holder of the certification as a result of the tax credits
6 provided to the holder under the revoked approval, from the holder
7 or a successor in interest to the business interests of the holder. All
8 tax credits provided to the holder and attributable to the fraudulently
9 or mistakenly obtained certification or portion of the certification
10 shall be forfeited.

11 “(b) If all of a credit has been transferred, an amount equal to the
12 amount of the tax credits allowable to the transferee under the re-
13 voked certification, from the transferor.

14 “(c) If a portion of a tax credit has been transferred, those taxes
15 not paid by the transferor as a result of the tax credits provided to the
16 transferor pursuant to the revoked certification, from the transferor
17 or a successor in interest to the business interests of the transferor,
18 and an amount equal to the amount of the tax credits allowable to the
19 transferee pursuant to the revoked certification, from the transferor.

20 “(3)(a) The Department of Revenue shall have the benefit of all laws
21 of the state pertaining to the collection of income and excise taxes and
22 may proceed to collect the amounts described in subsection (2) of this
23 section from the person that obtained certification or a successor in
24 interest to the business interests of that person. An assessment of tax
25 is not necessary and the collection of taxes described in this subsection
26 is not precluded by any statute of limitations.

27 “(b) For purposes of this subsection, a lender, bankruptcy trustee
28 or other person that acquires an interest through bankruptcy or
29 through foreclosure of a security interest is not considered to be a
30 successor in interest to the business interests of the person that ob-

1 **tained certification.**

2 **“(4) If the certification is ordered revoked pursuant to this section,**
3 **the holder of the certification shall be denied any further relief in**
4 **connection with the credit from and after the date that the order of**
5 **revocation becomes final.**

6 **“(5) Notwithstanding subsections (1) to (4) of this section, a certi-**
7 **fication or portion of a certification held by a transferee may not be**
8 **considered revoked for purposes of the transferee, the tax credit al-**
9 **lowable to the transferee may not be reduced and a transferee is not**
10 **liable under this section.**

11 **“(6) Interest under this section shall accrue at the rate established**
12 **in ORS 305.220 beginning the day after the due date of the return on**
13 **which the credit may first be claimed.**

14 **“(7) The Department of Revenue may collect amounts owed under**
15 **this section by a partnership from the partnership.**

16 **“SECTION 15.** ORS 314.752, as amended by section 7, chapter 108, Oregon
17 Laws 2018, is amended to read:

18 **“314.752. (1) Except as provided in ORS 314.740 (5)(b), the tax credits al-**
19 **lowed or allowable to a C corporation for purposes of ORS chapter 317 or**
20 **318 shall not be allowed to an S corporation. The business tax credits al-**
21 **lowed or allowable for purposes of ORS chapter 316 shall be allowed or are**
22 **allowable to the shareholders of the S corporation.**

23 **“(2) In determining the tax imposed under ORS chapter 316, as provided**
24 **under ORS 314.734, on income of the shareholder of an S corporation, there**
25 **shall be taken into account the shareholder’s pro rata share of business tax**
26 **credit (or item thereof) that would be allowed to the corporation (but for**
27 **subsection (1) of this section) or recapture or recovery thereof. The credit (or**
28 **item thereof), recapture or recovery shall be passed through to shareholders**
29 **in pro rata shares as determined in the manner prescribed under section**
30 **1377(a) of the Internal Revenue Code.**

1 “(3) The character of any item included in a shareholder’s pro rata share
2 under subsection (2) of this section shall be determined as if such item were
3 realized directly from the source from which realized by the corporation, or
4 incurred in the same manner as incurred by the corporation.

5 “(4) If the shareholder is a nonresident and there is a requirement appli-
6 cable for the business tax credit that in the case of a nonresident the credit
7 be allowed in the proportion provided in ORS 316.117, then that provision
8 shall apply to the nonresident shareholder.

9 “(5) As used in this section, ‘business tax credit’ means the following
10 credits: ORS 315.104 (forestation and reforestation), ORS 315.138 (fish
11 screening, by-pass devices, fishways), ORS 315.141 (biomass production for
12 biofuel), ORS 315.156 (crop gleaning), ORS 315.164 and 315.169 (agriculture
13 workforce housing), ORS 315.176 (bovine manure), ORS 315.204 (dependent
14 care assistance), ORS 315.208 (dependent care facilities), ORS 315.213 (con-
15 tributions for child care), ORS 315.237 (employee and dependent scholar-
16 ships), ORS 315.271 (individual development accounts), ORS 315.304
17 (pollution control facility), ORS 315.326 (renewable energy development con-
18 tributions), ORS 315.331 (energy conservation projects), ORS 315.336 (trans-

8 Code.

9 “(e) Charitable risk pools described in section 501(n) of the Internal Rev-
10 enue Code.

11 “(f) Organizations described in section 521 of the Internal Revenue Code.

12 “(g) Qualified state tuition programs described in section 529 of the
13 Internal Revenue Code.

14 “(h) Foreign or alien insurance companies, but only with respect to the
15 underwriting profit derived from writing wet marine and transportation in-
16 surance subject to tax under ORS 731.824 and 731.828.

17 “(i) Governmental entities.

18 “(j) Any person with commercial activity that does not exceed [*\$1*
19 *million*] **\$750,000** for the calendar year, other than a person that is part of
20 a unitary group as provided in section 60, **chapter 122, Oregon Laws 2019**
21 **(Enrolled House Bill 3427)**, [*of this 2019 Act*] with commercial activity in
22 excess of [*\$1 million*] **\$750,000**.

23 “(k) Hospitals subject to assessment under section 2, chapter 736, Oregon
24 Laws 2003, long term care facilities subject to assessment under section 16,
25 chapter 736, Oregon Laws 2003, or any entity subject to assessment under
26 section 3, 5 or 9, chapter 538, Oregon Laws 2017.

27 “[~~(7)~~] **(5)** ‘Financial institution’ has the meaning given that term in ORS
28 314.610, except that ‘financial institution’ does not include a credit union.

29 “[~~(8)(a)~~] **(6)(a)** ‘FR Y-9’ means the consolidated or parent-only financial
30 statements that a holding company is required to file with the Federal Re-

1 serve Board pursuant to 12 U.S.C. 1844.

2 “(b) In the case of a holding company required to file both consolidated
3 and parent-only financial statements, ‘FR Y-9’ means the consolidated finan-
4 cial statements that the holding company is required to file.

5 “[9] (7) ‘Governmental entity’ means:

6 “(a) The United States and any of its unincorporated agencies and in-
7 strumentalities.

8 “(b) Any incorporated agency or instrumentality of the United States
9 wholly owned by the United States or by a corporation wholly owned by the
10 United States.

11 “(c) The State of Oregon and any of its unincorporated agencies and in-
12 strumentalities.

13 “(d) Any county, city, district or other political subdivision of the state.

14 “(e) [*Any public corporation*] **A special government body as defined in**
15 **ORS 174.117.**

16 “(f) A federally recognized Indian tribe.

17 “[10] (8) ‘Groceries’ means food as defined in 7 U.S.C. 2012(k), **but does**
18 **not include cannabinoid edibles or marijuana seeds.**

19 “(9)(a) ‘**Hedging transaction’ means a hedging transaction as de-**
20 **defined in section 1221 of the Internal Revenue Code or a transaction**
21 **accorded hedge accounting treatment under Financial Accounting**
22 **Standards Board Statement No. 133.**

23 “(b) ‘**Hedging transaction’ does not include a transaction in which**
24 **an actual transfer of title of real or tangible property to another entity**
25 **occurs.**

26 “[11] (10) ‘Insurer’ has the meaning given that term in ORS 317.010.

27 “[12] (11) ‘Internal Revenue Code,’ except where the Legislative Assem-
28 bly has provided otherwise, refers to the laws of the United States or to the
29 Internal Revenue Code as they are amended and in effect on December 31,
30 2018.

1 “[13] (12) ‘Labor costs’ means total compensation of all employees, not
2 to include compensation paid to any single employee in excess of \$500,000.

3 “[14(a)] (13)(a) ‘Motor vehicle fuel or any other product used for the
4 propulsion of motor vehicles’ means:

5 “(A) Motor vehicle fuel as defined in ORS 319.010; and

6 “(B) Fuel the use of which in a motor vehicle is subject to taxation under
7 ORS 319.530.

8 “(b) ‘Motor vehicle fuel or any other product used for the propulsion of
9 motor vehicles’ does not mean:

10 “(A) Electricity; or

11 “(B) Electric batteries or any other mechanical or physical component or
12 accessory of a motor vehicle.

13 “[15] (14) ‘Person’ includes individuals, combinations of individuals of
14 any form, receivers, assignees, trustees in bankruptcy, firms, companies,
15 joint-stock companies, business trusts, estates, partnerships, limited liability
16 partnerships, limited liability companies, associations, joint ventures, clubs,
17 societies, entities organized as for-profit corporations under ORS chapter 60,
18 C corporations, S corporations, qualified subchapter S subsidiaries, qualified
19 subchapter S trusts, trusts, entities that are disregarded for federal income
20 tax purposes and any other entities.

21 “[16] (15) ‘Retailer’ means a person doing business by selling tangible
22 personal property to a purchaser for a purpose other than:

23 “(a) Resale by the purchaser of the property as tangible personal property
24 in the regular course of business;

25 “(b) Incorporation by the purchaser of the property in the course of reg-
26 ular business as an ingredient or component of real or personal property; or

27 “(c) Consumption by the purchaser of the property in the production for
28 sale of a new article of tangible personal property.

29 “[17] (16) ‘Taxable commercial activity’ means commercial activity
30 sourced to this state under section 66, **chapter 122, Oregon Laws 2019**

1 **(Enrolled House Bill 3427)** [of this 2019 Act], less any subtraction pursuant
2 to section 64, **chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427)**
3 [of this 2019 Act].

4 “[~~(18)~~(a)] **(17)(a)** ‘Taxpayer’ means any person or unitary group required
5 to register, file or pay tax under sections 58 to 76, **chapter 122, Oregon**
6 **Laws 2019 (Enrolled House Bill 3427)** [of this 2019 Act].

7 “(b) ‘Taxpayer’ does not include excluded persons, **except to the extent**
8 **that a tax-exempt entity has unrelated business income that is taxable**
9 **under the Internal Revenue Code.**

10 “[~~(19)~~(a)] **(18)(a)** ‘Unitary business’ means a business enterprise in which
11 there exists directly or indirectly between the members or parts of the en-
12 terprise a sharing or exchange of value as demonstrated by:

13 “(A) Centralized management or a common executive force;

14 “(B) Centralized administrative services or functions resulting in econo-
15 mies of scale; or

16 “(C) Flow of goods, capital resources or services demonstrating functional

3 **“Sec. 61.** (1) Except as provided in subsection (2) of this section:

4 “(a) A person shall include as taxable commercial activity the value of
5 property the person transfers into this state for the person’s own use in the
6 course of a trade or business within one year after the person receives the
7 property outside this state; and

8 “(b) In the case of a unitary group, the taxpayer shall include as taxable
9 commercial activity the value of property that any of the taxpayer’s members
10 transferred into this state for the use in the course of a trade or business
11 by any of the taxpayer’s members within one year after the taxpayer receives

13 “(2) Property brought into this state within one year after it is received

25 **“Sec. 63.** (1) A corporate activity tax is imposed on each person with
26 taxable commercial activity for the privilege of doing business in this state.
27 The tax is imposed upon persons with substantial nexus with this state. The
28 tax imposed under this section is not a transactional tax and is not subject
29 to the Interstate Income Act of 1959 (P.L. 86-272). The tax imposed under this
30 section is in addition to any other taxes or fees imposed under the tax laws

1 of this state. The tax imposed under this section is imposed on the person
2 [receiving] **with** the commercial activity and is not a tax imposed directly
3 on a purchaser. The tax imposed under this section is an annual privilege
4 tax for the calendar year and shall be remitted quarterly to the Department
5 of Revenue. A taxpayer is subject to the annual corporate activity tax for
6 doing business during any portion of such calendar year.

7 “(2) A person has substantial nexus with this state if any of the following
8 applies. The person:

9 “(a) Owns or uses a part or all of its capital in this state.

10 “(b) Holds a certificate of existence or authorization issued by the Sec-
11 retary of State authorizing the person to do business in this state.

12 “(c) Has bright-line presence in this state.

13 “(d) Otherwise has nexus with this state to an extent that the person can
14 be required to remit the tax imposed under sections 58 to 76, **chapter 122,**
15 **Oregon Laws 2019 (Enrolled House Bill 3427)**, [of this 2019 Act] under the
16 United States Constitution.

17 “(3) A person has bright-line presence in this state for the calendar year
18 if any of the following applies. The person:

19 “(a) Owns at any time during the calendar year property in this state with
20 an aggregate value of at least \$50,000. For purposes of this paragraph, owned
21 property is valued at original cost and rented property is valued at eight
22 times the net annual rental charge.

23 “(b) Has during the calendar year payroll in this state of at least \$50,000.
24 Payroll in this state includes the following:

25 “(A) Any amount subject to withholding by the person under ORS 316.167
26 and 316.172;

27 “(B) Any other amount the person pays as compensation to an individual
28 under the supervision or control of the person for work done in this state;
29 and

30 “(C) Any amount the person pays for services performed in this state on

1 the person's behalf by another.

2 “(c) Has during the calendar year commercial activity, sourced to this
3 state under section 66, **chapter 122, Oregon Laws 2019 (Enrolled House**
4 **Bill 3427)** [*of this 2019 Act*], of at least \$750,000.

5 “(d) Has at any time during the calendar year within this state at least
6 25 percent of the person's total property, total payroll or total commercial
7 activity.

8 “(e) Is a resident of this state or is domiciled in this state for corporate,
9 commercial or other business purposes.

10 **“(4) Notwithstanding subsection (1) of this section, a vehicle dealer**
11 **may collect from the purchaser of a motor vehicle the estimated por-**
12 **tion of the tax imposed under this section that is attributable to**
13 **commercial activity from the sale of the vehicle.**

14 **“SECTION 53.** Section 64, chapter 122, Oregon Laws 2019 (Enrolled
15 House Bill 3427), is amended to read:

16 **“Sec. 64.** (1) A taxpayer shall subtract from commercial activity sourced
17 to this state 35 percent of the greater of the following amounts paid or in-
18 curred by the taxpayer in the tax year:

19 “(a) The amount of cost inputs; or

20 “(b) The taxpayer's labor costs.

21 “(2) The amounts in subsection (1)(a) or (b) of this section shall be ap-
22 portioned to this state in the manner required for apportionment of income
23 under ORS 314.605 to 314.675.

24 **“(3) A subtraction under this section is not allowed for any amount**
25 **of:**

26 **“(a) Expenses from transactions among members of a group, as**
27 **excluded under section 60, chapter 122, Oregon Laws 2019 (Enrolled**
28 **House Bill 3427); or**

29 **“(b) Cost inputs or labor costs that are attributable to a person's**
30 **receipts from an item that is not commercial activity.**

1 “[3] (4) Notwithstanding subsection (1) of this section, the subtraction
2 under this section may not exceed 95 percent of the taxpayer’s commercial
3 activity in this state.

4 **“SECTION 54.** Section 66, chapter 122, Oregon Laws 2019 (Enrolled
5 House Bill 3427), is amended to read:

6 **“Sec. 66.** (1) For purposes of sections 58 to 76, **chapter 122, Oregon**
7 **Laws 2019 (Enrolled House Bill 3427)** [*of this 2019 Act*], commercial activity
8 [*other than commercial activity of financial institutions or insurers*] shall be
9 sourced to this state as follows:

10 “(a) In the case of the sale, rental, lease or license of real property, if and
11 to the extent the property is located in this state.

12 “(b) In the case of the rental, lease or license of tangible personal prop-
13 erty, if and to the extent the property is located in this state.

14 “(c) In the case of the sale of tangible personal property, if and to the
15 extent the property is delivered to a purchaser in this state.

16 “(d) In the case of the sale of a service, if and to the extent the service
17 is delivered to a location in this state.

18 “(e) In the case of the sale, rental, lease or license of intangible property,
19 if and to the extent the property is used in this state. If the receipts are not

29 this state, the person may request, or the Department of Revenue may re-

2 sections 58 to 76, **chapter 122, Oregon Laws 2019 (Enrolled House Bill**
3 **3427)** [*of this 2019 Act*].

4 “(3) The department may adopt rules to provide additional guidance to the
5 application of this section, and to provide alternative methods of sourcing
6 commercial activity that apply to financial institutions and to insurers, and
7 to any other persons, or a subset of persons, that are engaged in similar
8 business or trade activities.

9 **“SECTION 55.** Section 67, chapter 122, Oregon Laws 2019 (Enrolled
10 House Bill 3427), is amended to read:

11 **“Sec. 67.** (1) Except as expressly authorized by this section, the authority
12 to impose, in this state, a tax upon the commercial activity of an entity is
13 vested solely in the Legislative Assembly. A city, county, district or other
14 political subdivision or municipal corporation of this state may not impose,
15 by ordinance or other law, a tax upon commercial activity or upon receipts
16 from grocery sales.

17 “(2) Subsection (1) of this section does not apply:

18 “(a) To any tax, or to subsequent amendments of the provisions of any
19 tax, if the ordinance or other law imposing the tax is in effect and operative
20 on April 1, 2019, or is adopted by initiative or referendum petition at an

22 “(b) To the imposition of **privilege taxes not measured by commercial**
23 **activity, franchise fees [or franchise taxes] or right-of-way fees.**

26 **“Sec. 70.** (1) For purposes of the corporate activity tax imposed under
27 section 63, **chapter 122, Oregon Laws 2019 (Enrolled House Bill 3427)** [*of*
28 *this 2019 Act*], every person doing business in this state with commercial
29 activity for the tax year in excess of \$1 million shall file not later than April
30 15 of the following year an annual return. The return must be filed with the

1 Department of Revenue in a form prescribed by the department.

2 “(2) The corporate activity tax imposed under section 63, **chapter 122,**
3 **Oregon Laws 2019 (Enrolled House Bill 3427)**, [of this 2019 Act] is due and
4 **estimated tax payments are** payable to the department on or before the
5 last day of January, April, July and October of each year for the previous
6 calendar quarter.
