**PROPOSED AMENDMENTS TO  
A-ENGROSSED SENATE BILL 1005  
(INCLUDING AMENDMENTS TO RESOLVE CONFLICTS)**

1 On page 1 of the printed A-engrossed bill, line 2, delete “creating new  
2 provisions;”.

3 In line 3, after “2014” insert “, and section 32, chapter \_\_\_\_\_, Oregon  
4 Laws 2019 (Enrolled Senate Bill 1008)”.

5 Delete lines 5 through 20.

6 Delete page 2.

7 On page 3, delete lines 1 through 7.

8 In line 8, delete “7” and insert “1”.

9 On page 4, line 29, delete “8” and insert “2”.

10 After line 31, insert:

11 **“SECTION 3.** If Senate Bill 1008 becomes law and Senate Bill 1013 does  
12 not become law, section 32, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled  
13 Senate Bill 1008), is amended to read:

14 **“Sec. 32. (1)** Sections 24 and 25 [*of this 2019 Act*], **chapter \_\_\_\_\_,**  
15 **Oregon Laws 2019 (Enrolled Senate Bill 1008),** and the amendments to  
16 ORS 137.071, 137.124, 137.705, 137.707, 137.712, 144.185, 161.610, 161.620,  
17 163.105, 163.115, 163.155, 163A.130, 163A.135, 339.317, 339.319, 339.321,  
18 419C.005, 419C.050, 419C.346, 419C.349, 419C.352, 419C.355, 419C.358, 419C.361,  
19 420.011, 420.081 and 420A.203 by sections 1 to 23 and 26 to 29 [*of this 2019*  
20 *Act*], **chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill 1008),** apply

1 to sentences imposed on or after January 1, 2020.

2 “(2) Notwithstanding subsection (1) of this section, sections 24 and  
3 25, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill 1008), and  
4 the amendments to ORS 137.071, 137.124, 137.705, 137.707, 137.712, 144.185,

6 339.319, 339.321, 419C.005, 419C.050, 419C.346, 419C.349, 419C.352, 419C.355,  
7 419C.358, 419C.361, 420.011, 420.081 and 420A.203 by sections 1 to 23 and  
8 26 to 29, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill 1008),  
9 do not apply to persons who were originally sentenced before January  
10 1, 2020, and who are subsequently resentenced on or after January 1,  
11 2020, as the result of an appellate decision or a post-conviction relief  
12 proceeding or for any other reason.

13 “SECTION 4. If both Senate Bill 1008 and Senate Bill 1013 become law,  
14 section 32, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill 1008), as  
15 amended by section 3c, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate  
16 Bill 1013), is amended to read:

22 tion 3 [*of this 2019 Act*], **chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled**  
23 **Senate Bill 1013)**, by sections 1 to 23 and 26 to 29, chapter \_\_\_\_\_, Oregon  
24 Laws 2019 (Enrolled Senate Bill 1008), and section 3a [*of this 2019 Act*],  
25 **chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill 1013)**, apply to  
26 sentences imposed on or after January 1, 2020.

27 “(2) Notwithstanding subsection (1) of this section, sections 24 and

4 **23 and 26 to 29, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Senate Bill**  
5 **1008), and section 3a, chapter \_\_\_\_\_, Oregon Laws 2019 (Enrolled Sen-**  
6 **ate Bill 1013), do not apply to persons who were originally sentenced**  
7 **before January 1, 2020, and who are subsequently resentenced on or**  
8 **after January 1, 2020, as the result of an appellate decision or a post-**  
9 **conviction relief proceeding or for any other reason.”.**

10 In line 32, delete “9” and insert “5”.
