#### **Work Session**

HB 4066

CARRIED OVER FROM THE 2-11-2020 AGENDA: Authorizes Public Utility Commission to allow electric companies to recover costs for prudent investments or expenses in infrastructure measures that support adoption of electric vehicles if certain criteria are met.

HB 4068

CARRIED OVER FROM THE 2-11-2020 AGENDA: Requires Director of Department of Consumer and Business Services to amend state building code to create electric vehicle charging infrastructure requirements for new construction of certain buildings.

HB 4024

Prohibits certain products that use or contain hydrofluorocarbons from entering into commerce in Oregon if product was manufactured after specified date.

HB 4159 \*\*

Modifies statewide greenhouse gas emissions reduction goals.

#### **Possible Work Session**

HB 4049

Establishes eligibility for renewable energy certificates for facilities that generate electricity from direct combustion of municipal solid waste and became operational before January 1, 1995, if such facilities register with Western Renewable Energy Generation Information System at any time.

HB 4093

Exempts wood residue combusted as fuel or that has marketable value from solid waste regulation.
