HB 4030

CARRIED OVER FROM THE 02/04/2020 AGENDA: Modifies and delays implementation of requirements for pharmacy benefit managers. **Subsequent Referral(s) to Rules

HJR²⁰²**

CARRIED OVER FROM THE 02/04/2020 AGENDA: Proposes amendment to Oregon Constitution establishing obligation of state to ensure every resident of state access to cost-effective, clinically appropriate and affordable health care.

HB 4110

CARRIED OVER FROM THE 02/04/2020 AGENDA: Prescribes grace periods for payment of premiums on certain types of health insurance.

Public Hearing

HB 4029

Prohibits nonprofit hospital from requiring patient to apply for medical assistance before screening for or providing financial assistance.

HB 4115

Requires health care providers, including coordinated care organizations, and companies providing health care interpreters to health care providers to use health care interpreters who are qualified or certified by Oregon Health Authority.

HB 4073

Limits cost-sharing for health benefit plan coverage of insulin prescribed for treatment of diabetes.

HB 4089

Allows person employed by health care facility to practice surgical technology if person is enrolled in or has completed specified apprenticeship program.

HB 4032 **

Appropriates moneys from General Fund to Oregon Health Authority for expenses related to hospital nurse staffing program.

HB 4078

Prohibits remote sales of inhalant delivery systems.

HB 4102

Requires coordinated care organizations to report specified information to Oregon Health Authority regarding requests for prior authorization.
