Appropriates moneys to Department of Human Services for transition services for foster children.
- HB 4112 ** **Subsequent Referral(s) to Ways and Means
Modifies allocation formula for grants to children's advocacy centers.
- HB 4039 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys to Department of Human Services for services provided to unaccompanied homeless youth.
- HB 4141 ** **Subsequent Referral(s) to Ways and Means
Appropriates money to Oregon Department of Administrative Services for deposit in Court Appointed Special Advocate Fund and distribution to CASA Volunteer Programs.
- HB 4133 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys to Department of Human Services to fund existing contracted domestic violence specialist positions in child welfare offices.
