Directs Housing and Community Services Department to study laws related to housing and to report to Legislative Assembly no later than September 15, 2020.
- HB 4080 ** **Subsequent Referral(s) to Ways and Means
Establishes Task Force on Medicaid and Medicare Workforce Standards.

Public Hearing and Possible Work Session

- HB 4084 ** **Subsequent Referral(s) to Ways and Means
Establishes Rural System Development Charges Program within Housing and Community Services Department to pay system development charges for rural affordable multifamily housing.
- HB 4090
Authorizes Land Conservation and Development Commission to approve plans for urban growth boundary expansion to accommodate affordable housing in Pendleton.
- HB 4095
Authorizes Department of Land Conservation and Development to approve local governments' plans for urban growth boundary expansion areas that will accommodate affordable housing.

Possible Work Session

- HB 4002 ** **Subsequent Referral(s) to Ways and Means
Requires Housing and Community Services Department to study long-term rent assistance and to report to interim committee of Legislative Assembly no later than October 1, 2020.
- HB 4003 ** **Subsequent Referral(s) to Ways and Means
Authorizes Housing and Community Services Department to provide grants and technical assistance to organizations increasing homeownership program access to persons of color.
- HB 4112 ** **Subsequent Referral(s) to Ways and Means
Modifies allocation formula for grants to children's advocacy centers.
- HB 4039 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys to Department of Human Services for services provided to unaccompanied homeless youth.
