Work Session

SB 1538

Authorizes city, county, metropolitan service district, school district, college or university to adopt ordinance or policy limiting or precluding affirmative defense for possession of firearms in public buildings by concealed handgun licensees.

SB 1538 Work Session scheduled for the sole purpose of referring the bill to the Senate Committee on Rules.

SB 1561

CARRIED OVER FROM THE 2/11/2020 AGENDA: Directs State Department of Agriculture to develop Oregon Hemp Plan for establishment of Oregon Hemp Program for commercial production and sale of hemp.

SB 1567

CARRIED OVER FROM THE 2/11/2020 AGENDA: Restricts arbitration award from ordering disciplinary action that differs from disciplinary action imposed by law enforcement agency if arbitrator makes finding that misconduct occurred consistent with agency's finding of misconduct, and disciplinary action imposed by agency is consistent with provisions of discipline guide or discipline matrix adopted by agency as result of collective bargaining and incorporated into agency's disciplinary policies.

SB 1573

CARRIED OVER FROM THE 2/11/2020 AGENDA: Modifies procedure for expunction of certain juvenile records.

Note change: SB 1561, SB 1567, and SB 1573 carried over from 2/11/2020 agenda. SB 1538 Work Session scheduled for the sole purpose of referring the bill to the Senate Committee on Rules. Written testimony submitted to the Senate Judiciary Committee will be forwarded to the Senate Committee on Rules.
