Hello, I am a fellow Oregonian who has a lot to lose if there is a flavor ban! Diseases from Combustible cigarettes kill roughly 450,000 Americans EVERY year! First of all I was a cigarette smoker for 13 years. I tried doing everything to quit the habit. I tried lozenges, nicotine patches, gum, prescription medication and nothing worked until 3 years ago I discovered flavored nicotine vaping. I started at a relatively high nicotine e-juice that was candy flavored, after 2 weeks I was able to put down cigarettes for good. I have now been cigarette free well over 3 years now, I have decreased my nicotine content to the lowest possible but I still enjoy the nicotine e-juice. I also vape non nicotine e-juice flavors for when I don't feel like using nicotine, I have had regular x-rays and doctor check ups & it's incredible to see my lungs heal from years of damage due to combustible cigarettes. I am going to be completely honest with you, I am in recovery from a severe opiate/heroin addiction. FLAVOR e-juice products not only helped me quit smoking cigarettes but it's allowed to to turn vaping into a constructive hobby that's been extremely beneficial to my sobriety and recovery. I've watched vaping do so much good for our local Oregonian economy, we have vape shops that will no longer be able to stay open if you take away FLAVORED ejuice products from us, leaving many tax paying vape shop employees jobless.
