Definitions

McKinney-Vento Act

A homeless individual lacks a fixed, regular and adequate nighttime residence.

Living Situations for Data

- In Shelter, Transitional Housing
- Unsheltered: vehicle, substandard housing, camping
 - Motel/Hotel for lack of affordable housing
 - Doubled-Up due to hardship

Children & Youth in Homeless Families

Family is homeless together

Unaccompanied Homeless Youths

Not under supervision by a parent or guardian


Homelessness, especially unsheltered homelessness, is of catastrophic proportions in Oregon.


Nationally, Oregon, Hawaii and California had the highest rates of individuals experiencing homelessness, with 50 or more people experiencing homelessness per 10,000 individuals.

Oregon is one of four states in which more than half (61%) of all people experiencing homelessness were found in unsheltered living situations.





Parenting and unmarried




Oregon Shelter Report August 2019

OR Housing & Community Services

- Statewide, there are 436 shelter beds dedicated to youth.
- The 2018 Point-in-Time Count found 317 youth under age 18 experiencing homelessness, of which 70% were unsheltered.
- The PIT Count found 992 youth ages 18-24 experiencing homelessness, of which 60% were unsheltered.
- In 2018, HUD found Oregon to be **one of the five top states** in the rate of unsheltered, unaccompanied youth homelessness.





McKinney-Vento Liaison Duties

and School District Responsibilities toward keeping homeless students enrolled so they graduate with a solid plan for their future



TEN MAJOR LIAISON DUTIES

- 1. Identify eligible students
- 2. Ensure homeless students are enrolled
- 3. Ensure preschool and younger are served
- 4. Make referrals for health and social services
- 5. Inform parents of options and rights
- 6. Post notices and posters about rights
- 7. Mediate enrollment disputes
- 8. Arrange school of origin transportation
- 9. Provide awareness training to school and district staff
- 10. Ensure unaccompanied homeless youths are enrolled, can receive partial credits and are informed of FAFSA eligibility

Out-of-School Youths

The Oregon Youth Development Council estimates 60,000 school-age children and youth are not attending public, private or home schools. We do not have data on how many of these youths are homeless (do you?)

Shelter Challenges in Rural Areas

- Fewer year round emergency shelters.
- More reliant on winter and warming shelters.
- More reliant on volunteers to staff shelter.
- Transportation issues to get people to and from shelters.
- Few options exist for day shelter.
- Limited opportunities to exit homelessness due to few affordable housing options and limited services.
- All subpopulations are underserved.
- Challenges in expanding shelter due to local opposition (NIMBY).





Host Homes are an alternative to shelters, camping and couches for Unaccompanied Homeless Youths

What is a Host Home?

.... a private home that volunteers to host youth ages 16-24 in need of housing while they attend school or work. Generally, hosts provide lodging and board in a family-like environment, coordinating with the host home program to provide additional services the youth might need. With a "rental" contract, the youth may exchange light chores or house-sitting, as well as maintaining attendance at school or work.

Host Home Programs

....nonprofit, tax-exempt entities that recruit and train host homes/families to provide homes to youth. Host home programs recruit hosts, arrange background checks, match youths with hosts, offer case management and conflict mediation, and provide liability insurance.

Host Home Advantages

Community-driven

- Youth-centered, noninstitutional
- Cost-effective

- Hosts are culturally-matched to students
- LGBTQ students are matched where safe and accepted
 - Ideal for rural and remote areas

- Neighbors helping neighbors find solutions to youth homelessness
- Youth benefit from living with adult allies
- Youth experiencing homelessness are best supported when they are able to remain in the community where they are comfortable, have friends and attend school

Host Home Challenges

- Requires local or regional coordinator
- Recruitment of hosts can be difficult
- Trainings for hosts, ongoing support groups and mediation may require fulltime support

- Not all youth are ready to live in a host home
 - Hosts may have rules and expectations beyond what a youth is comfortable with
 - Background checks, liability waiver or insurance, agreements and contracts can be daunting



Second Home Program

- Second Home host home providers offer room and board to a student while they attend high school.
- Rental agreements and house rules are negotiated with Second Home staff and a volunteer mediator in the community.
- Students and home providers are matched and provided ongoing support such as conflict resolution.



Second Home Program

- Now in Washington, Clackamas and Lincoln Counties, and Gresham-Barlow School District. Looking to serve more communities.
- Liaisons make referrals to a Regional Coordinator (where they exist).
- Existing "informal" host homes can benefit from the contracts and mediation services.
- Youths gain a rental history through the contract. In Oregon, youths 16-18 are able to rent without parental permission.



Second Home Program
