Oregon Revised Statutes 181A.230 and 181A.245 require the Oregon State Police CJIS Division to provide Criminal History information to non-criminal justice agencies.

The law states "When a person or agency other than a criminal justice agency or law enforcement agency, pursuant to ORS 181A.230, requests from the department criminal offender information regarding an individual, if the department's compiled criminal offender information on the individual contains records of any conviction, or of any arrest less than one year old on which there has been no acquittal or dismissal, the department shall respond to the request."
