Oregonians in these fields along with agriculture and transportation are the care givers, the stewards of this land, this state and our resources. Much pride is taken in turning the soil, protecting forests from fires, managing timber growths to ensure the next generation has BIG TREES to see. As a child of this genre, I oppose Cap and Trade as it's written and not being given a voice, a VOTE.

I would like to say, unequivocally, that the proposed "emergency session" Cap and Trade SB 1530 legislation as drafted will KILL small businesses in Oregon.
