My name is Toma Deavers. I am from Southern Oregon. I currently live in Milwaukie, OR. I am a Great-Auntie dedicated to protecting our State's water, land and air for Future Generations. Thank you for your continued work on the critical issue of the climate emergency.

I have eleven nieces and nephews living in Southern Oregon. Year after year, my family that lives throughout Southern Oregon live in fear of wildfire season. We've already had to evacuate once already. We have many friends who have been evacuated before. We endure weeks upon weeks of heavy wildfire smoke. We have lost so much of Southern Oregon land to wildfire. It is time to stop this madness. It is time to stop the fossil fuel industry that is perpetuating this rise in temperature that is causing wildfires across the globe. We need more funding for wildfire crews and equipment. We need more helicopters and planes that can adequately prepare us for yet another wildfire season. We have seen what has happened in CA. There are over 100 Californians who have died in catastrophic fires down there. WE DO NOT WANT THAT IN OUR STATE. State legislators absolutely must take this seriously!!! Please declare a Climate Emergency for the State of Oregon. Oregon must "blaze the trial" and show the world how to prepare for global warming. On behalf of myself and the four generations of my family living in Southern Oregon, please protect Oregon from the toxic fossil fuel industry, declare a climate emergency, and provide more funds for our wildfire crews and much needed equipment to adequately fight wildfires in a timely matter. We need our leaders to lead. We must take urgent action to address Climate Change.
