My name is Keren Brown Wilson and I am Vice Chair of the Executive Committee for Portland State University Foundation Board and an alumni of PSU ('83). It is my honor to serve on the PSUF Board because I am committed to and passionate about the success of Portland State University, and more importantly, its students.

I am writing today to express deep support for the renovation of PSU's undergraduate science building. I am so appreciative of the \$4.5 million pledge Christine and Dave Vernier recently made to PSU to support this project. The Verniers' pledge reminds me of the commitment my husband, Michael DeShane, also an alumni, and I made in 1997 to help construct PSU's College of Urban and Public Affairs.
