

## Lake County Railroad - History

- Line was built in 1908.
- Southern Pacific RR filed to abandon the line in 1985.
- Lake County purchased the 55-mile rail line in 1986 to preserve service.
- Key Lakeview employers depend on Rail service as their critical Transportation Link for getting products to market.




## Lake County Rail Infrastructure

- Lake County owned infrastructure is poor
  - 41 miles at 10 mph
  - 13 miles at <u>5 mph</u>
  - Loaded cars 8 mph
- Restricted weight capacity
- As of 2017 study, 75% of the ties were substandard



## Lake County Railroad- Economic Impact

- Lakeview is very geographically isolated.
- 3.5 hours from the Interstate Highway System (I-5).
- Trucking is expensive, due to lack of "back-haul" products.
- Key Lakeview employers depend on the railroad as their critical Transportation Link for getting local products to market.

#### **Red Rock Biofuels**

- Project Status:
  - Nearing completion of \$ 250+ million
    Biorefinery in Lakeview, OR
  - Annually, will convert 166,000 tons of forest waste woody biomass into 15+ million gallons of renewable Jet and Diesel fuels.
  - Southwest Airlines and FedEx are committed customers
  - Biofuels will begin shipping by rail, starting in 2020
- The plant is <u>dependent on Lake County</u> <u>Railroad</u> to deliver product.
- Present track conditions <u>don't meet Federal</u> <u>Railroad Administration legal requirements</u> <u>for handling of Hazardous Materials.</u>



## Red Rock Biofuels- Ecological Benefits

- Catastrophic wildfire risk in Oregon reduced by processing forest waste.
- Production of renewable Jet and Diesel fuels, helping to tackle climate change.
- OR supporting a first-in-the-world conversion of waste woody biomass into Renewable, Low-Carbon fuels.

#### Bond Financing Purpose, Urgency and Impact


- 1. Funds Provided will permit the Lake County Railroad To Meet Federal Railroad Administration (FRA) – mandated legal requirements to achieve "Excepted Hazmat" rail line status.
- Bond financing will pay for the following:
- Reconstruction of Milepost 486.3 Curve: \$ 600,000
- Rehabilitate bridge decks & approaches: 1,500,000
- Bridge work for upgrading capacity:
- Crossing rehabilitation work:
- Broken rail, joint bar & bolt replacement 350,000
- Project Admin/Engineering/Contingency <u>250,000</u>

#### Bond Financing Purpose, Urgency and Impact

- 2. To Impact Lake County Job Growth:
  - Each Lake County private-sector job = 224 Multnomah County private-sector jobs in relative economic impact.
  - We have/are adding 183 new private-sector jobs to Lake County, which is equal to 40,992 jobs in Multnomah County.

## **\$3.5 Million Bond Financing accomplishes:**

- 1. Immediate fixes to Lake County-owned rail line, to meet FRA protocols to handle Hazmat carloads.
- 2. Thus, Allowing movement of the Renewable Jet and Diesel fuels to market.
- 3. And, Leveraging the \$3.5 million functionally into \$10.61 million \*, with the Bond Funding serving as match for Lake County's Federal CRISI \*\* grant.
