RE: -10 Amendment to HB 4015

Dear Chair Holvey and Members of the House Committee:

The City of Portland and the Bureau of Planning and Sustainability strongly supports the -10 amendment to HB 4015 to fund the Small Homes Northwest program with the Hacienda Community Development Corporation (Hacienda). Hacienda has assembled a coalition of partners to create a model program that will achieve multiple community benefits beyond the typical funding for affordable housing. This model will:

- Allow moderate income homeowners to leverage their largest asset in way that can generate additional income (rent) and long-term value (wealth) that can stabilize a household and provide a foundation for multi-generational success.
- Partner with and support small emerging construction contractors that can provide long term economic benefits
- Be scaleable to other communities across Oregon. One of the goals is to show how to do this create an affordable housing unit that also supports a moderate income household.

Additional ADU development in our residential neighborhoods is a key part of our growth management strategy. The City has taken steps to remove barriers to ADU construction in terms of permissive zoning standards (no ownership or parking requirements) and waiving development fees for certain rental units. But studies have shown that up to this point only the most affluent households are able to finance the construction of an ADU. There are structural barriers with conventional bank financing that prohibits moderate income homeowners from qualifying for ADU construction loans. There are also serious risks in terms of construction and property management that need to be addressed to ensure the units are built in a way that controls costs and provides technical assistance, so homeowners are successful over the long term.
