Subject:	HB 4040 – Relating to family treatment courts Work Session Recommendations

HB 4040 requires the Judicial Department to establish a Family Treatment Court in Clackamas and Douglas counites. The purpose of the program is to improve outcomes in child welfare cases that result from alleged substance use by a parent of caregiver. Specifically, the program seeks to reduce the amount of time a child spends in protective custody through a court-based collaboration of court, child welfare, and social service providers. The program sunsets January 2027.

The measure has a fiscal impact on three agencies: the Oregon Judicial Department, the Public Defense Services Commission, and the Department of Human Services. The total combined General Fund cost in the current biennium is estimated to be \$2,980,951, increasing to an estimated \$10,214,582 General Fund in 2021-23. For a more detailed breakdown of the fiscal impact by agency, please see the related fiscal impact statement in OLIS.

The -6 amendment adds the appropriations to the bill and reduces the number of counties in which the program is to be implemented.

### **Recommended Changes**

In addition, each agency is directed to include an update on the program in their respective budget presentations to the Joint

Committee on Ways and Means during the 2021 legislative session. The update should include, but not be limited to, a presentation on (1) the manner and degree of coordination between the public agencies involved in the program, (2) the development of related training, state standards and performance measures, and (3) the 2021-23 program costs.
