Summary of Revenue Changes

Senate Bill 1504 requires a study, thus it has no impact on revenues.

Summary of Capital Construction Subcommittee Action

Senate Bill 1504 requires the Oregon Department of Transportation (ODOT) to study modifying the classification of diesel fuel to motor vehicle fuel. It increases Other Funds expenditure limitation for ODOT by \$426,605 and adds one limited-duration Operations and Policy Analyst 4 position (0.50 FTE) to support completion of the study. ODOT must consult with the Department of Environmental Quality. The report will be made to the Legislative Assembly in 2021 and must include an implementation plan for reclassifying diesel fuel starting January 1, 2022. The study may include potential impacts of reclassification on:

- Motor vehicle fuel tax revenue collection;
- Weight-mile tax revenue collection and whether vehicles with a registration weight over 10,000 pounds should be included in this tax;
- ODOT operations; and
- Dyed fuels taxation
