# **Summary of Revenue Changes**

House Bill 4015 provides a one-time appropriation of \$960,000 General Fund to the Housing and Community Services Department (HCSD) to award a grant to the Hacienda Community Development Corporation to fund Accessory Dwelling Unit (ADU) community pilot programs to enable eligible homeowners to site an ADU on their properties and subsequently rent them to eligible tenants.

### **Summary of Capital Construction Subcommittee Action**

The Subcommittee approved a one-time appropriation of \$960,000 General Fund to HCSD for the 2019-21 biennium to fund a grant award to the Hacienda Community Development Corporation for the purpose of expanding ADU community pilot programs. The purpose of the pilot programs is to increase access to affordable housing for low-income tenants who meet certain criteria. The Hacienda Community Development Corporation has an existing initiative that leverages partnerships with other nonprofit organizations. HCSD will monitor the use of grant funds and submit a report to an appropriate committee of the Legislative Assembly by September 15, 2023.
