# **Summary of Revenue Changes**

House Bill 4166 appropriates General Fund to the Department of Administrative Services to contract with an independent economist as outlined in the bill.

### **Summary of Capital Construction Subcommittee Action**

House Bill 4166 allows the Department of Administrative Services to contract for an independent economist to collect data and provide a report on the costs of wildfire protection and wildfire suppression on lands protected by the State Forestry Department. This work is to be accomplished in coordination with a technical advisory team as outlined in the measure. The Subcommittee provided the agency with a \$250,000 General Fund appropriation to contract with an independent economist.

The reported findings of the economist are to be available to the Governor's Council on Wildfire Response and to a committee of the Legislative Assembly relating to natural resources no later than March 1, 2021.
