

House Bill 4041

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Veterans and Emergency Preparedness for Representative Paul Evans)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Renames Office of Emergency Management as Oregon Department of Emergency Management. Establishes department as state agency independent from Oregon Military Department. Vests in Oregon Department of Emergency Management emergency authority regarding public health emergencies, emergency quarantines and conflagrations. Transfers rulemaking authority regarding nuclear emergencies from State Department of Energy to Oregon Department of Emergency Management.

Transfers Oregon Emergency Response System from Department of State Police to Oregon Department of Emergency Management.

Renames office of State Fire Marshal as Department of the State Fire Marshal and establishes department as state agency independent from Department of State Police. Transfers search and rescue functions from Office of Emergency Management to Department of the State Fire Marshal.

Transfers Oregon Homeland Security Council from Office of Emergency Management to Office of the Governor. Adds seven members to council and expands duties of council.

Establishes Emergency Preparedness Advisory Council to advise and make policy recommendations to Oregon Homeland Security Council regarding federal emergency support functions.

Establishes Local Government Emergency Management Advisory Council to provide advice and recommendations to Oregon Department of Emergency Management regarding the department's emergency preparedness and response functions.

Becomes operative on July 1, 2023.

Be It Enacted by the People of the State of Oregon:

RENAMING AND REORGANIZATION OF THE OFFICE OF EMERGENCY MANAGEMENT

SECTION 1. (1) The amendments to ORS 401.052, 401.054, 401.062, 401.072, 401.076, 401.082,

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 401.088 and 401.092 by sections 2 to 9 of this 2020 Act are intended to change the name of the
2 “Office of Emergency Management” to the “Oregon Department of Emergency
3 Management” and to establish that entity as a state agency independent from the Oregon
4 Military Department.

5 (2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel
6 may substitute for words designating the “Office of Emergency Management,” wherever they
7 occur in statutory law, other words designating the “Oregon Department of Emergency
8 Management.”

9 **SECTION 2.** ORS 401.052 is amended to read:

10 401.052. (1) The [*Office*] **Oregon Department** of Emergency Management is established [*in the*
11 *Oregon Military Department*].

12 (2) The [*office*] **department** shall be responsible for:

13 (a) Coordinating and facilitating private sector and governmental efforts to prevent, prepare for,
14 respond to and recover from emergencies; and

15 (b) Coordinating exercises and training, planning, preparedness, response, mitigation and recov-
16 ery activities with state and local emergency services agencies and organizations.

17 (3) The [*office*] **department** shall prepare a statewide emergency management plan and update
18 the plan from time to time as necessary.

19 **SECTION 3.** ORS 401.054 is amended to read:

20 401.054. (1) Each of the following agencies, entities and officials shall designate an individual to
21 act as a liaison with the [*Office*] **Oregon Department** of Emergency Management:

22 (a) The Department of Consumer and Business Services;

23 (b) The Department of Corrections;

24 (c) The Department of Education;

25 (d) The Department of Environmental Quality;

26 (e) The Department of Human Services;

27 (f) The Department of Justice;

28 (g) The Department of Land Conservation and Development;

10 (2) Each agency, entity and official required to designate a liaison under this section shall des-
 11 ignate an individual who has authority during an emergency to allocate resources and assets of the
 12 agency, entity or official.

13 (3) Each individual designated as a liaison under subsection (1) of this section shall assist in the
 14 coordination of the functions of the agency, entity or official that designated the individual that
 15 relate to emergency preparedness and response with similar functions of the [Office] **Oregon De-**
 16 **partment** of Emergency Management.

17 **SECTION 4.** ORS 401.062 is amended to read:

18 401.062. (1) The [Office] **Oregon Department** of Emergency Management is **established. The**
 19 **department is** under the supervision and control of a director, who is responsible for the perform-
 20 ance of the duties, functions and powers of the [office] **department**.

21 (2) [The Adjutant General, with the approval of] The Governor[,] shall appoint the Director of the
 22 [Office] **Oregon Department** of Emergency Management, who holds office at the pleasure of the
 23 [Adjutant General.] **Governor. The appointment of the director is subject to confirmation by**
 24 **the Senate in the manner prescribed by ORS 171.562 and 171.565.**

25 (3) The director shall be paid a salary as provided by law or, if not so provided, as prescribed
 26 by [the Adjutant General, with the approval of] the Governor.

27 (4) For purposes of administration, subject to the approval of the [Adjutant General] **Governor,**
 28 the director may organize and reorganize the [office] **department** as the director considers neces-
 29 sary to properly conduct the work of the [office] **department**.

30 (5) The director may divide the functions of the [office] **department** into administrative divi-
 31 sions. Subject to the approval of the [Adjutant General] **Governor,** the director may appoint an in-
 32 dividual to administer each division. The administrator of each division serves at the pleasure of the
 33 director and is not subject to the provisions of ORS chapter 240. Each individual appointed under
 34 this subsection must be well qualified by technical training and experience in the functions to be
 35 performed by the individual.

36 **SECTION 5.** ORS 401.072 is amended to read:

37 401.072. (1) The Director of the [Office] **Oregon Department** of Emergency Management may,
 38 by written order filed with the Secretary of State, appoint a deputy director. The deputy director
 39 serves at the pleasure of the director, has authority to act for the director in the absence of the
 40 director and is subject to the control of the director at all times.

41 (2) Subject to any applicable provisions of ORS chapter 240, the director shall appoint all sub-
 42 ordinate officers and employees of the [Office of Emergency Management] **department,** prescribe
 43 their duties and fix their compensation.

44 **SECTION 6.** ORS 401.076 is amended to read:

45 401.076. In accordance with applicable provisions of ORS chapter 183, the Director of the

1 [Office] **Oregon Department** of Emergency Management may adopt rules necessary for the admin-
 2 istration of the laws that the [Office of Emergency Management] **department** is charged with ad-
 3 ministering.

4 **SECTION 7.** ORS 401.092 is amended to read:

5 401.092. (1) The Director of the [Office] **Oregon Department** of Emergency Management is re-
 6 sponsible for coordinating and facilitating exercises and training, emergency planning, preparedness,
 7 response, mitigation and recovery activities with the state and local emergency services agencies
 8 and organizations, and shall[, *with the approval of the Adjutant General or as directed by the Gover-*
 9 *nor*]:

10 (a) Make rules that are necessary and proper for the administration and implementation of this
 11 chapter;

12 (b) Coordinate the activities of all public and private organizations specifically related to pro-
 13 viding emergency services within this state;

14 (c) Maintain a cooperative liaison with emergency management agencies and organizations of
 15 local governments, other states and the federal government;

 36 Governor's authorized representative for the purpose of initiating the fire management assistance
 37 declaration process with the Federal Emergency Management Agency and administering Federal
 38 Emergency Management Agency fire management assistance grants.

39 **SECTION 8.** ORS 401.082 is amended to read:

40 401.082. (1) To aid and advise the Director of the [Office] **Oregon Department** of Emergency
 41 Management in the performance of the functions of the [Office] **Oregon Department** of Emergency
 42 Management, the director may establish such advisory and technical committees as the director
 43 considers necessary. The committees may be continuing or temporary. The director shall determine
 44 the representation, membership, terms and organization of the committees and shall appoint their
 45 members. The director is an ex officio member of each committee.

1 (2) Members of the committees are not entitled to compensation, but in the discretion of the
2 director may be reimbursed from funds available to the [office] **department** for actual and necessary
3 travel and other expenses incurred by them in the performance of their official duties in the manner
4 and amount provided in ORS 292.495.

5 **SECTION 9.** ORS 401.088 is amended to read:

6 401.088. The Director of the [Office] **Oregon Department** of Emergency Management may enter
7 into interagency agreements with other state agencies that the director determines are necessary
8 to carry out the duties of the [Office] **Oregon Department** of Emergency Management.

12 **SECTION 10.** (1) **The unexpended balances of amounts authorized to be expended by the**
13 **Oregon Military Department for purposes of the Office of Emergency Management for the**
14 **biennium beginning July 1, 2023, from revenues dedicated, continuously appropriated, appro-**
15 **priated or otherwise made available to the department, are transferred to and are available**
16 **for expenditure by the Oregon Department of Emergency Management for the biennium be-**
17 **ginning July 1, 2023.**

18 (2) **The expenditure classifications, if any, established by Acts authorizing or limiting**
19 **expenditures by the Office of Emergency Management remain applicable to expenditures by**
20 **the Oregon Department of Emergency Management under this section.**

22 (Action, Proceeding, Prosecution)

24 **SECTION 11.** **The amendments to ORS 401.052, 401.054, 401.062, 401.072, 401.076, 401.082,**
25 **401.088 and 401.092 by sections 2 to 9 of this 2020 Act do not affect any action, proceeding or**
26 **prosecution involving or with respect to any duties, functions and powers of the Office of**
27 **Emergency Management begun before and pending as of the operative date specified in sec-**
28 **tion 155 of this 2020 Act, except that the Oregon Department of Emergency Management is**
29 **substituted for the Office of Emergency Management in any such action, proceeding or**
30 **prosecution.**

32 (Liability, Duty, Obligation)

34 **SECTION 12.** (1) **Nothing in the amendments to ORS 401.052, 401.054, 401.062, 401.072,**
35 **401.076, 401.082, 401.088 and 401.092 by sections 2 to 9 of this 2020 Act relieves a person of a**
36 **liability, duty or obligation accruing under or with respect to the duties, functions and pow-**
37 **ers conferred by those statutes prior to the operative date specified in section 155 of this 2020**
38 **Act. The Oregon Department of Emergency Management may undertake the collection or**
39 **enforcement of any such liability, duty or obligation.**

40 (2) **The rights and obligations of the Office of Emergency Management legally incurred**
41 **under contracts, leases and business transactions executed, entered into or begun before the**
42 **operative date specified in section 155 of this 2020 Act are transferred to the Oregon De-**
43 **partment of Emergency Management. For the purpose of succession to these rights and ob-**
44 **ligations, the Oregon Department of Emergency Management is a continuation of the Office**
45 **of Emergency Management and not a new authority.**

(Rules, References)

SECTION 13. The rules of the Office of Emergency Management in effect on the operative date specified in section 155 of this 2020 Act continue in effect until superseded or repealed by rules of the Oregon Department of Emergency Management. References in rules of the Office of Emergency Management to the Office of Emergency Management or an officer or employee of the Office of Emergency Management are considered to be references to the Oregon Department of Emergency Management or an officer or employee of the Oregon Department of Emergency Management.

SECTION 14. Whenever, in any statutory law or resolution of the Legislative Assembly or in any rule, document, record or proceeding authorized by the Legislative Assembly, reference is made to the Office of Emergency Management or an officer or employee of the Office of Emergency Management, the reference is considered to be a reference to the Oregon Department of Emergency Management or an officer or employee of the Oregon Department of Emergency Management.

(Initial Director)

SECTION 15. The Director of the Office of Emergency Management on the operative date specified in section 155 of this 2020 Act shall serve as the initial Director of the Oregon Department of Emergency Management at the pleasure of the Governor and without the need for confirmation by the Senate.

(Transfer of Emergency Powers to
the Oregon Department of Emergency Management)

SECTION 16. ORS 401.094 is amended to read:

401.094. (1)(a) The **Oregon** Department of [*State Police*] **Emergency Management** shall maintain a system for the notification and interagency coordination of state resources in response to emergencies involving multijurisdictional cooperation between the various levels of government and private business entities.

[(b) The department shall provide the Office of Emergency Management with a service level agreement that describes the continued daily operations and maintenance of the system, the services and supplies needed to maintain the system 24 hours a day, every day of the year, and the policies and procedures that support the overall notification system.]

(2) The [*notification*] system shall be managed by the [*Office of Emergency Management*] **department** as a continuously available communications network and a component of the [*state's*] **State** Emergency Operations Center.

(3) The [*notification*] system shall be the primary point of contact by which any public agency provides the state notification of an emergency or disaster, or requests access to state and federal resources.

(4) Each department of state government, and those agencies of state government identified in the statewide emergency management plan prepared under ORS 401.052 as having emergency service or administrative responsibilities, shall appoint an emergency management coordinator as their representative to work with the [*Office of Emergency Management*] **department** on the development

1 and implementation of emergency plans and procedures.

2 (5) The *[Office of Emergency Management]* **department** shall adopt rules relating to the plan-
 3 ning, administration and operation of the *[notification]* system maintained under this section.

4 **SECTION 17.** ORS 433.441 is amended to read:

5 433.441. (1) Upon the occurrence of a public health emergency, the Governor may declare a state
 6 of public health emergency as authorized by ORS 433.441 to 433.452 to protect the public health.

7 (2) A *[proclamation]* **declaration** of a state of public health emergency must specify:

8 (a) The nature of the public health emergency;

9 (b) The political subdivision or geographic area subject to the *[proclamation]* **declaration**;

10 (c) The conditions that have brought about the public health emergency; and

11 (d) The duration of the state of public health emergency, if the duration is less than 14 days.

12 (3) During a **declared** public health emergency, the Governor **or the Director of the Oregon**
 13 **Department of Emergency Management** may:

14 (a) Close, order the evacuation of or **order** the decontamination of any facility the Governor
 15 **or the director** has reasonable cause to believe may endanger the public health.

16 (b) Regulate or restrict by any means necessary the use, sale or distribution of food, fuel, med-
 17 ical supplies, medicines or other goods and services.

18 (c) Prescribe modes of transportation, routes and destinations required for the evacuation of
 19 individuals or the provision of emergency services.

20 (d) Control or limit entry into, exit from, movement within and the occupancy of premises in any
 21 public area subject to or threatened by a public health emergency if such actions are reasonable
 22 and necessary to respond to the public health emergency.

23 (e) Authorize pharmacists licensed under ORS chapter 689 to administer vaccines to persons
 24 who are three years of age or older.

25 (f) Take any other action that may be necessary for the management of resources, or to protect
 26 the public during a public health emergency, including any actions *[authorized]* **the Governor may**
 27 **take** under ORS 401.168, 401.185, 401.188 and 401.192.

28 (4) Nothing in ORS 433.441 to 433.452 limits the authority of the Governor to declare a state
 29 of emergency under ORS 401.165. If a state of emergency is declared as authorized under ORS
 30 401.165, the Governor **or the director** may implement any action authorized by ORS 433.441 to
 31 433.452.

32 (5) A *[proclamation]* **declaration** of a state of public health emergency expires when terminated
 33 by a declaration of the Governor or no more than 14 days after the date the public health emergency
 34 is *[proclaimed]* **declared** unless the Governor expressly extends the *[proclamation]* **declaration** for
 35 an additional 14-day period.

36 (6) When real or personal property is taken under power granted by this section, the owner of
 37 the property shall be entitled to reasonable compensation from the state.

39 433.443. (1) As used in this section:

40 (a) "Covered entity" means:

41 (A) The Children's Health Insurance Program;

42 (B) A health insurer that is an insurer as defined in ORS 731.106 and that issues health insur-
 43 ance as defined in ORS 731.162;

44 (C) The state medical assistance program; and

45 (D) A health care provider.

- 1 (b) "Health care provider" includes but is not limited to:
- 2 (A) A psychologist, occupational therapist, regulated social worker, professional counselor or
3 marriage and family therapist licensed or otherwise authorized to practice under ORS chapter 675
4 or an employee of the psychologist, occupational therapist, regulated social worker, professional
5 counselor or marriage and family therapist;
- 6 (B) A physician or physician assistant licensed under ORS chapter 677, an acupuncturist li-

2 (A) Created or received by a covered entity, an employer or a health care provider that is not
3 a covered entity; and

4 (B) Identifiable to an individual, including demographic information that identifies the individual,
5 or for which there is a reasonable basis to believe the information can be used to identify an indi-
6 vidual, and that relates to:

7 (i) The past, present or future physical or mental health or condition of an individual;

8 (ii) The provision of health care to an individual; or

9 (iii) The past, present or future payment for the provision of health care to an individual.

10 (e) “Legal representative” means attorney at law, person holding a general power of attorney,
11 guardian, conservator or any person appointed by a court to manage the personal or financial affairs
12 of a person, or agency legally responsible for the welfare or support of a person.

13 (2)(a) During a **state of public health emergency** declared under ORS 433.441, the Public Health
14 Director, **after consultation with the Director of the Oregon Department of Emergency**
15 **Management**, may, as necessary to appropriately respond to the public health emergency:

16 (A) Adopt reporting requirements for and provide notice of those requirements to health care
17 providers, institutions and facilities for the purpose of obtaining information directly related to the
18 public health emergency;

19 (B) After consultation with appropriate medical experts, create and require the use of diagnostic
20 and treatment protocols to respond to the public health emergency and provide notice of those
21 protocols to health care providers, institutions and facilities;

22 (C) Order, or authorize local public health administrators to order, public health measures ap-
23 propriate to the public health threat presented;

24 (D) Authorize pharmacists licensed under ORS chapter 689 to administer vaccines to persons
25 who are three years of age or older;

26 (E) Upon approval of the [*Governor*] **Director of the Oregon Department of Emergency**
27 **Management**, take other actions necessary to address the public health emergency and provide
28 notice of those actions to health care providers, institutions and facilities, including public health
29 actions authorized by ORS 431A.015;

30 (F) Take any enforcement action authorized by ORS 431A.010, including the imposition of civil
31 penalties of up to \$500 per day against individuals, institutions or facilities that knowingly fail to
32 comply with requirements resulting from actions taken in accordance with the powers granted to
33 the Public Health Director under subparagraphs (A), (B) and (E) of this paragraph; and

34 (G) The authority granted to the Public Health Director under this section:

All final decisions under this paragraph and paragraph (b) of this subsection are the responsibility of the local government with jurisdiction over the site. A local government may not delegate such final decisions to any state agency.

(d) May deny a request to issue a building permit if a geotechnical report discloses that the entire parcel is subject to a rapidly moving landslide or that the subject lot or parcel does not contain sufficient buildable area that is not subject to a rapidly moving landslide.

(e) Shall maintain a record, available to the public, of properties for which a geotechnical report has been prepared within the jurisdiction of the local government.

(2) A landowner allowed a building permit under subsection (1)(c) of this section shall sign a statement that shall:

(a) Be recorded with the county clerk of the county in which the property is located, in which the landowner acknowledges that the landowner may not in the future bring any action against an adjacent landowner about the effects of rapidly moving landslides on or adjacent to the landowner's property; and

(b) Record in the deed records for the county where the lot or parcel is located a nonrevocable deed restriction that the landowner signs and acknowledges, that contains a legal description complying with ORS 93.600 and that prohibits any present or future owner of the property from bringing any action against an adjacent landowner about the effects of rapidly moving landslides on or adjacent to the property.

(3) Restrictions on forest practices adopted under ORS 527.710 (10) do not apply to risk situations arising solely from the construction of a building designed for human occupancy in a further review area on or after October 23, 1999.

(4) The following state agencies shall implement the following specific responsibilities to reduce the risk of serious bodily injury or death resulting from rapidly moving landslides:

(a) The State Department of Geology and Mineral Industries shall:

(A) Identify and map further review areas selected in cooperation with local governments and in coordination with the State Forestry Department, and provide technical assistance to local governments to facilitate the use and application of this information pursuant to subsection (1)(b) of this section; and

(B) Provide public education regarding landslide hazards.

1 (b) The State Forestry Department shall regulate forest operations to reduce the risk of serious

17 (c) Implement forensic techniques and controls developed under subsection (6) of this section;

18 (d) Evaluate the event for the purpose of possible improvements to the security of information
 19 systems; and

20 (e) Communicate and share information with appropriate agencies, using preexisting incident
 21 response capabilities.

22 (6) After consultation and collaborative development with appropriate agencies and the Oregon
 23 Department of Administrative Services, the State Chief Information Officer shall implement forensic
 24 techniques and controls for the security of information systems, whether those systems are within,
 25 interoperable with or outside the state's shared computing and network infrastructure. The tech-
 26 niques and controls must include using specialized expertise, tools and methodologies to investigate
 27 events that damage or threaten the availability, integrity or confidentiality of information systems
 28 or the information stored in information systems. The State Chief Information Officer shall consult
 29 with the Oregon State Police, the [Office] **Oregon Department** of Emergency Management, the
 30 Governor and others as necessary in developing forensic techniques and controls under this section.

31 (7) The State Chief Information Officer shall ensure that reasonably appropriate remedial
 32 actions are undertaken when the State Chief Information Officer finds that such actions are rea-
 33 sonably necessary by reason of vulnerability assessments of information systems under subsection
 34 (3) of this section, evaluation of events under subsection (5) of this section and other evaluations
 35 and audits.

36 (8)(a) State agencies are responsible for securing computers, hardware, software, storage media,
 37 networks, operational procedures and processes used in collecting, processing, storing, sharing or
 38 distributing information outside the state's shared computing and network infrastructure, following
 39 information security standards, policies and procedures established by the State Chief Information
 40 Officer and developed collaboratively with the agencies. Agencies may establish plans, standards and

8 (B) The results of Oregon State Lottery reviews, evaluations and vulnerability assessments of
 9 computer systems outside the state's shared computing and network infrastructure.

10 (10) The State Chief Information Officer shall adopt rules to implement the provisions of this

13 276A.326. (1) The Oregon Cybersecurity Advisory Council is established within the office of the
 14 State Chief Information Officer. The council consists of nine voting members appointed by the State
 15 Chief Information Officer in consultation with the Governor. A majority of the council's voting
 16 members must be representatives of cyber-related industries in Oregon. The voting members of the
 17 council must include at least one representative of post-secondary institutions of education and one
 18 representative of public law enforcement agencies in Oregon.

33 (b) Provide a statewide forum for discussing and resolving cybersecurity issues.

34 (c) Provide information and recommend best practices concerning cybersecurity and resilience
 35 measures to public and private entities.

36 (d) Coordinate cybersecurity information sharing and promote shared and real-time situational

45 preparedness equipment or require the recipient to reimburse the [office] **department** for the cost

2 (g) The [office] **department** may transfer between recipients, dispose of or otherwise manage the
 3 preparedness equipment as [it] **the department** determines is in the best interests of meeting the
 4 emergency preparedness needs of the State of Oregon. If the [office] **department** disposes of
 5 preparedness equipment for any reason, including sale to a recipient as provided in paragraph (e)(D)
 6 of this subsection, the [office] **department** shall deposit any moneys [it] **the department** receives
 7 from the disposal in the Resiliency Grant Fund established under ORS 401.552.

8 (4) On or before December 31 of each year, the [office] **department** shall submit a report to the
 9 Legislative Assembly and to the Oregon Homeland Security Council that describes the adminis-
 10 tration and effectiveness of the grant program established under this section and the current prior-

26 (b) Establishing a sufficient number of evacuation shelters equipped to temporarily shelter
27 companion animals and service animals in close proximity to a human sheltering facility;

28 (c) Allowing owners and their companion animals to be evacuated together whenever possible;

29 (d) Establishing an identification system to ensure that owners who are separated from their
30 companion animals or service animals during an evacuation are provided with all information nec-
31 essary to locate and reclaim their animals;

41 animals that will:

42 (A) Encourage owners to plan for and incorporate their animals in the owners' personal plans
43 in the event of a major disaster or an emergency; and

44 (B) Inform owners of companion animals or service animals about the animal emergency oper-
45 ations plan prepared under this section.

(d) Any other methods or arrangements that the department determines would protect livestock during a major disaster or an emergency.

SECTION 57. ORS 402.015 is amended to read:

402.015. In carrying out the provisions of ORS chapter 401, the Governor and the executive officers or governing bodies of the counties and cities may request and utilize the services, equipment, supplies and facilities of existing departments, offices and agencies of the state and of local governments. The officers and personnel of all local government departments, offices and agencies may cooperate with, and extend such services and facilities to the Governor, to the [Office] **Oregon Department of Emergency Management** and to emergency management agencies and emergency service agencies upon request.

8 (5) The agreement does not:

9 (a) Require a participant to provide resources to a requesting participant.

10 (b) Preclude a participant from entering into any other agreement with another participant.

11 (c) Affect any other agreement to which a participant is a party or may become a party.

12 (6) The [*Office*] **Oregon Department** of Emergency Management shall develop, adopt and dis-
13 seminate:

14 (a) Guidelines and procedures for requesting and providing assistance under the agreement;

15 (b) Requirements for recordkeeping by participants; and

16 (c) Other procedures and guidelines that the [*office*] **department** considers necessary to imple-
17 ment the agreement in an effective and efficient manner.

19 402.230. (1) The intent of the intrastate mutual assistance agreement created under ORS 402.210
20 is to provide for nonreimbursable assistance to a requesting participant.

36 disclose information received under this paragraph to a private collection agency or use the infor-
37 mation for a purpose other than the collection of debts as described in this paragraph. If the infor-
38 mation disclosed under this paragraph is not prepared for the use of the Employment Department,
39 the costs of disclosing the information shall be paid by the Department of Human Services or the
40 Oregon Health Authority.

41 (p) Disclose to the Alcohol and Drug Policy Commission information required by the commission
42 in evaluating and measuring the performance of alcohol and drug prevention and treatment pro-
43 grams under ORS 430.223 or the impact of the programs on employment. The information disclosed
44 to the commission may include total subject wages payroll and whole hours worked. The information
45 disclosed under this paragraph is confidential and may not be used for any other purpose. The

1 commission may not disclose the information in any manner that would identify an employing unit
 2 or employee except to the extent necessary to carry out the commission's duties under ORS 430.223.
 3 If the information disclosed under this paragraph is not prepared for the use of the Employment
 4 Department, the costs of disclosing the information shall be paid by the commission.

5 (q) Disclose to any person establishment level information secured pursuant to this chapter from
 6 federal, state and local government agencies, public universities listed in ORS 352.002 or the Oregon
 7 Health and Science University established under ORS 353.020. If the information disclosed under this
 8 paragraph is not prepared for the use of the Employment Department, the costs of disclosing the
 9 information shall be paid by the person requesting the information.

10 (r) Disclose to any person the industrial classification code assigned to an employing unit. If the
 11 information disclosed under this paragraph is not prepared for the use of the Employment Depart-
 12 ment, the costs of disclosing the information shall be paid by the person requesting the information.

13 (s) Disclose information to the State Treasurer useful for the purpose of performing the State
 14 Treasurer's duties under ORS 98.302 to 98.436, 98.992 and 116.253 and the role of an estate admin-
 15 istrator under ORS 113.235. The information disclosed is confidential and may not be used by the
 16 State Treasurer for any other purpose. If the information disclosed is not prepared for the use of the
 17 Employment Department, the costs of disclosing the information shall be paid by the State Treas-
 18 urer.

19 (5) The Employment Department may make public all decisions of the Employment Appeals
 20 Board.

21 (6) Any officer appointed by or any employee of the Director of the Employment Department

 24 with the Employment Department.

6 (2) If an insurer ceases to do business or collect premiums on direct domestic risks, it thereupon
 7 shall make a report to the director of its premiums subject to taxation as provided in subsection (1)
 8 of this section and collected or due as of the date when it ceased to do business or collect premiums
 9 on direct domestic risks, and not theretofore reported, and shall forthwith pay to the director the
 10 tax thereon.

11 (3) If the director, during the period in which the director under ORS 731.836 may collect taxes
 12 owing under this section, finds the amount of such taxes paid by an insurer to have been incorrect,
 13 the director shall charge or credit the insurer with the difference between the correct amount of tax
 14 and the amount actually paid.

16 735.470. (1)(a) The surplus lines licensee shall pay the Director of the Department of Consumer

(a) Develop strategies for the effective coordination of the emergency planning, preparedness and response, mitigation and recovery activities of state agencies.

(b) Receive briefings from state agencies on security matters, as determined by the council, including but not limited to security matters relating to:

(A) Catastrophic disasters declared by the Governor pursuant to Article X-A, section 1, of the Oregon Constitution;

(B) States of emergency declared by the Governor pursuant to ORS 401.165;

(C) Public health emergencies declared by the Governor pursuant to ORS 433.441;

(D) The exercise of the Governor’s authority under ORS 476.520; and

(E) Emergency quarantines ordered by the Director of the Oregon Department of Emergency Management pursuant to ORS 561.560.

[(b)] **(c) Advise state agencies with responsibility for security matters *[on the future direction of the office’s planning, preparedness, response and recovery activities]* to facilitate the coordination of the agencies’ emergency preparedness and response functions.**

(2) The membership of the council consists of:

(a) Four members from the Legislative Assembly appointed as follows:

(A) Two members from the Senate appointed by the President of the Senate; and

(B) Two members from the House of Representatives appointed by the Speaker of the House of Representatives;

(b) The Governor;

(c) The Adjutant General;

(d) The Superintendent of State Police;

(e) The Director of the *[Office]* **Oregon Department** of Emergency Management; and

(f) A representative of the Department of Justice appointed by the Attorney General.

(g) The State Resilience Officer;

(h) The State Fire Marshal;

(i) The Director of the Department of Public Safety Standards and Training;

(j) The Director of the Oregon Health Authority;

(k) The Director of Transportation;

(L) The State Forester; and

(m) One member appointed by the Governor to act as a senior policy advisor for emergency operations.

(3) Each member appointed to the council under subsection *[(2)]* **(2)(a), (f) and (m)** of this section serves at the pleasure of the appointing authority. The membership of a public official ceases upon termination of the office held by the official at the time of appointment to the council.

(4) The Governor is the chairperson of the council.

1 (5) The [*Adjutant General*] **Director of the Oregon Department of Emergency Management**
2 is the vice chairperson of the council and serves as the chairperson in the absence of the Governor.

3 (6) Members of the council are not entitled to compensation under ORS 292.495. The [*director*]
4 **Governor**, in the [*director's*] **Governor's** discretion, may reimburse members of the council as pro-
5 vided in ORS 292.495 for actual and necessary travel or other expenses incurred in the performance
6 of their duties as members of the council.

7 (7) **A majority of the members of the council constitutes a quorum for the transaction**

19 **laws relating to confidentiality, to furnish information and advice the members of the council**
20 **consider necessary to perform their duties.**

36 come immediately effective.

37 (8) The council shall meet at times and places specified by the call of the chairperson or

39 (9) The council may adopt rules necessary for the operation of the council.

40 (10) The department shall provide staff support to the council.

41 (11) Members of the council are not entitled to compensation or reimbursement for ex-
42 penses and serve as volunteers on the council.

43 (12) All agencies of state government, as defined in ORS 174.111, are directed to assist
44 the council in the performance of the duties of the council and, to the extent permitted by
45 laws relating to confidentiality, to furnish information and advice the members of the council
