

House Bill 4071

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Water for Representative Ken Helm)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs Department of Environmental Quality to purchase cyanotoxin autoanalyzer system and associated supplies and services. Directs department to create, fill and utilize seasonal position to assist with cyanotoxin analysis.

Directs Oregon Health Authority to create, fill and utilize small utility outreach coordinator.

Appropriates moneys to department to purchase equipment and support increased staffing level. Appropriates moneys to authority to support increased staffing level.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to harmful algal blooms; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Department of Environmental Quality shall purchase one cyanotoxin**
5 **autoanalyzer system instrument to be used to analyze water samples for cyanotoxins. The**
6 **department shall acquire any services and supplies necessary for the operation of the in-**
7 **strument described in this subsection.**

8 **(2) The department shall create, fill and utilize at least one seasonal position within the**
9 **department to assist with the analysis of water samples for cyanotoxins and to collect water**
10 **samples during peak periods.**

11 **SECTION 2. The Oregon Health Authority shall create, fill and utilize the position of**
12 **small utility outreach coordinator to provide outreach to small water suppliers and water**
13 **suppliers that depend on a vulnerable water body to ensure that water suppliers have the**
14 **plans, tools and training needed to respond to cyanobacterial harmful algal blooms and other**
15 **water-related emergencies.**

16 **SECTION 3. In addition to and not in lieu of any other appropriation, there is appropri-**
17 **ated to the Department of Environmental Quality, for the biennium ending June 30, 2021, out**
18 **of the General Fund, the following amounts:**

19 **(1) \$95,000 for the purpose of carrying out the provisions of section 1 (1) of this 2020 Act;**
20 **and**

21 **(2) \$115,000 for the purpose of carrying out the provisions of section 1 (2) of this 2020 Act.**

22 **SECTION 4. In addition to and not in lieu of any other appropriation, there is appropri-**
23 **ated to the Oregon Health Authority, for the biennium ending June 30, 2021, out of the**
24 **General Fund, the amount of \$100,000, which may be expended for the purpose of carrying**
25 **out the provisions of section 2 of this 2020 Act.**

26 **SECTION 5. This 2020 Act being necessary for the immediate preservation of the public**
27 **peace, health and safety, an emergency is declared to exist, and this 2020 Act takes effect**
28 **on its passage.**
