

HOUSE AMENDMENTS TO HOUSE BILL 4127

1 On page 2 of the printed bill, line 8, after “health services” insert “under ORS chapter 679 or
2 680”.

3 In line 9, delete “and”.

4 In line 11, delete the period and insert “; and

5 “(e) Is certified by a community dental health coordinator training program based on a curric-
6 ulum developed by the American Dental Association or its successor organization.”.

7 In line 15, delete “focus on” and insert “emphasize”.

8 In line 17, after “ORS 336.079” insert “, or to students enrolled at a school that is eligible for
9 financial assistance under Title I of the Elementary and Secondary Education Act of 1965, 20 U.S.C.
10 6301 et seq”.

11 In line 21, delete “The” and insert “Pursuant to a mutual agreement, the”.

12 Delete lines 22 through 30 and insert “nonprofit organizations, dental care organizations, local
13 public health authorities as defined in ORS 431.003 and other state and local government agencies.

14 “(5) The authority may adopt rules as necessary to carry out this section.

15 **“SECTION 4. (1) The Oregon Health Authority shall seek funding from gifts, grants or
16 other contributions from public and private sources for the purposes of carrying out the
17 Community Dental Health Coordinator Pilot Program described in section 3 of this 2020 Act.
18 Funds received under this subsection shall be deposited in the Community Dental Health
19 Coordinator Pilot Program Fund established under section 5 of this 2020 Act. Funds may be
20 used to sponsor individuals in a community dental health coordinator training program.**

21 **“(2) The authority may adopt rules as necessary to carry out this section.”.**

22 In line 31, delete “4” and insert “5”.

23 Delete lines 36 through 41 and insert:

24 **“SECTION 6. Sections 3, 4 and 5 of this 2020 Act are repealed on June 30, 2025.**

25 **“SECTION 7. (1) Section 3 of this 2020 Act becomes operative on January 1, 2022, if the
26 balance in the Community Dental Health Coordinator Pilot Program Fund established in
27 section 5 of this 2020 Act is at least \$200,000 on January 1, 2022.**

28 **“(2) Upon the date specified in subsection (1) of this section, the Oregon Health Authority
29 shall notify the interim committees of the Legislative Assembly related to education and the
30 Legislative Counsel of whether upon the date specified in subsection (1) of this section the
31 balance in the Community Dental Health Coordinator Pilot Program Fund is at least the
32 amount specified in subsection (1) of this section.”.**

33 On page 3, line 1, delete “7” and insert “8”.

34 In line 11, delete “8” and insert “9”.

35 In line 17, delete “9” and insert “10”.
