SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies statewide greenhouse gas emissions reduction goals.

Establishes Oregon Greenhouse Gas Initiative and related provisions, operative January 1, 2022.

Authorizes Public Utility Commission to allow rate or rate schedule to include differential rates or to reflect amounts for programs that enable public utilities to assist low-income residential customers. Authorizes commission to allow electric companies and natural gas utilities to recover costs for prudent investments in or expenses for infrastructure measures that support adoption **and service** of alternative forms of transportation.

Amends greenhouse gas reporting statute.

Repeals Energy Facility Siting Council carbon dioxide emissions standards.

Provides that energy facility subject to site certificate or amended site certificate shall comply with Oregon Greenhouse Gas Initiative if energy facility would otherwise be subject to initiative.

Requires Environmental Quality Commission to adopt by rule standards and requirements for reducing methane emissions from landfills.

Requires Environmental Quality Commission to regulate use of hydrofluorocarbons in certain products.

Abolishes Oregon Global Warming Commission, **operative December 31, 2020.**

Repeals authority of State Forester to establish forestry carbon offset program.

Modifies requirements for ethanol content in gasoline.

Prohibits sale or offer for sale of general service lamps that do not meet certain efficiency standards. Authorizes State Department of Energy to modify prohibition by rule to align with laws of adjacent states.

Provides for direct, expedited judicial review by Oregon Supreme Court of certain constitutional questions related to Oregon Greenhouse Gas Initiative.

Requires certain reports and reviews related to Oregon Greenhouse Gas Initiative.

Establishes, within Department of Environmental Quality, Oregon Greenhouse Gas Reduction Board, Administrator of the Office of Greenhouse Gas Regulation and Office of Greenhouse Gas Regulation and sets forth duties of board, administrator and office.

Declares emergency, effective on passage.

A BILL FOR AN ACT

Relating to greenhouse gas emissions; creating new provisions; amending ORS 244.050, 352.823, 468.015, 468.953, 468A.205, 468A.265, 468A.279, 468A.280, 469.300, 469.310, 469.373, 469.405, 469.407, 469.501, 469.503, 469.504, 469.505, 530.050, 530.500, 646.913, 757.259 and 757.528 and sections 75 and 76, chapter 750, Oregon Laws 2017; repealing ORS 468A.200, 468A.210, 468A.215, 468A.220, 468A.225, 468A.230, 468A.235, 468A.240, 468A.245, 468A.250, 468A.255, 468A.260, 469.409, 526.780, 526.783, 526.786 and 526.789; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

STATEWIDE GREENHOUSE GAS EMISSIONS
REDUCTION GOALS

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

SECTION 1. ORS 468A.205 is amended to read:

468A.205. (1) The Legislative Assembly declares that it is the *[policy]* **goal** of this state to **achieve a reduction in anthropogenic greenhouse gas emissions levels in Oregon:** *[reduce greenhouse gas emissions in Oregon pursuant to the following greenhouse gas emissions reduction goals:]*

[(a) By 2010, arrest the growth of Oregon's greenhouse gas emissions and begin to reduce greenhouse gas emissions.]

[(b) By 2020, achieve greenhouse gas levels that are 10 percent below 1990 levels.]

[(c) By 2050, achieve greenhouse gas levels that are at least 75 percent below 1990 levels.]

(a) To at least 45 percent below 1990 emissions levels by 2035; and

(b) To at least 80 percent below 1990 emissions levels by 2050.

(2) The Legislative Assembly declares that it is the policy of this state for state and local governments, businesses, nonprofit organizations and individual residents to prepare for the effects of *[global warming]* **climate change** and by doing so, prevent and reduce the social, economic and environmental effects of *[global warming]* **climate change**.

(3) This section does not create any additional regulatory authority for an agency of the executive department as defined in ORS 174.112.

OREGON GREENHOUSE GAS INITIATIVE
(Statement of Purpose)

SECTION 2. (1) The Legislative Assembly finds and declares that the purposes of sections 2, 4 to 32, 33 to 37, 38 to 40, 41, 42, 43, 45 to 53, 96 and 96a of this 2020 Act are:

(a) To achieve a reduction in total levels of regulated emissions under sections 4 to 32 of this 2020 Act to at least 45 percent below 1990 emissions levels by 2035 and to achieve a reduction in total regulated emissions levels to at least 80 percent below 1990 emissions levels by 2050;

(b) To promote greenhouse gas emissions sequestration and mitigation;

(c) To promote the adaptation and resilience of natural and working lands, fish and wildlife resources, communities, the economy and this state's infrastructure in the face of climate change and ocean acidification; and

(d) To provide assistance to households, businesses and workers impacted by climate change or by climate change policies.

(2) Sections 2, 4 to 32, 33 to 37, 38 to 40, 41, 42, 43, 45 to 53, 96 and 96a of this 2020 Act and the rules adopted pursuant to sections 2, 4 to 32, 33 to 37, 38 to 40, 41, 42, 43, 45 to 53, 96 and 96a of this 2020 Act may not be interpreted to limit the authority of any state agency to adopt and implement measures to reduce greenhouse gas emissions.

(Chapter Placement)

SECTION 3. Sections 97 to 100, 102 to 105, 107 and 107a of this 2020 Act are added to and made a part of ORS chapter 468.

(General Regulatory Provisions)

SECTION 4. Definitions. As used in sections 2 and 4 to 32 of this 2020 Act:

(1) **“Aggregation” means an approach for qualifying and quantifying offset projects, for the purposes of reducing costs and increasing the development of offset projects, that allows for the grouping together of two or more geographically separate activities:**

(a) **Undertaken by one or more parties; and**

(b) **That result in reductions or removals of greenhouse gases in a similar manner.**

(2) **“Allowance” means a fungible authorization to emit one metric ton of carbon dioxide equivalent.**

(3) **“Annual allowance budget” means the number of allowances available to be allocated during one year of the Oregon Greenhouse Gas Initiative.**

(4) **“Anthropogenic greenhouse gas emissions” means greenhouse gas emissions that are not biogenic emissions.**

(5) **“Best available science” means science that is reliable and unbiased and that involves the use of supporting studies conducted in accordance with sound and objective science practices, including, when available, peer-reviewed science and supporting studies and data collected by accepted methods or best available methods.**

(6) **“Biogenic emissions” means carbon dioxide emissions generated from the combustion of biomass-derived fuels.**

(7) **“Biomass-derived fuels” includes:**

(a) **Nonfossilized and biodegradable organic material originating from plants, animals or microorganisms;**

(b) **Products, by-products, residues or waste from agriculture, forestry or related industries; and**

(c) **The nonfossilized and biodegradable organic fractions of industrial and municipal wastes, including gases and liquids recovered from:**

(A) **The decomposition of nonfossilized and biodegradable organic material originating from plants, animals or microorganisms; or**

(B) **Municipal solid waste disposed of in a landfill.**

(8)(a) **“Business unit” means a business operation that is located at a facility permitted as a single air contamination source under ORS 468.065, 468A.040 or 468A.155, but that is distinguishable from one or more other business operations located at the facility by:**

(A) **The short title and six-digit code in the 2017 North American Industry Classification System applicable to the business operation;**

(B) **Accounting practices for the business operation that maintain the finances for the business operation as distinct from the finances of other business operations located at the facility; and**

(C) **The capability of the business operation to operate separately and independently of other business operations at the facility if not colocated with the other business operations.**

(b) **“Business unit” does not mean a cogeneration facility.**

(9) **“Carbon dioxide equivalent” means the amount of carbon dioxide by weight that would produce the same global warming impact as a given weight of another greenhouse gas, based on considerations including but not limited to the best available science, including information from the Intergovernmental Panel on Climate Change.**

(10) **“Compliance instrument” means one allowance or one offset credit that may be used to fulfill a compliance obligation.**

1 (11) “Compliance obligation” means the quantity of regulated emissions that are attrib-
2 utable to a covered entity, and for which compliance instruments must be retired, for a
3 compliance period.

4 (12) “Consumer-owned utility” has the meaning given that term in ORS 757.270.

5 (13) “Covered entity” means a person that is designated by the Office of Greenhouse Gas
6 Regulation as subject to the Oregon Greenhouse Gas Initiative.

7 (14) “Direct environmental benefits in this state” means:

8 (a) A reduction in or avoidance of emissions of any air contaminant in this state other
9 than a greenhouse gas;

10 (b) A reduction in or avoidance of pollution of any of the waters of the state, as the
11 terms “pollution” and “the waters of the state” are defined in ORS 468B.005; or

12 (c) An improvement in the health of natural and working lands in this state.

13 (15) “EITE entity” means a covered entity that is engaged in the manufacture of goods
14 through one or more emissions-intensive, trade-exposed processes, as further designated by
15 the office pursuant to section 19 of this 2020 Act.

16 (16) “Electric company” has the meaning given that term in ORS 757.600.

17 (17) “Electricity service supplier” has the meaning given that term in ORS 757.600.

18 (18) “Electric system manager” includes any entity that, as needed, operates or markets
19 electricity generating facilities, or purchases wholesale electricity, to manage the load for
20 wholesale or retail electricity customers within a balancing authority area that is at least
21 partially located in Oregon, including but not limited to the following types of entities:

22 (a) Electric companies.

23 (b) Electricity service suppliers.

24 (c) Consumer-owned utilities.

25 (d) The Bonneville Power Administration.

26 (e) Electric generation and transmission cooperatives.

27 (19) “Eligible Indian tribe” means each of the Burns Paiute Tribe, the Confederated
28 Tribes of Coos, Lower Umpqua and Siuslaw Indians, the Confederated Tribes of the Grand
29 Ronde Community of Oregon, the Confederated Tribes of Siletz Indians of Oregon, the Con-
30 federated Tribes of the Umatilla Indian Reservation, the Confederated Tribes of the Warm
31 Springs Reservation of Oregon, the Coquille Indian Tribe, the Cow Creek Band of Umpqua
32 Tribe of Indians and the Klamath Tribes.

33 (20) “General market participant” means a person that is not a covered entity and that
34 intends to purchase, hold, sell or voluntarily surrender compliance instruments.

35 (21) “Greenhouse gas” includes, but is not limited to, carbon dioxide, methane, nitrous
36 oxide, hydrofluorocarbons, perfluorocarbons, sulfur hexafluoride and nitrogen trifluoride.

37 (22) “Impacted community” means a community at risk of being disproportionately im-
38 pacted by climate change as designated by the Oregon Greenhouse Gas Reduction Board
39 under section 103 of this 2020 Act.

40 (23) “Indian trust lands” means lands within this state held in trust by the United States
41 for the benefit of an eligible Indian tribe or individual members of an eligible Indian tribe.

42 (24) “Multistate jurisdictional electric company” means an electric company that serves
43 electricity customers in both Oregon and one or more other states.

44 (25) “Natural and working lands” means:

45 (a) Lands and waters:

1 (A) Actively used by an agricultural owner or operator for an agricultural operation that
2 includes, but need not be limited to, active engagement in farming or ranching;

3 (B) Producing forest products;

4 (C) Consisting of forests, woodlands, grasslands, sagebrush steppes, deserts, freshwater
5 and riparian systems, wetlands, coastal and estuarine areas, the submerged and submersible
6 lands within Oregon's territorial sea, watersheds, wildlands or wildlife habitats; or

7 (D) Used for recreational purposes such as parks, urban and community forests, trails,
8 greenbelts and other similar open space land; and

9 (b) Lands and waters described in paragraph (a) of this subsection that are Indian trust
10 lands, lands within the boundaries of the reservation of an eligible Indian tribe or lands
11 otherwise owned by an eligible Indian tribe.

12 (26) "Natural gas supplier" means any entity that is not a natural gas utility and that:

13 (a) Procures natural gas for end use in this state; or

14 (b) Owns natural gas as it is imported into this state for end use in this state.

15 (27) "Natural gas utility" means a natural gas utility regulated by the Public Utility
16 Commission under ORS chapter 757.

17 (28) "Offset credit" means a fungible credit generated by an offset project that represents
18 a greenhouse gas emissions reduction or removal of one metric ton of carbon dioxide equiv-
19 alent.

20 (29) "Offset project" means a project that reduces or removes greenhouse gas emissions
21 that are not regulated emissions.

22 (30) "Oregon Greenhouse Gas Initiative" means the program adopted by rule by the
23 Oregon Greenhouse Gas Reduction Board under section 5 of this 2020 Act and in accordance
24 with the provisions of sections 4 to 32 of this 2020 Act.

25 (31) "Permitted air contamination source" means an air contamination source as defined
26 in ORS 468A.005 for which a permit is issued by the Department of Environmental Quality
27 pursuant to ORS 468.065, 468A.040 or 468A.155.

28 (32) "Person" has the meaning given that term in ORS 468.005.

29 (33) "Registered entity" means a covered entity or general market participant that has
30 successfully registered to participate in the Oregon Greenhouse Gas Initiative.

31 (34) "Regulated emissions" means the verified anthropogenic greenhouse gas emissions
32 reported by or assigned to a covered entity under ORS 468A.280 that the office determines
33 are anthropogenic greenhouse gas emissions regulated under sections 4 to 32 of this 2020 Act.

34 (35) "Surrender" means to transfer a compliance instrument to the office to fulfill a
35 compliance obligation or on a voluntary basis.

36 (36) "Trade-exposed natural gas user" means a person that is engaged in processes for
37 which the indirect costs of compliance with the Oregon Greenhouse Gas Initiative may cre-
38 ate a substantial risk of leakage, as further designated by the office pursuant to section 18
39 of this 2020 Act.

40 **SECTION 5. General provisions; designation of covered entities.** (1)(a) The Oregon
41 Greenhouse Gas Reduction Board shall, in accordance with ORS chapter 183, adopt rules
42 necessary for the Office of Greenhouse Gas Regulation to implement the Oregon Greenhouse
43 Gas Initiative established under sections 4 to 32 of this 2020 Act. The rules shall:

44 (A) Place a limit on the total anthropogenic greenhouse gas emissions that are regulated
45 emissions by setting annual allowance budgets for 2022 to 2050; and

1 (B) Provide a system for covered entities to buy and sell allowances and offset credits
2 used to demonstrate compliance with the covered entities' compliance obligations.

3 (b)(A) The annual allowance budget for 2022 shall be a number of allowances equal to
4 baseline emissions as calculated under paragraph (c) of this subsection.

5 (B) In 2023 and each following calendar year before 2036, the number of allowances
6 available in each annual allowance budget shall decline by a constant amount necessary to
7 accomplish a reduction in total regulated emissions levels to at least 45 percent below 1990
8 emissions levels by 2035.

9 (C) In 2036 and in each following calendar year before 2051, the number of allowances
10 available in each annual allowance budget shall decline by a constant amount necessary to
11 accomplish a reduction in total regulated emissions levels to at least 80 percent below 1990
12 emissions levels by 2050.

13 (c) The office shall calculate baseline emissions to be equal to a forecast of regulated
14 emissions for 2022, informed by the three-year average of the total, expressed in metric tons
15 of carbon dioxide equivalent, of anthropogenic greenhouse gas emissions attributable to all
16 persons that the office designates to be covered entities under the Oregon Greenhouse Gas
17 Initiative. In calculating baseline emissions, the office shall use greenhouse gas emissions
18 information from the three most recent years prior to 2022 for which greenhouse gas emis-
19 sions information is available and confirmed by the office. The office shall exclude from the
20 calculation of baseline emissions those greenhouse gas emissions during the three most re-
21 cent years prior to 2022 that would not have been regulated emissions if the Oregon
22 Greenhouse Gas Initiative had been in effect during the time that the greenhouse gas emis-
23 sions occurred.

24 (2) Subject to section 6 of this 2020 Act, the office shall designate persons as covered
25 entities as follows:

26 (a) The office shall designate an electric system manager as a covered entity for the
27 purpose of addressing annual regulated emissions from outside this state that are attribut-
28 able to the generation of electricity that the electric system manager schedules for delivery
29 and consumption in this state, including wholesale market purchases for which the energy
30 source for the electricity is not known, and accounting for transmission and distribution line
31 losses. For the purposes of this paragraph, the board may adopt rules necessary to address
32 electricity scheduled for delivery and consumption in this state through an energy imbalance
33 market or other centralized market administered by a market operator.

34 (b) The office shall designate a natural gas supplier as a covered entity for the purpose
35 of addressing annual regulated emissions that are attributable to the combustion of natural
36 gas that is:

37 (A) Sold by the natural gas supplier for use in this state;

38 (B) Distributed on a local distribution system operated by a natural gas utility; and

39 (C) Directly consumed or resold for use in this state by the customer of the natural gas
40 supplier.

41 (c) The office shall designate a natural gas utility as a covered entity for the purpose of
42 addressing annual regulated emissions that are attributable to the combustion of natural gas
43 that the natural gas utility sells for use in this state and that are not emissions accounted
44 for through the regulation of natural gas suppliers under paragraph (b) of this subsection.

45 (d) The office shall designate as covered entities persons that produce in Oregon, or im-

1 port into Oregon, liquid or gaseous fuel other than natural gas that is sold or distributed for
2 use in this state, as necessary to address annual regulated emissions that are attributable
3 to the combustion of the fuel.

4 (e) Except as provided in paragraph (f) of this subsection, the office shall designate a
5 permitted air contamination source as a covered entity if the annual regulated emissions
6 attributable to the permitted air contamination source meet or exceed 25,000 metric tons of
7 carbon dioxide equivalent. For purposes of this paragraph, the annual regulated emissions
8 attributable to the permitted air contamination source may not include anthropogenic
9 greenhouse gas emissions accounted for through the regulation of a person described in
10 paragraph (b), (c) or (d) of this subsection, unless the permitted air contamination source
11 has an applicable code of 221112 under the 2017 North American Industry Classification Sys-
12 tem.

13 (f) If a permitted air contamination source is a facility composed of two or more business
14 units colocated with a cogeneration facility that generates energy utilized by the permitted
15 air contamination source, the office shall designate the permitted air contamination source
16 as a covered entity for each individual business unit with annual regulated emissions attrib-
17 utable to the business unit that meet or exceed 25,000 metric tons of carbon dioxide equiv-
18 alent. A person designated as a covered entity under this paragraph shall be a covered entity
19 only for addressing the annual regulated emissions attributable to the business units for
20 which the person is designated as a covered entity. For the purposes of this paragraph, the
21 office shall attribute to a business unit the annual regulated emissions from the cogeneration
22 facility colocated with the business unit that are proportionate to the annual energy usage
23 of the business unit.

24 (3) The board shall adopt rules for the system required by subsection (1) of this section
25 that include, but need not be limited to:

26 (a) Rules allowing for the purchase, sale and exchange of compliance instruments;

27 (b) Rules allowing registered entities to bank and carry forward allowances;

28 (c) Rules prohibiting the borrowing of allowances from future compliance periods;

29 (d) Rules allowing general market participants to participate in the Oregon Greenhouse
30 Gas Initiative; and

31 (e) Compliance periods, standards for calculating compliance obligations and procedures
32 for covered entities to fulfill their compliance obligations.

33 (4) The office shall require a covered entity to surrender to the office the quantity of
34 compliance instruments necessary to fulfill the covered entity's compliance obligation no
35 later than the surrender date specified by the board by rule or order.

36 (5) For purposes of determining the compliance obligation for a covered entity that is an
37 electric system manager, electricity scheduled by the electric system manager that is gen-
38 erated from a renewable energy resource, regardless of the disposition of the renewable en-
39 ergy certificate associated with the electricity, shall be considered to have the emissions
40 attributes of the underlying renewable energy resource.

41 (6) In addition to any penalty provided by law, rules adopted by the board:

42 (a) Shall require a covered entity that fails to fulfill a compliance obligation to surrender
43 to the office a number of compliance instruments that is in addition to the entity's compli-
44 ance obligation; and

45 (b) May establish a process for placing restrictions on the holding account of a registered

1 entity determined to have engaged in a violation of a provision of sections 4 to 32 of this 2020
2 Act or rules adopted under sections 4 to 32 of this 2020 Act.

3 (7)(a) All covered entities and general market participants must register as registered
4 entities to participate in the Oregon Greenhouse Gas Initiative.

5 (b) The board shall adopt by rule registration requirements and any additional require-
6 ments necessary for registered entities to participate in auctions administered pursuant to
7 section 28 of this 2020 Act.

8 (8) In adopting rules pursuant to this section or any other rulemaking authority provided
9 under sections 4 to 32 of this 2020 Act, the board shall:

10 (a) Endeavor to develop the rules in a manner that does not preclude participation by the
11 State of Oregon in regional greenhouse gas emissions reduction programs; and

12 (b) Avoid rules under which greenhouse gas emissions or greenhouse gas emissions re-
13 ductions are counted more than once.

14 **SECTION 6. Exclusions.** (1) The Office of Greenhouse Gas Regulation shall exclude from
15 regulated emissions under sections 4 to 32 of this 2020 Act:

16 (a) Greenhouse gas emissions from the combustion of fuel that is demonstrated to have
17 been used as aviation fuel or as fuel in watercraft or railroad locomotives; and

18 (b) The emissions attributable to a landfill, as defined in ORS 459.005.

19 (2) For purposes of section 5 (2)(d) of this 2020 Act, the office may exempt from desig-
20 nation as a covered entity any person that imports in a calendar year less than a de minimis
21 amount of gasoline or diesel fuel, in total, as determined by the Oregon Greenhouse Gas
22 Reduction Board by rule. Gasoline and diesel fuel imported by persons that are related or
23 share common ownership or control shall be aggregated in determining whether a person
24 may be exempted under this subsection.

25 **SECTION 7. Allocation of allowances, generally.** The Office of Greenhouse Gas Regulation
26 shall allocate the allowances available in each annual allowance budget as follows:

27 (1) The office shall allocate a number of the allowances for deposit in an allowance price
28 containment reserve.

29 (2) The office shall allocate for retirement a number of the allowances as necessary to
30 meet statutory requirements for retirement of allowances under the Oregon Greenhouse Gas
31 Initiative.

32 (3) The office shall allocate a number of the allowances for direct distribution at no cost
33 to covered entities that are electric companies pursuant to rules adopted under section 14
34 of this 2020 Act.

35 (4) The office shall allocate a number of the allowances for direct distribution at no cost
36 to covered entities that are electric system managers other than electric companies pursu-
37 ant to section 15 of this 2020 Act.

38 (5) The office shall allocate a number of the allowances for deposit in an electricity price
39 containment reserve. Allowances may be directly distributed to covered entities that are
40 electric system managers at no cost from the electricity price containment reserve only
41 when the distribution is necessary to protect retail customers from cost increases associated
42 with unexpected increases in regulated emissions attributable to an electric system manager
43 that are outside of the control of the electric system manager, including but not limited to
44 unexpected increases in regulated emissions due to hydroelectric power generation variabil-
45 ity. The Oregon Greenhouse Gas Reduction Board shall adopt rules for electric system

1 managers to apply for direct distribution at no cost of allowances from the electricity price
2 containment reserve. The rules shall prioritize distribution of allowances from the electric-
3 ity price containment reserve to electric system managers that experience unexpected in-
4 creases in regulated emissions attributable to variation in hydroelectric power generation to
5 serve the load of retail customers in Oregon.

6 (6) The office shall allocate a number of the allowances for direct distribution at no cost
7 to covered entities that are natural gas utilities pursuant to section 17 of this 2020 Act.

8 (7) In order to mitigate leakage and pursuant to sections 19 and 20 of this 2020 Act, the
9 office shall allocate a number of the allowances for direct distribution at no cost to covered
10 entities that are EITE entities.

11 (8) The office shall allocate a number of the allowances for deposit in an emissions-
12 intensive, trade-exposed process reserve. Allowances in the emissions-intensive, trade-
13 exposed process reserve may be directly distributed at no cost only to:

14 (a) EITE entities pursuant to rules adopted under section 20 (9) of this 2020 Act; or

15 (b) An EITE entity designated as such pursuant to section 19 (2) of this 2020 Act.

16 (9) The office may allocate a number of the allowances for deposit in any other reserves
17 or accounts, including but not limited to a voluntary renewable electricity generation re-
18 serve, that the board establishes by rule and as the office determines is necessary.

19 (10) The office shall allocate the allowances that are not otherwise allocated pursuant to
20 subsections (1) to (9) of this section for deposit in an auction holding account for auction
21 pursuant to section 28 of this 2020 Act. If allowances deposited in the auction holding account
22 under this subsection remain unsold after two or more consecutive auctions held pursuant
23 to section 28 of this 2020 Act, the office may redistribute the unsold allowances to the al-
24 lowance price containment reserve described in subsection (1) of this section.

25 **SECTION 8. Retirement of allowances for certain electric system managers.** (1) In 2022
26 and each following calendar year before 2051, the Office of Greenhouse Gas Regulation shall
27 retire from the annual allowance budget, on behalf of a covered entity that is an electric
28 system manager, a number of allowances equal to the regulated emissions attributable to a
29 consumer-owned utility, if the three-year average of the annual anthropogenic greenhouse
30 gas emissions attributable to electricity that is scheduled, by the consumer-owned utility or
31 by an electric generation and transmissions cooperative, for final delivery by the consumer-
32 owned utility for consumption in this state is less than 25,000 metric tons of carbon dioxide
33 equivalent.

34 (2) Allowances directly retired by the office on behalf of a covered entity under this sec-
35 tion shall count toward fulfilling the covered entity's compliance obligation for the compli-
36 ance period during which the allowances are directly retired.

37 **SECTION 9. Retirement of allowances for certain electricity service suppliers.** (1) As used
38 in this section:

39 (a) "Direct access" has the meaning given that term in ORS 757.600.

40 (b) "Electricity services" has the meaning given that term in ORS 757.600.

41 (c) "Retail electricity consumer" has the meaning given that term in ORS 757.600.

42 (2) In 2022 and in each following calendar year before 2026, the Office of Greenhouse Gas
43 Regulation shall retire from the annual allowance budget, on behalf of a covered entity that
44 is an electricity service supplier, a number of allowances equal to the regulated emissions
45 attributable to the electricity service supplier for electricity services provided:

1 (a) To a person that was a direct access retail electricity consumer prior to January 31,
2 2020; and

3 (b) Pursuant to a contract that became effective on or before January 31, 2020.

4 (3) An electricity service supplier may not include in the rate or bill charged to a retail
5 electricity consumer the costs associated with compliance by the electricity service supplier
6 with the Oregon Greenhouse Gas Initiative that are attributable to the regulated emissions
7 for which allowances are retired under subsection (2) of this section.

8 (4) The office may annually request from retail electricity consumers the information
9 that is necessary to administer this section. If a retail electricity consumer does not comply
10 with a request under this subsection, the office may not retire under this section any al-
11 lowances for regulated emissions attributable to electricity services provided to that retail
12 electricity consumer.

13 (5) Allowances directly retired by the office on behalf of a covered entity under this sec-
14 tion shall count toward fulfilling the covered entity's compliance obligation for the compli-
15 ance period during which the allowances are directly retired.

16 SECTION 10. Section 9 of this 2020 Act is repealed on January 2, 2026.

17 SECTION 11. Retirement of allowances for covered entities that are natural gas powered
18 electric power generation facilities. (1) In 2022 and each following calendar year before 2027,
19 the Office of Greenhouse Gas Regulation shall retire from the annual allowance budget, on
20 behalf of a covered entity described in section 5 (2)(e) of this 2020 Act, if the covered entity
21 is a natural gas powered electric power generation facility with an applicable code of 221112
22 under the 2017 North American Industry Classification System, a number of allowances equal
23 to the regulated emissions that are attributable to the generation in this state by the cov-
24 ered entity of electricity:

25 (a) That is delivered to and consumed in another state, accounting for transmission and
26 distribution line losses; and

27 (b) For which the capital and fuel costs associated with the generation are included in
28 the rates of a multistate jurisdictional electric company that are charged to electricity cus-
29 tomers in a state other than Oregon.

30 (2) Allowances directly retired by the office on behalf of a covered entity under this sec-
31 tion shall count toward fulfilling the covered entity's compliance obligation for the compli-
32 ance period during which the allowances are directly retired.

33 SECTION 12. Section 11 of this 2020 Act is repealed on January 2, 2027.

34 SECTION 13. Retirement of allowances for certain motor vehicle fuel importers and
35 suppliers. (1) As used in this section:

36 (a) "Metropolitan planning area" has the meaning given that term in 49 U.S.C. 5303(b).

37 (b) "Motor vehicle" means a vehicle that is self-propelled or designed for self-propulsion.

38 (c) "Motor vehicle fuel" means any combustible gas, liquid or material of a kind used as
39 fuel for the generation of power to propel a motor vehicle.

40 (d) "Truck stop" means a public facility for the fueling of motor vehicles that has, at the
41 facility:

42 (A) At least four showers available for public use;

43 (B) A permanently established truck scale; and

44 (C) One or more underground storage tanks that are dedicated to supplying diesel motor
45 vehicle fuel to at least four fueling islands that are each:

1 (i) Dedicated to fueling trucks; and

2 (ii) Equipped with both a pump designed for the high-speed dispensing of diesel motor
3 vehicle fuel and a satellite diesel motor vehicle fuel pump.

4 (2) In 2022 and each following calendar year before 2025, the Office of Greenhouse Gas
5 Regulation shall retire from the annual allowance budget, on behalf of a covered entity de-
6 scribed in section 5 (2)(d) of this 2020 Act, a number of allowances equal to 100 percent of
7 regulated emissions attributable to the combustion of motor vehicle fuel that is:

8 (a) Produced in Oregon or imported into Oregon by the covered entity; and

9 (b) Delivered into a fuel tank used for propelling a motor vehicle at:

10 (A) A delivery point with a zip code that is located outside the boundary of the metro-
11 politan planning area that includes Portland; or

12 (B) A truck stop that is geographically located 1.5 miles or less from the border between
13 the State of Oregon and a state that has not adopted a program for regulating greenhouse
14 gas emissions from motor vehicle fuel.

15 (3) In 2025 and each following calendar year before 2028, and subject to subsection (6) of
16 this section, the office shall retire from the annual allowance budget, on behalf of a covered
17 entity described in section 5 (2)(d) of this 2020 Act, a number of allowances equal to 100
18 percent of regulated emissions attributable to the combustion of motor vehicle fuel that is:

19 (a) Produced in Oregon or imported into Oregon by the covered entity; and

20 (b) Delivered into a fuel tank used for propelling a motor vehicle at:

21 (A) A delivery point with a zip code that is located outside the boundaries of Benton,
22 Clackamas, Clatsop, Columbia, Douglas, Hood River, Jackson, Josephine, Lane, Lincoln, Linn,
23 Marion, Multnomah, Polk, Tillamook, Washington and Yamhill Counties; or

24 (B) A truck stop that is geographically located 1.5 miles or less from the border between
25 the State of Oregon and a state that has not adopted a program for regulating greenhouse
26 gas emissions from motor vehicle fuel.

27 (4) In 2028 and each following calendar year before 2051, and subject to subsection (6) of
28 this section, the office shall retire from the annual allowance budget, on behalf of a covered
29 entity described in section 5 (2)(d) of this 2020 Act, a number of allowances equal to 100
30 percent of regulated emissions attributable to the combustion of motor vehicle fuel that is:

31 (a) Produced in Oregon or imported into Oregon by the covered entity; and

32 (b) Delivered into a fuel tank used for propelling a motor vehicle at:

33 (A) A delivery point with a zip code that is located outside the boundaries of:

34 (i) Benton, Clackamas, Clatsop, Columbia, Coos, Curry, Douglas, Hood River, Jackson,
35 Josephine, Lane, Lincoln, Linn, Marion, Multnomah, Polk, Tillamook, Washington and
36 Yamhill Counties; and

37 (ii) The City of Bend and the City of Klamath Falls; or

38 (B) A truck stop that is geographically located 1.5 miles or less from the border between
39 the State of Oregon and a state that has not adopted a program for regulating greenhouse
40 gas emissions from motor vehicle fuel.

41 (5) The electors or the governing body of a county or city may, by ordinance or resolu-
42 tion, exercise the option for the cost of the Oregon Greenhouse Gas Initiative to apply to
43 motor vehicle fuel delivered into the fuel tanks for propelling motor vehicles at delivery
44 points located within the boundary of the county or city. Not later than 10 days after passage
45 of an ordinance or resolution approving exercise of the option described in this subsection,

1 the governing body of the county or city shall provide by certified mail to the office a certi-
2 fied copy of the adopted ordinance or resolution.

3 (6) The office shall cease to retire allowances from the annual allowance budget under
4 this section on January 1 of the year following the year in which the total number of coun-
5 ties in this state that have exercised the option described in subsection (5) of this section
6 first meets or exceeds 23 counties.

7 (7) Allowances directly retired by the office on behalf of a covered entity under this sec-
8 tion shall count toward fulfilling the covered entity's compliance obligation for the compli-
9 ance period during which the allowances are directly retired. A covered entity may not
10 include in the rate or bill charged for motor vehicle fuel delivered at a delivery point for
11 which allowances are directly retired under this section any costs associated with compliance
12 by the covered entity with the Oregon Greenhouse Gas Initiative.

13 **SECTION 14. Direct distribution of allowances for electric companies.** The Oregon
14 Greenhouse Gas Reduction Board shall, in consultation with the Public Utility Commission,
15 adopt rules for allocating allowances for direct distribution at no cost to covered entities
16 that are electric companies. Direct distributions under this section must be for the exclusive
17 benefit of retail customers that are supplied electricity by the electric company. Rules
18 adopted under this section must allow for an electric company to use allowances directly
19 distributed under this section to fulfill the compliance obligation associated with electricity
20 supplied by the electric company to serve the load of the electric company's retail customers
21 in Oregon, subject to the oversight of the commission. The rules must include provisions
22 necessary to implement direct distributions of allowances to electric companies as follows:

23 (1)(a) For the purpose of aligning the effects of sections 4 to 32 of this 2020 Act with the
24 trajectory of emissions reductions by electric companies resulting from the requirements of
25 ORS 469A.005 to 469A.210 and 757.518:

26 (A) The annual direct distributions to an electric company in 2022 and in each following
27 calendar year before 2030 must be a number of allowances such that the electric company
28 receives a total direct distribution of allowances over that time period equal to 100 percent
29 of the electric company's forecast regulated emissions for 2022 and for each following year
30 until and including 2029 associated with the electricity supplied to serve the load of the
31 electric company's retail customers in Oregon; and

32 (B) The direct distribution to an electric company in 2030 must be a number of allow-
33 ances equal to 100 percent of the electric company's forecast regulated emissions associated
34 with the electricity supplied to serve the load of the electric company's retail customers in
35 Oregon for the calendar year 2030.

36 (b) For purposes of this subsection, forecast regulated emissions for an electric company
37 must be based on or contained in the following, as of January 1, 2022:

38 (A) The most recent integrated resource plan filed by the electric company and ac-
39 knowledged by order by the commission;

40 (B) Any updates to the integrated resource plan filed by the electric company with the
41 commission; or

42 (C) In the case of a multistate jurisdictional electric company, other information devel-
43 oped consistent with a methodology approved by the commission.

44 (2) In 2031 and in each following calendar year before 2051, the direct distribution to an
45 electric company under this section shall decline annually from the number of allowances

1 directly distributed to the electric company in 2030 by the constant amount necessary to
2 reduce the annual direct distributions such that the direct distribution in 2050 is a number
3 of allowances equal to 20 percent of the average of the annual emissions of the electric
4 company for the five most recent years prior to the effective date of this 2020 Act, as re-
5 ported under ORS 468A.280.

6 **SECTION 15. Direct distribution of allowances for certain electric system managers.** (1)
7 The Office of Greenhouse Gas Regulation shall allocate allowances for direct distribution at
8 no cost to covered entities that are electric system managers other than electric companies
9 as follows:

10 (a) The direct distribution to an electric system manager under this subsection in 2022
11 shall be a number of allowances equal to 100 percent of the anthropogenic greenhouse gas
12 emissions that are:

13 (A) The electric system manager's 2022 baseline emissions attributable to electricity
14 scheduled by the electric system manager for final delivery by consumer-owned utilities for
15 consumption in this state; and

16 (B) Not regulated emissions for which the office has retired allowances on behalf of the
17 electric system manager.

18 (b) In 2023 and in each following calendar year before 2051, the direct distribution re-
19 ceived by an electric system manager for emissions described in paragraph (a) of this sub-
20 section shall decline annually by a constant amount proportionate to the decline in the
21 number of allowances available in annual allowance budgets pursuant to section 5 (1)(b) of
22 this 2020 Act.

23 (c) Notwithstanding paragraph (b) of this subsection, the direct distribution to an electric
24 system manager in any year may not be a number of allowances that is less than 20 percent
25 of the number of allowances directly distributed to the electric system manager in 2022.

26 (2) Proceeds from the sale by a consumer-owned utility of allowances distributed at no
27 cost under this section must be used by the consumer-owned utility for the benefit of
28 ratepayers, in furtherance of the purposes set forth in section 2 of this 2020 Act and as
29 further required by the governing body of the consumer-owned utility.

30 (3) The governing body of a consumer-owned utility that receives or sells directly dis-
31 tributed allowances under this section shall, no later than September 15 of each even-
32 numbered year, submit a report to the Legislative Assembly on the use by the
33 consumer-owned utility of the directly distributed allowances. The report must include, but
34 not be limited to, a description of the uses by the consumer-owned utility of proceeds from
35 the sale of allowances distributed to the consumer-owned utility under this section.

36 **SECTION 16. 2022 emissions baseline for electric system managers.** In determining the
37 baseline of anthropogenic greenhouse gas emissions for 2022 for an electric system manager
38 as required by section 15 (1)(a)(A) of this 2020 Act, the Office of Greenhouse Gas Regulation
39 shall consider:

40 (1) Anthropogenic greenhouse gas emissions information available for the electric system
41 manager for representative years prior to 2022, as reported under ORS 468A.280;

42 (2) Hydroelectric power generation variability;

43 (3) Increases in load requirements anticipated to occur on or before January 1, 2025, due
44 to acquisitions of large industrial customers not previously served by the electric system
45 manager; and

1 (4) Any other indicators of changes in load requirements on or before January 1, 2025,
2 that are relevant to determining an electric system manager's 2022 baseline anthropogenic
3 greenhouse gas emissions.

4 **SECTION 17. Direct distribution of allowances for natural gas utilities.** (1) Subject to
5 subsections (2) and (3) of this section, the Office of Greenhouse Gas Regulation shall annually
6 allocate allowances for direct distribution at no cost to covered entities that are natural gas
7 utilities, such that the number of allowances directly distributed is equal to the total of:

8 (a) The regulated emissions attributable to the provision of natural gas service to the
9 low-income residential sales customers of the natural gas utility, as determined by the office
10 after consultation with the Public Utility Commission;

11 (b) 60 percent of the weather-normalized anthropogenic greenhouse gas emissions fore-
12 cast for 2022 to be regulated emissions attributable to natural gas use or combustion by the
13 natural gas sales customers of the natural gas utility that are not trade-exposed natural gas
14 users;

15 (c) 60 percent of the weather-normalized anthropogenic greenhouse gas emissions fore-
16 cast for 2022 to be regulated emissions attributable to natural gas use or combustion by the
17 natural gas transportation customers of the natural gas utility that are not trade-exposed
18 natural gas users; and

19 (d) The regulated emissions addressed by designation of a person as a covered entity
20 under section 5 (2)(b) or (c) of this 2020 Act attributable to natural gas use or combustion
21 by trade-exposed natural gas users that receive natural gas on the natural gas utility's dis-
22 tribution system, as determined by the office after consultation with the commission.

23 (2) In 2023 and in each following calendar year before 2051, the direct distributions re-
24 ceived by a natural gas utility under subsection (1) (b) and (c) of this section shall each de-
25 cline annually by a constant amount proportionate to the decline in the number of
26 allowances available in annual allowance budgets pursuant to section 5 (1)(b) of this 2020 Act.

27 (3) Allowances distributed under subsection (1)(a) of this section must be used by the
28 natural gas utility only to fulfill a compliance obligation, with the benefit of the use accruing
29 to the natural gas utility's low-income residential sales customers in a manner authorized
30 by the commission pursuant to section 55 of this 2020 Act.

31 (4) The office shall require a natural gas utility to consign all allowances directly dis-
32 tributed under subsection (1)(b) to (d) of this section to the office to be auctioned pursuant
33 to section 28 of this 2020 Act. Proceeds from the sale of allowances directly distributed under
34 subsection (1)(b) to (d) of this section may be used only in the manner authorized by the
35 commission under section 48 of this 2020 Act.

36 **SECTION 18. Designation of trade-exposed natural gas users.** (1) The Office of
37 Greenhouse Gas Regulation shall designate a person as a trade-exposed natural gas user if,
38 as of the operative date of this section and as may be verified by the office, the person re-
39 ceives natural gas through a natural gas utility's distribution system and uses the natural
40 gas to engage in one or more of the following trade-exposed processes, as identified by in-
41 dustry group and code in the 2017 North American Industry Classification System:

42 (a) Aerospace Product and Parts Manufacturing, code 3364.

43 (b) Bakeries and Tortilla Manufacturing, code 3118.

44 (c) Basic Chemical Manufacturing, code 3251.

45 (d) Cement and Concrete Product Manufacturing, code 3273.

- 1 (e) **Converted Paper Product Manufacturing, code 3222.**
- 2 (f) **Dairy Product Manufacturing, code 3115.**
- 3 (g) **Forest Nurseries and Gathering of Forest Products, code 1132.**
- 4 (h) **Foundries, code 3315.**

30 (2) **The Oregon Greenhouse Gas Reduction Board shall adopt by rule a procedure for**
31 **designating as a trade-exposed natural gas user a person not described in subsection (1) of**
32 **this section that faces a significant risk of leakage due to the indirect impacts of the Oregon**
33 **Greenhouse Gas Initiative on natural gas costs. Designation of a person as a trade-exposed**
34 **natural gas user under the procedure must be consistent with the purpose set forth in sec-**
35 **tion 2 (1)(a) of this 2020 Act.**

36 (3) **A person that is a fossil fuel distribution and storage facility or infrastructure or an**
37 **electric generating unit may not be designated as a trade-exposed natural gas user under**
38 **subsection (2) of this section.**

39 **SECTION 19. Designation of covered entities engaged in emissions-intensive, trade-**
40 **exposed processes as EITE entities.** (1) **The Office of Greenhouse Gas Regulation shall des-**
41 **ignate a covered entity as an EITE entity if the covered entity is a permitted air**
42 **contamination source and is primarily engaged, as of the operative date of this section and**
43 **as may be verified by the office, in the manufacture of goods through one or more of the**
44 **following emissions-intensive, trade-exposed processes, as identified by industry group and**
45 **code in the 2017 North American Industry Classification System:**

- 1 (a) Aerospace Product and Parts Manufacturing, code 3364.
- 2 (b) Basic Chemical Manufacturing, code 3251.
- 3 (c) Cement and Concrete Product Manufacturing, code 3273.
- 4 (d) Converted Paper Product Manufacturing, code 3222.
- 5 (e) Foundries, code 3315.
- 6 (f) Fruit and Vegetable Preserving and Specialty Food Manufacturing, code 3114.
- 7 (g) Glass and Glass Product Manufacturing, code 3272.

- 28 section through an emissions-intensive, trade-exposed process listed in subsection (1) of this
- 29 section; or
- 30 (B) Manufactures a good or goods through a process not listed in subsection (1) of this
- 31 section that the board, by rule, identifies as an emissions-intensive, trade-exposed process.
- 32 (b) Designation of a person as an EITE entity under the procedure adopted pursuant to
- 33 this subsection must be consistent with the purpose set forth in section 2 (1)(a) of this 2020
- 34 Act.
- 35 (3) Rules adopted under subsection (2) of this section may allow the office to assign a
- 36 good manufactured by a covered entity designated as an EITE entity pursuant to this section
- 37 a temporary benchmark, consistent with the processes for calculating benchmarks under
- 38 section 20 of this 2020 Act, and to adjust the temporary benchmark after the close of the
- 39 first compliance period for which the EITE entity must fulfill a compliance obligation.
- 40 (4) A covered entity that is a fossil fuel distribution and storage facility or infrastructure
- 41 or an electric generating unit may not be designated as an EITE entity under subsection (2)
- 42 of this section and may not receive allowances at no cost under section 20 of this 2020 Act.
- 43 **SECTION 20. Direct distribution of allowances for EITE entities.** (1) As used in this sec-
- 44 tion, 'annual benchmarked emissions calculation' means the product of an emissions effi-
- 45 ciency benchmark for a good or group of goods multiplied by the EITE entity's output,

1 during the calendar year for which allowances will be allocated for direct distribution at no
2 cost to the EITE entity, of the good or group of goods to which the emissions efficiency
3 benchmark applies.

4 (2) The annual allocation of allowances for direct distribution at no cost to an EITE en-
5 tity shall be a number of allowances equal to the sum total of the annual benchmarked
6 emissions calculations for the goods manufactured by the EITE entity.

7 (3) The Office of Greenhouse Gas Regulation shall establish, by order, the emissions ef-
8 ficiency benchmarks for goods manufactured in this state by EITE entities.

9 (4) In establishing the emissions efficiency benchmarks, the office may:

10 (a) Establish an emissions efficiency benchmark separately for each individual good
11 manufactured in this state by an EITE entity; or

12 (b) Establish a single emissions efficiency benchmark for a group of goods manufactured
13 in this state by an EITE entity, if the office determines that the anthropogenic greenhouse
14 gas emissions attributable to the manufacture of each of the goods in the group:

15 (A) Are not materially different in quantity; or

16 (B) Cannot be distinguished as emissions attributable to any one of the goods in the
17 group.

18 (5)(a) The office shall establish emissions efficiency benchmarks based on recent years'
19 efficiency as provided in this subsection. An emissions efficiency benchmark established
20 based on recent years' efficiency shall be applicable for the period beginning January 1, 2022,
21 and ending December 31, 2025. To determine each emissions efficiency benchmark, the office
22 shall:

23 (A) Calculate the three-year average of the total, expressed in metric tons of carbon
24 dioxide equivalent, of the anthropogenic greenhouse gas emissions attributable to the man-
25 ufacture of the good or group of goods for which the EITE entity would have been the reg-
26 ulated covered entity if the Oregon Greenhouse Gas Initiative had been in effect during the
27 time that the anthropogenic greenhouse gas emissions occurred; and

28 (B) Divide the number calculated under subparagraph (A) of this paragraph by the
29 three-year average of the total annual output of the good or group of goods in this state by
30 the EITE entity.

31 (b) In conducting the calculation required by paragraph (a) of this subsection, the office:

32 (A) Shall use anthropogenic greenhouse gas emissions information and output data from
33 the three most recent years prior to 2022 for which anthropogenic greenhouse gas emissions
34 information is available and verified by the office; and

35 (B) Except as provided in subsection (6) of this section, shall exclude from the data de-
36 scribed in subparagraph (A) of this paragraph the anthropogenic greenhouse gas emissions
37 attributable to combustion by an EITE entity described in section 24 of this 2020 Act of na-
38 tural gas purchased as described in section 24 (1) of this 2020 Act.

39 (6) At the request of an EITE entity described in section 24 of this 2020 Act, the office
40 shall include in the calculation required by subsection (5)(a) of this section the emissions
41 described in subsection (5)(b)(B) of this section. An EITE entity described in section 24 of
42 this 2020 Act that requests inclusion of the emissions described in subsection (5)(b)(B) of this
43 section in the calculation required by subsection (5)(a) of this section is exempt from the
44 requirements of section 24 of this 2020 Act and may not be allocated allowances for direct
45 distribution at no cost under section 24 of this 2020 Act.

1 (7) An EITE entity may file with the office a written request for a contested case hearing
2 to challenge an order establishing the emissions efficiency benchmarks for goods produced
3 by the EITE entity. The request shall be filed within 30 days after the date the order was
4 entered. If an EITE entity requests a hearing, the hearing shall be conducted in accordance
5 with the provisions applicable to contested case proceedings under ORS chapter 183.

6 (8) In order to implement this section, the Oregon Greenhouse Gas Reduction Board shall
7 adopt by rule:

8 (a) A means for attributing an EITE entity's anthropogenic greenhouse gas emissions to
9 the manufacture of individual goods or groups of goods;

10 (b) Requirements for EITE entities to provide any pertinent records necessary for the
11 office to verify output data; and

12 (c) A process for adjusting an allocation of allowances for direct distribution at no cost,
13 if necessary, to reconcile for output variability or type of good.

14 (9) The board shall adopt by rule a process for EITE entities to apply to the office for
15 an adjustment to the allocation of allowances for direct distribution at no cost that the EITE
16 entity may receive. The office may grant an adjustment under this subsection only for a
17 significant unanticipated change in the anthropogenic greenhouse gas emissions attributable
18 to the manufacture of a good or group of goods in this state by the EITE entity, based on a
19 finding by the office that the adjustment is necessary to accommodate changes to the man-
20 ufacturing process that have a material impact on anthropogenic greenhouse gas emissions.
21 Rules adopted under this subsection may provide for the office to contract with an external
22 third-party expert to assist the office in making individual determinations on applications for
23 adjustments.

24 **SECTION 21. Operation of emissions efficiency benchmarks based on best available**
25 **technology.** (1) The amendments to section 20 of this 2020 Act by section 22 of this 2020 Act
26 become operative on January 1, 2026.

27 (2)(a) Subject to paragraph (b) of this subsection, the Office of Greenhouse Gas Regu-
28 lation shall first establish, by order, emissions efficiency benchmarks based on best available
29 technology for EITE entities under the amendments to section 20 of this 2020 Act by section
30 22 of this 2020 Act no later than January 1, 2025.

31 (b) The office shall first establish emissions efficiency benchmarks based on best avail-
32 able technology on a date prior to January 1, 2025, as mutually agreed upon by the office and
33 an EITE entity, if the office receives a written request from the EITE entity that an early
34 determination of best available technology is necessary to inform any significant new in-
35 vestments in technology by the EITE entity.

36 (c) An order issued under this subsection may not become effective prior to January 1,
37 2026.

38 (3) The Oregon Greenhouse Gas Reduction Board may adopt or amend rules and the of-
39 fice may issue orders or take any actions before the operative date specified in subsection
40 (1) of this section that are necessary to enable the board or the office, on and after the op-
41 erative date specified in subsection (1) of this section, to carry out subsection (2) of this
42 section and the amendments to section 20 by section 22 of this 2020 Act.

43 **SECTION 22.** Section 20 of this 2020 Act is amended to read:

44 **Sec. 20.** (1) As used in this section[,]:

45 (a) "Annual benchmarked emissions calculation" means the product of an emissions efficiency

1 benchmark for a good or group of goods multiplied by the EITE entity's output, during the calendar
2 year for which allowances will be allocated for direct distribution at no cost to the EITE entity, of
3 the good or group of goods to which the emissions efficiency benchmark applies.

4 **(b) "Best available technology" means the fuels, processes, equipment and technology**
5 **that will most effectively reduce the regulated emissions:**

6 **(A) For which an EITE entity must meet a compliance obligation; and**

7 **(B) That are associated with the manufacture by an EITE entity of a good, without**
8 **changing the characteristics of the good being manufactured, that is technically feasible,**
9 **commercially available, economically viable and compliant with all applicable laws.**

10 (2) The annual allocation of allowances for direct distribution at no cost to an EITE entity shall
11 be a number of allowances equal to the sum total of the annual benchmarked emissions calculations
12 for the goods manufactured by the EITE entity.

13 (3) The Office of Greenhouse Gas Regulation shall establish, by order, the emissions efficiency
14 benchmarks for goods manufactured in this state by EITE entities.

15 (4) In establishing the emissions efficiency benchmarks, the office may:

16 (a) Establish an emissions efficiency benchmark separately for each individual good manufac-
17 tured in this state by an EITE entity; or

18 (b) Establish a single emissions efficiency benchmark for a group of goods manufactured in this
19 state by an EITE entity, if the office determines that the anthropogenic greenhouse gas emissions
20 attributable to the manufacture of each of the goods in the group:

21 (A) Are not materially different in quantity; or

22 (B) Cannot be distinguished as emissions attributable to any one of the goods in the group.

23 *[(5)(a) The office shall establish emissions efficiency benchmarks based on recent years' efficiency*
24 *as provided in this subsection. An emissions efficiency benchmark established based on recent years'*
25 *efficiency shall be applicable for the period beginning January 1, 2022, and ending December 31, 2025.*
26 *To determine each emissions efficiency benchmark, the office shall:]*

27 *[(A) Calculate the three-year average of the total, expressed in metric tons of carbon dioxide*
28 *equivalent, of the anthropogenic greenhouse gas emissions attributable to the manufacture of the good*
29 *or group of goods for which the EITE entity would have been the regulated covered entity if the Oregon*
30 *Greenhouse Gas Initiative had been in effect during the time that the anthropogenic greenhouse gas*
31 *emissions occurred; and]*

32 *[(B) Divide the number calculated under subparagraph (A) of this paragraph by the three-year*
33 *average of the total annual output of the good or group of goods in this state by the EITE entity.]*

34 *[(b) In conducting the calculation required by paragraph (a) of this subsection, the office:]*

35 *[(A) Shall use anthropogenic greenhouse gas emissions information and output data from the three*
36 *most recent years prior to 2022 for which anthropogenic greenhouse gas emissions information is*
37 *available and verified by the office; and]*

38 *[(B) Except as provided in subsection (6) of this section, shall exclude from the data described in*
39 *subparagraph (A) of this paragraph the anthropogenic greenhouse gas emissions attributable to com-*
40 *bustion by an EITE entity described in section 24 of this 2020 Act of natural gas purchased as de-*
41 *scribed in section 24 (1) of this 2020 Act.]*

42 *[(6) At the request of an EITE entity described in section 24 of this 2020 Act, the office shall in-*
43 *clude in the calculation required by subsection (5)(a) of this section the emissions described in sub-*
44 *section (5)(b)(B) of this section. An EITE entity described in section 24 of this 2020 Act that requests*
45 *inclusion of the emissions described in subsection (5)(b)(B) of this section in the calculation required*

1 *by subsection (5)(a) of this section is exempt from the requirements of section 24 of this 2020 Act and*
2 *may not be allocated allowances for direct distribution at no cost under section 24 of this 2020 Act.]*

3 **(5)(a) The office shall establish emissions efficiency benchmarks based on best available**
4 **technology as provided in this subsection. The office shall update each emissions efficiency**
5 **benchmark once every nine years. Each emissions efficiency benchmark must represent the**
6 **anthropogenic greenhouse gas emissions that would be the resulting regulated emissions at-**
7 **tributable to an EITE entity for the manufacture of a good or group of goods in this state,**
8 **if the EITE entity were to use the best available technology, as of the date that the emis-**
9 **sions efficiency benchmark was last updated, that materially contributes to the regulated**
10 **emissions of the EITE entity.**

11 **(b) In determining an emissions efficiency benchmark, the office shall:**

12 **(A) Consider any anthropogenic greenhouse gas emissions intensity audit reports specific**
13 **to the EITE entity submitted under paragraph (c) of this subsection;**

14 **(B) Consider the technical feasibility, commercial availability and economic viability of**
15 **options to reduce anthropogenic greenhouse gas emissions;**

16 **(C) Consider the fuels, processes, equipment and technology used by facilities in this**
17 **state or in other jurisdictions to produce goods of comparable type, quantity and quality;**

18 **(D) Consider barriers that would prevent adoption of best available technology by the**
19 **EITE entity; and**

20 **(E) Exclude from any calculation the anthropogenic greenhouse gas emissions attribut-**
21 **able to natural gas combustion by an EITE entity described in section 24 of this 2020 Act.**

22 **(c) An EITE entity may submit to the office, for consideration in adopting emissions ef-**
23 **iciency benchmarks, an anthropogenic greenhouse gas emissions intensity audit report**
24 **produced by a qualified, independent third-party organization. The audit report must:**

25 **(A) Include an analysis of the current fuels, processes, equipment and technology that**
26 **materially contribute to the regulated emissions of the EITE entity attributable to the**
27 **manufacture of each good or group of goods by the EITE entity and the resulting emissions**
28 **intensity per unit of output for each good or group of goods.**

29 **(B) Include an analysis of the best available technology to produce the goods manufac-**
30 **tured by the EITE entity and the resulting anthropogenic greenhouse gas emissions intensity**
31 **per unit of output for each good or group of goods if best available technology were used by**
32 **the EITE entity. The analysis required by this subparagraph must, to the greatest extent**
33 **practicable, consider the factors described in paragraph (b)(C) and (D) of this subsection.**

34 **(C) Based on the analyses required under subparagraphs (A) and (B) of this paragraph,**
35 **provide an estimate of the anthropogenic greenhouse gas emissions intensity per unit of**
36 **output to produce the same goods or groups of goods at the same facility if the facility used**
37 **the best available technology.**

38 **(6) At the request of an EITE entity described in section 24 of this 2020 Act, the office**
39 **shall include in the determination of an emissions efficiency benchmark the emissions de-**
40 **scribed in subsection (5)(b)(E) of this section. An EITE entity described in section 24 of this**
41 **2020 Act that requests inclusion of the emissions described in subsection (5)(b)(E) of this**
42 **section in the determination of an emissions efficiency benchmark is exempt from the re-**
43 **quirements of section 24 of this 2020 Act and may not be allocated allowances for direct**
44 **distribution at no cost under section 24 of this 2020 Act.**

45 **(7) An EITE entity may file with the office a written request for a contested case hearing to**

1 challenge an order establishing the emissions efficiency benchmarks for goods produced by the EITE
2 entity. The request shall be filed within 30 days after the date the order was entered. If an EITE
3 entity requests a hearing, the hearing shall be conducted in accordance with the provisions appli-
4 cable to contested case proceedings under ORS chapter 183.

5 (8) In order to implement this section, the Oregon Greenhouse Gas Reduction Board shall adopt
6 by rule:

7 (a) A means for attributing an EITE entity's anthropogenic greenhouse gas emissions to the
8 manufacture of individual goods or groups of goods;

9 (b) Requirements for EITE entities to provide any pertinent records necessary for the office to
10 verify output data; and

11 (c) A process for adjusting an allocation of allowances for direct distribution at no cost, if nec-
12 essary, to reconcile for output variability or type of good.

13 (9) The board shall adopt by rule a process for EITE entities to apply to the office for an ad-
14 justment to the allocation of allowances for direct distribution at no cost that the EITE entity may
15 receive. The office may grant an adjustment under this subsection only for a significant unantic-
16 ipated change in the anthropogenic greenhouse gas emissions attributable to the manufacture of a
17 good or group of goods in this state by the EITE entity, based on a finding by the office that the
18 adjustment is necessary to accommodate changes to the manufacturing process that have a material
19 impact on anthropogenic greenhouse gas emissions. Rules adopted under this subsection may pro-
20 vide for the office to contract with an external third-party expert to assist the office in making in-
21 dividual determinations on applications for adjustments.

22 **SECTION 23. Benchmark report. No later than September 15, 2030, the Office of**
23 **Greenhouse Gas Regulation shall provide a report to the Legislative Assembly, in the manner**
24 **provided in ORS 192.245, on the emissions efficiency benchmarks established pursuant to**
25 **section 20 of this 2020 Act. The report may include recommendations for legislation. The**
26 **report shall assess:**

27 (1) **The anthropogenic greenhouse gas emissions intensity and trade exposure of covered**
28 **entities that have been designated as EITE entities pursuant to section 19 of this 2020 Act;**

29 (2) **The anthropogenic greenhouse gas emissions reduction opportunities available to the**
30 **covered entities described in subsection (1) of this section; and**

31 (3) **Whether the conclusions of the assessments required under subsections (1) and (2)**
32 **of this section warrant an adjustment to the methods of calculating the emissions efficiency**
33 **benchmarks established pursuant to section 20 of this 2020 Act.**

34 **SECTION 24. (1) If an EITE entity purchases natural gas from a person that is not a**
35 **covered entity described in section 5 (2)(b) or (c) of this 2020 Act, in addition to the annual**
36 **allocation of allowances received under section 20 of this 2020 Act, the Office of Greenhouse**
37 **Gas Regulation shall annually allocate for direct distribution at no cost to the EITE entity**
38 **a number of allowances as follows:**

39 (a) **In 2022 and each following calendar year before 2025, the direct distribution received**
40 **by the EITE entity shall be a number of allowances equal to the total of the regulated**
41 **emissions by the EITE entity attributable to the combustion of natural gas purchased as**
42 **described in this subsection.**

43 (b)(A) **In 2025 and each following calendar year before 2051, and except as provided in**
44 **subparagraph (B) of this paragraph, the direct distribution received by the EITE entity shall**
45 **decline annually by a constant amount proportionate to the decline in the number of allow-**

1 ances available in annual allowance budgets pursuant to section 5 (1)(b) of this 2020 Act.

2 (B) If the EITE entity is in compliance with an approved energy management system
3 audit and implementation plan subject to subsection (2) of this section, the direct distribution
4 received by the EITE entity during the following years shall be as follows:

5 (i) In 2025 and each year before 2030, the direct distribution shall be a number of allow-
6 ances equal to the total of the regulated emissions by the EITE entity attributable to the
7 combustion of natural gas purchased as described in this subsection; and

8 (ii) In 2030 and each year before 2051, the direct distribution shall be a number of allow-
9 ances equal to 97 percent of the total of the regulated emissions by the EITE entity attrib-
10 utable to the combustion of natural gas purchased as described in this subsection.

11 (2)(a) An EITE entity described in subsection (1) of this section may, no later than De-
12 cember 31, 2024, and once every five years thereafter, submit to the office a completed en-
13 ergy management system audit and implementation plan for approval.

14 (b) The office shall approve an energy management system audit and implementation
15 plan if:

16 (A) The audit meets the requirements of section 50 (4) of this 2020 Act; and

17 (B) The implementation plan identifies how the EITE entity will complete all efficiency
18 improvements identified in the audit report that are related to natural gas use and that have
19 a payback period of five years or less by:

20 (i) Two years after the date of the audit; or

21 (ii) A reasonable extension date not to exceed four years after the date of the audit, if
22 the office determines that additional time is reasonable and necessary for the EITE entity
23 to complete the efficiency improvements.

24 (c) In determining the payback period for an efficiency improvement identified in an audit
25 report, the office shall consider any grants or loans for completing the efficiency improve-
26 ment received by the EITE entity from the Traded Sector Greenhouse Gas Reduction Re-
27 volving Loan Fund established under section 51 of this 2020 Act.

28 (d) An approved energy management system audit and implementation plan shall be valid
29 for five years.

30 (3) The office may contract with an independent third party entity to review and approve
31 energy management system audits and implementation plans under this section.

32 (4) The Oregon Greenhouse Gas Reduction Board shall adopt rules necessary to imple-
33 ment this section, including but not limited to a process for an EITE entity to appeal the
34 approval or disapproval of an energy management system audit or implementation plan.

35 **SECTION 25. Offsets generally; rules. (1) Offset projects:**

36 (a) Must be located in the United States;

37 (b) May not be otherwise required by law; and

38 (c) Must result in greenhouse gas emissions reductions or removals that:

39 (A) Are real, permanent, quantifiable, verifiable and enforceable; and

40 (B) Are in addition to greenhouse gas emissions reductions or removals otherwise re-
41 quired by law or legally enforceable mandate and that exceed any other greenhouse gas
42 emissions reductions or removals that would otherwise occur in a conservative business-as-
43 usual scenario.

44 (2)(a) A total of no more than eight percent of a covered entity's compliance obligation
45 may be fulfilled by surrendering offset credits. A total of no more than four percent of a

1 covered entity's compliance obligation may be fulfilled by surrendering offset credits gener-
2 ated by offset projects that do not provide direct environmental benefits in this state.

3 (b) The Oregon Greenhouse Gas Reduction Board may by rule adopt additional re-
4 strictions on the number of offset credits that may be surrendered by a covered entity that
5 is a permitted air contamination source and that is geographically located in an impacted
6 community if:

7 (A) The geographic area within which the permitted air contamination source is located
8 is also a nonattainment area and the permitted air contamination source substantially con-
9 tributes to or causes the nonattainment of air quality standards; or

10 (B) The permitted air contamination source is in violation of the terms or conditions of
11 any permit required or authorized under ORS 468.065 or ORS chapter 468A and issued by the
12 Department of Environmental Quality or a regional air quality control authority formed un-
13 der ORS 468A.105.

14 (3) The board shall adopt rules governing offset projects and the generation, issuance and
15 use of offset credits. The rules must:

16 (a) Take into consideration standards, rules or protocols for:

17 (A) Offset projects and the generation, issuance and use of offset credits established by
18 other states, provinces and countries with programs comparable to the Oregon Greenhouse
19 Gas Initiative; and

20 (B) Voluntary offset projects and the generation, issuance and use of offset credits es-
21 tablished by organizations that operate offset credit registries;

22 (b) Allow for the broadest possible participation by landowners in developing and operat-
23 ing offset projects across the broadest possible variety of types and sizes of lands;

24 (c) Encourage opportunities for developing offset projects that provide direct environ-
25 mental benefits in this state;

26 (d) Encourage offset projects that benefit impacted communities, members of eligible
27 Indian tribes and natural and working lands; and

28 (e) Address qualifications for persons and agencies that provide third-party verification
29 and registration of offset projects and offset credits.

30 (4) The board shall adopt by rule a process for the Office of Greenhouse Gas Regulation
31 to issue early action offset credits for greenhouse gas emissions reductions or removals that
32 occur during the period beginning on January 1, 2020, and ending on January 1, 2022. Rules
33 adopted under this subsection may include:

34 (a) Designation of offset protocols under which an offset project may qualify for early
35 action offset credits;

36 (b) Requirements for offset projects to be registered with qualified third-party organiza-
37 tions that operate offset credit registries to receive early action offset credits; and

38 (c) Requirements for offset credits issued by qualified third-party organizations that op-
39 erate offset credit registries to be converted to offset credits issued through or acceptable
40 under the Oregon Greenhouse Gas Initiative.

41 (5) The board shall adopt by rule a process to investigate and invalidate issued offset
42 credits as necessary to uphold the environmental integrity of the Oregon Greenhouse Gas
43 Initiative. Reasons for invalidating issued offset credits may include, but are not limited to:

44 (a) A misstatement, of more than five percent, of the amount of greenhouse gas emis-
45 sions reductions or removals attributable to an offset project for which offset credits were

1 issued;

2 (b) An environmental, health or safety violation by an offset project for which offset
3 credits were issued; or

4 (c) A determination that offset credits are duplicative of other offset credits issued for
5 the same greenhouse gas emissions reductions or removals by another offset credit issuing
6 body and that the invalidation is necessary to remedy the duplication.

7 (6) The board shall establish by rule one or more offset integrity accounts. The office
8 shall withhold a percentage of the offset credits issued by the office for each offset project
9 and deposit the withheld offset credits in an offset integrity account. Uses of offset credits
10 deposited in offset integrity accounts may include, but need not be limited to, using the off-
11 set credits to replace offset credits that are invalidated pursuant to rules adopted under
12 subsection (5) of this section.

13 **SECTION 26. Offset protocols.** (1) Offset protocols, and any greenhouse gas emissions
14 inventory and monitoring requirements related to the offset protocols, developed pursuant
15 to rules adopted under section 25 of this 2020 Act:

16 (a) Must be straightforward to implement and administer, for both offset project opera-
17 tors and persons purchasing offset credits;

18 (b) Must provide flexibility for landowners in the development and operation of offset
19 projects;

20 (c) Must establish, for each offset protocol, a predetermined crediting period for which
21 an offset project will remain eligible to receive offset credits for greenhouse gas emissions
22 reductions or removals; and

23 (d) May make use of aggregation or other mechanisms, including cost-effective inventory
24 and monitoring provisions, to increase the development of offset projects by landowners
25 across the broadest possible variety of types and sizes of lands.

26 (2)(a) The Oregon Greenhouse Gas Reduction Board and the Office of Greenhouse Gas
27 Regulation shall collaborate and consult with the State Forestry Department in developing
28 and monitoring offset protocols related to forestry. Offset protocols related to forestry that
29 are developed pursuant to this subsection:

30 (A) Must prioritize reforestation, avoided forest conversion and improved forest man-
31 agement.

32 (B) Must, to the extent practicable, prioritize low-carbon-impact building materials and
33 urban forestry.

34 (C) Must have the ability to be administered consistently with the applicable state and
35 local land use laws of Oregon.

36 (D) May account for differences in forest management practices between private owners
37 of forestland and state or other owners of nonfederal forestlands in establishing the baselines
38 for the generation of offset credits by offset projects on the private, state or other nonfed-
39 eral forestlands.

40 (E) May not authorize the generation or issuance of offset credits for greenhouse gas
41 emissions reductions or removals that occur during the period beginning on January 1, 2022,
42 and ending on December 31, 2030, as the result of offset projects on state forestlands, unless
43 as of the effective date of this 2020 Act the state forestlands are:

44 (i) Trust lands as defined in ORS 273.462;

45 (ii) Lands in the Elliott State Forest as described in ORS 530.450;

1 (iii) Common School Forest Lands as described in ORS 530.460; or

2 (iv) Any other lands placed under the jurisdiction of the State Land Board consistent
3 with Article VIII, section 5, Oregon Constitution.

4 (b) In developing offset protocols related to forestry, the Oregon Greenhouse Gas Re-
5 duction Board, the office and the department shall include a method by which, upon an af-
6 firmative recommendation under section 27 (2)(c) of this 2020 Act, offset protocols for offset
7 projects are adjusted to avoid permanent or temporary net cumulative reductions, attribut-
8 able to offset projects, in the regional supply of wood fiber harvested from nonfederal
9 forestlands in Oregon that is available to wood products manufacturing facilities in this
10 state. This paragraph does not apply to offset projects located on Indian trust lands or Indian
11 fee lands.

12 (c) The board and the department shall jointly convene a technical advisory committee
13 to advise the board, the office and the department in developing and monitoring offset pro-
14 tocols related to forestry. The technical advisory committee must include members with
15 expertise in offset protocols related to forestry.

16 (3) The board and the office shall collaborate and consult with all relevant state agencies,
17 including but not limited to the State Department of Agriculture and the Oregon Watershed
18 Enhancement Board, in developing and monitoring offset protocols related to agriculture and
19 conservation on natural and working lands. In developing offset protocols pursuant to this
20 subsection, the Oregon Greenhouse Gas Reduction Board shall:

21 (a) Consider developing offset protocols for:

22 (A) Manure management that reduces methane emissions from agricultural operations;

23 (B) Avoided grassland conversion; and

24 (C) Other categories of offset projects that would otherwise result in the reduction of
25 greenhouse gas emissions related to agricultural operations; and

26 (b) Ensure that the offset protocols have the ability to be administered consistently with
27 the applicable state and local land use laws of Oregon.

28 (4) In developing any offset protocol related to a matter not addressed by subsections (2)
29 and (3) of this section, the board shall convene a technical advisory committee composed of
30 persons with expertise relevant to the development of the offset protocol.

31 (5) The office shall regularly review and recommend to the board updates to offset pro-
32 tocols developed pursuant to rules adopted under section 25 of this 2020 Act. The reviews and
33 updates of offset protocols shall include any updates, as necessary, to the methods or tech-
34 nologies used for measuring and monitoring the greenhouse gas emissions reductions or re-
35 movals attributable to the offset projects addressed by the offset protocols.

36 (6) Offset protocols shall be developed and updated by the board pursuant to the
37 rulemaking provisions of ORS chapter 183.

38 **SECTION 27. Offset protocol consultation and reporting.** (1) In developing and updating
39 rules and offset protocols pursuant to sections 25 and 26 of this 2020 Act, the Oregon
40 Greenhouse Gas Reduction Board:

41 (a) Shall consult with and consider the recommendations of:

42 (A) The State Department of Agriculture, the State Forestry Department, the Environ-
43 mental Justice Task Force, the Oregon Watershed Enhancement Board, other relevant state
44 agencies and eligible Indian tribes; and

45 (B) Persons and agencies that provide third-party verification and registration of offset

1 projects and offset credits; and

2 (b) May contract with one or more persons or agencies that provide third-party verifi-
3 cation and registration of offset projects and offset credits to assist in the development of
4 offset protocols.

5 (2)(a) No later than September 15 of each year, the State Forestry Department, in col-
6 laboration with the Office of Greenhouse Gas Regulation, shall submit a report to the Leg-
7 islative Assembly that provides an analysis of the implementation in Oregon of offset
8 protocols related to forestry. The report shall:

9 (A) Describe the location and scope of offset projects in Oregon registered under offset
10 protocols related to forestry developed pursuant to sections 25 and 26 of this 2020 Act for
11 which offset credits have been issued under the Oregon Greenhouse Gas Initiative, to date,
12 and the number of offset credits issued;

13 (B) Describe forestry carbon offsets marketed, registered, transferred or sold, to date,
14 by the State Forester under ORS 526.725, 530.050 and 530.500;

15 (C) Include information and analysis of any cobenefits attributable to the forestry offset
16 projects and forestry carbon offsets described under subparagraphs (A) and (B) of this par-
17 agraph; and

18 (D) Identify and address any significant effects attributable to the forestry offset projects
19 and forestry carbon offsets described in subparagraphs (A) and (B) of this paragraph on the
20 supply of wood fiber available from nonfederal forestlands to wood products manufacturing
21 facilities in this state.

22 (b) The information and analysis required under paragraph (a)(D) of this subsection shall
23 include and consider significant effects attributable to the forestry offset projects and
24 forestry carbon offsets on the supply of wood fiber that are applicable to specific geographic
25 areas of this state, relative to the changes in demand for wood fiber by wood products
26 manufacturing facilities located in those specific geographic areas.

27 (c) The report required by this subsection may include recommendations by the State
28 Forestry Department on whether a temporary suspension of acceptance of new offset project
29 applications under offset protocols related to forestry developed pursuant to sections 25 and
30 26 of this 2020 Act, or a temporary adjustment of the offset protocols, is necessary. The
31 purpose of a temporary suspension or adjustment must be to address any negative effects
32 attributable to forestry offset projects on the supply of wood fiber harvested from nonfederal
33 forestlands that is available to wood products manufacturing facilities in one or more specific
34 geographic areas of this state, relative to the changes in demand for wood fiber in the spe-
35 cific geographic areas. If the department recommends a temporary suspension or adjust-
36 ment, the recommendation must also include recommendations for measures to minimize
37 adverse effects on landowners developing offset projects.

38 **SECTION 28. Auctions.** (1) Except as provided in subsection (8) of this section, auctions
39 of allowances are open to registered entities.

40 (2) The Office of Greenhouse Gas Regulation shall hold auctions at least annually.

41 (3) The office may engage:

42 (a) A qualified, independent auction administrator to administer auctions; or

43 (b) A qualified financial services administrator to conduct financial transactions related
44 to the auction.

45 (4) The office shall issue notice for an upcoming auction prior to the auction.

1 (5) The office shall:

2 (a) Set an auction floor price for 2022 and a schedule for the floor price to increase by a
3 fixed percentage over inflation each calendar year.

4 (b) Set an allowance price containment reserve floor price for 2022 and a schedule for the
5 allowance price containment reserve floor price to increase by a fixed percentage over in-
6 flation each calendar year.

7 (c) Set a hard price ceiling for 2022 and a schedule for the hard price ceiling to increase
8 by a fixed percentage over inflation each calendar year.

9 (d) Take actions to minimize the potential for market manipulation and to guard against
10 bidder collusion, including but not limited to specifying as holding limits the maximum
11 number of allowances that may be held by a registered entity at any time.

12 (6) In setting the auction floor price, allowance price containment reserve floor price and
13 hard price ceiling, the office shall consider prevailing prices for carbon in other jurisdictions.

14 (7) The proceeds of an auction shall be paid to the office and deposited with the State
15 Treasurer to be credited as follows:

16 (a) Auction proceeds from the sale of allowances consigned to the office for auction by
17 a natural gas utility pursuant to section 17 of this 2020 Act shall be credited to the appro-
18 priate trust account established by the Public Utility Commission pursuant to section 48 of
19 this 2020 Act; and

20 (b) Auction proceeds payable to the state shall be credited to the Auction Proceeds Dis-
21 tribution Fund established under section 29 of this 2020 Act.

22 (8) Sales of allowances from the allowance price containment reserve shall be conducted
23 separately from the auction of other allowances for the purpose of addressing high costs of
24 compliance instruments. Allowances unsold from the reserve sale must be made available
25 again at future reserve sales. General market participants may not purchase allowances at
26 reserve sales. The proceeds from any sale of allowances pursuant to this subsection shall be
27 credited to the Auction Proceeds Distribution Fund established under section 29 of this 2020
28 Act.

29 (9)(a) If the hard price ceiling for an auction is reached, the office shall offer for sale,
30 at the hard price ceiling, allowances from any reserve described in or established by rule
31 under section 7 of this 2020 Act, as necessary to meet demand from covered entities. If the
32 supplies of all allowances from all reserves are exhausted and additional sales of allowances
33 are necessary for one or more covered entities to fulfill a compliance obligation, the office
34 may sell, at the hard price ceiling, price ceiling allowances in addition to the allowances
35 available in the annual allowance budget.

36 (b) The proceeds from any sales of allowances at the hard price ceiling shall be paid to
37 the office and deposited with the State Treasurer to be credited as follows:

38 (A) All moneys that constitute revenues described in Article IX, section 3a, of the Oregon
39 Constitution, shall be credited to the Transportation Decarbonization Investments Account
40 established in section 34 of this 2020 Act;

41 (B) All moneys that constitute revenues described in Article VIII, section 2 (1)(g), of the
42 Oregon Constitution, shall be credited to the Common School Fund; and

43 (C) Moneys remaining after meeting the requirements of subparagraphs (A) and (B) of
44 this paragraph shall be credited to the Oregon Greenhouse Gas Initiative Operating Fund
45 established under section 31 of this 2020 Act, to be used only as described in section 31 (4)

1 of this 2020 Act.

2 (10) The Oregon Greenhouse Gas Reduction Board:

3 (a) Shall adopt rules for making an unlimited number of allowances available for auction
4 upon exceedance of the hard price ceiling set by the office under subsection (5) of this sec-
5 tion; and

6 (b) May adopt rules as necessary to administer auctions.

7 **SECTION 29. Auction Proceeds Distribution Fund.** (1) The Auction Proceeds Distribution
8 Fund is established in the State Treasury, separate and distinct from the General Fund.
9 Moneys in the Auction Proceeds Distribution Fund is continuously appropriated to the Office
10 of Greenhouse Gas Regulation for distribution as required by this section.

11 (2) The fund shall consist of moneys credited to the fund under section 28 of this 2020
12 Act. Interest earned by the fund shall be credited to the fund.

13 (3) The office shall certify the amount of moneys deposited in the fund available for dis-
14 tribution and shall cause the moneys to be distributed as follows:

15 (a) All moneys that constitute revenues described in Article IX, section 3a, of the Oregon
16 Constitution, shall be transferred to the Transportation Decarbonization Investments Ac-
17 count established in section 34 of this 2020 Act;

18 (b) All moneys that constitute revenues described in Article VIII, section 2 (1)(g), of the
19 Oregon Constitution, shall be transferred to the Common School Fund;

20 (c) An amount necessary for administration, other than administration paid for by mon-
21 eys described in paragraphs (a) and (b) of this subsection, of sections 2, 4 to 32, 38 to 40, 41,
22 42, 43 and 45 to 53 of this 2020 Act and rules adopted pursuant to sections 2, 4 to 32, 38 to
23 40, 41, 42, 43 and 45 to 53 of this 2020 Act shall be transferred to the Oregon Greenhouse Gas
24 Initiative Operating Fund established under section 31 of this 2020 Act; and

25 (d) Moneys remaining after the transfers under paragraphs (a) to (c) of this subsection
26 shall be transferred to the Climate Investments Fund established under section 39 of this
27 2020 Act.

28 **SECTION 30. Progress report.** (1) The Office of Greenhouse Gas Regulation shall, no later
29 than one year after the close of each compliance period, submit a report in the manner
30 provided by ORS 192.245 to the Legislative Assembly. The report shall:

31 (a) Detail activity during the most-recently closed compliance period under the Oregon
32 Greenhouse Gas Initiative;

33 (b) Include, but need not be limited to, aggregated information on the following for the
34 compliance period:

35 (A) The number of allowances bought and sold at each auction held and all auction prices,
36 including the floor and ceiling prices, for the allowances bought and sold at each auction;

37 (B) The beginning and ending balances of all auction holding accounts and reserves held
38 by the office; and

39 (C) The anthropogenic greenhouse gas emissions reductions achieved during the compli-
40 ance period;

41 (c) Estimate the impacts of the Oregon Greenhouse Gas Initiative on fuel prices and on
42 electricity and natural gas bills in Oregon;

43 (d) Analyze the state's progress in reducing anthropogenic greenhouse gas emissions
44 consistent with ORS 468A.205 and examine trends in anthropogenic greenhouse gas emissions
45 by sector; and

1 (e) Evaluate the public health and other cobenefits of greenhouse gas emissions re-
2 ductions, with a particular emphasis on the cobenefits for impacted communities.

3 (2) In addition to the information required by subsection (1) of this section, every second
4 report required by this section shall evaluate the efficacy of the Oregon Greenhouse Gas
5 Initiative and investments of the proceeds from auctions under section 28 of this 2020 Act
6 in carrying out the purposes set forth in section 2 of this 2020 Act.

7 **SECTION 31. Operating fund.** (1) The Oregon Greenhouse Gas Initiative Operating Fund
8 is established in the State Treasury, separate and distinct from the General Fund. Interest
9 earned by the Oregon Greenhouse Gas Initiative Operating Fund shall be credited to the
10 fund. Moneys in the fund are continuously appropriated to the Department of Environmental
11 Quality for use by the Office of Greenhouse Gas Regulation:

12 (a) In the performance of the duties, functions and powers vested in the office by law;
13 and

14 (b) To provide, at the request of another state agency, for the reimbursement or advance
15 payment of reasonable expenses incurred by the state agency to administer duties required
16 of the state agency by sections 2, 4 to 32, 38 to 40, 41, 42, 43 and 45 to 53 of this 2020 Act and
17 rules adopted pursuant to sections 2, 4 to 32, 38 to 40, 41, 42, 43 and 45 to 53 of this 2020 Act,
18 if the expenses of the state agency cannot otherwise reasonably be paid from moneys avail-
19 able to the state agency for payment of the administrative expenses.

20 (2) The fund shall consist of:

21 (a) Moneys deposited in the fund pursuant to sections 28, 29 and 107a of this 2020 Act;

22 (b) Moneys appropriated or otherwise transferred to the fund by the Legislative Assem-
23 bly; and

24 (c) Other moneys deposited in the fund from any source.

25 (3) Civil penalties deposited in the fund under section 107a of this 2020 Act shall be de-
26 posited in a separate subaccount created in the fund and must be used only for providing
27 technical assistance to covered entities.

28 (4) The proceeds from sales of allowances at the hard price ceiling pursuant to section
29 28 (9) of this 2020 Act shall be deposited in a separate subaccount created in the fund and
30 must be used by the office only for the purchase and retirement of offset credits.

31 **SECTION 32. Public records law; application.** (1) The Legislative Assembly finds and de-
32 clares that it is the policy of this state that the Oregon Greenhouse Gas Initiative operate
33 free of abuse and disruptive activity. It is therefore the intent of the Legislative Assembly
34 that the provisions of sections 4 to 32 of this 2020 Act be implemented in a manner necessary
35 to prevent fraud, abuse or market manipulation to the greatest extent possible while up-
36 holding the public interest in transparency in public process and government by making
37 certain market activity information available in aggregated form.

38 (2) The following public records are exempt from disclosure under ORS 192.311 to 192.478
39 and may not be disclosed to any person or entity except as provided in subsection (3) or (4)
40 of this section, unless the party seeking disclosure demonstrates by clear and convincing
41 evidence that, as related to the particular covered entity identifiable in the records requested
42 to be disclosed, the public interest in disclosure outweighs other interests in nondisclosure:

43 (a) Individually identifiable information related to a registered entity's bid activity and
44 auction results for auctions held under section 28 of this 2020 Act.

45 (b) Other individually identifiable information not described in paragraph (a) of this sub-

1 section related to the holding, transfer or surrender of compliance instruments by registered
2 entities.

3 (c) Any individually identifiable information on the manufacturing output of goods, other
4 than emissions data reported under ORS 468A.280, obtained by the Office of Greenhouse Gas
5 Regulation as necessary to administer and implement sections 18, 19, 20, 23 and 24 of this
6 2020 Act.

7 (d) Individually identifiable information obtained by the office from retail electricity
8 consumers pursuant to a request under section 9 (4) of this 2020 Act.

9 (3) Information described in subsection (2) of this section may be used and disclosed in
10 aggregated form.

11 (4) This section does not prohibit the disclosure of information between the office and
12 other agencies of the executive department, as defined in ORS 174.112, or to persons engaged
13 by the State of Oregon to provide administrative or technical services to support implemen-
14 tation of sections 4 to 32 or 45 to 53 of this 2020 Act, if the disclosure is necessary for pur-
15 poses of the administration and implementation of sections 4 to 32 or 45 to 53 of this 2020
16 Act.

17 (5) Any person to whom information described in subsection (2) of this section is dis-
18 closed under subsection (4) of this section shall treat the information as exempt from dis-
19 closure under ORS 192.311 to 192.478. Redisclosure of individually identifiable information
20 outside the office remains subject to the provisions of this section.

21
22 **INVESTMENT OF STATE PROCEEDS FROM OREGON**
23 **GREENHOUSE GAS INITIATIVE AUCTIONS**
24 **(Transportation Decarbonization Investments Account)**
25

26 **SECTION 33. Definitions.** As used in sections 33 to 37 of this 2020 Act:

27 (1) “Building materials” means asphalt, cement, concrete or any other aggregate product,
28 aluminum, steel, iron, coatings for steel and iron, glass, manufactured wood products and
29 copper.

30 (2) “Contracting agency” has the meaning given that term in ORS 279A.010.

31 (3) “Eligible Indian tribe” has the meaning given that term in section 4 of this 2020 Act.

32 (4) “Impacted community” has the meaning given that term in section 4 of this 2020 Act.

33 (5) “Local government” means a metropolitan service district, a metropolitan planning
34 organization, a county or a city.

35 (6) “Metropolitan climate plan” means a plan that implements:

36 (a) A land use and transportation scenario adopted by a metropolitan service district as
37 required under section 37, chapter 865, Oregon Laws 2009, and that has been approved by the
38 Land Conservation and Development Commission;

39 (b) A land use and transportation scenario adopted by a metropolitan planning organiza-
40 tion in accordance with the guidelines established by the Department of Transportation and
41 the Department of Land Conservation and Development under ORS 184.893, and that has
42 been approved by the Land Conservation and Development Commission; or

43 (c) A transportation greenhouse gas emissions reduction and climate adaptation plan
44 adopted by a county or city and that has been approved by the Oregon Greenhouse Gas Re-
45 duction Board.

1 (7) “Metropolitan planning organization” has the meaning given that term in ORS 197.629,
2 except that “metropolitan planning organization” does not mean an organization that coordi-
3 nates transportation planning for an urbanized area that is also subject to the jurisdiction
4 of a metropolitan service district.

5 (8) “Metropolitan service district” means a metropolitan service district organized under
6 ORS chapter 268.

7 (9) “Nursery stock” has the meaning given that term in ORS 571.005.

8 (10) “Oregon Greenhouse Gas Initiative” has the meaning given that term in section 4
9 of this 2020 Act.

10 (11) “State contracting agency” has the meaning given that term in ORS 279A.010.

11 (12) “Subject to a carbon pricing program” means a building materials manufacturer
12 whose emissions from the manufacture of goods:

13 (a) Are subject to a tax or governmental regulatory program that has the effect of
14 placing a price on greenhouse gas emissions and that is at least as stringent as the Oregon
15 Greenhouse Gas Initiative, as determined by the board by rule; or

16 (b) Are directly regulated by the jurisdiction where the manufacturing facility is located
17 for the greenhouse gas emissions attributable to the manufacturing of goods at the facility
18 operated by the manufacturer.

19 **SECTION 34. Transportation Decarbonization Investments Account; rules.** (1) The
20 Transportation Decarbonization Investments Account is established as a separate account
21 within the State Highway Fund. The account consists of moneys deposited in the account
22 under sections 28 and 29 of this 2020 Act. Interest earned by the account shall be credited
23 to the account.

24 (2) Moneys in the account are continuously appropriated to the Department of Trans-
25 portation:

26 (a) For any necessary administration by the department of sections 2, 4 to 32, 33 to 37,
27 41 and 43 of this 2020 Act; and

28 (b) To be distributed for transportation projects pursuant to sections 33 to 37 of this 2020
29 Act.

30 (3) A transportation project may not be funded with moneys distributed from the account
31 unless:

32 (a) The transportation project furthers one or more of the purposes set forth in section
33 2 of this 2020 Act; and

34 (b) The transportation project may be constitutionally funded by revenues described in
35 Article IX, section 3a, of the Oregon Constitution.

36 (4) Of the moneys available in the account for distribution each biennium:

37 (a) 10 percent shall be used by the department for transportation projects selected by the
38 Oregon Transportation Commission pursuant to section 35 of this 2020 Act; and

39 (b) 90 percent shall be distributed by the commission to local governments under section
40 36 of this 2020 Act for implementation, including planning for implementation, of metropol-
41 itan climate plans.

42 (5) The amount of moneys distributed to plan for implementation of metropolitan climate
43 plans under subsection (4)(b) of this section may not exceed one percent of the amount of
44 moneys deposited in the account each biennium.

45 (6) Examples of uses of moneys deposited in the account may include, but are not limited

1 to, uses related to:

2 (a) Enhancing roadway drainage, improving slope stability, investment in the safe routes
3 to schools program established under ORS 184.741, the repower, retrofit or replacement of
4 certain diesel engines, reducing vehicle miles traveled through bike, pedestrian or other
5 multimodal improvements and traffic signal optimization; and

6 (b) Increasing the resilience of transportation infrastructure and evacuation routes
7 against the effects of climate change, extreme precipitation, sea level rise and extreme
8 temperatures and wildfires.

9 (7) Expenditures from the account shall, to the extent feasible and consistent with law,
10 be in addition to and not in replacement of any existing allocation or appropriation for
11 transportation projects.

12 (8) The commission may adopt rules as necessary for the administration and implemen-
13 tation of sections 33 to 37 of this 2020 Act.

14 **SECTION 35. Selection of transportation projects by Oregon Transportation Commission.**

15 (1) The Oregon Transportation Commission shall select the transportation projects to be
16 funded with moneys in the Transportation Decarbonization Investments Account pursuant
17 to section 34 (4)(a) of this 2020 Act.

18 (2) Prior to selecting transportation projects, the commission shall seek input from the
19 applicable area commission on transportation.

20 (3) In selecting transportation projects, the Oregon Transportation Commission shall:

21 (a) Consider whether a proposed transportation project will further the objectives of the
22 statewide transportation strategy on greenhouse gas emissions adopted by the commission
23 pursuant to ORS 184.617; and

24 (b) Give priority to proposed transportation projects that will facilitate the planning or
25 development of metropolitan climate plans by local governments that, as of the date of the
26 selection, have not adopted metropolitan climate plans.

27 **SECTION 36. Distribution of moneys to local governments.** (1) A local government shall
28 be allocated a share of the moneys described in section 34 (4)(b) of this 2020 Act if, as of the
29 date of the allocation:

30 (a) The local government has adopted a metropolitan climate plan; and

31 (b) The local government has jurisdiction over an area for which a covered entity de-
32 scribed in section 5 (2)(d) of this 2020 Act is not the beneficiary of allowances retired under
33 section 13 of this 2020 Act.

34 (2) The proportionate share allocated for distribution to each eligible local government
35 shall be determined by the Oregon Transportation Commission based on a formula that:

36 (a) Must account for population and vehicle miles traveled; and

37 (b) May incorporate any other factors relevant to the proportionate amount of
38 greenhouse gas emissions attributable to transportation within the jurisdiction of each local
39 government.

40 (3) Of the moneys allocated for a metropolitan service district or a metropolitan planning
41 organization under subsection (1) of this section, the commission shall distribute half the
42 moneys to the metropolitan service district or metropolitan planning organization and half
43 the moneys to the counties and cities within the metropolitan service district or metropol-
44 itan planning organization. The proportionate share allocated for distribution to each county
45 and city within the metropolitan service district or metropolitan planning organization shall

1 be determined based on the formula provided in subsection (2) of this section.

2 (4) Moneys received by a local government under this section must be expended on a
3 climate adaptation project or in a manner that, to the extent practicable, will yield the
4 greatest reductions in greenhouse gas emissions per dollar spent. In allocating the moneys
5 to specific expenditures:

6 (a) A metropolitan service district shall consult with a joint policy advisory committee
7 on transportation;

8 (b) A county or city within a metropolitan service district shall consult with the metro-
9 politan service district;

10 (c) A metropolitan planning organization shall consult with the governing bodies of the
11 counties or cities within the boundaries of the metropolitan planning organization; and

12 (d) A local government shall consult with affected eligible Indian tribes and with repre-
13 sentatives of impacted communities.

14 **SECTION 37. Procurement provisions.** (1) Notwithstanding provisions of law requiring a
15 contracting agency to award a contract to the lowest responsible bidder or best proposer or
16 provider of a quotation, and except as provided in subsection (3) of this section or as pro-
17 hibited by federal law, a state contracting agency, when using funds from the Transportation
18 Decarbonization Investments Account established under section 34 of this 2020 Act, shall give
19 a preference of not more than 10 percent to building materials procured from manufacturers
20 subject to a carbon pricing program.

21 (2) Notwithstanding provisions of law requiring a contracting agency to award a contract
22 to the lowest responsible bidder or best proposer or provider of a quotation, and except as
23 provided in subsection (3) of this section or as prohibited by federal law, a contracting agency
24 other than a state contracting agency, when using funds from the Transportation
25 Decarbonization Investments Account, may give a preference of not more than 10 percent
26 to building materials procured from manufacturers subject to a carbon pricing program.

27 (3) If the contracting agency finds in a written determination that the building material
28 is not available in the quantity, quality, type or time frame required for the procurement,
29 or if the cost of the building material is greater than 10 percent more than the building
30 material costs from manufacturers not subject to a carbon pricing program, the contracting
31 agency may decline to give the building material preference.

32 (4) If a transportation project selected by the Oregon Transportation Commission under
33 section 35 of this 2020 Act involves the use of roadside vegetation, the Department of
34 Transportation shall purchase the roadside vegetation from nursery stock that is grown and
35 propagated entirely within this state. The commission may specify by rule grades, standards,
36 considerations and processes for roadside vegetation expenditures conducted pursuant to this
37 subsection.

38 (5) This section does not apply to emergency work, minor alterations, ordinary repairs
39 or maintenance work for public improvements or to other construction contracts described
40 in ORS 279C.320 (1).

41
42 (Climate Investments Fund)

43
44 **SECTION 38. Definitions.** As used in sections 38 to 40 of this 2020 Act:

45 (1) "Building materials" means asphalt, cement, concrete or any other aggregate product,

1 aluminum, steel, iron, coatings for steel and iron, glass, manufactured wood products and
2 copper.

3 (2) "Contracting agency" has the meaning given that term in ORS 279A.010.

4 (3) "Eligible Indian tribe" has the meaning given that term in section 4 of this 2020 Act.

5 (4) "Impacted community" has the meaning given that term in section 4 of this 2020 Act.

6 (5) "Natural and working lands" has the meaning given that term in section 4 of this 2020
7 Act.

8 (6) "Oregon Greenhouse Gas Initiative" has the meaning given that term in section 4 of
9 this 2020 Act.

10 (7) "State contracting agency" has the meaning given that term in ORS 279A.010.

11 (8) "Subject to a carbon pricing program" means a building materials manufacturer
12 whose emissions from the manufacture of goods:

13 (a) Are subject to a tax or governmental regulatory program that has the effect of
14 placing a price on greenhouse gas emissions and that is at least as stringent as the Oregon
15 Greenhouse Gas Initiative, as determined by the Oregon Greenhouse Gas Reduction Board
16 by rule; or

17 (b) Are directly regulated by the jurisdiction where the manufacturing facility is located
18 for the greenhouse gas emissions attributable to the manufacturing of goods at the facility
19 operated by the manufacturer.

20 **SECTION 39. Climate Investments Fund.** (1) The Climate Investments Fund is established
21 in the State Treasury, separate and distinct from the General Fund. The Climate Invest-
22 ments Fund shall consist of moneys deposited in the fund under sections 28 and 29 of this
23 2020 Act. Interest earned by the fund shall be credited to the fund. The Office of Greenhouse
24 Gas Regulation shall administer the fund.

25 (2) Moneys in the fund are continuously appropriated to the office to be distributed by
26 the office as provided in this section. The office shall keep a record of moneys deposited in
27 and distributed out of the fund.

28 (3)(a) Moneys distributed pursuant to this section must be used only for programs,
29 projects and activities that further one or more of the purposes set forth in section 2 of this
30 2020 Act.

31 (b) A majority of the moneys distributed pursuant to this section must be used in a
32 manner that benefits impacted communities.

33 (c) In allocating moneys received under subsection (5)(b) of this section to specific
34 expenditures, a local government shall consult with affected eligible Indian tribes and rep-
35 resentatives of impacted communities.

36 (d) Moneys distributed to the State Forestry Department under subsection (5)(e) of this
37 section may not be used for fire suppression efforts.

38 (4) Of the moneys deposited in the fund each biennium, the office shall first transfer 10
39 percent or \$10 million, whichever is less, to the Just Transition Fund established under sec-
40 tion 96 of this 2020 Act.

41 (5) After transferring moneys as required by subsection (4) of this section, the office
42 shall distribute the remaining moneys deposited in the Climate Investments Fund each
43 biennium as follows:

44 (a) 10 percent shall be distributed pursuant to allocations made by the Legislative As-
45 sembly for uses that directly benefit eligible Indian tribes;

1 (b) 20 percent shall be distributed pursuant to allocations made by the Legislative As-
2 sembly to local governments, as that term is defined in ORS 174.116, for use in a manner that
3 prioritizes greenhouse gas reductions;

4 (c) 20 percent shall be distributed pursuant to allocations made by the Legislative As-
5 sembly to agencies of state government for use in a manner that prioritizes greenhouse gas
6 reductions;

7 (d) 25 percent shall be distributed to the Oregon Watershed Enhancement Board for uses
8 that benefit natural and working lands; and

9 (e) 25 percent shall be distributed to the State Forestry Department for wildfire miti-
10 gation efforts, including but not limited to projects under the Good Neighbor Authority
11 Agreement, as that term is defined in ORS 526.275, and as informed by the recommendations
12 of any council formed by the Governor to address wildfire response.

13 (6) Distributions from the fund shall, to the maximum extent feasible and consistent with
14 law, be in addition to and not in replacement of any existing allocations or appropriations for
15 programs, projects and activities.

16 SECTION 39a. Biennial climate action investment plan. (1) No later than June 1 of each
17 even-numbered year and in the manner provided in ORS 192.245, the Oregon Greenhouse Gas
18 Reduction Board shall deliver a biennial climate action investment plan to the Legislative
19 Assembly and the Governor. The climate action investment plan shall identify the short-term
20 and long-term opportunities for uses of moneys allocated by the Legislative Assembly from
21 the Climate Investments Fund established under section 39 of this 2020 Act.

22 (2) The biennial climate action investment plan must include an analysis of how the
23 programs, projects and activities that may be funded by the moneys allocated by the Legis-
24 lative Assembly from the Climate Investments Fund established under section 39 of this 2020
25 Act would serve to effectively further the purposes set forth in section 2 of this 2020 Act.

26 (3) In preparing the biennial climate action investment plan, the board shall consult with:

27 (a) Representatives of eligible Indian tribes;

28 (b) Local governments, as that term is defined in ORS 174.116;

29 (c) Interested agencies of state government; and

30 (d) Representatives of impacted communities.

31 SECTION 39b. The Oregon Greenhouse Gas Reduction Board shall deliver the first
32 biennial climate action investment plan as required by section 39a of this 2020 Act no later
33 than June 1, 2022.

34 SECTION 39c. Use of biennial climate action investment plan in budget process. In pre-
35 paring the Governor's budget as required under ORS 291.202, the Governor shall consider the
36 recommendations contained in the biennial climate action investment plan prepared by the
37 Oregon Greenhouse Gas Reduction Board under section 39a of this 2020 Act.

38 SECTION 40. Procurement preferences. (1) Notwithstanding provisions of law requiring
39 a contracting agency to award a contract to the lowest responsible bidder or best proposer
40 or provider of a quotation, and except as provided in subsection (3) of this section or as
41 prohibited by federal law, a state contracting agency, when using funds from the Climate
42 Investments Fund established under section 39 of this 2020 Act, shall give a preference of
43 not more than 10 percent to building materials procured from manufacturers subject to a
44 carbon pricing program.

45 (2) Notwithstanding provisions of law requiring a contracting agency to award a contract

1 to the lowest responsible bidder or best proposer or provider of a quotation, and except as
2 provided in subsection (3) of this section or as prohibited by federal law, a contracting agency
3 other than a state contracting agency, when using funds from the Climate Investments
4 Fund, may give a preference of not more than 10 percent to building materials procured from
5 manufacturers subject to a carbon pricing program.

6 (3) If the contracting agency finds in a written determination that the building material
7 is not available in the quantity, quality, type or time frame required for the procurement,
8 or if the building material cost is greater than 10 percent more than the building material
9 costs from manufacturers not subject to a carbon pricing program, the contracting agency
10 may decline to give the building material preference.

11
12 (Labor and Contracting Provisions)

13
14 **SECTION 41.** (1) If a construction project or a transportation project receives more than
15 \$50,000 in funding from moneys in the Climate Investments Fund established under section
16 39 of this 2020 Act or the Transportation Decarbonization Investments Account established
17 under section 34 of this 2020 Act, the primary contractor participating in the project:

18 (a) Shall pay the prevailing rate of wage for an hour's labor in the same trade or occu-
19 pation in the locality where the labor is performed;

20 (b) Shall offer health care and retirement benefits to the employees performing the labor
21 on the construction project or transportation project;

22 (c) Shall participate in an apprenticeship program registered with the State Apprentice-
23 ship and Training Council;

24 (d) May not be a contractor listed by the Commissioner of the Bureau of Labor and In-
25 dustries under ORS 279C.860 as ineligible to receive a contract or subcontract for public
26 works;

27 (e) Must demonstrate a history of material compliance with the rules and other re-
28 quirements of the Construction Contractors Board and of the Workers' Compensation Divi-
29 sion, the Building Codes Division and the Occupational Safety and Health Division of the
30 Department of Consumer and Business Services; and

31 (f) Must demonstrate a history of compliance with federal and state wage and hour laws.

32 (2) A farm labor contractor, as defined in ORS 658.405, may not receive moneys distrib-
33 uted from the Climate Investments Fund or the Transportation Decarbonization Investments
34 Account unless the farm labor contractor is in compliance with all licensing and any other
35 requirements or regulations imposed upon farm labor contractors pursuant to ORS 658.405
36 to 658.511.

37 (3)(a) The Oregon Department of Administrative Services, in consultation with the At-
38 torney General, shall adopt model rules that specify labor, workforce and contracting pro-
39 cedures for state agencies to use in administering funds for construction projects or
40 transportation projects that receive more than \$50,000 in funding from moneys in the Cli-
41 mate Investments Fund or the Transportation Decarbonization Investments Account. The
42 department shall adopt the rules in accordance with ORS chapter 183.

43 (b) Model rules adopted under this subsection shall require the use of a project labor
44 agreement for construction projects or transportation projects that receive more than
45 \$200,000 in funding from moneys in the Climate Investments Fund or the Transportation

1 **Decarbonization Investments Account. For all other construction projects or transportation**
2 **projects funded as described in paragraph (a) of this subsection, the model rules shall:**

3 **(A) Establish measurable, enforceable goals for the training and hiring of persons who**
4 **are members of impacted communities, as defined in section 4 of this 2020 Act, and for con-**
5 **tracting with businesses that are owned or operated by members of impacted communities;**
6 **and**

7 **(B) Establish wage, benefit and labor relations standards consistent with the provisions**
8 **of this section.**

9 **(c) The model rules shall promote best practices in procurement and contracting.**

10 **(d)(A) The model rules shall require that, in each contract awarded by a state agency for**
11 **a construction project or transportation project funded as described in paragraph (a) of this**
12 **subsection, building materials as defined in section 38 of this 2020 Act that the contractor**
13 **purchases for the project and that become part of a permanent structure must be produced**
14 **in the United States.**

15 **(B) The requirement in subparagraph (A) of this paragraph shall not apply if the admin-**
16 **istering agency finds that:**

17 **(i) The requirement is inconsistent with the public interest;**

18 **(ii) Building materials required for the project are not produced in the United States in**
19 **sufficient and reasonably available quantities and with satisfactory quality; or**

20 **(iii) The requirement set forth in subparagraph (A) of this paragraph will increase the**
21 **costs of the project, exclusive of labor costs involved in final assembly for manufactured**
22 **products, by 25 percent or more.**

23 **(C) Notwithstanding a finding by the administering agency under subparagraph (B) of this**
24 **paragraph, a contractor shall spend at least 75 percent of the total amount the contractor**
25 **spends in connection with the construction project or transportation project on building**
26 **materials that become part of a permanent structure on purchasing building materials that**
27 **are produced in the United States.**

28 **(e) Before adopting or amending a rule under this subsection, the department shall con-**
29 **sult with representatives of labor, contractors and other knowledgeable persons.**

30 **(4) Except as provided in subsection (5) of this section, a state agency charged with ad-**
31 **ministering funds for construction projects or transportation projects that receive more**
32 **than \$50,000 in funding from moneys in the Climate Investments Fund or the Transportation**
33 **Decarbonization Investments Account may not adopt the administering agency's own rules**
34 **for labor and workforce procedures related to administering funds allocated from the Climate**
35 **Investments Fund or the Transportation Decarbonization Investments Account and shall be**
36 **subject to the model rules adopted by the Oregon Department of Administrative Services**
37 **under subsection (3) of this section.**

38 **(5) The Department of Transportation may adopt the department's own rules specifying**
39 **labor, workforce and contracting procedures for use in administering funds for transporta-**
40 **tion projects that receive more than \$50,000 in funding from moneys in the Transportation**
41 **Decarbonization Investments Account. Rules adopted by the department pursuant to this**
42 **subsection must meet the requirements of subsection (3) of this section.**

43
44 **(Common School Fund)**
45

1 **SECTION 42.** Moneys deposited in the Common School Fund under sections 28 and 29 of
2 this 2020 Act are continuously appropriated to the Department of State Lands to be used in
3 a manner that:

- 4 (1) Is consistent with the requirements of the Oregon Constitution; and
5 (2) Furthers one or more of the purposes set forth in section 2 of this 2020 Act.

6
7 (Biennial Expenditure Reporting and Auditing)
8

9 **SECTION 43.** (1) All agencies of the executive department as defined in ORS 174.112,
10 counties, cities and all other public and private entities receiving moneys from the Climate
11 Investments Fund shall annually report to the Office of Greenhouse Gas Regulation on the
12 expenditure of the moneys received and the results of the expenditures. No later than Jan-
13 uary 1 of each even-numbered year, the office shall deliver a biennial report, in the manner
14 provided in ORS 192.245, to the Oregon Transportation Commission, the Governor and the
15 Legislative Assembly describing:

- 16 (a) The investments from the Climate Investments Fund;
17 (b) Whether the investments met the requirements of section 39 of this 2020 Act; and
18 (c) The effectiveness of those investments in furthering the purposes set forth in section
19 2 of this 2020 Act.

20 (2) All agencies of the executive department, metropolitan service districts, metropolitan
21 planning organizations, counties, cities and all other public and private entities receiving
22 moneys from the Transportation Decarbonization Investments Account shall annually report
23 to the Department of Transportation on the expenditure of the moneys received and the re-
24 sults of the expenditures. No later than January 1 of each even-numbered year, the depart-
25 ment shall deliver a biennial report, in the manner provided in ORS 192.245, to the Oregon
26 Transportation Commission, the Governor and the Legislative Assembly describing:

- 27 (a) The transportation projects funded by moneys from the Transportation
28 Decarbonization Investments Account;
29 (b) How the transportation projects met the requirements of section 34 of this 2020 Act;
30 and
31 (c) The effectiveness of the transportation projects in furthering the purposes set forth
32 in section 2 of this 2020 Act.

33 (3) Notwithstanding sections 33 to 37 and 39 of this 2020 Act, any agency of the executive
34 department, metropolitan service district, metropolitan planning organization, county, city
35 or other public or private entity failing to file a report under this section may not receive
36 any payments from the Climate Investments Fund or the Transportation Decarbonization
37 Investments Account until the report is filed.

38 (4)(a) The office and the department jointly shall select an independent third-party or-
39 ganization to, beginning in 2025, prepare a performance audit once every five years of:

- 40 (A) All programs, projects or activities funded by moneys from the Climate Investments
41 Fund; and
42 (B) All transportation projects funded by moneys from the Transportation
43 Decarbonization Investments Account.

44 (b) The office and the department shall provide for the audit report prepared by the in-
45 dependent third-party organization under this subsection to be transmitted to the Oregon

1 **Transportation Commission, the Governor and the Legislative Assembly.**

2
3 **PROVISIONS RELATED TO THE PUBLIC UTILITY COMMISSION**

4
5 **SECTION 44. Sections 45 to 53 of this 2020 Act are added to and made a part of ORS**
6 **chapter 757.**

7 **SECTION 45. Definitions. As used in sections 45 to 53 of this 2020 Act:**

8 (1) "Allowance" has the meaning given that term in section 4 of this 2020 Act.

9 (2) "Electric company" has the meaning given that term in ORS 757.600.

10 (3) "Natural gas utility" means a natural gas utility regulated by the Public Utility
11 Commission under ORS chapter 757.

12 (4) "Oregon Greenhouse Gas Initiative" has the meaning given that term in section 4 of
13 this 2020 Act.

14 (5) "Trade-exposed natural gas user" has the meaning given that term in section 4 of this
15 2020 Act.

16 **SECTION 46. Use of certain allowance sale proceeds by electric companies. (1) If, rather**
17 **than surrendering the allowances to fulfill its compliance obligation under the Oregon**
18 **Greenhouse Gas Initiative, an electric company sells allowances that were directly distrib-**
19 **uted at no cost to the electric company under section 14 of this 2020 Act, the Public Utility**
20 **Commission shall require the proceeds received by the electric company through the sale:**

21 (a) To be spent by the electric company for the exclusive benefit of retail customers that
22 are supplied electricity by the electric company; and

23 (b) To be used only for activities that serve to reduce greenhouse gas emissions or pro-
24 vide assistance to the electric company's retail customers, in furtherance of the purposes
25 set forth in section 2 of this 2020 Act.

26 (2) Subject to subsection (1) of this section, an electric company shall prioritize the use
27 of proceeds received by the electric company from the sale of allowances that were directly
28 distributed at no cost to the electric company for:

29 (a) Providing weatherization, energy efficiency improvements, bill assistance or rate as-
30 sistance to the electric company's low-income residential customers;

31 (b) Accelerated transportation electrification;

32 (c) Investments and activities that serve to reduce greenhouse gas emissions through
33 actions such as energy efficiency improvements, voltage optimization, portfolio optimization
34 and renewable energy procurement; and

35 (d) Facilitating integration and utilization of variable energy resources through invest-
36 ments in programs and technologies such as demand response, smart grid communication
37 and control systems, grid-connected end uses and energy storage.

38 (3) An electric company that receives allowances directly distributed at no cost under
39 section 14 of this 2020 Act shall develop a plan for the use of the allowances and file the plan
40 with the commission. The plan must be revised and updated on a schedule established by the
41 commission by rule. At a minimum, a plan must contain:

42 (a) A strategy for the use of proceeds received by the electric company from the sale of
43 the allowances in compliance with this section; and

44 (b) A description of any previous uses of proceeds received by the electric company from
45 the sale of the allowances.

1 (4) The commission shall, pursuant to ORS 756.040 and after consultation with the
2 Housing and Community Services Department, adopt rules for the implementation and
3 enforcement of this section.

4 **SECTION 47.** An electric company shall develop and file with the Public Utility Commis-
5 sion an initial plan under section 46 of this 2020 Act no later than December 31, 2022.

6 **SECTION 48. Trust accounts.** (1)(a) The Public Utility Commission, as trustee, shall es-
7 tablish a separate trust account with the State Treasurer for the benefit of each natural gas
8 utility regulated under the Oregon Greenhouse Gas Initiative. Moneys in each trust account
9 shall consist of proceeds due to the natural gas utility from the sale at auction of allowances
10 consigned to the Office of Greenhouse Gas Regulation under section 17 of this 2020 Act. The
11 State Treasurer may invest moneys deposited in the trust accounts as provided in ORS
12 293.701 to 293.857. Interest earned by a trust account must be credited to the account.

13 (b) Upon request by a natural gas utility, the commission shall require the State Treas-
14 urer to transfer from the natural gas utility's trust account to the natural gas utility
15 amounts necessary to pay for programs or activities found to be consistent with the plan
16 required under subsection (2) of this section.

17 (c) Upon making the determinations required by subsections (3) and (4) of this section,
18 the commission shall direct the State Treasurer to transfer amounts from a natural gas
19 utility's trust account to the natural gas utility or a designee of the natural gas utility nec-
20 essary for use consistent with subsections (3) and (4) of this section.

21 (2) A natural gas utility shall develop a plan for use of moneys in the trust account for
22 the benefit of the natural gas utility's sales customers. The natural gas utility shall file the
23 plan for acknowledgment with the commission as part of each of the natural gas utility's
24 integrated resource plan filings, as further specified by the commission by rule. A plan must:

25 (a) Identify a portfolio of approaches in furtherance of the purposes set forth in section
26 2 of this 2020 Act;

27 (b) Provide that no less than 25 percent of the proceeds from the sale of allowances di-
28 rectly distributed to the natural gas utilities pursuant to section 17 (1)(b) of this 2020 Act
29 be used for nonvolumetric bill credits or other rate relief for residential, commercial and
30 industrial sales customers; and

31 (c) Address the impacts of the regulated emissions attributable to the natural gas utility
32 with due consideration of the risks associated with climate change and the need for urgent
33 action to address greenhouse gas emissions reductions, through one or more of the following
34 approaches:

35 (A) Implementing programs, activities or technologies designed to reduce greenhouse gas
36 emissions from sales customers, including programs for low and moderate income residential
37 sales customers;

38 (B) Developing renewable natural gas or renewable hydrogen infrastructure and the
39 provision of renewable natural gas or renewable hydrogen to the natural gas utility's sales
40 customers;

41 (C) Providing renewable thermal resources for sales customers;

42 (D) Providing renewable natural gas or hydrogen to vehicles and the necessary related
43 infrastructure in the utility's service territory as consistent with section 56 of this 2020 Act;

44 (E) Implementing pilot projects or research, development and demonstration activities
45 to determine the cost and viability of activities described in subparagraphs (A) to (D) of this

1 paragraph; or

2 (F) Contributing to a state grant or loan program for financing projects or upgrades to
3 reduce greenhouse gas emissions for industrial or commercial sales customers.

4 (3)(a) Subject to paragraph (b) of this subsection, the commission shall determine the
5 amounts of the proceeds from the sale of allowances directly distributed to natural gas util-
6 ities pursuant to section 17 (1)(c) of this 2020 Act to be used for each of the following pur-
7 poses:

8 (A) Providing nonvolumetric bill credits or other rate relief for natural gas transporta-
9 tion customers of the natural gas utility;

10 (B) Implementing programs, activities or technologies, which may include cost-effective
11 projects for switching to the use of lower-carbon-emitting fuels, designed to reduce
12 greenhouse gas emissions attributable to commercial and industrial natural gas transporta-
13 tion customers; and

14 (C) Contributing to a state grant or loan program for financing projects or upgrades,
15 which may include cost-effective projects for switching to the use of lower-carbon-emitting
16 fuels, to reduce greenhouse gas emissions for natural gas transportation customers.

17 (b) No less than 25 percent of the proceeds described in this subsection must be used for
18 rate relief as described in paragraph (a)(A) of this subsection. The commission shall set the
19 level of rate relief as part of the tariff between the transportation customer and the natural
20 gas utility. In setting the level of rate relief, the commission shall consider:

21 (A) The availability of reasonable opportunities for natural gas transportation customers
22 of the natural gas utility to reduce greenhouse gas emissions, including but not limited to
23 opportunities for investments in energy efficiency; and

24 (B) Competitive considerations related to natural gas service options.

25 (4) The commission shall determine the amounts of the proceeds from the sale of allow-
26 ances directly distributed to natural gas utilities pursuant to section 17 (1)(d) of this 2020
27 Act to be used for the benefit of trade-exposed natural gas users consistent with section 50
28 of this 2020 Act.

29 (5)(a) The proceeds described in subsections (2) and (3) of this section may not be used
30 for the benefit of natural gas customers that are also trade-exposed natural gas users.

31 (b) A natural gas utility, upon approval by the commission, may select one or more third
32 parties to implement a program described in subsection (2)(c)(A) or (3)(a)(B) of this section.

33 (6) The commission may adopt rules for the implementation and enforcement of this
34 section and section 50 of this 2020 Act, including but not limited to a process for trade-
35 exposed natural gas users to appeal the approval or disapproval of an energy management
36 system audit or implementation plan under section 50 of this 2020 Act.

37 SECTION 49. A natural gas utility shall develop and file with the Public Utility Commis-
38 sion an initial plan under section 48 (2) of this 2020 Act no later than June 30, 2022.

39 SECTION 50. (1) In 2022 and each following calendar year before 2025, a trade-exposed
40 natural gas user shall receive rate relief in each year equal to the amount of revenue gen-
41 erated by the sale at auction of the allowances allocated to the natural gas utility on behalf
42 of that user under section 17 (1)(d) of this 2020 Act for that year.

43 (2)(a) In 2025 and each following calendar year before 2051, and except as provided in
44 paragraph (b) of this subsection, the amount of rate relief received by a trade-exposed na-
45 tural gas user shall decline annually by a constant amount proportionate to the decline in

1 the number of allowances available in annual allowance budgets pursuant to section 5 (1)(b)
2 of this 2020 Act.

3 (b) If a trade-exposed natural gas user is in compliance with an approved energy man-
4 agement system audit and implementation plan subject to subsection (3) of this section, the
5 trade-exposed natural gas user shall receive a nonvolumetric bill credit pursuant to a for-
6 mula developed by the Public Utility Commission by rule. The formula developed by the
7 commission must be designed to recognize early action, encourage ongoing efficiency im-
8 provements, accommodate growth of operations or output, and mitigate to the greatest ex-
9 tent practicable any impacts by the Oregon Greenhouse Gas Initiative on the rates for
10 natural gas paid by trade-exposed natural gas users. During the following years, the com-
11 mission shall use the following amounts for the benefit of trade-exposed natural gas users
12 pursuant to the formula developed under this section:

13 (A) In 2025 and each year before 2030, an amount equal to the amount of revenue gen-
14 erated by the sale at auction of the allowances allocated to the natural gas utility on behalf
15 of the users under section 17 (1)(d) of this 2020 Act for that year; and

16 (B) In 2030 and each year before 2051, an amount equal to 97 percent of the amount of
17 revenue generated by the sale at auction of the allowances allocated to the natural gas utility
18 on behalf of the users under section 17 (1)(d) of this 2020 Act for that year.

19 (3)(a) A trade-exposed natural gas user may, no later than December 31, 2024, and once
20 every five years thereafter, submit to the Public Utility Commission a completed energy
21 management system audit and implementation plan for approval.

22 (b) The commission shall approve an energy management system audit and implementa-
23 tion plan if:

24 (A) The audit meets the requirements of subsection (4) of this section; and

25 (B) The implementation plan identifies how the trade-exposed natural gas user will com-
26 plete all efficiency improvements identified in the audit report that are related to natural
27 gas use and that have a payback period of five years or less by:

28 (i) Two years after the date of the audit; or

29 (ii) A reasonable extension date not to exceed four years after the date of the audit, if
30 the commission determines that additional time is reasonable and necessary for the trade-
31 exposed natural gas user to complete the efficiency improvements.

32 (c) In determining the payback period for an efficiency improvement identified in an audit
33 report, the commission shall consider any loans for completing the efficiency improvement
34 available to the trade-exposed natural gas user from the Traded Sector Greenhouse Gas Re-
35 duction Revolving Loan Fund established under section 51 of this 2020 Act.

36 (d) An approved energy management system audit and implementation plan shall be valid
37 for five years.

38 (4) An energy management system audit must adhere to established federal or interna-
39 tional standards for developing plans identifying energy efficiency opportunities and related
40 best practices for commercial, industrial and institutional facilities, as the commission may

42 elements of an audit shall include but need not be limited to:

2 (c) An inventory of the major onsite energy use systems at the facility;

3 (d) A review of the architectural and engineering plans for the facility, the facility's op-
4 eration and maintenance procedures and logs, and the fuel usage of the facility;

5 (e) A review of the facility's energy management program and recommendations for im-
6 provements to the program;

7 (f) A review of opportunities for the facility to switch to the use of fuels that are less
8 greenhouse gas emissions intensive;

9 (g) A list of energy conservation measures that are within the facility's control to im-
10 plement;

11 (h) An evaluation of the energy savings potential of implementing the energy conserva-
12 tion measures listed under paragraph (g) of this subsection; and

13 (i) A comprehensive audit report detailing ways to improve the efficiency of the facility,
14 the cost of any specific improvements identified in the report, the benefits of the identified
15 improvements and the time frame for recouping the investments in the identified improve-
16 ments.

17 (5) Beginning in 2030, the commission shall annually direct any proceeds described in

6 **(a) Support the adoption of alternative forms of transportation vehicles that are powered**
7 **by electricity, compressed natural gas, renewable natural gas or hydrogen;**

8 **(b) Support reductions of transportation sector greenhouse gas emissions over time; and**

9 **(c) Benefit the electric company's retail electricity consumers or the natural gas utility's**
10 **retail customers in ways that may include, but need not be limited to:**

11 **(A) Distribution or transmission management benefits;**

22 **SECTION 57.** ORS 468A.280 is amended to read:

23 468A.280. [(1) *In addition to any registration and reporting that may be required under ORS*
24 *468A.050, the Environmental Quality Commission by rule may require registration and reporting by:*]

25 **(1) As used in this section, "greenhouse gas" includes, but is not limited to, carbon**
26 **dioxide, methane, nitrous oxide, hydrofluorocarbons, perfluorocarbons, sulfur hexafluoride**
27 **and nitrogen trifluoride.**

28 **(2) The Environmental Quality Commission by rule may require registration and report-**
29 **ing of information necessary to determine greenhouse gas emissions by:**

30 **(a) A person in control of an air contamination source of any class for which registration**
31 **and reporting is required under ORS 468A.050.**

32 [(a)] **(b) [Any] A person who imports, sells, allocates or distributes electricity for use in this**
33 **state [electricity, the generation of which emits greenhouse gases].**

34 [(b)] **(c) [Any] A person who imports, sells or distributes for use in this state [fossil] fuel that**
35 **generates greenhouse gases when combusted.**

36 **(3) A person required to register and report under subsection (2) of this section shall**
37 **register with the Department of Environmental Quality and make reports containing infor-**
38 **mation that the commission by rule may require that is relevant to determining and verify-**
39 **ing greenhouse gas emissions. The commission may by rule require the person to provide an**

40 **ENERGY FACILITY CARBON DIOXIDE EMISSIONS STANDARDS**
41 **(Repeal of Carbon Dioxide Emissions Standards)**
42

43 **SECTION 58.** ORS 469.503 is amended to read:

44 469.503. In order to issue a site certificate, the Energy Facility Siting Council shall determine
45 that the preponderance of the evidence on the record supports the following conclusions:

1 (1) The facility complies with the applicable standards adopted by the council pursuant to ORS
2 469.501 or the overall public benefits of the facility outweigh any adverse effects on a resource or
3 interest protected by the applicable standards the facility does not meet.

4 *[(2) If the energy facility is a fossil-fueled power plant, the energy facility complies with any ap-
5 plicable carbon dioxide emissions standard adopted by the council or enacted by statute. Base load
6 gas plants shall comply with the standard set forth in subsection (2)(a) of this section. Other fossil-
7 fueled power plants shall comply with any applicable standard adopted by the council by rule pursuant
8 to subsection (2)(b) of this section. Subsections (2)(c) and (d) of this section prescribe the means by
9 which an applicant may comply with the applicable standard.]*

10 *[(a) The net carbon dioxide emissions rate of the proposed base load gas plant shall not exceed 0.70
11 pounds of carbon dioxide emissions per kilowatt hour of net electric power output, with carbon dioxide
12 emissions and net electric power output measured on a new and clean basis. Notwithstanding the
13 foregoing, the council may by rule modify the carbon dioxide emissions standard for base load gas
14 plants if the council finds that the most efficient stand-alone combined cycle, combustion turbine, na-
15 tural gas-fired energy facility that is commercially demonstrated and operating in the United States has
16 a net heat rate of less than 7,200 Btu per kilowatt hour higher heating value adjusted to ISO condi-
17 tions. In modifying the carbon dioxide emission standard, the council shall determine the rate of carbon
18 dioxide emissions per kilowatt hour of net electric output of such energy facility, adjusted to ISO con-
19 ditions, and reset the carbon dioxide emissions standard at 17 percent below this rate.]*

20 *[(b) The council shall adopt carbon dioxide emissions standards for other types of fossil-fueled
21 power plants. Such carbon dioxide emissions standards shall be promulgated by rule. In adopting or
22 amending such carbon dioxide emissions standards, the council shall consider and balance at least the
23 following principles, the findings on which shall be contained in the rulemaking record:]*

24 *[(A) Promote facility fuel efficiency;]*

25 *[(B) Promote efficiency in the resource mix;]*

26 *[(C) Reduce net carbon dioxide emissions;]*

27 *[(D) Promote cogeneration that reduces net carbon dioxide emissions;]*

28 *[(E) Promote innovative technologies and creative approaches to mitigating, reducing or avoiding
29 carbon dioxide emissions;]*

30 *[(F) Minimize transaction costs;]*

31 *[(G) Include an alternative process that separates decisions on the form and implementation of
32 offsets from the final decision on granting a site certificate;]*

33 *[(H) Allow either the applicant or third parties to implement offsets;]*

34 *[(I) Be attainable and economically achievable for various types of power plants;]*

35 *[(J) Promote public participation in the selection and review of offsets;]*

36 *[(K) Promote prompt implementation of offset projects;]*

37 *[(L) Provide for monitoring and evaluation of the performance of offsets; and]*

38 *[(M) Promote reliability of the regional electric system.]*

39 *[(c) The council shall determine whether the applicable carbon dioxide emissions standard is met
40 by first determining the gross carbon dioxide emissions that are reasonably likely to result from the
41 operation of the proposed energy facility. Such determination shall be based on the proposed design of
42 the energy facility. The council shall adopt site certificate conditions to ensure that the predicted carbon
43 dioxide emissions are not exceeded on a new and clean basis. For any remaining emissions reduction
44 necessary to meet the applicable standard, the applicant may elect to use any of subparagraphs (A) to
45 (D) of this paragraph, or any combination thereof. The council shall determine the amount of carbon*

1 *dioxide or other greenhouse gas emissions reduction that is reasonably likely to result from the*
2 *applicant's offsets and whether the resulting net carbon dioxide emissions meet the applicable carbon*
3 *dioxide emissions standard. For purposes of determining the net carbon dioxide emissions, the council*
4 *shall by rule establish the global warming potential of each greenhouse gas based on a generally ac-*
5 *cepted scientific method, and convert any greenhouse gas emissions to a carbon dioxide equivalent.*
6 *Unless otherwise provided by the council by rule, the global warming potential of methane is 23 times*
7 *that of carbon dioxide, and the global warming potential of nitrous oxide is 296 times that of carbon*
8 *dioxide. If the council or a court on judicial review concludes that the applicant has not demonstrated*
9 *compliance with the applicable carbon dioxide emissions standard under subparagraphs (A), (B) or (D)*
10 *of this paragraph, or any combination thereof, and the applicant has agreed to meet the requirements*
11 *of subparagraph (C) of this paragraph for any deficiency, the council or a court shall find compliance*
12 *based on such agreement.]*

13 *[(A) The facility will sequentially produce electrical and thermal energy from the same fuel source,*
14 *and the thermal energy will be used to displace another source of carbon dioxide emissions that would*
15 *have otherwise continued to occur, in which case the council shall adopt site certificate conditions en-*
16 *suring that the carbon dioxide emissions reduction will be achieved.]*

17 *[(B) The applicant or a third party will implement particular offsets, in which case the council may*
18 *adopt site certificate conditions ensuring that the proposed offsets are implemented but shall not require*
19 *that predicted levels of avoidance, displacement or sequestration of greenhouse gas emissions be*
20 *achieved. The council shall determine the quantity of greenhouse gas emissions reduction that is rea-*
21 *sonably likely to result from each of the proposed offsets based on the criteria in sub-subparagraphs*
22 *(i) to (iii) of this subparagraph. In making this determination, the council shall not allow credit for*
23 *offsets that have already been allocated or awarded credit for greenhouse gas emissions reduction in*
24 *another regulatory setting. In addition, the fact that an applicant or other parties involved with an*
25 *offset may derive benefits from the offset other than the reduction of greenhouse gas emissions is not,*
26 *by itself, a basis for withholding credit for an offset.]*

27 *[(i) The degree of certainty that the predicted quantity of greenhouse gas emissions reduction will*
28 *be achieved by the offset;]*

29 *[(ii) The ability of the council to determine the actual quantity of greenhouse gas emissions re-*
30 *duction resulting from the offset, taking into consideration any proposed measurement, monitoring and*
31 *evaluation of mitigation measure performance; and]*

32 *[(iii) The extent to which the reduction of greenhouse gas emissions would occur in the absence of*
33 *the offsets.]*

34 *[(C) The applicant or a third party agrees to provide funds in an amount deemed sufficient to*
35 *produce the reduction in greenhouse gas emissions necessary to meet the applicable carbon dioxide*
36 *emissions standard, in which case the funds shall be used as specified in paragraph (d) of this sub-*
37 *section. Unless modified by the council as provided below, the payment of 57 cents shall be deemed to*
38 *result in a reduction of one ton of carbon dioxide emissions. The council shall determine the offset*
39 *funds using the monetary offset rate and the level of emissions reduction required to meet the applicable*
40 *standard. If a site certificate is approved based on this subparagraph, the council may not adjust the*
41 *amount of such offset funds based on the actual performance of offsets. After three years from June*
42 *26, 1997, the council may by rule increase or decrease the monetary offset rate of 57 cents per ton of*
43 *carbon dioxide emissions. Any change to the monetary offset rate shall be based on empirical evidence*
44 *of the cost of offsets and the council's finding that the standard will be economically achievable with*

2 *[(D) Any other means that the council adopts by rule for demonstrating compliance with any ap-*
3 *licable carbon dioxide emissions standard.]*

4 *[(d) If the applicant elects to meet the applicable carbon dioxide emissions standard in whole or in*
5 *part under paragraph (c)(C) of this subsection, the applicant shall identify the qualified organization.*
6 *The applicant may identify an organization that has applied for, but has not received, an exemption*
7 *from federal income taxation, but the council may not find that the organization is a qualified organ-*
8 *ization unless the organization is exempt from federal taxation under section 501(c)(3) of the Internal*
9 *Revenue Code as amended and in effect on December 31, 1996. The site certificate holder shall provide*
10 *a bond or comparable security in a form reasonably acceptable to the council to ensure the payment*
11 *of the offset funds and the amount required under subparagraph (A)(ii) of this paragraph. Such secu-*
12 *rity shall be provided by the date specified in the site certificate, which shall be no later than the*
13 *commencement of construction of the facility. The site certificate shall require that the offset funds be*
14 *disbursed as specified in subparagraph (A) of this paragraph, unless the council finds that no qualified*
15 *organization exists, in which case the site certificate shall require that the offset funds be disbursed*
16 *as specified in subparagraph (B) of this paragraph.]*

17 *[(A) The site certificate holder shall disburse the offset funds and any other funds required by*
18 *sub-subparagraph (ii) of this subparagraph to the qualified organization as follows:]*

19 *[(i) When the site certificate holder receives written notice from the qualified organization certifying*
20 *that the qualified organization is contractually obligated to pay any funds to implement offsets using*
21 *the offset funds, the site certificate holder shall make the requested amount available to the qualified*
22 *organization unless the total of the amount requested and any amounts previously requested exceeds*
23 *the offset funds, in which case only the remaining amount of the offset funds shall be made available.*
24 *The qualified organization shall use at least 80 percent of the offset funds for contracts to implement*
25 *offsets. The qualified organization shall assess offsets for their potential to qualify in, generate credits*
26 *in or reduce obligations in other regulatory settings. The qualified organization may use up to 20*
27 *percent of the offset funds for monitoring, evaluation, administration and enforcement of contracts to*
28 *implement offsets.]*

29 *[(ii) At the request of the qualified organization and in addition to the offset funds, the site certif-*
30 *icate holder shall pay the qualified organization an amount equal to 10 percent of the first \$500,000*
31 *of the offset funds and 4.286 percent of any offset funds in excess of \$500,000. This amount shall not*
32 *be less than \$50,000 unless a lesser amount is specified in the site certificate. This amount compensates*
33 *the qualified organization for its costs of selecting offsets and contracting for the implementation of*
34 *offsets.]*

35 *[(iii) Notwithstanding any provision to the contrary, a site certificate holder subject to this sub-*
36 *paragraph shall have no obligation with regard to offsets, the offset funds or the funds required by*
37 *sub-subparagraph (ii) of this subparagraph other than to make available to the qualified organization*
38 *the total amount required under paragraph (c) of this subsection and sub-subparagraph (ii) of this*
39 *subparagraph, nor shall any nonperformance, negligence or misconduct on the part of the qualified*
40 *organization be a basis for revocation of the site certificate or any other enforcement action by the*
41 *council with respect to the site certificate holder.]*

42 *[(B) If the council finds there is no qualified organization, the site certificate holder shall select*
43 *one or more offsets to be implemented pursuant to criteria established by the council. The site certificate*
44 *holder shall give written notice of its selections to the council and to any person requesting notice. On*
45 *petition by the State Department of Energy, or by any person adversely affected or aggrieved by the*

1 *site certificate holder's selection of offsets, or on the council's own motion, the council may review such*
 2 *selection. The petition must be received by the council within 30 days of the date the notice of selection*
 3 *is placed in the United States mail, with first-class postage prepaid. The council shall approve the site*
 4 *certificate holder's selection unless it finds that the selection is not consistent with criteria established*
 5 *by the council. The site certificate holder shall contract to implement the selected offsets within 18*

 15 *ability for implementation, monitoring, evaluation and enforcement of offsets pursuant to this subsection*
 16 *shall be limited to the amount of any offset funds not already contractually obligated. Nonperformance,*
 17 *negligence or misconduct by the entity or entities implementing, monitoring or evaluating the selected*
 18 *offset shall not be a basis for revocation of the site certificate or any other enforcement action by the*
 19 *council with respect to the site certificate holder.]*

20 *[(C) Every qualified organization that has received funds under this paragraph shall, at five-year*
 21 *intervals beginning on the date of receipt of such funds, provide the council with the information the*
 22 *council requests about the qualified organization's performance. The council shall evaluate the infor-*
 23 *mation requested and, based on such information, shall make any recommendations to the Legislative*
 24 *Assembly that the council deems appropriate.]*

25 *[(e) As used in this subsection:]*

26 *[(A) "Adjusted to ISO conditions" means carbon dioxide emissions and net electric power output*
 27 *as determined at 59 degrees Fahrenheit, 14.7 pounds per square inch atmospheric pressure and 60*
 28 *percent humidity.]*

29 *[(B) "Base load gas plant" means a generating facility that is fueled by natural gas, except for*
 30 *periods during which an alternative fuel may be used and when such alternative fuel use shall not*
 31 *exceed 10 percent of expected fuel use in Btu, higher heating value, on an average annual basis, and*
 32 *where the applicant requests and the council adopts no condition in the site certificate for the generat-*
 33 *ing facility that would limit hours of operation other than restrictions on the use of alternative fuel.*
 34 *The council shall assume a 100 percent capacity factor for such plants and a 30-year life for the plants*
 35 *for purposes of determining gross carbon dioxide emissions.]*

36 *[(C) "Carbon dioxide equivalent" means the global warming potential of a greenhouse gas reflected*
 37 *in units of carbon dioxide.]*

38 *[(D) "Fossil-fueled power plant" means a generating facility that produces electric power from na-*
 39 *tural gas, petroleum, coal or any form of solid, liquid or gaseous fuel derived from such material.]*

40 *[(E) "Generating facility" means those energy facilities that are defined in ORS 469.300 (11)(a)(A),*
 41 *(B) and (D).]*

42 *[(F) "Global warming potential" means the determination of the atmospheric warming resulting*
 43 *from the release of a unit mass of a particular greenhouse gas in relation to the warming resulting from*
 44 *the release of the equivalent mass of carbon dioxide.]*

45 *[(G) "Greenhouse gas" means carbon dioxide, methane and nitrous oxide.]*

1 *[(H) “Gross carbon dioxide emissions” means the predicted carbon dioxide emissions of the pro-*
2 *posed energy facility measured on a new and clean basis.]*

3 *[(I) “Net carbon dioxide emissions” means gross carbon dioxide emissions of the proposed energy*
4 *facility, less carbon dioxide or other greenhouse gas emissions avoided, displaced or sequestered by any*
5 *combination of cogeneration or offsets.]*

6 *[(J) “New and clean basis” means the average carbon dioxide emissions rate per hour and net*
7 *electric power output of the energy facility, without degradation, as determined by a 100-hour test at*
8 *full power completed during the first 12 months of commercial operation of the energy facility, with the*
9 *results adjusted for the average annual site condition for temperature, barometric pressure and relative*
10 *humidity and use of alternative fuels, and using a rate of 117 pounds of carbon dioxide per million*
11 *Btu of natural gas fuel and a rate of 161 pounds of carbon dioxide per million Btu of distillate fuel,*
12 *if such fuel use is proposed by the applicant. The council may by rule adjust the rate of pounds of*
13 *carbon dioxide per million Btu for natural gas or distillate fuel. The council may by rule set carbon*
14 *dioxide emissions rates for other fuels.]*

15 *[(K) “Nongenerating facility” means those energy facilities that are defined in ORS 469.300*
16 *(11)(a)(C) and (E) to (I).]*

17 *[(L) “Offset” means an action that will be implemented by the applicant, a third party or through*
18 *the qualified organization to avoid, sequester or displace emissions.]*

19 *[(M) “Offset funds” means the amount of funds determined by the council to satisfy the applicable*
20 *carbon dioxide emissions standard pursuant to paragraph (c)(C) of this subsection.]*

21 *[(N) “Qualified organization” means an entity that:]*

22 *[(i) Is exempt from federal taxation under section 501(c)(3) of the Internal Revenue Code as*
23 *amended and in effect on December 31, 1996;]*

24 *[(ii) Either is incorporated in the State of Oregon or is a foreign corporation authorized to do*
25 *business in the State of Oregon;]*

26 *[(iii) Has in effect articles of incorporation that require that offset funds received pursuant to this*
27 *section are used for offsets that require that decisions on the use of the offset funds are made by a*
28 *decision-making body composed of seven voting members of which three are appointed by the council,*
29 *three are Oregon residents appointed by the Bullitt Foundation or an alternative environmental*
30 *nonprofit organization named by the body, and one is appointed by the applicants for site certificates*
31 *that are subject to paragraph (d) of this subsection and the holders of such site certificates, and that*
32 *require nonvoting membership on the body for holders of site certificates that have provided funds not*
33 *yet disbursed under paragraph (d)(A) of this subsection;]*

34 *[(iv) Has made available on an annual basis, beginning after the first year of operation, a signed*
35 *opinion of an independent certified public accountant stating that the qualified organization’s use of*
36 *funds pursuant to this statute conforms with generally accepted accounting procedures except that the*
37 *qualified organization shall have one year to conform with generally accepted accounting principles in*
38 *the event of a nonconforming audit;]*

39 *[(v) Has to the extent applicable, except for good cause, entered into contracts obligating at least*
40 *60 percent of the offset funds to implement offsets within two years after the commencement of con-*
41 *struction of the facility; and]*

42 *[(vi) Has to the extent applicable, except for good cause, complied with paragraph (d)(A)(i) of this*
43 *subsection.]*

44 **[(3)] (2)** *Except as provided in ORS 469.504 for land use compliance and except for those statutes*
45 *and rules for which the decision on compliance has been delegated by the federal government to a*

1 state agency other than the council, the facility complies with all other Oregon statutes and ad-
2 ministrative rules identified in the project order, as amended, as applicable to the issuance of a site
3 certificate for the proposed facility. If compliance with applicable Oregon statutes and administra-
4 tive rules, other than those involving federally delegated programs, would result in conflicting con-
5 ditions in the site certificate, the council may resolve the conflict consistent with the public interest.
6 A resolution may not result in the waiver of any applicable state statute.

7 [(4)] (3) The facility complies with the statewide planning goals adopted by the Land Conserva-
8 tion and Development Commission.

9 **SECTION 59.** ORS 469.501 is amended to read:

10 469.501. (1) The Energy Facility Siting Council shall adopt standards for the siting, construction,
11 operation and retirement of facilities. The standards may address but need not be limited to the
12 following subjects:

13 (a) The organizational, managerial and technical expertise of the applicant to construct and
14 operate the proposed facility.

15 (b) Seismic hazards.

16 (c) Areas designated for protection by the state or federal government, including but not limited

19 (e) Effects of the facility, taking into account mitigation, on fish and wildlife, including threat-
20 ened and endangered fish, wildlife or plant species.

21 (f) Impacts of the facility on historic, cultural or archaeological resources listed on, or deter-
22 mined by the State Historic Preservation Officer to be eligible for listing on, the National Register
23 of Historic Places or the Oregon State Register of Historic Properties.

24 (g) Protection of public health and safety, including necessary safety devices and procedures.

25 (h) The accumulation, storage, disposal and transportation of nuclear waste.

26 (i) Impacts of the facility on recreation, scenic and aesthetic values.

27 (j) Reduction of solid waste and wastewater generation to the extent reasonably practicable.

28 (k) Ability of the communities in the affected area to provide sewers and sewage treatment,
29 water, storm water drainage, solid waste management, housing, traffic safety, police and fire pro-
30 tection, health care and schools.

31 (L) The need for proposed nongenerating facilities [*as defined in ORS 469.503*], consistent with
32 the state energy policy set forth in ORS 469.010 and 469.310. The council may consider least-cost
33 plans when adopting a need standard or in determining whether an applicable need standard has
34 been met. The council shall not adopt a standard requiring a showing of need or cost-effectiveness
35 for generating facilities [*as defined in ORS 469.503*].

36 (m) Compliance with the statewide planning goals adopted by the Land Conservation and De-
37 velopment Commission as specified by ORS 469.503.

38 (n) Soil protection.

39 [(o) *For energy facilities that emit carbon dioxide, the impacts of those emissions on climate change.*
40 *For fossil-fueled power plants, as defined in ORS 469.503, the council shall apply a standard as pro-*
41 *vided for by ORS 469.503 (2).]*

42 (2) The council may adopt exemptions from any need standard adopted under subsection (1)(L)
43 of this section if the exemption is consistent with the state's energy policy set forth in ORS 469.010
44 and 469.310.

45 (3)(a) The council may issue a site certificate for a facility that does not meet one or more of

1 the applicable standards adopted under subsection (1) of this section if the council determines that
 2 the overall public benefits of the facility outweigh any adverse effects on a resource or interest
 3 protected by the applicable standards the facility does not meet.

4 (b) The council by rule shall specify the criteria by which the council makes the determination
 5 described in paragraph (a) of this subsection.

6 (4) Notwithstanding subsection (1) of this section, the council may not impose any standard de-
 7 veloped under subsection (1)(b), (f), (j) or (k) of this section to approve or deny an application for
 8 an energy facility producing power from wind, solar or geothermal energy. However, the council
 9 may, to the extent it determines appropriate, apply any standards adopted under subsection (1)(b),
 10 (f), (j) or (k) of this section to impose conditions on any site certificate issued for any energy facility.

14 **SECTION 60. (1) Notwithstanding ORS 469.401 (2), any conditions in a site certificate or**
 15 **amended site certificate issued before January 1, 2022, that are conditions related to any**

 17 **469.503 (2019 Edition) or to rules adopted by the Energy Facility Siting Council pursuant to**

20 (2) Any provision in a site certificate or amended site certificate for a generating facility,

23 (3) Any site certificate amendment approved by the council on or after January 1, 2022,
 24 shall remove from the site certificate being amended all conditions and provisions rendered
 25 unenforceable by subsections (1) or (2) of this section or section 61 of this 2020 Act.
 26 Notwithstanding ORS 469.405 or any council rule, the contested case hearing on a site cer-
 27 tificate amendment subject to this subsection may not include a hearing on amendments
 28 necessary to comply with this subsection. The provisions of the council's order relevant to
 29 compliance with this subsection are not subject to judicial review.

30 **SECTION 61. Any provision in a site certificate or amended site certificate that requires**
 31 **the offset of estimated future excess carbon dioxide emissions emitted on or after the ef-**
 32 **fective date of this 2020 Act based on a report of actual plant operations shall cease to be**
 33 **enforceable on January 1, 2021.**

34 **SECTION 62. The Energy Facility Siting Council shall, no later than January 1, 2023,**
 35 **complete rulemaking to amend or repeal any rules adopted by the council relating to the**

 37 **facilities, as those terms are defined in ORS 469.300, necessary to bring the rules of the**

42 (2) On or after the operative date of this section and the amendments to ORS 469.503 by
 43 section 58 of this 2020 Act and in accordance with the provisions of ORS 469.503 (2)(d) (2019
 44 Edition), a qualified organization that, before the operative date of this section and the
 45 amendments to ORS 469.503 by section 58 of this 2020 Act, received payment of offset funds

1 **pursuant to ORS 469.503 (2)(c)(C) (2019 Edition):**

2 (a) **Shall use at least 80 percent of the offset funds for contracts to implement offsets**
3 **and assess offsets for their potential to qualify in, generate credits in or reduce obligations**
4 **in other regulatory settings;**

5 (b) **May use up to 20 percent of the offset funds for monitoring, evaluating, administering**
6 **and enforcing contracts to implement offsets; and**

7 (c) **Shall, at five-year intervals beginning on the date of the receipt of the offset funds**
8 **and ending the year after the year that the qualified organization in no longer involved in**
9 **the investment of offset funds received pursuant to ORS 469.503 (2)(c)(C) (2019 Edition),**
10 **provide the Energy Facility Siting Council with the information the council requests about**
11 **the qualified organization's performance. The council shall evaluate the information re-**
12 **quested and, based on the information, shall make any recommendations to the Legislative**

39 (4) "Average electric generating capacity" means the peak generating capacity of the facility
40 divided by one of the following factors:

41 (a) For wind facilities, 3.00;

42 (b) For geothermal energy facilities, 1.11; or

43 (c) For all other energy facilities, 1.00.

44 (5) "Combustion turbine power plant" means a thermal power plant consisting of one or more
45 fuel-fired combustion turbines and any associated waste heat combined cycle generators.

1 (6) "Construction" means work performed on a site, excluding surveying, exploration or other
2 activities to define or characterize the site, the cost of which exceeds \$250,000.

3 (7) "Council" means the Energy Facility Siting Council established under ORS 469.450.

4 (8) "Department" means the State Department of Energy created under ORS 469.030.

5 (9) "Director" means the Director of the State Department of Energy appointed under ORS
6 469.040.

7 (10) "Electric utility" means persons, regulated electrical companies, people's utility districts,
8 joint operating agencies, electric cooperatives, municipalities or any combination thereof, engaged
9 in or authorized to engage in the business of generating, supplying, transmitting or distributing
10 electric energy.

11 (11)(a) "Energy facility" means any of the following:

12 (A) An electric power generating plant with a nominal electric generating capacity of 25 mega-
13 watts or more, including but not limited to:

14 (i) Thermal power;

15 (ii) Combustion turbine power plant; or

16 (iii) Solar thermal power plant.

17 (B) A nuclear installation as defined in this section.

18 (C) A high voltage transmission line of more than 10 miles in length with a capacity of 230,000
19 volts or more to be constructed in more than one city or county in this state, but excluding:

20 (i) Lines proposed for construction entirely within 500 feet of an existing corridor occupied by
21 high voltage transmission lines with a capacity of 230,000 volts or more;

22 (ii) Lines of 57,000 volts or more that are rebuilt and upgraded to 230,000 volts along the same
23 right of way; and

24 (iii) Associated transmission lines.

25 (D) A solar photovoltaic power generation facility using more than:

26 (i) 160 acres located on high-value farmland as defined in ORS 195.300;

27 (ii) 1,280 acres located on land that is predominantly cultivated or that, if not cultivated, is
28 predominantly composed of soils that are in capability classes I to IV, as specified by the National
29 Cooperative Soil Survey operated by the Natural Resources Conservation Service of the United
30 States Department of Agriculture; or

31 (iii) 1,920 acres located on any other land.

32 (E) A pipeline that is:

33 (i) At least six inches in diameter, and five or more miles in length, used for the transportation
34 of crude petroleum or a derivative thereof, liquefied natural gas, a geothermal energy form in a
35 liquid state or other fossil energy resource, excluding a pipeline conveying natural or synthetic gas;

36 (ii) At least 16 inches in diameter, and five or more miles in length, used for the transportation
37 of natural or synthetic gas, but excluding:

38 (I) A pipeline proposed for construction of which less than five miles of the pipeline is more than
39 50 feet from a public road, as defined in ORS 368.001; or

40 (II) A parallel or upgraded pipeline up to 24 inches in diameter that is constructed within the
41 same right of way as an existing 16-inch or larger pipeline that has a site certificate, if all studies
42 and necessary mitigation conducted for the existing site certificate meet or are updated to meet
43 current site certificate standards; or

44 (iii) At least 16 inches in diameter and five or more miles in length used to carry a geothermal
45 energy form in a gaseous state but excluding a pipeline used to distribute heat within a geothermal

1 heating district established under ORS chapter 523.

2 (F) A synthetic fuel plant which converts a natural resource including, but not limited to, coal
3 or oil to a gas, liquid or solid product intended to be used as a fuel and capable of being burned to
4 produce the equivalent of two billion Btu of heat a day.

5 (G) A plant which converts biomass to a gas, liquid or solid product, or combination of such
6 products, intended to be used as a fuel and if any one of such products is capable of being burned
7 to produce the equivalent of six billion Btu of heat a day.

8 (H) A storage facility for liquefied natural gas constructed after September 29, 1991, that is de-
9 signed to hold at least 70,000 gallons.

10 (I) A surface facility related to an underground gas storage reservoir that, at design injection
11 or withdrawal rates, will receive or deliver more than 50 million cubic feet of natural or synthetic
12 gas per day, or require more than 4,000 horsepower of natural gas compression to operate, but ex-
13 cluding:

14 (i) The underground storage reservoir;

15 (ii) The injection, withdrawal or monitoring wells and individual wellhead equipment; and

16 (iii) An underground gas storage reservoir into which gas is injected solely for testing or res-
17 ervoir maintenance purposes or to facilitate the secondary recovery of oil or other hydrocarbons.

18 (J) An electric power generating plant with an average electric generating capacity of 50
19 megawatts or more if the power is produced from geothermal or wind energy at a single energy fa-
20 cility or within a single energy generation area.

21 (b) "Energy facility" does not include a hydroelectric facility or an energy facility under para-
22 graph (a)(A)(iii) or (D) of this subsection that is established on the site of a decommissioned United
23 States Air Force facility that has adequate transmission capacity to serve the energy facility.

24 (12) "Energy generation area" means an area within which the effects of two or more small
25 generating plants may accumulate so the small generating plants have effects of a magnitude similar
26 to a single generating plant of 35 megawatts average electric generating capacity or more. An "en-
27 ergy generation area" for facilities using a geothermal resource and covered by a unit agreement,
28 as provided in ORS 522.405 to 522.545 or by federal law, shall be defined in that unit agreement. If
29 no such unit agreement exists, an energy generation area for facilities using a geothermal resource
30 shall be the area that is within two miles, measured from the electrical generating equipment of the
31 facility, of an existing or proposed geothermal electric power generating plant, not including the site
32 of any other such plant not owned or controlled by the same person.

33 (13) "Extraordinary nuclear occurrence" means any event causing a discharge or dispersal of
34 source material, special nuclear material or by-product material as those terms are defined in ORS
35 453.605, from its intended place of confinement off-site, or causing radiation levels off-site, that the
36 United States Nuclear Regulatory Commission or its successor determines to be substantial and to
37 have resulted in or to be likely to result in substantial damages to persons or property off-site.

38 (14) "Facility" means an energy facility together with any related or supporting facilities.

39 **(15) "Generating facility" means those energy facilities that are defined in subsection**
40 **(11)(a)(A), (B) and (D) of this section.**

41 [(15)] **(16) "Geothermal reservoir" means an aquifer or aquifers containing a common geothermal**
42 **fluid.**

43 [(16)] **(17) "Local government" means a city or county.**

44 [(17)] **(18) "Nominal electric generating capacity" means the maximum net electric power output**
45 **of an energy facility based on the average temperature, barometric pressure and relative humidity**

1 at the site during the times of the year when the facility is intended to operate.

2 **(19) “Nongenerating facility” means those energy facilities that are defined in subsection**
3 **(11)(a)(C) and (E) to (I) of this section.**

4 [(18)] **(20) “Nuclear incident” means any occurrence, including an extraordinary nuclear occur-**
5 **rence, that results in bodily injury, sickness, disease, death, loss of or damage to property or loss**
6 **of use of property due to the radioactive, toxic, explosive or other hazardous properties of source**
7 **material, special nuclear material or by-product material as those terms are defined in ORS 453.605.**

8 [(19)] **(21) “Nuclear installation” means any power reactor, nuclear fuel fabrication plant, nu-**
9 **clear fuel reprocessing plant, waste disposal facility for radioactive waste, and any facility handling**
10 **that quantity of fissionable materials sufficient to form a critical mass. “Nuclear installation” does**
11 **not include any such facilities that are part of a thermal power plant.**

12 [(20)] **(22) “Nuclear power plant” means an electrical or any other facility using nuclear energy**
13 **with a nominal electric generating capacity of 25 megawatts or more, for generation and distribution**
14 **of electricity, and associated transmission lines.**

15 [(21)] **(23) “Person” means an individual, partnership, joint venture, private or public corpo-**
16 **ration, association, firm, public service company, political subdivision, municipal corporation, gov-**
17 **ernment agency, people’s utility district, or any other entity, public or private, however organized.**

18 [(22)] **(24) “Project order” means the order, including any amendments, issued by the State De-**
19 **partment of Energy under ORS 469.330.**

20 [(23)(a)] **(25)(a) “Radioactive waste” means all material which is discarded, unwanted or has no**
21 **present lawful economic use, and contains mined or refined naturally occurring isotopes, accelerator**
22 **produced isotopes and by-product material, source material or special nuclear material as those**
23 **terms are defined in ORS 453.605. The term does not include those radioactive materials identified**
24 **in OAR 345-50-020, 345-50-025 and 345-50-035, adopted by the council on December 12, 1978, and re-**
25 **vised periodically for the purpose of adding additional isotopes which are not referred to in OAR**
26 **345-50 as presenting no significant danger to the public health and safety.**

27 (b) Notwithstanding paragraph (a) of this subsection, “radioactive waste” does not include ura-
28 nium mine overburden or uranium mill tailings, mill wastes or mill by-product materials as those
29 terms are defined in Title 42, United States Code, section 2014, on June 25, 1979.

30 [(24)] **(26) “Related or supporting facilities” means any structure, proposed by the applicant, to**
31 **be constructed or substantially modified in connection with the construction of an energy facility,**
32 **including associated transmission lines, reservoirs, storage facilities, intake structures, road and rail**
33 **access, pipelines, barge basins, office or public buildings, and commercial and industrial structures.**
34 **“Related or supporting facilities” does not include geothermal or underground gas storage reser-**
35 **voirs, production, injection or monitoring wells or wellhead equipment or pumps.**

36 [(25)] **(27) “Site” means any proposed location of an energy facility and related or supporting**
37 **facilities.**

38 [(26)] **(28) “Site certificate” means the binding agreement between the State of Oregon and the**
39 **applicant, authorizing the applicant to construct and operate a facility on an approved site, incor-**
40 **porating all conditions imposed by the council on the applicant.**

41 [(27)] **(29) “Thermal power plant” means an electrical facility using any source of thermal en-**
42 **ergy with a nominal electric generating capacity of 25 megawatts or more, for generation and dis-**
43 **tribution of electricity, and associated transmission lines, including but not limited to a**
44 **nuclear-fueled, geothermal-fueled or fossil-fueled power plant, but not including a portable power**
45 **plant the principal use of which is to supply power in emergencies. “Thermal power plant” includes**

1 a nuclear-fueled thermal power plant that has ceased to operate.

2 [(28)] (30) "Transportation" means the transport within the borders of the State of Oregon of
3 radioactive material destined for or derived from any location.

4 [(29)] (31) "Underground gas storage reservoir" means any subsurface sand, strata, formation,
5 aquifer, cavern or void, whether natural or artificially created, suitable for the injection, storage
6 and withdrawal of natural gas or other gaseous substances. "Underground gas storage reservoir"
7 includes a pool as defined in ORS 520.005.

8 [(30)] (32) "Utility" includes:

9 (a) A person, a regulated electrical company, a people's utility district, a joint operating agency,
10 an electric cooperative, municipality or any combination thereof, engaged in or authorized to engage
11 in the business of generating, transmitting or distributing electric energy;

12 (b) A person or public agency generating electric energy from an energy facility for its own
13 consumption; and

14 (c) A person engaged in this state in the transmission or distribution of natural or synthetic gas.

15 [(31)] (33) "Waste disposal facility" means a geographical site in or upon which radioactive
16 waste is held or placed but does not include a site at which radioactive waste used or generated
17 pursuant to a license granted under ORS 453.635 is stored temporarily, a site of a thermal power
18 plant used for the temporary storage of radioactive waste from that plant for which a site certificate
19 has been issued pursuant to this chapter or a site used for temporary storage of radioactive waste
20 from a reactor operated by a college, university or graduate center for research purposes and not
21 connected to the Northwest Power Grid. As used in this subsection, "temporary storage" includes
22 storage of radioactive waste on the site of a nuclear-fueled thermal power plant for which a site
23 certificate has been issued until a permanent storage site is available by the federal government.

24 **SECTION 67.** ORS 469.310 is amended to read:

25 469.310. In the interests of the public health and the welfare of the people of this state, it is the
26 declared public policy of this state that the siting, construction and operation of energy facilities
27 shall be accomplished in a manner consistent with protection of the public health and safety and in
28 compliance with the energy policy and air, water, solid waste, land use and other environmental
29 protection policies of this state. It is, therefore, the purpose of ORS 469.300 to 469.563, 469.590 to
30 469.619, 469.930 and 469.992 to exercise the jurisdiction of the State of Oregon to the maximum ex-
31 tent permitted by the United States Constitution and to establish in cooperation with the federal
32 government a comprehensive system for the siting, monitoring and regulating of the location, con-
33 struction and operation of all energy facilities in this state. It is furthermore the policy of this state,
34 notwithstanding ORS 469.010 (2)(f) and the definition of cost-effective in ORS 469.020, that the need
35 for new generating facilities[, *as defined in ORS 469.503,*] is sufficiently addressed by reliance on
36 competition in the market rather than by consideration of cost-effectiveness and shall not be a
37 matter requiring determination by the Energy Facility Siting Council in the siting of a generating
38 facility[, *as defined in ORS 469.503*].

39 **SECTION 68.** ORS 469.373 is amended to read:

40 469.373. (1) Notwithstanding the expedited review process established pursuant to ORS 469.370,
41 an applicant may apply under the provisions of this section for expedited review of an application
42 for a site certificate for an energy facility if the energy facility:

43 (a) Is a combustion turbine energy facility fueled by natural gas or is a reciprocating engine
44 fueled by natural gas, including an energy facility that uses petroleum distillate fuels for backup
45 power generation;

1 (b) Is a permitted or conditional use allowed under an applicable local acknowledged compre-
2 hensive plan, land use regulation or federal land use plan, and is located:

3 (A) At or adjacent to an existing energy facility; or

4 (B)(i) At, adjacent to or in close proximity to an existing industrial use; and

5 (ii) In an area currently zoned or designated for industrial use;

6 (c)(A) Requires no more than three miles of associated transmission lines or three miles of new
7 natural gas pipelines outside of existing rights of way for transmission lines or natural gas pipelines;
8 or

9 (B) Imposes, in the determination of the Energy Facility Siting Council, no significant impact in
10 the locating of associated transmission lines or new natural gas pipelines outside of existing rights
11 of way;

12 (d) Requires no new water right or water right transfer; **and**

13 *[(e) Provides funds to a qualified organization in an amount determined by the council to be suf-*
14 *ficient to produce any required reduction in emissions as specified in ORS 469.503 (2)(c)(C) and in rules*
15 *adopted under ORS 469.503 for the total carbon dioxide emissions produced by the energy facility for*
16 *the life of the energy facility; and]*

17 *[(f)(A)]* (e)(A) Discharges process wastewater to a wastewater treatment facility that has an
18 existing National Pollutant Discharge Elimination System permit, can obtain an industrial pretreat-
19 ment permit, if needed, within the expedited review process time frame and has written confirmation
20 from the wastewater facility permit holder that the additional wastewater load will be accommo-
21 dated by the facility without resulting in a significant thermal increase in the facility effluent or
22 without requiring any changes to the wastewater facility National Pollutant Discharge Elimination
23 System permit;

24 (B) Plans to discharge process wastewater to a wastewater treatment facility owned by a mu-
25 nicipal corporation that will accommodate the wastewater from the energy facility and supplies ev-
26 idence from the municipal corporation that:

27 (i) The municipal corporation has included, or intends to include, the process wastewater load
28 from the energy facility in an application for a National Pollutant Discharge Elimination System
29 permit; and

30 (ii) All conditions required of the energy facility to allow the discharge of process wastewater
31 from the energy facility will be satisfied; or

32 (C) Obtains a National Pollutant Discharge Elimination System or water pollution control fa-
33 cility permit for process wastewater disposal, supplies evidence to support a finding that the dis-
34 charge can likely be permitted within the expedited review process time frame and that the

38 (ii) A change in any effluent limit or discharge location under an existing National Pollutant
39 Discharge Elimination System or water pollution control facility permit.

40 (2) An applicant seeking expedited review under this section shall submit documentation to the
41 State Department of Energy, prior to the submission of an application for a site certificate, that
42 demonstrates that the energy facility meets the qualifications set forth in subsection (1) of this
43 section. The department shall determine, within 14 days of receipt of the documentation, on a pre-
44 liminary, nonbinding basis, whether the energy facility qualifies for expedited review.

45 (3) If the department determines that the energy facility preliminarily qualifies for expedited

1 review, the applicant may submit an application for expedited review. Within 30 days after the date
 2 that the application for expedited review is submitted, the department shall determine whether the

30 (a) A description of the proposed energy facility;

31 (b) A list of the permits, licenses and certificates that are addressed in the application and that

44 (c) The requirements of ORS 469.503 [(3)] (2); and

45 (d) The requirements of ORS 469.504 (1)(b).

1 (7) Following submission of an application for a site certificate, the council shall hold a public
2 informational meeting on the application. Following the issuance of the proposed order, the council
3 shall hold at least one public hearing on the application. The public hearing shall be held in the area
4 affected by the energy facility. The council shall mail notice of the hearing at least 20 days prior
5 to the hearing. The notice shall comply with the notice requirements of ORS 197.763 (2) and shall
6 include, but need not be limited to, the following:

7 (a) A description of the energy facility and the general location of the energy facility;

8 (b) The name of a department representative to contact and the telephone number at which
9 people may obtain additional information;

10 (c) A statement that copies of the application and proposed order are available for inspection
11 at no cost and will be provided at reasonable cost; and

12 (d) A statement that the record for public comment on the application will close at the conclu-

18 additional written evidence, arguments or testimony regarding the application. In the alternative,

20 application. If the applicant requests an opportunity to present written evidence, arguments or tes-
21 timony, the council shall leave the record open for that purpose only for a period not to exceed 14
22 days after the date of the hearing. Following the close of the record, the department shall prepare
23 a draft final order for the council. If the applicant requests a contested case hearing, the council
24 may grant the request if the applicant has shown good cause for a contested case hearing. If a re-
25 quest for a contested case hearing is granted, subsections (9) to (11) of this section do not apply,

28 (9) The council shall make its decision based on the record and the draft final order prepared
29 by the department. The council shall, within six months of the date that the application is deemed

34 (d) Return the application to the site certification process required by ORS 469.320.

35 (10) If the application is granted, the council shall issue a site certificate pursuant to ORS
36 469.401 and 469.402. Notwithstanding subsection (6) of this section, the council may impose condi-
37 tions based on standards adopted under ORS 469.501 (1)(b), (f) and (i) to (k), but may not deny an
38 application based on those standards.

39 (11) Judicial review of the approval or rejection of a site certificate by the council under this
40 section shall be as provided in ORS 469.403.

41 **SECTION 69.** ORS 469.405 is amended to read:

42 469.405. (1) A site certificate may be amended with the approval of the Energy Facility Siting
43 Council. The council may establish by rule the type of amendment that must be considered in a
44 contested case proceeding. Judicial review of an amendment to a site certificate shall be as provided
45 in ORS 469.403.

1 (2) Notwithstanding ORS 34.020 or 197.825, or any other provision of law, the land use approval
 2 by an affected local government of a proposed amendment to a facility and the recommendation of
 3 the special advisory group of applicable substantive criteria shall be subject to judicial review only
 4 as provided in ORS 469.403. If the applicant elects to show compliance with the statewide planning
 5 goals by demonstrating that the facility has received local land use approval, the provisions of this
 6 section shall apply only to proposed projects for which the land use approval by the local govern-

9 (3) An amendment to a site certificate is not required for a pipeline less than 16 inches in di-

 12 face facility related to an underground gas storage reservoir or to a council certified gas pipeline,

25 **SECTION 70.** ORS 469.407 is amended to read:

26 469.407. (1) A recipient may by amendment of its application for a site certificate or by amend-
 27 ment of its site certificate increase the capacity of the facility if the Energy Facility Siting Council
 28 finds that:

29 (a) The facility will satisfy the conditions of the 500-megawatt exemption, unless modified by the
 30 council;

31 (b) The enlarged facility does not exceed 500 megawatts and meets the applicable carbon dioxide
 32 standard provided for in ORS 469.503 (2) (2019 Edition) for any increase in capacity beyond the
 33 capacity of the 500-megawatt exemption; and

35 (2) A recipient is deemed to meet any applicable need standard and carbon dioxide emissions

 37 cipient satisfies the conditions of the 500-megawatt exemption, unless the council modifies the con-
 38 ditions.

39 (3) As used in this section:

40 (a) "Recipient" means any base load gas plant, as defined in ORS 469.503 (2019 Edition), de-
 41 termined by the council to have the lowest net monetized air emissions among the applicants par-
 42 ticipating in a contested case proceeding.

43 (b) "500-megawatt exemption" means the council order in which a recipient was determined to
 44 have the lowest net monetized air emissions.

45 **SECTION 71.** ORS 469.504 is amended to read:

1 469.504. (1) A proposed facility shall be found in compliance with the statewide planning goals
2 under ORS 469.503 [(4)] (3) if:

3 (a) The facility has received local land use approval under the acknowledged comprehensive
4 plan and land use regulations of the affected local government; or

5 (b) The Energy Facility Siting Council determines that:

6 (A) The facility complies with applicable substantive criteria from the affected local
7 government's acknowledged comprehensive plan and land use regulations that are required by the
8 statewide planning goals and in effect on the date the application is submitted, and with any Land
9 Conservation and Development Commission administrative rules and goals and any land use statutes
10 that apply directly to the facility under ORS 197.646;

11 (B) For an energy facility or a related or supporting facility that must be evaluated against the
12 applicable substantive criteria pursuant to subsection (5) of this section, that the proposed facility
13 does not comply with one or more of the applicable substantive criteria but does otherwise comply
14 with the applicable statewide planning goals, or that an exception to any applicable statewide
15 planning goal is justified under subsection (2) of this section; or

16 (C) For a facility that the council elects to evaluate against the statewide planning goals pur-
17 suant to subsection (5) of this section, that the proposed facility complies with the applicable state-
18 wide planning goals or that an exception to any applicable statewide planning goal is justified under
19 subsection (2) of this section.

20 (2) The council may find goal compliance for a facility that does not otherwise comply with one
21 or more statewide planning goals by taking an exception to the applicable goal. Notwithstanding
22 the requirements of ORS 197.732, the statewide planning goal pertaining to the exception process
23 or any rules of the Land Conservation and Development Commission pertaining to an exception
24 process goal, the council may take an exception to a goal if the council finds:

25 (a) The land subject to the exception is physically developed to the extent that the land is no
26 longer available for uses allowed by the applicable goal;

27 (b) The land subject to the exception is irrevocably committed as described by the rules of the
28 Land Conservation and Development Commission to uses not allowed by the applicable goal because
29 existing adjacent uses and other relevant factors make uses allowed by the applicable goal imprac-
30 ticable; or

31 (c) The following standards are met:

32 (A) Reasons justify why the state policy embodied in the applicable goal should not apply;

33 (B) The significant environmental, economic, social and energy consequences anticipated as a
34 result of the proposed facility have been identified and adverse impacts will be mitigated in ac-
35 cordance with rules of the council applicable to the siting of the proposed facility; and

36 (C) The proposed facility is compatible with other adjacent uses or will be made compatible
37 through measures designed to reduce adverse impacts.

38 (3) If compliance with applicable substantive local criteria and applicable statutes and state
39 administrative rules would result in conflicting conditions in the site certificate or amended site
40 certificate, the council shall resolve the conflict consistent with the public interest. A resolution
41 may not result in a waiver of any applicable state statute.

42 (4) An applicant for a site certificate shall elect whether to demonstrate compliance with the
43 statewide planning goals under subsection (1)(a) or (b) of this section. The applicant shall make the
44 election on or before the date specified by the council by rule.

45 (5) Upon request by the State Department of Energy, the special advisory group established

1 under ORS 469.480 shall recommend to the council, within the time stated in the request, the ap-
 2 plicable substantive criteria under subsection (1)(b)(A) of this section. If the special advisory group
 3 does not recommend applicable substantive criteria within the time established in the department's
 4 request, the council may either determine and apply the applicable substantive criteria under sub-
 5 section (1)(b) of this section or determine compliance with the statewide planning goals under sub-
 6 section (1)(b)(B) or (C) of this section. If the special advisory group recommends applicable
 7 substantive criteria for an energy facility described in ORS 469.300 or a related or supporting fa-
 8 cility that does not pass through more than one local government jurisdiction or more than three
 9 zones in any one jurisdiction, the council shall apply the criteria recommended by the special advi-
 10 sory group. If the special advisory group recommends applicable substantive criteria for an energy
 11 facility as defined in ORS 469.300 (1)(a)(C) to (E) or a related or supporting facility that passes
 12 through more than one jurisdiction or more than three zones in any one jurisdiction, the council
 13 shall review the recommended criteria and determine whether to evaluate the proposed facility
 14 against the applicable substantive criteria recommended by the special advisory group, against the
 15 statewide planning goals or against a combination of the applicable substantive criteria and state-
 16 wide planning goals. In making its determination, the council shall consult with the special advisory
 17 group and shall consider:

18 (a) The number of jurisdictions and zones in question;

19 (b) The degree to which the applicable substantive criteria reflect local government consider-
 20 ation of energy facilities in the planning process; and

21 (c) The level of consistency of the applicable substantive criteria from the various zones and
 22 jurisdictions.

23 (6) The council is not subject to ORS 197.180 and a state agency may not require an applicant
 24 for a site certificate to comply with any rules or programs adopted under ORS 197.180.

25 (7) On or before its next periodic review, each affected local government shall amend its com-
 26 prehensive plan and land use regulations as necessary to reflect the decision of the council per-
 27 taining to a site certificate or amended site certificate.

28 (8) Notwithstanding ORS 34.020 or 197.825 or any other provision of law, the affected local
 29 government's land use approval of a proposed facility under subsection (1)(a) of this section and the
 30 special advisory group's recommendation of applicable substantive criteria under subsection (5) of
 31 this section shall be subject to judicial review only as provided in ORS 469.403. If the applicant
 32 elects to comply with subsection (1)(a) of this section, the provisions of this subsection shall apply
 33 only to proposed projects for which the land use approval of the local government occurs after the
 34 date a notice of intent or an application for expedited processing is submitted to the State Depart-

36 (9) The State Department of Energy, in cooperation with other state agencies, shall provide, to
 37 the extent possible, technical assistance and information about the siting process to local govern-
 38 ments that request such assistance or that anticipate having a facility proposed in their jurisdiction.

40 469.505. (1) In making a determination regarding compliance with statutes, rules and ordinances

13 **to 469.563.**

14 **SECTION 72b. (1) The Legislative Assembly finds and declares that greenhouse gas**
15 **emissions from energy facilities subject to site certificates or amended site certificates are**
16 **a significant threat to the public health, safety or the environment.**

17 (2) Notwithstanding ORS 469.401 (2), a facility with a site certificate or amended site
18 certificate in effect on or after the effective date of this 2020 Act shall comply with sections
19 4 to 32 of this 2020 Act to the extent that compliance by the facility is required under
20 sections 4 to 32 of this 2020 Act.

21
22 **REGULATION OF LANDFILL METHANE EMISSIONS**

23
24 **SECTION 73. Section 74 of this 2020 Act is added to and made a part of ORS chapter**
25 **468A.**

26 **SECTION 74. (1) As used in this section:**

27 (a) "Anthropogenic greenhouse gas emissions" means greenhouse gas emissions that are
28 not biogenic emissions.

29 (b) "Carbon dioxide equivalent" means the amount of carbon dioxide by weight that would
30 produce the same global warming impact as a given weight of another greenhouse gas, based
31 on considerations including but not limited to the best available science, including informa-
32 tion from the Intergovernmental Panel on Climate Change.

33 (c) "Hazardous waste" has the meaning given that term in ORS 466.005.

34 (d) "Land disposal site" has the meaning given that term in ORS 459.005.

35 (e) "Landfill" has the meaning given that term in ORS 459.005.

36 (f) "Solid waste" has the meaning given that term in ORS 459.005.

37 (2) It is the intent of the Legislative Assembly that the standards and requirements
38 adopted by rule under this section be at least as stringent as the most stringent standards
39 and requirements for reducing methane gas emissions from landfills adopted among the
40 states having a boundary with Oregon.

41 (3) The Environmental Quality Commission shall adopt by rule standards and require-
42 ments for reducing methane gas emissions from landfills.

43 (4) The following landfills are exempt from standards and requirements adopted by rule
44 under this section:

45 (a) Landfills that emit less than 25,000 metric tons of carbon dioxide equivalent in

1 anthropogenic greenhouse gas emissions annually, as reported under ORS 468A.280.

2 (b) Landfills that receive only hazardous waste.

3 (c) Landfills that receive only waste from building demolition or construction.

4 (d) Land disposal sites that are closed as of the effective date of this 2020 Act and are
5 no longer receiving solid waste, are maintained in compliance with ORS 459.268 and have less
6 than 450,000 metric tons of waste in place.

7 (5) Rules adopted under this section shall include but need not be limited to:

8 (a) Reporting requirements related to waste in place, calculated landfill gas heat input
9 capacity, and landfill surface emissions monitoring.

10 (b) Methane gas collection and control system requirements for landfills with reported
11 calculated landfill gas heat input capacity exceeding 3 million British thermal units per hour.

12 (c) Standards and requirements for methane surface emissions, monitoring and correc-
13 tive actions.

14 (d) Alternative compliance measures and methods that may be applied for certain land-
15 fills on a case-by-case basis.

16 (e) Standards and requirements for records retention, landfill closure notification,
17 methane gas collection and control device removal or modification and annual operating re-
18 ports.

19 **SECTION 75.** The Environmental Quality Commission shall adopt rules under section 74
20 of this 2020 Act in time for the rules to become operative no later than July 1, 2022.

21
22 **REGULATION OF HYDROFLUOROCARBONS**

23
24 **SECTION 76.** Section 77 of this 2020 Act is added to and made a part of ORS chapter 468.

25 **SECTION 77.** (1) As used in this section:

26 (a) "Class I substance" means a substance listed as a Class I substance in:

27 (A) 42 U.S.C. 7671a(a), as that section read on November 15, 1990; or

28 (B) Appendix A of 40 C.F.R. part 82, subpart A, as that appendix read on January 3, 2017.

29 (b) "Class II substance" means a substance listed as a Class II substance in:

30 (A) 42 U.S.C. 7671a(b), as that section read on November 15, 1990; or

31 (B) Appendix B of 40 C.F.R. part 82, subpart A, as that appendix read on January 3, 2017.

32 (c) "Greenhouse gas" has the meaning given that term in ORS 468A.280.

33 (d) "Hydrofluorocarbons" means a class of greenhouse gases that are saturated organic
34 compounds containing hydrogen, fluorine and carbon.

35 (e) "Retrofit" has the meaning given that term as defined in 40 C.F.R. 82.152, as that
36 section read on January 3, 2017.

37 (f)(A) "Substitute" includes a chemical, product substitute or alternative manufacturing
38 process, whether existing or new, that is used to perform a function previously performed
39 by a class I substance or class II substance and any substitute subsequently adopted to
40 perform that function, including, but not limited to, hydrofluorocarbons.

41 (B) "Substitute" does not include 2-BTP or any compound as applied to its use in aero-
42 space fire extinguishing systems.

43 (2)(a) The Environmental Quality Commission shall adopt rules prohibiting the sale,
44 lease, rent, installation, or other actions causing equipment or products to enter into com-
45 merce in Oregon if that equipment or product consists of, uses, or will use a substitute, as

1 set forth in appendices U and V of 40 C.F.R. part 82, subpart G, as those laws read on Jan-
2 uary 3, 2017, for the applications or end uses restricted by appendix U or V of 40 C.F.R. part
3 82, subpart G, as those laws read on January 3, 2017. Except where existing equipment is
4 retrofit, nothing in this section requires a person that acquired a restricted product or
5 equipment prior to the effective date of the restrictions in rules adopted pursuant to this
6 section to cease use of that product or equipment.

7 (b) The commission may adopt additional prohibitions of the sale, lease, rent or installa-
8 tion of, or of other actions that cause equipment or products to enter into commerce in
9 Oregon that contain hydrofluorocarbons or other substitutes if the commission determines
10 that the equipment or products pose a risk to human health or the environment and that a
11 substitute is currently or potentially available.

12 (3) Rules adopted by the commission under this section:

13 (a) May require regular reporting by manufacturers, importers and distributors of
14 equipment and products containing hydrofluorocarbons or other substitutes.

15 (b) May require the labeling and disclosure of equipment and products containing
16 hydrofluorocarbons or other substitutes.

17 (c) May include rules necessary for the administration, implementation, and enforcement
18 of this section.

19 (4) Where feasible and appropriate, the commission shall endeavor to adopt rules under
20 this section that are consistent with the regulatory standards, exemptions, reporting obli-
21 gations, disclosure requirements and other compliance requirements of other states or the
22 federal government, if those jurisdictions have adopted restrictions on the use of
23 hydrofluorocarbons and other substitutes.

24 **SECTION 78.** Section 79 of this 2020 Act is added to and made a part of ORS chapter 455.

25 **SECTION 79.** The Department of Consumer and Business Services shall adopt rules to
26 amend the state building code as necessary to permit, in equipment or products, the use of
27 hydrofluorocarbons or other substitutes that are not prohibited by regulations adopted by
28 rule by the Environmental Quality Commission under section 77 of this 2020 Act.

29
30 **OREGON GLOBAL WARMING COMMISSION ABOLISHED**

31
32 **SECTION 80.** (1) The Oregon Global Warming Commission is abolished. On the operative
33 date of this section, the tenure of office of the members of the Oregon Global Warming
34 Commission ceases.

35 (2) ORS 468A.200, 468A.210, 468A.215, 468A.220, 468A.225, 468A.230, 468A.235, 468A.240,
36 468A.245, 468A.250, 468A.255 and 468A.260 are repealed.

38 **(Amendments to Statutes)**

40 **SECTION 81.** ORS 352.823 is amended to read:

41 352.823. (1) The Oregon Climate Change Research Institute is established at Oregon State Uni-
42 versity. In administering the institute, Oregon State University may seek the cooperation of other
43 public universities listed in ORS 352.002.

44 (2) The purpose of the Oregon Climate Change Research Institute is to:

45 (a) Facilitate research by faculty at public universities listed in ORS 352.002 on climate change

1 and its effects on natural and human systems in Oregon;

2 (b) Serve as a clearinghouse for climate change information;

3 (c) Provide climate change information to the public in integrated and accessible formats; **and**

4 [(d) *Support the Oregon Global Warming Commission in developing strategies to prepare for and*
5 *to mitigate the effects of climate change on natural and human systems; and*]

6 [(e)] (d) Provide technical assistance to local governments to assist them in developing climate
7 change policies, practices and programs.

8 (3) The Oregon Climate Change Research Institute shall assess, at least once each biennium, the
9 state of climate change science, including biological, physical and social science, as it relates to
10 Oregon and the likely effects of climate change on the state. The institute shall submit the assess-
11 ment to the Legislative Assembly in the manner provided in ORS 192.245 and to the Governor.

12 (4) State agencies may contract with the Oregon Climate Change Research Institute to fulfill
13 agency needs regarding the collection, storage, integration, analysis, dissemination and monitoring
14 of climate change information, research and training.

15 **SECTION 82.** ORS 468A.265 is amended to read:

16 468A.265. As used in ORS 468A.265 to 468A.277:

17 (1) "Biodiesel" means a motor vehicle fuel consisting of mono-alkyl esters of long chain fatty
18 acids derived from vegetable oils, animal fats or other nonpetroleum resources, not including palm
19 oil.

20 (2) "Clean fuels program" means the program adopted by rule by the Environmental Quality
21 Commission under ORS 468A.266 (1)(b).

22 (3) "Compliance period" means the calendar year during which a regulated party must demon-
23 strate compliance with the low carbon fuel standards through participation in the clean fuels pro-
24 gram.

25 (4) "Credit" means a unit of measure generated when a fuel with a carbon intensity that is less
26 than the applicable low carbon fuel standard is produced, imported or dispensed for use in Oregon,
27 such that one credit is equal to one metric ton of carbon dioxide equivalent.

28 (5) "Credit aggregator" means a person who voluntarily registers to participate in the clean
29 fuels program to facilitate credit generation on behalf of a credit generator and to trade credits with
30 regulated parties, credit generators and other credit aggregators.

31 (6) "Credit generator" means a person eligible to generate credits by providing fuels for use in
32 Oregon with carbon intensities less than the applicable low carbon fuel standard.

33 (7) "Deferral" means a delay or change in the applicability of a scheduled applicable low carbon
34 fuel standard for a period of time, accomplished pursuant to an order issued under ORS 468A.273
35 or 468A.274.

36 (8) "Deficit" means a unit of measure generated when a fuel with a carbon intensity that is more
37 than the applicable low carbon fuel standard is produced, imported or dispensed for use in Oregon,
38 such that one deficit is equal to one metric ton of carbon dioxide equivalent.

39 (9) "Greenhouse gas" [*has the meaning given that term in ORS 468A.210*] **includes, but is not**
40 **limited to, carbon dioxide, methane, nitrous oxide, hydrofluorocarbons, perfluorocarbons,**
41 **sulfur hexafluoride and nitrogen trifluoride.**

42 (10) "Low carbon fuel standard" means a standard adopted by the commission by rule under
43 ORS 468A.266 for the reduction of greenhouse gas emissions, on average, per unit of fuel energy.

44 (11) "Motor vehicle" has the meaning given that term in ORS 801.360.

45 (12) "Regulated party" means a person responsible for complying with the low carbon fuel

1 standards.

2 (13) "Small deficit" means a net deficit balance at the end of a compliance period, after retire-
3 ment of all credits held by a regulated party, that does not exceed a percentage set by the com-
4 mission by rule of the total number of deficits that the regulated party generated for a compliance
5 period and that may not be greater than 10 percent of the total number of deficits that the regulated
6 party generated for a compliance period.

7 **SECTION 83.** ORS 468A.279 is amended to read:

8 468A.279. (1) As used in this section:

9 (a) "Greenhouse gas" has the meaning given that term in ORS [468A.210] **468A.265.**

10 (b) "Motor vehicle" has the meaning given that term in ORS 801.360.

11 (2) The Environmental Quality Commission may adopt by rule standards and requirements de-
12 scribed in this section to reduce greenhouse gas emissions.

13 (3)(a) The commission may adopt requirements to prevent the tampering, alteration and modifi-
14 cation of the original design or performance of motor vehicle pollution control systems.

15 (b) Before adopting requirements under this section, the commission shall consider the anti-
16 tampering requirements and exemptions of the State of California.

17 (4) The commission may adopt requirements for motor vehicle service providers to check and
18 inflate tire pressure according to the tire manufacturer's or motor vehicle manufacturer's recom-
19 mended specifications, provided that the requirements:

20 (a) Do not apply when the primary purpose of the motor vehicle service is fueling vehicles; and

21 (b) Do not require motor vehicle service providers to purchase equipment to check and inflate
22 tire pressure.

23 (5) The commission may adopt restrictions on engine use by commercial ships while at port, and
24 requirements that ports provide alternatives to engine use such as electric power, provided that:

25 (a) Engine use shall be allowed when necessary to power mechanical or electrical operations if
26 alternatives are not reasonably available;

27 (b) Engine use shall be allowed when necessary for reasonable periods due to emergencies and
28 other considerations as determined by the commission; and

29 (c) The requirements must be developed in consultation with representatives of Oregon ports
30 and take into account operational considerations, operational agreements, international protocols
31 and limitations, the ability to fund the purchase and use of electric power equipment and the po-
32 tential effect of the requirements on competition with other ports.

33 (6) In adopting rules under this section, the commission shall evaluate:

34 (a) Safety, feasibility, net reduction of greenhouse gas emissions and cost-effectiveness;

35 (b) Potential adverse impacts to public health and the environment, including but not limited to
36 air quality, water quality and the generation and disposal of waste in this state;

37 (c) Flexible implementation approaches to minimize compliance costs; and

38 (d) Technical and economic studies of comparable greenhouse gas emissions reduction measures
39 implemented in other states and any other studies as determined by the commission.

40 (7) The provisions of this section do not apply to:

41 (a) Motor vehicles registered as farm vehicles under the provisions of ORS 805.300.

42 (b) Farm tractors, as defined in ORS 801.265.

43 (c) Implements of husbandry, as defined in ORS 801.310.

44 (d) Motor trucks, as defined in ORS 801.355, used primarily to transport logs.

45 **SECTION 84.** ORS 757.528 is amended to read:

1 757.528. (1) Unless modified by rule by the State Department of Energy as provided in this sec-
2 tion, the greenhouse gas emissions standard that applies to consumer-owned utilities is 1,100 pounds
3 of greenhouse gases per megawatt-hour for a generating facility.

4 (2) Unless modified pursuant to subsection (4) of this section, the greenhouse gas emissions
5 standard includes only carbon dioxide emissions.

6 (3) For purposes of applying the emissions standard to cogeneration facilities, the department
7 shall establish an output-based methodology to ensure that the calculation of emissions of
8 greenhouse gases for cogeneration facilities recognizes the total usable energy output of the process
9 and includes all greenhouse gases emitted by the facility in the production of both electrical and
10 thermal energy.

11 (4) The department shall review the greenhouse gas emissions standard established under this
12 section no more than once every three years. After public notice and hearing, and consultation with
13 the Public Utility Commission, the department may:

14 (a) Modify the emissions standard to include other greenhouse gases as defined in ORS
15 [468A.210] **468A.265**, with the other greenhouse gases expressed as their carbon dioxide equivalent;
16 and

17 (b) Modify the emissions standard based upon current information on the rate of greenhouse gas
18 emissions from a commercially available combined-cycle natural gas generating facility that:

19 (A) Employs a combination of one or more gas turbines and one or more steam turbines and
20 produces electricity in the steam turbines from waste heat produced by the gas turbines;

21 (B) Has a heat rate at high elevation within the boundaries of the Western Electricity Coordi-
22 nating Council; and

23 (C) Has a heat rate at ambient temperatures when operating during the hottest day of the year.

24 (5) In modifying the greenhouse gas emissions standard, the department shall:

25 (a) Use an output-based methodology to ensure that the calculation of greenhouse gas emissions
26 through cogeneration recognizes the total usable energy output of the process and includes all
27 greenhouse gases emitted by the generating facility in the production of both electrical and thermal
28 energy; and

29 (b) Consider the effects of the emissions standard on system reliability and overall costs to
30 electricity consumers.

31 (6) If upon a review conducted pursuant to subsection (4) of this section, the department deter-
32 mines that a mandatory greenhouse gas emissions limit has been established pursuant to state or
33 federal law, the department shall issue a report to the appropriate legislative committees of the
34 Legislative Assembly stating which portions, if any, of the greenhouse gas emissions standard are
35 no longer necessary as a matter of state law.

41 530.050. Under the authority and direction of the State Board of Forestry except as otherwise
42 provided for the sale of forest products, the State Forester shall manage the lands acquired pursuant
43 to ORS 530.010 to 530.040 so as to secure the greatest permanent value of those lands to the state,
44 and to that end may:

45 (1) Protect the lands from fire, disease and insect pests, cooperate with the counties and with

1 persons owning lands within the state in the protection of the lands and enter into all agreements
2 necessary or convenient for the protection of the lands.

3 (2) Sell forest products from the lands, and execute mining leases and contracts as provided for
4 in ORS 273.551.

6 the State Board of Forestry and the State Forestry Department.

7 (4) Enter into and administer contracts for activities necessary or convenient for the sale of
8 timber under subsection (3) of this section, either separately from or in conjunction with contracts
9 for the sale of timber, including but not limited to activities such as timber harvesting and sorting,
10 transporting, gravel pit development or operation, and road construction, maintenance or improve-
11 ment.

12 (5) Permit the use of the lands for other purposes, including but not limited to forage and browse
13 for domestic livestock, fish and wildlife environment, landscape effect, protection against floods and
14 erosion, recreation, and protection of water supplies when, in the opinion of the board, the use is
15 not detrimental to the best interest of the state.

16 (6) Grant easements, permits and licenses over, through and across the lands. The State Forester
17 may require and collect reasonable fees or charges relating to the location and establishment of
18 easements, permits and licenses granted by the state over the lands. The fees and charges collected
19 shall be used exclusively for the expenses of locating and establishing the easements, permits and
20 licenses under this subsection and shall be placed in the State Forestry Department Account.

21 (7) Require and collect fees or charges for the use of state forest roads. The fees or charges
22 collected shall be used exclusively for purposes of maintenance and improvements of the roads and
23 shall be placed in the State Forestry Department Account.

24 (8) Reforest the lands and cooperate with the counties, and with persons owning timberlands
25 within the state, in the reforestation, and make all agreements necessary or convenient for the
26 reforestation.

27 (9) Require such undertakings as in the opinion of the board are necessary or convenient to
28 secure performance of any contract entered into under the terms of this section or ORS 273.551.

29 (10) Sell rock, sand, gravel, pumice and other such materials from the lands. The sale may be
30 negotiated without bidding, provided the appraised value of the materials does not exceed \$2,500.

31 (11) Enter into agreements, each for not more than 10 years duration, for the production of mi-
32 nor forest products.

33 (12) *[Establish a forestry carbon offset program to]* Market, register, transfer or sell forestry
34 carbon offsets. *[In establishing the program, the forester may:]*

35 *[(a) Execute any contracts or agreements necessary to create opportunities for the creation of*
36 *forestry carbon offsets; and]*

37 *[(b) Negotiate prices that are at, or greater than, fair market value for the transfer or sale of*
38 *forestry carbon offsets.]*

39 (13) Do all things and make all rules, not inconsistent with law, necessary or convenient for the
40 management, protection, utilization and conservation of the lands.

41 **SECTION 84c.** ORS 530.500 is amended to read:

42 530.500. In order to accomplish the purposes of ORS 530.490, the State Forester may:

43 (1) Protect the lands from fire, disease and insect pests, cooperate with the counties and with
44 persons owning lands within the state in the protection of the lands and enter into all agreements
45 necessary or convenient for the protection of the lands.

1 (2) Enter into and administer contracts for the sale of timber from lands owned or managed by
2 the State Board of Forestry and the State Forestry Department.

3 (3) Enter into and administer contracts for activities necessary or convenient for the sale of
4 timber under subsection (2) of this section, either separately from or in conjunction with contracts
5 for the sale of timber, including but not limited to activities such as timber harvesting and sorting,
6 transporting, gravel pit development or operation, and road construction, maintenance or improve-
7 ment.

8 (4) Permit the use of the lands for other purposes, including but not limited to fish and wildlife
9 environment, landscape effect, protection against flood and erosion, recreation and production and

29 **REQUIREMENTS FOR ETHANOL CONTENT IN GASOLINE**

30
31 **SECTION 85.** ORS 646.913 is amended to read:

32 646.913. (1) Except as provided in subsection (4) of this section, a wholesale dealer, retail dealer
33 or nonretail dealer may not sell gasoline or offer gasoline for sale unless the gasoline contains **at**
34 **least** 10 percent denatured fuel ethanol by volume. Gasoline that contains anhydrous ethanol in
35 concentrations *[between 9.2 percent and 10 percent]* **of at least 9.2 percent** by volume complies with
36 the requirement set forth in this subsection.

37 (2) The State Department of Agriculture shall adopt standards for gasoline blended with ethanol
38 that is sold in this state. The standards that the department adopts shall require that the gasoline
39 blended with ethanol:

40 (a) Contains ethanol that is derived from agricultural or woody waste or residue;

41 (b) Complies with the volatility requirements specified in 40 C.F.R. part 80;

42 (c) Complies with ASTM International specification D 4814, Standard Specification for Autom-
43 tive Spark-Ignition Engine Fuel;

44 (d) Is not blended with casinghead gasoline, absorption gasoline, drip gasoline or natural gaso-
45 line after the gasoline has been sold, transferred or otherwise removed from a refinery or terminal;

1 and

2 (e) Contains denatured fuel ethanol that complies with ASTM International specification D 4806,
3 Standard Specification for Denatured Fuel Ethanol for Blending with Gasolines for Use as Automot-
4 tive Spark-Ignition Engine Fuel.

5 (3) The department may review specifications adopted by ASTM International, or equivalent
6 organizations, and federal regulations and revise the standards adopted under this section as nec-
7 essary.

8 (4) A wholesale dealer, retail dealer or nonretail dealer may sell or offer for sale gasoline that
9 is not blended with ethanol if the gasoline has an octane rating, as defined in ORS 646.945, of 91
10 or above or if the gasoline is for use in:

11 (a) An aircraft:

12 (A) With a supplemental type certificate approved by the Federal Aviation Administration that
13 allows the aircraft to use gasoline that is intended for use in motor vehicles; or

14 (B) Issued a type certificate by an aircraft engine manufacturer that allows the aircraft to use
15 gasoline that is intended for use in motor vehicles;

16 (b) An aircraft that has been issued an experimental certificate, as described in 14 C.F.R. 21.191,
17 by the Federal Aviation Administration and for which the manufacturer's specifications require the
18 use of gasoline that is intended for use in motor vehicles;

19 (c) A light-sport aircraft, as defined in 14 C.F.R. 1.1, for which the manufacturer's specifications
20 require the use of gasoline that is intended for use in motor vehicles;

21 (d) A vintage aircraft, as defined by the Oregon Department of Aviation by rule, for which the
22 manufacturer's specifications require the use of gasoline that is intended for use in motor vehicles;

23 (e) An antique vehicle, as defined in ORS 801.125;

24 (f) A Class I all-terrain vehicle, as defined in ORS 801.190;

25 (g) A Class III all-terrain vehicle, as defined in ORS 801.194;

26 (h) A Class IV all-terrain vehicle, as defined in ORS 801.194 (2);

27 (i) A racing activity vehicle, as defined in ORS 801.404;

28 (j) A snowmobile, as defined in ORS 801.490;

29 (k) Tools, including but not limited to lawn mowers, leaf blowers and chain saws; or

30 (L) A watercraft.

32 **LIGHT BULB ENERGY EFFICIENCY STANDARDS**

33
34 **SECTION 86. (1) As used in this section:**

35 (a) **"General service lamp" includes general service incandescent lamps, compact flu-**
36 **orescent lamps, general service light-emitting diode lamps, organic light-emitting diode**
37 **lamps and any other lamps that are used to satisfy lighting applications traditionally served**
38 **by general service incandescent lamps.**

39 (b) **"High CRI fluorescent lamp" means a fluorescent lamp with a color rendering index**
40 **of 87 or greater and that is not a compact fluorescent lamp.**

41 (2) **A person may not sell or offer for sale in this state a new general service lamp**
42 **manufactured on or after January 1, 2020, unless the efficiency of the new general service**
43 **lamp meets or exceeds 45 lumens per watt, when tested in accordance with the applicable**
44 **federal test procedures for general service lamps prescribed in 10 C.F.R. 430.23 in effect as**
45 **of January 3, 2017.**

1 (3)(a) Subject to paragraph (b) of this subsection, a person may not sell or offer for sale
2 a new high CRI fluorescent lamp unless the efficiency of the new high CRI fluorescent lamp
3 meets or exceeds the efficiency standards set forth in 10 C.F.R. 430.32(n)(4) in effect as of
4 January 3, 2017, as measured in accordance with the test methods prescribed in appendix R
5 of 10 C.F.R. part 430, subpart B, in effect as of January 3, 2017.

6 (b) Paragraph (a) of this subsection applies to high CRI fluorescent lamps manufactured
7 on or after January 1, 2023, or an earlier applicability date, not to precede January 1, 2022,
8 as established by the State Department of Energy by rule. The department may not adopt
9 by rule an earlier applicability date unless an adjoining state adopts an efficiency standard
10 for high CRI fluorescent lamps that is comparable to the standard described in paragraph (a)
11 of this subsection and that becomes applicable before January 1, 2023.

12 (4) The department may by rule adjust the definition of “general service lamp” or “high
13 CRI fluorescent lamp” or may by rule adjust the minimum efficiency standards described in
14 subsections (2) and (3) of this section if the department determines that the adjustments are

37 (5) Proceedings for review under this section shall be given priority over all other mat-
38 ters before the Supreme Court.

39 (6) In the event that the Supreme Court determines that there are factual issues in the

42 **SECTION 88.** (1) Original jurisdiction is conferred on the Supreme Court to determine:

43 (a) Whether the proceeds received from the auction or sale of an allowance conducted
44 under section 28 of this 2020 Act are tax revenues subject to Article IX, section 3a, Oregon
45 Constitution, when the allowance is purchased by or on behalf of a covered entity described

1 in section 5 (2)(d) of this 2020 Act that produces in Oregon, or imports into Oregon, motor
2 vehicle fuel; and

3 (b) Whether Article IX, section 3a, Oregon Constitution, applies to the surrender of a
4 compliance instrument under section 5 (4) of this 2020 Act to fulfill a compliance obligation
5 attributable to the combustion of motor vehicle fuel.

6 (2)(a) Any person interested in or affected or aggrieved by, or who will be affected or
7 aggrieved by, sections 5 (4) or 28 of this 2020 Act may petition for judicial review under this
8 section. A petition for review must be filed within 60 days after the effective date of this
9 2020 Act. The petition shall be captioned "In the Matter of the Disposition of Carbon Allow-
10 ance Auction Proceeds" and the Supreme Court shall consolidate all petitions filed under this
11 subsection in a single proceeding with that caption. All petitioners shall be deemed parties
12 to the consolidated proceeding. The state shall be deemed a respondent to all petitions filed

34 section 28 of this 2020 Act each biennium to reduce greenhouse gas emissions through the
35 replacement of medium-duty trucks and heavy-duty trucks powered by diesel engines or the
36 repower or retrofit of diesel engines that power medium-duty trucks and heavy-duty trucks;

37 (3) Identify specific opportunities for using state proceeds from auctions conducted under
38 section 28 of this 2020 Act each biennium to reduce greenhouse gas emissions related to ag-
39 riculture, with priority given to the replacement, repower or retrofit of nonroad equipment
40 to reduce emissions that present serious risks to farmworker health; and

41 (4) Modify the distributions of state proceeds from auctions as provided in sections 28,
42 29, 33 to 37 and 38 to 40 of this 2020 Act, and repeal or amend any other statutes or session
43 laws, as deemed necessary to:

44 (a) Address the judicial declaration by the Supreme Court that section 28 of this 2020 Act
45 does not impose a tax that is subject to the provisions of Article IX, section 3a, of the

1 Oregon Constitution; and

2 (b) Implement the opportunities identified pursuant to subsections (1) to (3) of this sec-
3 tion.

43 (b) Economic modeling of the impacts on costs to procure and build public infrastructure
44 including streets, roads, bridges and highways due to regulation of motor vehicle fuel pro-
45 ducers and importers under both the Oregon Greenhouse Gas Initiative established under

1 sections 4 to 32 of this 2020 Act and the clean fuels program adopted by rule under ORS
2 468A.266.

3 (c) An analysis of the pace of the following changes within the Oregon transportation
4 sector that would be necessary to allow for the State of Oregon to achieve the greenhouse
5 gas emissions reduction goals set forth in ORS 468A.205, and an analysis of the costs and
6 benefits to consumers associated with accomplishing those changes:

7 (A) Transportation electrification;

8 (B) Adoption of alternative fuel and high efficiency vehicles; and

9 (C) Reductions in vehicle miles traveled.

10 (d) An analysis of the permissible uses of moneys deposited in the Transportation
11 Decarbonization Investments Account established in section 34 of this 2020 Act.

12 (e) An analysis of alternatives to the current system of taxing highway use through
13 motor vehicle fuel taxes.

14 (f) An analysis of the potential for the geographic implementation of a carbon price for
15 motor vehicle fuels, as provided in section 13 of this 2020 Act, to influence:

16 (A) Choices by the sellers of motor vehicle fuel at retail regarding where to locate retail
17 facilities in response to the Oregon Greenhouse Gas Initiative; or

18 (B) Choices by retail motor vehicle fuel customers in response to the Oregon Greenhouse
19 Gas Initiative regarding where to purchase motor vehicle fuel.

20 (2) On or before September 15, 2022, and in the manner provided by ORS 192.245, the
21 Legislative Revenue Officer shall provide a report detailing the results of the economic
22 modeling and analyses required by this section to a committee of the Legislative Assembly
23 related to the environment and to the Joint Committee on Transportation.

25 **Sec. 75.** (1) The Oregon Transportation Commission shall conduct a **biennial** study.

26 (2)(a) The purpose of the study is to determine:

27 [(a)] (A) The proportionate share that users of vehicles that are powered by different means
28 should pay for the costs of maintenance, operation and improvement of the highways in this state;
29 and

30 [(b)] (B) Whether users of vehicles that are powered by different means are paying that share.

31 [(2)] (b) If the commission determines that users are not paying a proportionate share, then the
32 commission may include in the report recommendations for legislation.

33 [(3)] (c) This [section] **subsection** applies to users paying the vehicle registration fee under ORS
34 803.420 (6)(a).

35 (3) In addition to addressing the purpose set forth in subsection (2) of this section, the
36 study shall examine the effects of the Oregon Greenhouse Gas Initiative established under
37 sections 4 to 32 of this 2020 Act on accelerating the transition in this state to high efficiency
38 vehicles and engines and alternative fuels, and the impacts of those changes on the long-
39 term funding sources for paying the costs of maintenance, operation and improvement of the
40 highways in this state.

41 (4) The commission shall report the results of the study to the **Road User Fee Task Force**
42 **established under ORS 184.843**, the Joint Committee on Transportation established under [section
43 26 of this 2017 Act] **ORS 171.858** and a committee of the Legislative Assembly related to the
44 **environment**, in the manner provided by ORS 192.245, no later than September 15[, 2023] of each
45 **odd-numbered year, beginning in 2025.**

1 **SECTION 95.** Section 76, chapter 750, Oregon Laws 2017, is amended to read:

2 **Sec. 76.** Section 75, chapter 750, Oregon Laws 2017, [of this 2017 Act] is repealed on January
3 2, [2024] 2030.

4 **SECTION 95a.** (1) The Office of Greenhouse Gas Regulation shall conduct a study on
5 whether amendments to section 13 of this 2020 Act are necessary or recommended to further
6 the purposes set forth in section 2 of this 2020 Act.

7 (2) The office shall submit a report on the study, which may include recommendations
8 for legislation, in the manner provided under ORS 192.245 to an appropriate interim com-
9 mittee of the Legislative Assembly no later than September 15, 2022.

33 (4) Options included in the proposal under subsection (1)(c) of this section must take into
34 consideration the carbon intensities of fuels for the home heating equipment or systems, as

36 Environmental Quality Commission under ORS 468A.266 (1)(b) or based on another appro-
37 priate methodology.

38 (5) On or before September 15, 2021, and in the manner provided by ORS 192.245, the

40 and steps, which may include recommendations for legislation, necessary to implement the
41 proposal, to the Oregon Greenhouse Gas Reduction Board and the Legislative Assembly.

11 for, when awarding state procurement contracts, accounting for the greenhouse gas emis-
12 sions implications of transporting goods and services to Oregon. The department shall, in the
13 manner provided by ORS 192.245, provide a report detailing the options to the Legislative
14 Assembly no later than September 15, 2021. The report may include recommendations for
15 legislation.

16 **SECTION 95e.** (1) The Oregon Business Development Department, in consultation with
17 the Legislative Revenue Officer and the Department of Revenue, shall identify and examine
18 policy options for addressing barriers to capital investment by businesses in Oregon to re-
19 duce greenhouse gas emissions through:

- 20 (a) Vehicle fleet conversion; and
- 21 (b) Vehicle technology and facility upgrades.

22 (2) The policy options examined under this section shall include modifications to depre-
23 ciation and subtractions for Oregon tax purposes. The Oregon Business Development De-
24 partment shall, in the manner provided by ORS 192.245, provide a report detailing the
25 identified policy options to the Legislative Assembly no later than September 15, 2021. The
26 report may include recommendations for legislation.

27 **SECTION 95f.** (1) The Department of Environmental Quality shall study opportunities for
28 further reducing greenhouse gas emissions through waste reduction and recycling. The study
29 shall include but need not be limited to:

- 30 (a) Opportunities for reducing the amount of putrescible wastes going to landfills;
- 31 (b) An analysis of the greenhouse gas emissions implications of local versus distant re-
32 cycling; and
- 33 (c) Opportunities to develop grant programs to improve recycling and compost
34 infrastructure in Oregon.

35 (2) The department shall, in the manner provided by ORS 192.245, provide a report on the
36 study to the Legislative Assembly no later than September 15, 2021. The report may include
37 recommendations for legislation.

38 **SECTION 95g.** (1) The State Parks and Recreation Department shall develop a proposal
39 for a program to include and engage all Oregonians in an annual, one-day tree planting event
40 on public lands. The proposal shall identify how the program will:

- 41 (a) Provide opportunities for the program to be implemented in partnership with all local
42 governments as defined in ORS 174.116 and special government bodies as defined in ORS
43 174.117; and
- 44 (b) Include a comprehensive educational component, available to all participants and to
45 the general public, on the lifecycle of trees, forest science, and the benefits of timber harvest

1 and use to Oregon's economy and to a sustainable environment, including but not limited to
2 the carbon sequestration benefits of timber and forest products.

3 (2) On or before September 15, 2021, and in the manner provided by ORS 192.245, the de-
4 partment shall provide a report, which may include recommendations for legislation, detail-
5 ing the proposal and steps necessary to implement the proposal, to the Legislative Assembly.

6
7 **JUST TRANSITION**

8
9 **SECTION 96.** (1) The Just Transition Fund is established in the State Treasury, separate
10 and distinct from the General Fund. Interest earned by the Just Transition Fund shall be
11 credited to the fund. Moneys in the fund are continuously appropriated to the Oregon
12 Greenhouse Gas Reduction Board to be used to carry out the purposes described in section
13 96a of this 2020 Act.

14 (2) The fund shall consist of moneys deposited in the fund from any source.

15 (3) The fund shall include a reserve account, which shall consist of moneys allocated or
16 appropriated to the fund by the Legislative Assembly for deposit in the reserve account. The
17 reserve account shall be maintained and used by the board only for the purposes described
18 in section 96a (2)(b) of this 2020 Act.

19 **SECTION 96a.** (1) The Oregon Greenhouse Gas Reduction Board, in consultation with the
20 Higher Education Coordinating Commission, the State Workforce and Talent Development
21 Board, the Employment Department and other interested state agencies, shall:

22 (a) Establish a Just Transition Program for the purpose of distributing moneys, other
23 than moneys deposited in the reserve account of the Just Transition Fund, that are deposited
24 in the Just Transition Fund established under section 96 of this 2020 Act; and

25 (b) Establish a Just Transition Plan for:

26 (A) The implementation and administration of the Just Transition Program; and

27 (B) The use of moneys deposited in the reserve account of the Just Transition Fund.

28 (2)(a) Moneys distributed through the Just Transition Program shall be distributed to
29 support economic diversification, job creation, job training and other employment services.

30 (b) Moneys deposited in the reserve account of the Just Transition Fund may be used
31 only to fund programs and activities that provide financial support for workers displaced or
32 adversely affected by climate change or climate change policies.

33 (3) Each even-numbered year, the Oregon Greenhouse Gas Reduction Board shall deliver
34 a report, in the manner provided in ORS 192.245, to the Governor and the Legislative As-
35 sembly on the Just Transition Plan. The report shall include:

36 (a) Information on implementing the Just Transition Program;

37 (b) Recommendations regarding the level of funding necessary to carry out the Just
38 Transition Program; and

39 (c) Recommendations regarding the maintenance and use of the reserve account of the
40 Just Transition Fund, including but not limited to recommendations regarding:

41 (A) The funding necessary to maintain the reserve account at a level necessary to carry
42 out the programs and activities described in subsection (2)(b) of this section, based on an
43 evaluation of the impacts of climate change or climate change policies on workers; and

44 (B) The use of moneys deposited in the reserve account for the replacement of wages or
45 benefits for workers displaced or adversely affected by climate change or climate change

1 policies.

2 (4) The board shall seek to develop and implement the Just Transition Program in a
3 manner that is consistent with and complementary to other local, state and federal pro-
4 grams, policies and incentives that serve to carry out the activities described in subsection
5 (2) of this section, including but not limited to activities undertaken by the Higher Education
6 Coordinating Commission under ORS 660.318. The Just Transition Program may include, but
7 need not be limited to, a competitive grant program.

8 (5) The board may adopt rules as necessary to administer this section, including but not
9 limited to rules that set standards for awarding grants.

10 (6) A grant program adopted as part of the Just Transition Program may:

11 (a) Encourage, but not require, a grant applicant to provide matching funds for com-
12 pletion of the project, program or activity for which a grant is awarded; and

13 (b) Allow a grant applicant to appeal to the board for reevaluation of any determination
14 of grant funding.

15 (7) The board may perform activities necessary to ensure that recipients of moneys dis-
16 tributed from the Just Transition Fund comply with applicable requirements. If the board
17 determines that a recipient has not complied with applicable requirements, the board may
18 order the recipient to refund all moneys distributed to the recipient from the fund. Moneys
19 refunded pursuant to this subsection shall be paid to the board and deposited in the Just
20 Transition Fund.

21 (8) The board shall appoint a just transition advisory committee. The committee shall be
22 composed of representatives from communities and workplaces that have the potential to
23 be displaced adversely affected by climate change or climate change policies and shall include
24 members representing labor and management. The committee shall:

25 (a) Advise the board in developing rules under this section;

26 (b) Provide recommendations for grant awards and other expenditures from the Just
27 Transition Fund, including expenditures from the reserve account of the Just Transition
28 Fund; and

29 (c) Provide other recommendations related to the Just Transition Plan and the Just
30 Transition Program.

31
32 **OREGON GREENHOUSE GAS REDUCTION BOARD,**
33 **OFFICE OF GREENHOUSE GAS REGULATION ESTABLISHED**
34 **(Oregon Greenhouse Gas Reduction Board)**
35

36 **SECTION 97.** (1) The Oregon Greenhouse Gas Reduction Board is established within the
37 Department of Environmental Quality.

38 (2) The following shall serve as nonvoting members of the board:

39 (a) One member jointly appointed by the President of the Senate and the Speaker of the
40 House of Representatives who is a member of either the Senate or the House of Represen-
41 tatives and who is also a member of the Republican party and serves as a member of a
42 committee of the Legislative Assembly related to climate.

43 (b) One member jointly appointed by the President of the Senate and the Speaker of the
44 House of Representatives who is a member of either the Senate or the House of Represen-
45 tatives and who is also a member of the Democratic party and serves as a member of a

1 committee of the Legislative Assembly related to climate.

2 (c) The chairperson of the Environmental Justice Task Force.

3 (d)(A) A representative from an eligible Indian tribe appointed by the Governor after
4 consultation with the Commission on Indian Services.

5 (B) As used in this section, “eligible Indian tribe” means each of the Burns Paiute Tribe,
6 the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians, the Confederated
7 Tribes of the Grand Ronde Community of Oregon, the Confederated Tribes of Siletz Indians
8 of Oregon, the Confederated Tribes of the Umatilla Indian Reservation, the Confederated
9 Tribes of the Warm Springs Reservation of Oregon, the Coquille Indian Tribe, the Cow Creek
10 Band of Umpqua Tribe of Indians and the Klamath Tribes.

11 (e) One member appointed by the Governor who represents the Oregon Climate Change
12 Research Institute.

13 (f) The Director of the Department of Environmental Quality.

14 (g) A member of the Public Utility Commission.

15 (h) The Director of Transportation.

16 (i) One member appointed by the Governor who is a representative of urban communities
17 at risk of being disproportionately impacted by climate change.

18 (j) One member appointed by the Governor who is a representative of rural communities
19 at risk of being disproportionately impacted by climate change.

20 (3) The Governor shall appoint seven voting members to the board, subject to confirma-
21 tion by the Senate as provided in ORS 171.562 and 171.565. Voting members of the board ap-
22 pointed under this subsection must be residents of this state well informed on energy and
23 climate issues. At least one voting member must represent communities at risk of being
24 disproportionately impacted by climate change.

25 (4) The Administrator of the Office of Greenhouse Gas Regulation and the Office of
26 Greenhouse Gas Regulation shall provide clerical, technical and management personnel to
27 serve the board. Other agencies shall provide support as requested by the office or the board.

28 **SECTION 98.** (1) The term of office of each voting member appointed to the Oregon
29 Greenhouse Gas Reduction Board is four years, but the members of the board may be re-
30 moved by the Governor. Before the expiration of the term of a voting member, the Governor
31 shall appoint a successor to assume the duties of the voting member on July 1 of the next
32 following year.

33 (2) A voting member is eligible for reappointment, but no voting member appointed by
34 the Governor under section 97 of this 2020 Act may serve more than two consecutive terms.
35 In case of a vacancy for any cause, the Governor shall make an appointment to become im-
36 mediately effective for the unexpired term.

37 (3) The Governor shall select one of the voting members as chairperson, for a term and
38 with duties and powers necessary for the performance of the functions of the chairperson
39 as the board determines.

40 (4) A majority of the voting members of the board constitutes a quorum for the trans-
41 action of business.

42 (5) The board shall meet at least once during each calendar quarter at a time and place
43 determined by the chairperson. The board shall endeavor to hold meetings at various lo-
44 cations throughout this state. The board may hold additional meetings at times and places
45 determined by the chairperson, or as requested by a majority of the voting members.

1 **(6)(a) Members of the board who are not members of the Legislative Assembly are not**
2 **entitled to compensation but may be reimbursed from funds available to the board for actual**
3 **and necessary travel and other expenses the members incur in the performance of the**
4 **members' official duties in the manner and amount provided in ORS 292.495.**

5 **(b) Members of the board who are members of the Legislative Assembly shall be entitled**
6 **to payment of per diem and expense reimbursement under ORS 171.072, payable from funds**
7 **appropriated to the Legislative Assembly.**

8 **SECTION 99. Notwithstanding the term of office specified by section 98 of this 2020 Act,**
9 **of the voting members first appointed by the Governor to the Oregon Greenhouse Gas Re-**
10 **duction Board:**

11 **(1) Two shall serve for terms ending July 1, 2021.**

12 **(2) Two shall serve for terms ending July 1, 2022.**

13 **(3) Two shall serve for terms ending July 1, 2023.**

14 **(4) One shall serve for a term ending July 1, 2024.**

15 **SECTION 100. (1) A person may not be eligible to be a voting member of the Oregon**
16 **Greenhouse Gas Reduction Board if:**

17 **(a) The person holds any office or position under any political committee or party; or**

18 **(b) A business with which the person is associated, as that term is defined in ORS**
19 **244.020, is an entity directly regulated by the board.**

20 **(2) If the Governor determines that any board member is in violation of subsection (1)**
21 **of this section, the Governor shall remove the board member pursuant to section 98 of this**
22 **2020 Act.**

23 **SECTION 101. ORS 468.015 is amended to read:**

24 **468.015. (1) Except as provided in subsection (2) of this section, it is the function of the**
25 **Environmental Quality Commission to establish the policies for the operation of the Department of**
26 **Environmental Quality in a manner consistent with the policies and purposes of ORS 448.305,**
27 **454.010 to 454.040, 454.205 to 454.255, 454.505 to 454.535, 454.605 to 454.755 and ORS chapters 468,**
28 **468A and 468B. In addition, the commission shall perform any other duty vested in it by law.**

29 **(2) It is the function of the Oregon Greenhouse Gas Reduction Board to establish the**
30 **policies for the operation of the Office of Greenhouse Gas Regulation established under sec-**
31 **tion 104 of this 2020 Act in a manner consistent with the policies and purposes of sections**
32 **2, 4 to 32, 38 to 40, 43, 96, 96a, 97 to 100, 102 to 105, 107 and 107a of this 2020 Act. Where a**
33 **conflict between rules adopted by the commission and rules adopted by the board exists, the**
34 **conflict shall be resolved in favor of the public interest, as determined by the commission in**
35 **consultation with the board.**

36 **SECTION 102. (1) The Oregon Greenhouse Gas Reduction Board shall:**

37 **(a) In accordance with the applicable provisions of ORS chapter 183, adopt standards and**
38 **rules to perform the functions vested by law in the board including but not limited to the**
39 **adoption of standards and rules for implementation of the Oregon Greenhouse Gas Initiative**
40 **under sections 4 to 32 of this 2020 Act;**

41 **(b) Provide oversight to and advise the Office of Greenhouse Gas Regulation in imple-**
42 **menting, administering and enforcing the programs and activities of the office;**

43 **(c) Identify the highest and best opportunities for investments of state proceeds from the**
44 **sale of allowances under section 28 of this 2020 Act in actions that carry out the purposes**
45 **of the Oregon Greenhouse Gas Initiative as set forth in section 2 of this 2020 Act;**

1 (d) Identify and provide recommendations to the Governor and the Legislative Assembly
2 on ways to coordinate state and local efforts to reduce greenhouse gas emissions in Oregon
3 consistent with the greenhouse gas emissions reduction goals established by ORS 468A.205
4 and the purposes of the Oregon Greenhouse Gas Initiative as set forth in section 2 of this
5 2020 Act and recommend efforts to help Oregon prepare for the effects of climate change;

6 (e) Work with state and local governments, the State Department of Energy, the De-
7 partment of Education, the Higher Education Coordinating Commission, businesses and rep-
8 resentatives of impacted communities to develop and implement an outreach strategy to
9 educate Oregonians about the scientific aspects and economic impacts of climate change and
10 to inform Oregonians of ways to reduce greenhouse gas emissions and ways to prepare for
11 the effects of climate change; and

12 (f) Carry out any other duties, functions and powers vested in the board by law.

13 (2) In conducting the duties set forth in subsection (1) of this section, the board shall
14 take into consideration best available science.

15 (3)(a) In furtherance of the greenhouse gas emissions reduction goals established by ORS
16 468A.205, the board may:

17 (A) Recommend statutory and administrative changes, policy measures and other rec-
18 ommendations to be carried out by state and local governments, businesses, nonprofit or-
19 ganizations or residents; or

20 (B) Recommend to the Governor the formation of citizen advisory groups to explore
21 particular areas of concern with regard to the reduction of greenhouse gas emissions and the
22 effects of climate change.

23 (b) In developing recommendations under this subsection, the board shall consider eco-
24 nomic, environmental, health and social costs, and the risks and benefits of alternative
25 strategies, including least-cost options. The board shall solicit and consider public comment
26 relating to statutory, administrative or policy recommendations. Recommendations devel-
27 oped under this subsection may include, but need not be limited to recommendations for
28 addressing greenhouse gas emissions from the use of propane in this state.

29 (4) The board may at any time convene advisory committees to assist the board in car-
30 rying out the duties set forth in this section. If the board convenes an advisory committee,
31 it shall be composed of members appointed by the chairperson of the board. In appointing
32 members, the chairperson shall include at least one member who represents impacted com-
33 munities and shall take into consideration the geographic and demographic diversity of this
34 state.

35 (5) The board shall hold public hearings and provide an opportunity for public comment
36 in carrying out the board's activities under this section.

37 SECTION 103. Methodology for designating impacted communities. (1) The Oregon
38 Greenhouse Gas Reduction Board, by rule and in consultation with the Portland State Uni-
39 versity Population Research Center, the Oregon Health Authority, other relevant state
40 agencies, local agencies and officials and community representatives, shall designate as im-
41 pacted communities those communities in Oregon at risk of being disproportionately im-
42 pacted by climate change. In carrying out this section, the board shall identify impacted
43 communities based on a methodology that takes into consideration geographic,
44 socioeconomic, historic disadvantage, public health and environmental hazard criteria. Im-
45 pacted communities may include, but are not limited to:

1 (a) Rural communities.

2 (b) Coastal communities.

3 (c) Areas with above-average concentrations of low-income households, historically dis-
4 advantaged households, high unemployment, high linguistic isolation, low levels of
5 homeownership, high rent burden, sensitive populations or residents with low levels of edu-
6 cational attainment.

7 (d) Areas disproportionately affected by environmental pollution and other hazards that
8 can lead to negative public health effects, exposure or environmental degradation.

9 (2) The methodology required by this section must give greater weight to those criteria
10 that the board determines are the most accurate measurements of vulnerability to the im-
11 pacts of climate change and ocean acidification.

12 (3) The board shall review and update the methodology required by this section and the
13 designation of impacted communities at least once every five years.

14
15 (Office of Greenhouse Gas Regulation)

16
17 SECTION 104. Office of Greenhouse Gas Regulation. (1) There is established within the
18 Department of Environmental Quality and under the Oregon Greenhouse Gas Reduction
19 Board the Office of Greenhouse Gas Regulation.

20 (2) The office shall:

21 (a) Administer the Oregon Greenhouse Gas Initiative established under sections 4 to 32
22 of this 2020 Act; and

23 (b) Carry out the duties, functions and powers vested in the office by law.

24 (3) The office may advise, consult and cooperate with other agencies of the state, political
25 subdivisions, other states or the federal government, and shall make a reasonable effort to
26 cooperate with affected eligible Indian tribes as defined in section 97 of this 2020 Act, with
27 respect to any proceedings and all matters pertaining to the reduction of greenhouse gas
28 emissions levels in Oregon.

29
30 (Administrator of the Office of Greenhouse Gas Regulation)

31
32 SECTION 105. Administrator. (1) The Office of Greenhouse Gas Regulation is under the
33 supervision and control of an administrator who, subject to the direction of the Oregon
34 Greenhouse Gas Reduction Board, is responsible for the performance of the duties, functions
35 and powers of the office.

36 (2) The Governor shall appoint the Administrator of the Office of Greenhouse Gas Reg-
37 ulation, subject to confirmation by the Senate in the manner prescribed in ORS 171.562 and
38 171.565. The administrator holds office at the pleasure of the Governor.

39 (3) The administrator shall be paid a salary as provided by law or, if not so provided, as
40 prescribed by the Governor.

41 (4) Subject to the approval of the Governor, the administrator may organize and reor-
42 ganize the administrative structure of the office as the administrator considers appropriate
43 to properly conduct the work of the office.

44 (5) Subject to any applicable provisions of ORS chapter 240, the administrator shall ap-
45 point all subordinate officers and employees of the office, including specialists and consult-

1 **ants, prescribe their duties and fix their compensation. The office may purchase materials**
2 **and supplies and enter into contracts necessary to exercise and carry out the duties, func-**
3 **tions and powers of the office.**

9 **SECTION 107. Enforcement procedures; status of procedures.** (1) Whenever the Oregon
10 Greenhouse Gas Reduction Board has good cause to believe that any person is engaged in
11 or is about to engage in any acts or practices that constitute a violation of a provision of
12 sections 4 to 32 of this 2020 Act, or any rule, standard or order adopted or entered pursuant
13 to sections 4 to 32 of this 2020 Act, the board may institute actions or proceedings for legal
14 or equitable remedies to enforce compliance or to restrain further violations.

15 (2) The actions or proceedings authorized by subsection (1) of this section may be insti-
16 tuted without the necessity of prior agency notice, hearing and order, or may be instituted
17 during an agency hearing if the hearing has been initially commenced by the board.

18 (3) The provisions of this section are in addition to and not in lieu of any other civil or
19 criminal enforcement provisions available to the board.

20 **SECTION 107a. Civil penalties.** (1) In addition to any other liability or penalty provided
21 by law, the Oregon Greenhouse Gas Reduction Board may impose a civil penalty on a person
22 for any of the following:

23 (a) A violation of a provision of sections 4 to 32 of this 2020 Act or rules adopted under
24 sections 4 to 32 of this 2020 Act.

25 (b) Submitting any record, information or report required by sections 4 to 32 of this 2020
26 Act or rules adopted under sections 4 to 32 of this 2020 Act that falsifies or conceals a ma-
27 terial fact or makes any false or fraudulent representation.

28 (2) Each day of violation under subsection (1) of this section constitutes a separate of-
29 fense.

30 (3)(a) The board shall adopt by rule a schedule of civil penalties that may be imposed for
31 violations described in subsection (1) of this section. Except as provided in paragraph (b) of
32 this subsection, a civil penalty may not exceed \$25,000 per offense.

33 (b) In addition to any other civil penalty provided by law, the civil penalty for a violation
34 described in subsection (1) of this section may include an amount equal to an estimate of the
35 economic benefit received as a result of the violation.

36 (4) In imposing a civil penalty pursuant to this section, the board shall consider the fol-
37 lowing factors:

38 (a) The history of the person incurring the civil penalty in taking all feasible steps or
39 procedures necessary or appropriate to correct any violation.

40 (b) Any actions taken by the person to mitigate the violation.

41 (c) Any prior act committed by the person that resulted in a violation described in sub-
42 section (1) of this section.

43 (d) The economic and financial conditions of the person.

44 (e) The gravity and magnitude of the violation.

45 (f) Whether the violation was repeated or continuous.

1 (g) Whether the cause of the violation was an unavoidable accident, negligence or an in-
2 tentional act.

3 (h) The person's cooperativeness and efforts to correct the violation.

4 (i) Whether the person gained an economic benefit as a result of the violation.

5 (5) Civil penalties under this section must be imposed in the manner provided by ORS
6 183.745. All civil penalties recovered under this section shall be paid to the Department of
7 Environmental Quality for deposit in the Oregon Greenhouse Gas Initiative Operating Fund
8 established under section 31 of this 2020 Act and may be used only pursuant to section 31 (3)
9 of this 2020 Act.

10 **SECTION 107b.** ORS 468.953 is amended to read:

11 468.953. (1) A person commits the crime of supplying false information to any agency if the
12 person:

13 (a) Makes any false material statement, representation or certification knowing it to be false,
14 in any application, notice, plan, record, report or other document required by any provision of ORS
15 chapter 465, 466, 468, 468A or 468B or sections 4 to 32 of this 2020 Act or any rule adopted pur-
16 suant to ORS chapter 465, 466, 468, 468A or 468B or sections 4 to 32 of this 2020 Act;

21 sections 4 to 32 of this 2020 Act or any rule adopted pursuant to ORS chapter 465, 466, 468, 468A
22 or 468B or sections 4 to 32 of this 2020 Act.

23 (2) Supplying false information is a Class C felony.

31 Act.

32 **SECTION 108a.** Notwithstanding any other law limiting expenditures, the amount of \$1
33 is established for the biennium ending June 30, 2021, as the maximum limit for payment of
34 expenses by the Oregon Business Development Department from the Traded Sector
35 Greenhouse Gas Reduction Revolving Loan Fund established under section 51 of this 2020
36 Act.

39 SECTION 111. This 2020 Act being necessary for the immediate preservation of the public
40 peace, health and safety, an emergency is declared to exist, and this 2020 Act takes effect
41 on its passage.
