SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes State Board of Towing within Department of Transportation. Authorizes board to [*file request directing*] **order** department to deny, suspend, revoke or refuse to renew towing business certificate or letter of appointment to participate on rotational list of towing businesses for certain violations. Authorizes board to impose civil penalties for certain violations.

Declares emergency, effective on passage.

2	Relating to towing; creating new provisions; amending ORS 646.608 and 822.215; repealing ORS

4	Be It Enacted by the People of the State of Oregon:
5	SECTION 1. State Board of Towing; membership; term; compensation and expenses. (1)
6	The State Board of Towing is established within the Department of Transportation.
7	(2) The State Board of Towing consists of nine members appointed by the Governor as
8	follows:
9	(a) One tower who holds a towing business certificate issued under ORS 822.205 and who
10	represents a city in Oregon with a population of 100,000 or more;
11	(b) One tower who holds a towing business certificate issued under ORS 822.205 and who
12	represents a city in Oregon with a population of less than 100,000;
13	(c) One tower who holds a towing business certificate issued under ORS 822.205 and who
14	has specialized knowledge in towing equipment and vehicles with a gross vehicle weight rat-
15	ing of more than 44,000 pounds;
16	(d) One tower who holds a towing business certificate issued under ORS 822.205 and who
17	has specialized knowledge in towing vehicles with a gross vehicle weight rating of 26,000
18	pounds or less;
19	(e) One member who represents the insurance industry;
20	(f) One member from a tow program within the Department of State Police;
21	(g) One member who is a chief of police;
22	(h) One member who is a member of the public; and
23	(i) One member who is a consumer advocate.
24	(3) All members of the board must be residents of Oregon.

25 (4) The term of office of each member of the board is four years, but a member serves

1 at the pleasure of the Governor. Before the expiration of the term of a member, the Gover-

2 nor shall appoint a successor whose term begins on July 1 next following. A member is eli-

gible for reappointment. If there is a vacancy for any cause, the Governor shall make an
appointment to become immediately effective for the unexpired term.

5 (5) A member of the board is entitled to compensation and expenses as provided in ORS
6 292.495.

7 <u>SECTION 2.</u> Initial terms of office. Notwithstanding the term of office specified by sec-8 tion 1 of this 2020 Act, of the members first appointed to the State Board of Towing:

9 (1) Two shall serve for a term ending July 1, 2021.

10 (2) Two shall serve for a term ending July 1, 2022.

11 (3) Two shall serve for a term ending July 1, 2023.

12 (4) Three shall serve for a term ending July 1, 2024.

13 <u>SECTION 3.</u> Officers; quorum; meetings. (1) The State Board of Towing shall select one 14 of its members as chairperson and another as vice chairperson, for terms and with duties 15 and powers necessary for the performance of the functions of the offices as the board de-16 termines.

(2) Except as provided in subsection (3) of this section, a majority of the members of the
 board constitutes a quorum for the transaction of business.

(3) When the board is deliberating or voting on a matter before it, four members of the
 board constitute a quorum.

(4) No more than two members who are towers may vote on any matter. The chairperson shall assign a rotation of voting members who are towers. If an assigned member who is a tower has an actual or potential conflict of interest in a matter before the board, the chairperson shall designate a different member who is a tower and who does not have an actual or potential conflict of interest in the matter before the board to deliberate and vote on that matter.

(5) The board shall meet at least once a quarter at a time and place determined by the
board. The board shall also meet at such other times and places as are specified by the call
of the chairperson, vice chairperson or administrative officer.

30 <u>SECTION 4.</u> Administrative officer for board; other employees. (1) The State Board of 31 Towing shall appoint an administrative officer to serve at the pleasure of the Governor. The 32 determination of qualifications of the administrative officer and appointment of the admin-33 istrative officer shall be made by the board after consulting with the Governor.

34 (2) The administrative officer may not be a member of the board.

(3) The designation of the administrative officer must be by written order, filed with the
 Secretary of State.

(4) The administrative officer is in the unclassified service under ORS chapter 240, and
the board shall fix the salary of the administrative officer in accordance with the applicable
provisions of ORS chapter 240.

40 (5) Subject to any applicable provisions of ORS chapter 240, the administrative officer
41 shall appoint all subordinate officers and employees of the board, prescribe their duties and
42 fix their compensation.

43 <u>SECTION 5.</u> <u>Rulemaking authority; board seal.</u> (1) In accordance with applicable pro-44 visions of ORS chapter 183, the State Board of Towing may adopt rules:

45 (a) Necessary for the administration of the laws that the board is charged with admin-

1 istering.

2 (b) To implement ORS 98.853 to 98.862.

3 (2) The board may adopt a seal.

4 <u>SECTION 6.</u> State Board of Towing Account. (1) The State Board of Towing Account is 5 established in the State Treasury, separate and distinct from the General Fund.

6 (2) The account consists of the following:

7 (a) Moneys collected from fees imposed under section 9 of this 2020 Act.

8 (b) Moneys appropriated to the account by the Legislative Assembly.

9 (c) Moneys from any other source.

(3) Moneys in the account are continuously appropriated to the Department of Trans portation to carry out the provisions of sections 1 to 11 of this 2020 Act.

12SECTION 7. Administration of oaths; obtaining and taking evidence at board proceedings; effect of failure to obey board subpoena. The State Board of Towing, acting through its 13 chairperson or vice chairperson, may administer oaths, take depositions and issue subpoenas 14 15 to compel the attendance of witnesses and the production of documents or other written information necessary to carry out the provisions of sections 1 to 11 of this 2020 Act. If any 16 person fails to comply with a subpoena issued under this section or refuses to testify on 17 18 matters on which the person lawfully may be interrogated, the procedure set out in ORS 19 183.440 shall be followed to compel obedience.

20 <u>SECTION 8.</u> Denial, suspension, revocation or refusal of towing business certificate. (1) 21 As used in this section:

(a) "Person" includes individuals, public bodies as defined in ORS 174.109, corporations,
 firms, associations, partnerships, limited liability companies, joint stock companies or any
 other business entity created under law.

(b) "Relative" means an individual related within the third degree as determined by the common law, a spouse, an individual related to a spouse within the third degree as determined by the common law or an individual in an adoptive relationship within the third degree as determined by the common law.

(2) In addition to any other penalty provided under ORS 822.215 and subject to ORS
chapter 183, the State Board of Towing may order the Department of Transportation to deny,
suspend, revoke or refuse to renew a towing business certificate issued under ORS 822.205,
if the person holding or applying for the certificate:

(a) Fails to comply with any rule adopted by the board;

34(b) Violates any provision of, or rules or ordinances adopted under, ORS 98.853, 98.854,3598.856, 98.858, 181A.350, 822.200, 822.215, 822.225, 822.230, 822.235 or 822.605;

(c) Fails to comply with an order of the board, including but not limited to the failure to
 pay a civil penalty as ordered by the board;

(d) Has performed work as a tower without the appropriate certification or letter of appointment to participate on the rotational list of towing businesses established under ORS
181A.350, or has employed individuals to perform work as towers without appropriate certification or letter of appointment;

42 (e) Has advertised or otherwise held themselves out as being a certified towing business
43 without holding the appropriate certification;

(f) As a, or as a relative of a, partner, officer, member or employee of a towing business,
 advertises or holds themselves out as a towing business that is certified if the towing busi-

1 ness does not possess the appropriate certification;

2 (g) Has engaged in towing or recovering by any means, as part of any business operation

of the person, vehicles that are wrecked, damaged, disabled or abandoned or replacement
 vehicles;

5 (h) Fails to meet any condition or requirement to obtain a certificate or letter of ap-6 pointment;

7 (i) Acts or has acted in a manner creating a serious danger to the public health or safety;
8 or

(j) Has been subject to a revocation, cancellation or suspension order or to other disciplinary action related to towing or the towing industry by any other public body, as defined
in ORS 174.109, or has failed to pay a civil penalty imposed by the public body.

(3) A violation described in subsection (2) of this section for which the board orders that the department deny, suspend, revoke or refuse to renew a certificate to perform work or conduct business may be treated as a failure to be in conformance with sections 1 to 11 of this 2020 Act.

(4) A person subject to discipline under this section is entitled to a contested case hear ing in accordance with ORS chapter 183.

(5) The board is the agency responsible for providing notice and contested case hearing
 rights under ORS chapter 183 to a person subject to discipline under this section.

20 <u>SECTION 9.</u> Additional powers of the board. (1) In carrying out its investigative and 21 enforcement duties, functions and powers, and notwithstanding any other provision of law, 22 the State Board of Towing may procure services and award a contract for the personal ser-23 vices of a subject matter expert, on a case-by-case basis, in any manner deemed practical 24 or convenient. The price of such contracts, including any amendments, may not exceed 25 \$25,000.

(2) If the board has reason to believe that any person has been engaged or is engaging 2627in any violation of ORS 98.853, 98.854, 98.856, 98.858, 181A.350, 822.200, 822.215, 822.225, 822.230, 822.235 or 822.605 or sections 1 to 11 of this 2020 Act or any rule adopted under those stat-28utes, or any order issued by the board, the board may, without bond, bring suit in the name 2930 and on behalf of the State of Oregon in the circuit court of any county of this state to enjoin 31 the acts or practices and to enforce compliance with ORS 98.853, 98.854, 98.856, 98.858, 181A.350, 822.200, 822.215, 822.225, 822.230, 822.235 or 822.605 or sections 1 to 11 of this 2020 32Act or any rule adopted under those statutes, or any order issued by the board. Upon a 33 34 proper showing, a permanent or temporary injunction, restraining order or writ of 35 mandamus shall be granted.

(3) The board, by rule, may impose a fee on any person holding or applying for a towing
business certificate. The amount of the fee shall be established to recover expenses incurred
by the board in carrying out sections 1 to 11 of this 2020 Act. Any fees collected under this
subsection shall be deposited into the State Board of Towing Account established under
section 6 of this 2020 Act.

41 <u>SECTION 10.</u> Participation in the Department of State Police tow rotation. (1) As used 42 in this section:

(a) "Person" includes individuals, public bodies as defined in ORS 174.109, corporations,
firms, associations, partnerships, limited liability companies, joint stock companies or any
other business entity created under law.

 holding the appropriate certification;

advertises or holds themselves out as a towing business that is certified if the towing business does not possess the appropriate certification;

(g) Has engaged in towing or recovering by any means, as part of any business operation
of the person, vehicles that are wrecked, damaged, disabled or abandoned or replacement
vehicles;

(h) Fails to meet any condition or requirement to obtain a certificate or letter of ap pointment;

(i) Acts or has acted in a manner creating a serious danger to the public health or safety;
or

(j) Has been subject to a revocation, cancellation or suspension order or to other disciplinary action related to towing or the towing industry by any other public body, as defined
in ORS 174.109, or has failed to pay a civil penalty imposed by the public body.

(3) A violation described in subsection (2) of this section for which the board orders the
department to deny, suspend, condition or revoke a letter of appointment to participate on
the rotational list of towing business established under ORS 181A.350 may be treated as a
failure to be in conformance with sections 1 to 11 of this 2020 Act.

SECTION 11. Civil penalties; factors; rules. (1) In addition to any other penalty provided
 by law, any person who violates any provision of ORS 98.853, 98.854, 98.856, 98.858, 181A.350,
 822.200, 822.215, 822.225, 822.230, 822.235 or 822.605 or any rule adopted by the State Board of
 Towing is subject to payment of a civil penalty to the board.

(2) The board may adopt rules establishing a schedule of civil penalties that may be imposed under this section. Civil penalties imposed under this section may not exceed \$25,000
for each violation.

43 (3) Civil penalties under this section shall be imposed as provided in ORS 183.745.

45 tion of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact.

(3) In order to prevail in an action or suit under ORS 336.184 and 646.605 to 646.652, a prose-1 2 cuting attorney need not prove competition between the parties or actual confusion or misunderstanding. 3

(4) An action or suit may not be brought under subsection (1)(u) of this section unless the At-4 torney General has first established a rule in accordance with the provisions of ORS chapter 183 5 declaring the conduct to be unfair or deceptive in trade or commerce. 6

(5) Notwithstanding any other provision of ORS 336.184 and 646.605 to 646.652, if an action or 7 suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attor-8 9 ney, relief is limited to an injunction and the prevailing party may be awarded reasonable attorney 10 fees.

(1) The Department of Transportation may deny or refuse to issue any towing business 13 certificate under ORS 822.205 or may suspend, revoke or refuse to renew any towing business certificate issued upon proof that the applicant for or holder of the certificate has done any of the 14 15 following:

[(1)] (a) Used fraud or deception in securing the certificate.

[(2)] (b) Received in any manner or by any device any rebate or other additional fee for towing 17 or recovery from a person who performs repairs on a vehicle who does not also own the vehicle. 18 This [subsection] paragraph does not prohibit the payment of the towing fee by a person who per-19 forms repairs on a vehicle if the fee is included in the charges by that person for repairs on the 20vehicle. 21

22[(3)] (c) Used vehicles for the purposes of towing or recovering services that did not meet the minimum safety standards established by the department. 23

[(4)] (d) Failed to display special towing business registration plates, stickers or indicia or 24identification devices for proportionally registered tow vehicles authorized under ORS 805.200 on 25each vehicle used to tow or recover vehicles. 26

27[(5)] (e) Failed to maintain the amounts and types of insurance required to qualify for issuance of a towing business certificate under ORS 822.205. 28

[(6)] (f) Failed to obtain any permits or authority required under any provision of ORS chapter 2930 825 or rules adopted thereunder.

31 [(7)] (g) Violated any provision of ORS 98.853, 98.854, 98.856 or 98.858 or a rule adopted under [ORS 98.864] section 5 of this 2020 Act. 32

(2) After receiving an order from the State Board of Towing under section 8 of this 2020 33 34 Act, the department shall impose the disciplinary action requested by the board.

SECTION 14. ORS 98.864 is repealed. 35

SECTION 15. Section captions. The section captions used in this 2020 Act are provided 36 37 only for the convenience of the reader and do not become part of the statutory law of this 38 state or express any legislative intent in the enactment of this 2020 Act.

SECTION 16. Effective date. This 2020 Act being necessary for the immediate preserva-39 tion of the public peace, health and safety, an emergency is declared to exist, and this 2020 40 41 Act takes effect on its passage.

42
