PROPOSED AMENDMENTS TO HOUSE BILL 4039

Delete lines 4 through 10 of the printed bill and insert:

- "SECTION 1. Statewide assessment. (1) As used in this section, unaccompanied homeless youth' means a person who is at least 14 years of age but not more than 24 years of age, who is not in the physical custody of a parent or legal guardian and who is homeless.
- "(2) The Department of Human Services shall conduct a statewide assessment of the needs of and the continuum of services for unaccompanied homeless youth in Oregon. The assessment must determine:
- "(a) Demographic information about unaccompanied homeless
 youth in this state, including age, race, primary language, gender,
 school enrollment status and types of homelessness experienced.
- "(b) To the extent possible, other demographic information about unaccompanied homeless youth in this state, including disability, school grade level, length of homelessness and reasons for homelessness.
- "(c) The average numbers of beds needed for unaccompanied homeless youth, the types of housing available and the durations of stay required.
- "(d) Other services that are needed and available, including but not limited to culturally specific programming, mental health treatment,

- addiction treatment, academic support and job training.
- "(e) To the extent possible, the capacity of community action agencies, emergency housing assistance programs, state homeless assistance programs, shelters, host home programs, other housing programs and resources available through the McKinney-Vento Homeless Assistance Act, 42 U.S.C. 11301 et seq., to serve the unaccompanied homeless youth population.
- "(f) The existing partnerships and coordination between the Department of Human Services and other organizations, including but not limited to the Housing and Community Services Department, the Oregon Youth Authority, the Department of Education, school districts and nonprofit organizations serving unaccompanied homeless youth and youth at risk of becoming homeless.
 - "(3)(a) In addition to any other scholarships or grants, the Department of Human Services may award one-year grants in the amount of no more than \$10,000 per grant to organizations that provide services to unaccompanied homeless youth to assist with the assessment required by this section.
 - "(b) An organization is eligible to apply for a grant under this subsection if the organization has an existing contract with the department or the Housing and Community Services Department to provide services to unaccompanied homeless youth.
 - "(c) The Department of Human Services may adopt rules to administer the grant program described in this subsection.
 - "(4)(a) The department shall provide a preliminary report on the results of the assessment to an appropriate committee or interim committee of the Legislative Assembly no later than December 1, 2020.
 - "(b) The department shall provide a final report on the results of the assessment to an appropriate committee or interim committee of the Legislative Assembly no later than March 1, 2021.

- "SECTION 2. Unaccompanied homeless youth services enhancement
- 2 grant program. (1) As used in this section, 'unaccompanied homeless
- 3 youth' means a person who is at least 14 years of age but not more
- 4 than 24 years of age, who is not in the physical custody of a parent
- 5 or legal guardian and who is homeless.
- 6 "(2) In addition to any other scholarships or grants, the Department
- 7 of Human Services may award one-year grants to organizations that
- 8 provide services to unaccompanied homeless youth.
- 9 "(3) An organization is eligible to apply for a grant under this sec-
- 10 tion if the organization has an existing grant with the department to
- 11 provide services to unaccompanied homeless youth.
- "(4) Grants awarded under this section may be used to increase the
- 13 accessibility of the following programs and services to unaccompanied
- 14 homeless youth:
- 15 "(a) Shelter facilities.
- 16 "(b) Outreach.
- 17 "(c) Culturally specific services.
- 18 "(d) Mental health or substance abuse services.
- "(e) Transitional housing options, including host home projects as
- 20 defined in section 3 of this 2020 Act.
 - "(5) The department may adopt rules to administer the grant pro-
- 22 gram described in this section.
- 23 "SECTION 3. Host home projects. (1) As used in this section:
- 24 "(a) 'Host home project' means a project that facilitates an ar-
- 25 rangement under which an unaccompanied homeless youth resides in
- 26 the home of a private individual, pursuant to the terms of a contract
- 27 between the private individual and the youth, for free or at below-
- 28 market rent.

- (b) 'Unaccompanied homeless youth' means a person who is:
- 30 "(A) At least 16 years of age but not more than 21 years of age;

- "(B) Not in the physical custody of a parent or legal guardian;
- 2 "(C) Not in the custody of the Department of Human Services;
- 3 "(D) Not a ward of the state; and
- 4 "(E) Homeless.

- 5 "(2) In addition to and not in lieu of any other scholarships or 6 grants, the department may award one-year grants to organizations 7 that operate host home projects for unaccompanied homeless youth.
- "(3) An organization is eligible to apply for a grant under this section if the organization operated a host home project on January 1, 2020, and can demonstrate the ability to:
 - "(a) Expand host home projects in communities in which the organization provides services; or
 - "(b) Establish new host home projects in communities that do not have long-term host home projects.
- 15 "(4) Recipients of grants awarded under this section shall work to 16 achieve the following outcomes for unaccompanied homeless youth:
- 17 "(a) Improved school attendance.
- 18 "(b) Participation in formal or informal mentoring.
- 19 "(c) Increased access to nutrition, health care, mental trauma-20 informed support and transportation services.
- "(5) A recipient of a grant awarded under this section shall conduct a criminal records check as provided in ORS 181A.200 on all individuals 18 years of age or older, other than the unaccompanied homeless youth, residing in a host home that is part of a project operated by the grant recipient.
- 26 "(6) A host home is not a child-caring agency as defined in ORS 418.205.
- 28 "(7) The department may adopt rules to administer the grant pro-29 gram described in this section.
- "SECTION 4. Report. The Department of Human Services shall re-

- port on the host home projects established under section 3 of this 2020
- 2 Act to committees or interim committees of the Legislative Assembly
- 3 relating to housing, homeless youth services and high school educa-
- 4 tion no later than September 15, 2021. The report must include infor-
- 5 mation about the effectiveness of the projects, including:
- 6 "(1) A description of the process used to identify and reach out to 7 unaccompanied homeless youth;
- 8 "(2) Assessment data and other indicators to determine how well 9 the housing, health and academic needs of unaccompanied homeless 10 youth are being met;
 - "(3) Demographic information about youth served or assessed for program participation;
 - "(4) The academic progress of students participating in host home projects that have a host home-related memorandum of understanding or letter of agreement with one or more school districts and in which unaccompanied homeless youth participants, on average during the most recent two years, resided in host homes for a minimum of 180 days, as reported by the relevant school districts; and
 - "(5) Assessment by the youth, host families and partner government and nonprofit entities about their experience in the host home projects.
 - "SECTION 5. Appropriations. (1) In addition to and not in lieu of any other appropriation, there is appropriated to the Department of Human Services, for the biennium ending June 30, 2021, out of the General Fund, the amount of \$230,000, to conduct the statewide assessment required under section 1 of this 2020 Act.
- "(2) In addition to and not in lieu of any other appropriation, there
 is appropriated to the Department of Human Services, for the
 biennium ending June 30, 2021, out of the General Fund, the amount
 of \$70,000, to provide grants to organizations that provide services to

- unaccompanied homeless youth to assist with the statewide assessment required under section 1 of this 2020 Act.
- "(3) In addition to and not in lieu of any other appropriation, there is appropriated to the Department of Human Services, for the biennium ending June 30, 2021, out of the General Fund, the amount of \$1,000,000, to provide the unaccompanied homeless youth services enhancement grants described in section 2 of this 2020 Act.
 - "(4) In addition to and not in lieu of any other appropriation, there is appropriated to the Department of Human Services, for the biennium ending June 30, 2021, out of the General Fund, the amount of \$1,200,000, to provide the host home project grants described in section 3 of this 2020 Act.
 - "SECTION 6. Sunset dates. (1) Sections 2 and 3 of this 2020 Act are repealed on July 1, 2021.
 - "(2) Section 1 of this 2020 Act is repealed on January 1, 2022.
 - "SECTION 7. Captions. The section captions used in this 2020 Act are provided only for the convenience of the reader and do not become part of the statutory law of this state or express any legislative intent in the enactment of this 2020 Act.
 - "SECTION 8. Emergency clause. This 2020 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2020 Act takes effect on its passage.".
