"(2) A licensed genetic counselor shall, upon the receipt of a patient's positive test for Down syndrome or another chromosomal condition, provide to the patient, or the patient's family, information compiled by the Oregon Health Authority under subsection (3) of this section related to Down syndrome or the other chromosomal condition for which the test shows a positive result.
"(3) The authority shall make available to a licensed genetic counselor described in subsection (2) of this section the following information regarding Down syndrome and other chromosomal conditions:
"(a) Current, evidence-based, written information about Down syndrome or other chromosomal conditions that has been reviewed by relevant experts and any national organizations identified by the authority, and that includes physical, developmental, educational and psychosocial outcomes, life expectancy, clinical course and intellectual and functional development and treatment options; and
"(b) Contact information for support programs and services, including information for hotlines, resource centers, local and national organizations and other educational programs related to Down syndrome or other chromosomal conditions.
"(4) The information described in subsection (3) of this section must be culturally and linguistically appropriate for the patient or the patient's family.
"(5) The authority may adopt rules to carry out this section.".
