SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Declares Oregon policy regarding Indian children. Modifies Oregon child welfare laws regarding Indian children to reconcile with provisions of federal Indian Child Welfare Act.

7 Whereas current research shows that family, culture and community promote resiliency and
8 health development in Indian children; and

9 Whereas Congress, working with tribal nations, tribal leadership and advocates for Indian chil-
10 dren, passed the Indian Child Welfare Act (25 U.S.C. 1901 et seq.) in 1978 to stop the removal of
11 Indian children from their homes, families and communities; and

12 Whereas at the time Congress passed the Indian Child Welfare Act, Indian children were being
13 removed by public and private agencies at rates as high as 25 percent to 35 percent; and

14 Whereas Indian children continue to be removed from their homes at rates higher than other
15 non-Indian children; and

16 Whereas despite requirements under the Indian Child Welfare Act, application of the Indian
17 Child Welfare Act in Oregon courts is inconsistent; and

18 Whereas clearly addressing in state law the coordination between and respective roles of the
19 state and tribes regarding the provision of child welfare services to Indian children will provide
20 uniform and consistent direction to state courts, tribes and practitioners to prevent unlawful re-
21 movals of Indian children from their families and promote the stable placement of Indian children
22 in loving, permanent homes that are connected to family and culture; now, therefore,

23 **Be It Enacted by the People of the State of Oregon:**

24 **OREGON INDIAN CHILD WELFARE**
25 **(Policy Regarding Indian Children)**
26

27 **SECTION 1. The Legislative Assembly finds that the United States Congress recognizes**
28 **the special legal status of Indian tribes and their members. It is the policy of the State of**

1 Oregon to protect the health and safety of Indian children and the stability and security of
2 Indian tribes and families by promoting practices designed to prevent the removal of Indian
3 children from their families and, if removal is necessary and lawful, to prioritize the place-
4 ment of an Indian child with the Indian child’s extended family and tribal community. The
5 state recognizes the inherent jurisdiction of Indian tribes to make decisions regarding the
6 custody of Indian children. The state also recognizes the importance of ensuring that Indian
7 children and Indian families receive appropriate services to obviate the need to remove an
8 Indian child from the Indian child’s home and, if removal is necessary and lawful, to effect
9 the child’s safe return home. Sections 1 to 23 of this 2020 special session Act create addi-
10 tional safeguards for Indian children to address disproportionate rates of removal, to im-
11 prove the treatment of and services provided to Indian children and Indian families in the
12 child welfare system and to ensure that Indian children who must be removed are placed
13 with Indian families, communities and cultures.

15 **(Definitions; Custody; Parentage;**
16 **Best Interests of Indian Child; Domicile;**
17 **Indian Child’s Tribe)**
18

19 **SECTION 2. Definitions.** As used in sections 1 to 23 of this 2020 special session Act, un-
20 less the context provides otherwise:

21 (1) “Emergency proceeding” means any court action that involves the emergency re-
22 moval or emergency placement of an Indian child, including removal under ORS 419B.150,
23 with or without a protective custody order, or a shelter care proceeding under ORS 419B.185.

24 (2)(a) “Extended family member” has the meaning given that term by the law or custom
25 of an Indian child’s tribe.

26 (b) If the meaning of “extended family member” cannot be determined under paragraph
27 (a) of this subsection, “extended family member” means a person who has attained 18 years
28 of age and who is the Indian child’s grandparent, aunt, uncle, brother, sister, sister-in-law,
29 brother-in-law, niece, nephew, first cousin, second cousin, stepparent or, as determined by
30 the Indian child’s tribe, clan or band member.

31 (3) “Indian” means a person who is a member of an Indian tribe or who is an Alaska
32 Native and a member of a regional corporation as defined in section 7 of the Alaska Native
33 Claims Settlement Act (43 U.S.C. 1606).

34 (4) “Indian child” means any unmarried person who has not attained 18 years of age and:

35 (a) Is a member or citizen of an Indian tribe; or

36 (b) Is eligible for membership or citizenship in an Indian tribe and is the biological child
37 of a member of an Indian tribe.

38 (5) “Indian custodian” means an Indian, other than the Indian child’s parent, who has
39 custody, as described in section 3 (1) of this 2020 special session Act, of the Indian child, or
40 to whom temporary physical care, custody and control has been transferred by the Indian
41 child’s parent.

42 (6) “Indian tribe” or “tribe” means any Indian tribe, band, nation or other organized
43 group or community of Indians federally recognized as eligible for the services provided to
44 Indians by the United States Secretary of the Interior because of their status as Indians,
45 including any Alaska Native village as defined in 43 U.S.C. 1602(c).

1 (7) “Juvenile court” has the meaning given that term in ORS 419A.004.

2 (8) “Member” or “membership” means a determination by an Indian tribe that a person
3 is a member or citizen in that Indian tribe.

4 (9) “Parent” means:

5 (a) A biological parent of an Indian child;

6 (b) An Indian who has lawfully adopted an Indian child, including adoptions made under
7 tribal law or custom; or

8 (c) A father whose parentage has been acknowledged or established under section 4 of
9 this 2020 special session Act.

10 (10) “Party” or “parties” means parties to a proceeding, as described in ORS 419B.875.

11 (11) “Reservation” means Indian country as defined in 18 U.S.C. 1151 and any lands not
12 covered under that section, title to which is held by the United States in trust for the benefit
13 of an Indian tribe or individual or held by an Indian tribe or individual subject to a restriction
14 by the United States against alienation.

15 (12) “Tribal court” means a court with jurisdiction over child custody proceedings and
16 that is either a Court of Indian Offenses, a court established and operated under the code
17 or custom of an Indian tribe or any other administrative body of a tribe that is vested with
18 authority over child custody proceedings.

19 **SECTION 3. Custody of Indian child.** (1) An individual has custody of an Indian child
20 under sections 1 to 23 of this 2020 special session Act if the individual has physical custody
21 or legal custody of the Indian child under any applicable tribal law, tribal custom or state
22 law.

23 (2) An Indian child’s parent has continued custody of the Indian child if the parent cur-
24 rently has, or previously had, custody of the Indian child.

25 (3) For purposes of sections 1 to 23 of this 2020 special session Act, the following indi-
26 viduals are presumed to have continued custody of an Indian child:

27 (a) The Indian child’s biological mother.

28 (b) A man who is married to the Indian child’s biological mother.

29 (c) A man whose parentage has been acknowledged or established as described in section
30 4 of this 2020 special session Act.

31 **SECTION 4. Parentage.** In addition to the methods for establishing parentage under ORS
32 109.065, a man’s parentage of an Indian child is acknowledged or established for purposes of
33 sections 1 to 23 of this 2020 special session Act and ORS chapter 419B if the man’s parentage
34 has been:

35 (1) Established under tribal law;

36 (2) Recognized in accordance with tribal custom; or

37 (3) Openly proclaimed by the man to the court, to the Indian child’s family, to the De-
38 partment of Human Services or to an Oregon licensed adoption agency.

39 **SECTION 5. Best interests of Indian child.** When making a determination regarding the
40 best interests of an Indian child under sections 1 to 23 of this 2020 special session Act, ORS
41 chapter 419B, the Indian Child Welfare Act (25 U.S.C. 1901 et seq.) or any regulations or rules
42 regarding sections 1 to 23 of this 2020 special session Act or the Indian Child Welfare Act,
43 the juvenile court shall, in consultation with the Indian child’s tribe, consider the following
44 relevant factors:

45 (1) The protection of the safety, well-being, development and stability of the Indian child;

1 (2) The prevention of unnecessary out-of-home placement of the Indian child;

2 (3) The prioritization of placement of the Indian child in accordance with the placement
3 preferences under section 23 of this 2020 special session Act;

4 (4) The value to the Indian child of establishing, developing or maintaining a political,
5 cultural, social and spiritual relationship with the Indian child's tribe and tribal community;
6 and

7 (5) The importance to the Indian child of the Indian tribe's ability to maintain the tribe's
8 existence and integrity in promotion of the stability and security of Indian children and
9 families.

10 **SECTION 6. Domicile.** For purposes of sections 1 to 23 of this 2020 special session Act:

11 (1) A person's domicile is the place the person regards as home, where the person intends
12 to remain or to which, if absent, the person intends to return.

13 (2) An Indian child's domicile is, in order of priority, the domicile of:

14 (a) The Indian child's parents or, if the Indian child's parents do not have the same
15 domicile, the Indian child's parent who has physical custody of the Indian child;

16 (b) The Indian child's Indian custodian; or

17 (c) The Indian child's guardian.

18 **SECTION 7. Enrollment.** (1) Unless an Indian child's parent objects, the Department of
19 Human Services shall provide assistance with enrolling an Indian child within the juvenile
20 court's jurisdiction under ORS 419B.100 in a tribe with which the child is eligible for enroll-
21 ment.

22 (2) In any proceeding under ORS chapter 419B where there is reason to know the child
23 is an Indian child and the department reasonably believes that the Indian child is eligible for
24 enrollment in a tribe, the department shall notify the Indian child's parent of the parent's
25 right to object to the department's assistance under subsection (1) of this section.

26 **SECTION 8. Determination of Indian child's tribe.** (1) In a proceeding under ORS chapter
27 419B when there is reason to know that the child is an Indian child, the Indian child's tribe
28 is:

29 (a) If the Indian child is a member of or is eligible for membership in only one tribe, the
30 tribe of which the Indian child is a member or eligible for membership.

31 (b) If the Indian child is a member of one tribe but is eligible for membership in one or
32 more other tribes, the tribe of which the Indian child is a member.

33 (c) If the Indian child is a member of more than one tribe or if the Indian child is not a
34 member of any tribe but is eligible for membership with more than one tribe:

35 (A) The tribe designated by agreement between the tribes of which the Indian child is a
36 member or in which the Indian child is eligible for membership; or

37 (B) If the tribes are unable to agree on the designation of the Indian child's tribe, the
38 tribe designated by the court.

39 (2) When designating an Indian child's tribe under subsection (1)(c)(B) of this section, the
40 court shall, after hearing, designate the tribe with which the Indian child has the more sig-
41 nificant contacts, taking into consideration the following:

42 (a) The preference of the Indian child's parent;

43 (b) The duration of the Indian child's current or prior domicile or residence on or near
44 the reservation of each tribe;

45 (c) The tribal membership of the Indian child's custodial parent or Indian custodian;

1 (d) The interests asserted by each tribe;

2 (e) Whether a tribe has previously adjudicated a case involving the Indian child; and

3 (f) If the court determines that the Indian child is of sufficient age and capacity to
4 meaningfully self-identify, the self-identification of the Indian child.

5 (3) If an Indian child is a member of or is eligible for membership in more than one tribe,
6 the court may, in its discretion, permit a tribe, in addition to the Indian child's tribe deter-
7 mined under subsection (1) of this section, to participate in a proceeding under ORS chapter
8 419B involving the Indian child in an advisory capacity or as a party.

9
10 (Jurisdiction; Transfer)

11
12 **SECTION 9. Determination of domicile and residence.** In any proceeding under ORS
13 chapter 419B involving an Indian child, the juvenile court must determine the residence and
14 domicile of the Indian child and whether the Indian child is a ward of tribal court. The ju-
15 venile court shall communicate with any tribal courts to the extent necessary to make a
16 determination under this section.

17 **SECTION 10. Tribal-state agreements.** (1)(a) The Department of Human Services shall
18 make a good faith effort to enter into a tribal-state agreement with any Indian tribe within
19 the borders of this state.

20 (b) The department may also enter into a tribal-state agreement with any Indian tribe
21 outside of this state having significant numbers of member children or membership-eligible
22 children residing in this state.

23 (2) The purposes of a tribal-state agreement are to promote the continued existence and
24 integrity of the Indian tribe as a political entity and to protect the vital interests of Indian
25 children in securing and maintaining political, cultural and social relationships with their
26 tribe.

27 (3) A tribal-state agreement may include, but is not limited to, agreements regarding
28 default jurisdiction over cases in which the state courts and tribal courts have concurrent
29 jurisdiction, the transfer of cases between state courts and tribal courts, the assessment,
30 removal, placement and custody of Indian children and any other child welfare services pro-
31 vided to Indian children.

32 (4) A tribal-state agreement must:

33 (a) Provide for the cooperative delivery of child welfare services to Indian children in this
34 state, including the utilization, to the extent available, of services provided by the tribe or
35 an organization whose mission is to serve the American Indian or Alaska Native population
36 to implement the terms of the tribal-state agreement; and

37 (b) If services provided by the tribe or an organization whose mission is to serve the
38 American Indian or Alaska Native population are unavailable, provide for the department's
39 use of community services and resources developed specifically for Indian families and that
40 have the demonstrated experience and capacity to provide culturally relevant and effective
41 services to Indian children.

42 **SECTION 11. Saving clause.** Section 10 of this 2020 special session Act applies to tribal-
43 state agreements entered into or renewed on or after the effective date of this 2020 special
44 session Act.

45 **SECTION 12. Jurisdiction.** (1) Except as otherwise provided in this section, the juvenile

1 court's jurisdiction under ORS 419B.100 (1) in a case involving an Indian child is concurrent
2 with the Indian child's tribe.

3 (2) If a tribe is not subject to Public Law 83-280, the tribe has exclusive jurisdiction in a
4 case described in ORS 419B.100 (1) involving an Indian child if:

5 (a) The Indian child is a ward of a tribal court of the Indian child's tribe; or

6 (b) The Indian child resides or is domiciled within the reservation of the tribe.

7 (3)(a) An Indian tribe subject to Public Law 83-280 may limit the juvenile court's exercise
8 of jurisdiction under ORS 419B.100 (1) over an Indian child by entering into a tribal-state
9 agreement described in section 10 of this 2020 special session Act.

10 (b) The juvenile court shall decline to exercise its jurisdiction under ORS 419B.100 (1)
11 over an Indian child who is a ward of a tribal court of the Indian child's tribe, or who resides
12 or is domiciled within the reservation of the tribe, if:

13 (A) The tribe has entered into a tribal-state agreement in which the state has agreed to
14 decline jurisdiction; and

15 (B) The tribal-state agreement provides that the tribe has default jurisdiction over those
16 cases.

17 (c)(A) If the juvenile court declines to exercise its jurisdiction under paragraph (b) of this
18 subsection, the court shall coordinate with the tribal court to facilitate the tribal court's
19 assumption of jurisdiction.

20 (B) The juvenile court shall:

21 (i) Allow the Indian child's parent, Indian custodian or tribe to participate in any com-
22 munications under this subsection with a tribal court or, if the person is unable to partic-
23 ipate in a communication, provide the person with an opportunity to represent facts and
24 legal arguments supporting the person's position before the juvenile court makes a decision
25 regarding jurisdiction;

26 (ii) Create records of any communications under this subsection;

27 (iii) Notify the Indian child's parent, Indian custodian or tribe in advance of each com-
28 munication; and

29 (iv) Provide the Indian child's parent, Indian custodian or tribe with access to the record
30 of the communication.

31 (C) Communications between the juvenile court and a tribal court regarding calendars,
32 court records and similar matters may occur without informing the parties or creating a
33 record of the communications.

34 (D) As used in this paragraph, "record" means information that is inscribed on a tangible
35 medium or that is stored in an electronic or other medium and is retrievable in perceivable
36 form.

37 (4) Notwithstanding subsections (2) and (3) of this section, the juvenile court has tempo-
38 rary exclusive jurisdiction over an Indian child who is taken into protective custody under
39 ORS 419B.150 or 419B.152.

40 **SECTION 13. Motion to transfer to tribal court; objection.** (1) Except as provided in
41 subsection (5) of this section, the juvenile court shall transfer a proceeding under ORS
42 chapter 419B involving an Indian child if, at any time during the proceeding, the Indian
43 child's parent, Indian custodian or tribe petitions the court to transfer the proceeding to the
44 tribal court.

45 (2) Upon receipt of a transfer motion, the juvenile court shall contact the Indian child's

1 **tribe and request a timely response regarding whether the tribe intends to decline the**
2 **transfer.**

3 **(3) A party may object to the transfer motion on the basis of one of the following:**

4 **(a) That the Indian child's tribe has declined the transfer;**

5 **(b) That one or both of the Indian child's parents object to the transfer; or**

6 **(c) That good cause exists to deny the transfer.**

7 **(4)(a) If a party objects to the transfer motion for good cause, the court shall fix the time**
8 **for hearing on objections to the motion.**

9 **(b) At the hearing, the objecting party has the burden of proof of establishing by clear**
10 **and convincing evidence that good cause exists to deny the transfer.**

11 **(c) If the Indian child's tribe contests the assertion that good cause exists to deny the**
12 **transfer, the court shall give the tribe's argument substantial weight.**

13 **(d) When making a determination whether good cause exists to deny the transfer motion,**
14 **the juvenile court may not consider:**

15 **(A) Whether the proceeding is at an advanced stage;**

16 **(B) Whether there has been a prior proceeding involving the Indian child in which a**
17 **transfer motion was not filed;**

18 **(C) Whether the transfer could affect the placement of the Indian child;**

19 **(D) The Indian child's cultural connections with the tribe or the tribe's reservation;**

20 **(E) The socioeconomic conditions of the Indian child's tribe or any negative perception**
21 **of tribal or United States Bureau of Indian Affairs' social services or judicial systems; or**

22 **(F) Whether the transfer serves the best interests of the Indian child.**

23 **(5)(a) The court shall deny the transfer motion if:**

24 **(A) The tribe declines the transfer orally on the record or in writing;**

25 **(B) The Indian child's parent objects to the transfer; or**

26 **(C) The court finds by clear and convincing evidence, after hearing, that good cause ex-**
27 **ists to deny the transfer.**

28 **(b) Notwithstanding paragraph (a)(B) of this subsection, the objection of the Indian**
29 **child's parent does not preclude the transfer if:**

30 **(A) The objecting parent dies or the objecting parent's parental rights are terminated and**
31 **have not been reinstated under ORS 419B.532; and**

32 **(B) The Indian child's remaining parent, Indian custodian or tribe files a new transfer**
33 **motion subsequent to the death of the objecting parent or the termination of the parental**
34 **rights of the objecting parent.**

35 **(6) If the juvenile court denies a transfer under this section, the court shall document**
36 **the basis for the denial in a written order.**

37 **SECTION 14. Transfer. Upon granting a transfer motion under section 13 of this 2020**
38 **special session Act, the juvenile court shall expeditiously:**

39 **(1) Notify the tribal court of the pending dismissal of the proceeding;**

40 **(2) Transfer all information regarding the proceeding, including but not limited to**
41 **pleadings and court records, to the tribal court;**

42 **(3) Direct the Department of Human Services to:**

43 **(a) Coordinate with the tribal court and the Indian child's tribe to ensure that the**
44 **transfer of the proceeding and the transfer of custody of the Indian child is accomplished**
45 **with minimal disruption of services to the Indian child and the Indian child's family; and**

1 (b) Provide the Indian child's tribe with documentation related to the Indian child's el-
2 igibility for state and federal assistance and information related to the Indian child's social
3 history, treatment diagnosis and services and other relevant case and service related data;
4 and

5 (4) Dismiss the proceeding upon confirmation from the tribal court that the tribal court
6 received the transferred information.

7
8 (Inquiry; Notice)

9
10 **SECTION 15. Emergency inquiry; inquiry; reason to know child is Indian child.** (1) In an
11 emergency proceeding, the person taking the child into protective custody shall make a good
12 faith effort to determine whether there is reason to know that the child is an Indian child
13 and to contact by telephone, electronic mail, facsimile or other means of immediate com-
14 munication any tribe of which the child is or may be a member to determine the child's af-
15 filiation.

16 (2) Except as provided in subsection (1) of this section, whenever a person is required
17 under ORS chapter 419B to determine whether there is reason to know that a child is an
18 Indian child, if the person has not already determined that the child is an Indian child, the
19 person shall make a good faith effort to determine whether there is reason to know the child
20 is an Indian child, including by consulting with:

21 (a) The child;

22 (b) The child's parent or parents;

23 (c) Any person having custody of the child or with whom the child resides;

24 (d) Extended family members of the child;

25 (e) Any other person who may reasonably be expected to have information regarding the
26 child's membership or eligibility for membership in an Indian tribe; and

27 (f) Any Indian tribe of which the child may be a member or of which the child may be
28 eligible for membership.

29 (3)(a) At the commencement of any hearing in which the court is required to inquire
30 whether a child is an Indian child, the court shall ask, on the record, each individual present
31 on the matter whether the individual knows or has reason to know that the child is an Indian
32 child.

33 (b) If no individual in the proceeding knows or has reason to know that the child is an
34 Indian child, the court shall instruct each party to inform the court immediately if the party
35 later receives information that provides reason to know the child is an Indian child.

36 (4) A court has reason to know that a child is an Indian child if:

37 (a) Any individual present in the proceeding, officer of the court involved in the pro-
38 ceeding, Indian tribe, Indian organization or agency informs the court that the child is an
39 Indian child;

40 (b) Any individual present in the proceeding, officer of the court involved in the pro-
41 ceeding, Indian tribe, Indian organization or agency informs the court that information has
42 been discovered indicating that the child is an Indian child;

43 (c) The child indicates to the court that the child is an Indian child;

44 (d) The court is informed that the domicile or residence of the child, the child's parent
45 or the child's Indian custodian is on a reservation or in an Alaska Native village;

1 (e) The court is informed that the child is or has been a ward of a tribal court;

2 (f) The court is informed that the child or the child's parent possesses an identification
3 card or other record indicating membership in an Indian tribe;

4 (g) Testimony or documents presented to the court indicate in any way that the child
5 may be an Indian child; or

6 (h) Any other indicia provided to the court, or within the court's knowledge, indicates
7 that the child is an Indian child.

8 (5) If the court has reason to know the child is an Indian child but the court does not
9 have sufficient evidence to determine whether the child meets the definition of Indian child,
10 the court must:

11 (a) Treat the child as an Indian child until the court determines, on the record, that the
12 child does not meet the definition of an Indian child; and

13 (b) Require the Department of Human Services or another party to submit a report,
14 declaration or testimony on the record that the department or other party used due diligence
15 to identify and work with all of the tribes of which there is reason to know the child may
16 be a member or be eligible for membership to verify whether:

17 (A) The child is a member; or

18 (B) The child is eligible for membership and is the biological child of a member.

19 **SECTION 16. Emergency notification; formal notice.** (1)(a) In an emergency proceeding,
20 if there is reason to know that a child is an Indian child and the nature of the emergency
21 allows, the Department of Human Services must notify by telephone, electronic mail, fac-
22 simile or other means of immediate communication any tribe of which the child is or may
23 be a member.

24 (b) Notification under this subsection must include the basis for the child's removal, the
25 time, date and place of the initial hearing and a statement that the tribe, as a party to the
26 proceeding under ORS 419B.875, has the right to participate in the proceeding.

27 (2) Except as provided in subsection (1) of this section, if there is reason to know a child
28 in a proceeding under ORS chapter 419B is an Indian child and notice is required, the party
29 providing notice must:

30 (a) Promptly send notice of the proceeding as described in subsection (3) of this section;
31 and

32 (b) File an original or a copy of each notice sent under this section with the court, to-
33 gether with any return receipts or other proof of service.

34 (3) Notice under subsection (2) of this section must:

35 (a) Be sent to:

36 (A) Each tribe of which the child may be a member or of which the Indian child may be
37 eligible for membership;

38 (B) The child's parents;

39 (C) The child's Indian custodian, if applicable; and

40 (D) The appropriate United States Bureau of Indian Affairs Regional Director listed in
41 25 C.F.R. 23.11(b), if the identity or location of the child's parents, Indian custodian or tribe
42 cannot be ascertained.

43 (b) Be sent by registered or certified mail, return receipt requested.

44 (c) Be in clear and understandable language and include the following:

45 (A) The child's name, date of birth and place of birth;

1 (B) To the extent known, all names, including maiden, married and former names or al-
2 iases, of the child's parents, the parents' birthplaces and tribal enrollment numbers;

3 (C) To the extent known, the names, dates of birth, places of birth and tribal enrollment
4 information of other direct lineal ancestors of the child;

5 (D) The name of each Indian tribe in which the child is a member or of which the Indian
6 child may be eligible for membership;

7 (E) If notice is required to be sent to the United States Bureau of Indian Affairs under
8 paragraph (a) of this subsection, to the extent known, information regarding the child's di-
9 rect lineal ancestors, an ancestral chart for each biological parent, and the child's tribal af-
10 filiations and blood quantum;

11 (F) A copy of the petition initiating the proceeding and, if a hearing has been scheduled,
12 information on the date, time and location of the hearing;

13 (G) The name of the petitioner and the name and address of the petitioner's attorney;

14 (H) A statement that the child's parent or Indian custodian, as a party to the proceeding
15 under ORS 419B.875, has the right to participate in the proceeding;

16 (I) A statement that the child's tribe, as a party to the proceeding under ORS 419B.875,
17 has the right to participate in the proceeding;

18 (J) A statement that if the court determines that the child's parent or Indian custodian
19 is unable to afford counsel, the parent or Indian custodian has the right to court-appointed
20 counsel;

21 (K) A statement that the child's parent, Indian custodian or tribe has the right, upon
22 request, to up to 20 additional days to prepare for the proceeding;

23 (L) A statement that the child's parent, Indian custodian or tribe has the right to peti-
24 tion the court to transfer the proceeding to the tribal court;

25 (M) A statement describing the potential legal consequences of the proceeding on the
26 future parental and custodial rights of the parent or Indian custodian;

27 (N) The mailing addresses and telephone numbers of the court and contact information
28 for all parties to the proceeding and individuals notified under this section; and

29 (O) A statement that the information contained in the notice is confidential and that the
30 notice should not be shared with any person not needing the information to exercise rights
31 under sections 1 to 23 of this 2020 special session Act.

32 (4) If there is a reason to know that the Indian child's parent or Indian custodian has
33 limited English proficiency and may not understand the contents of the notice under sub-
34 section (2) of this section, the court must provide language access services as required by
35 Title VI of the Civil Rights Act of 1964 and other applicable federal and state laws. If the
36 court is unable to secure translation or interpretation support, the court shall contact or
37 direct a party to contact the Indian child's tribe or the local office of the United States Bu-
38 reau of Indian Affairs for assistance identifying a qualified translator or interpreter.

39 (5)(a) No hearing requiring notice under subsection (2) of this section may be held until
40 at least 10 days after the later of receipt of the notice by the Indian child's parent, Indian
41 custodian or tribe or, if applicable, the United States Bureau of Indian Affairs. Upon request,
42 the court shall grant the Indian child's parent, Indian custodian or tribe up to 20 additional
43 days from the date upon which notice was received by the parent, Indian custodian or tribe
44 to prepare for participation in the hearing.

45 (b) Nothing in this subsection prevents a court from reviewing a removal of an Indian

1 child from the Indian child's parent or Indian custodian at an emergency proceeding before
2 the expiration of the waiting period described in paragraph (a) of this subsection to deter-
3 mine the appropriateness of the removal and potential return of the child.

5 (Hearing Procedure)
6

7 **SECTION 17. Qualified expert witness.** (1) In any proceeding under ORS chapter 419B
8 that requires the testimony of a qualified expert witness, the petitioner shall contact the
9 Indian child's tribe and request that the tribe identify one or more individuals meeting the
10 criteria described in subsection (3) or (4) of this section. The petitioner may also request the
11 assistance of the United States Bureau of Indian Affairs in locating individuals meeting the
12 criteria described in subsection (3) or (4) of this section. The petitioner shall file a declara-
13 tion with the court describing the efforts the petitioner made under this subsection to iden-
14 tify a qualified expert witness.

15 (2) At a hearing under ORS 419B.340, 419B.365, 419B.366 or 419B.521 when there is reason
16 to know a child is an Indian child and a qualified expert witness is required, at least one
17 qualified expert witness must testify regarding:

18 (a) Whether the Indian child's continued custody by the Indian child's parent or Indian
19 custodian is likely to result in serious emotional or physical damage to the Indian child; and

20 (b) The prevailing social and cultural standards and child rearing practices of the Indian
21 child's tribe.

22 (3) A person is a qualified expert witness under this section if the Indian child's tribe has
23 designated the person as being qualified to testify to the prevailing social and cultural stan-
24 dards of the tribe.

25 (4) If the Indian child's tribe has not identified a qualified expert witness, the following
26 individuals, in order of priority, may testify as a qualified expert witness:

27 (a) A member of the Indian child's tribe or another person of the tribe's choice who is
28 recognized by the tribe as knowledgeable tribal customs regarding family organization or
29 child rearing practices;

30 (b) A person having substantial experience in the delivery of child and family services to
31 Indians and extensive knowledge of prevailing social and cultural standards and child rearing
32 practices within the Indian child's tribe; or

33 (c) Any person having substantial experience in the delivery of child and family services
34 to Indians and knowledge of prevailing social and cultural standards and child rearing prac-
35 tices in Indian tribes with cultural similarities to the child's tribe.

36 (5) In addition to testimony from a qualified expert witness, the court may hear supple-
37 mental testimony regarding information described in subsection (2) of this section from a
38 professional having substantial education and experience in the area of the professional's
39 specialty.

40 (6) No petitioning party, employees of the petitioning party or an employee of the De-
41 partment of Human Services may serve as a qualified expert witness or a professional under
42 this section.

43 **SECTION 18. Active efforts.** (1) As used in this section, "active efforts" means efforts
44 that are affirmative, active, thorough, timely and intended to maintain or reunite an Indian
45 child with the Indian child's family.

1 **(2) If there is reason to know that a child in a proceeding under ORS chapter 419B is an**
2 **Indian child and active efforts are required, the court must determine whether active efforts**
3 **have been made to prevent the breakup of the family or to reunite the family.**

4 **(3) Active efforts require a higher standard of conduct than reasonable efforts.**

5 **(4) Active efforts must:**

6 **(a) Be documented in detail in writing and on the record;**

7 **(b) Include assisting the Indian child's parent or parents or Indian custodian through the**
8 **steps of a case plan and with accessing or developing the resources necessary to satisfy the**
9 **case plan;**

10 **(c) Include providing assistance in a manner consistent with the prevailing social and**
11 **cultural standards and way of life of the Indian child's tribe;**

12 **(d) Be conducted in partnership with the Indian child and the Indian child's parents, ex-**
13 **tended family members, Indian custodians and tribe; and**

14 **(e) Be tailored to the facts and circumstances of the case.**

15 **(5) Active efforts may include, as applicable, the following:**

16 **(a) Conducting a comprehensive assessment of the circumstances of the Indian child's**
17 **family, with a focus on reunification as the most desirable goal;**

18 **(b) Identifying appropriate services and helping the Indian child's parents overcome bar-**
19 **riers to reunification, including actively assisting the parents in obtaining the identified**
20 **services;**

21 **(c) Identifying, notifying and inviting representatives of the Indian child's tribe to par-**
22 **ticipate in providing support and services to the Indian child's family and in family team**
23 **meetings, permanency planning, resolution of placement issues, reviews or other case man-**
24 **agement related meetings;**

25 **(d) Conducting or causing to be conducted a diligent search for the Indian child's ex-**
26 **tended family members, contacting and consulting with the Indian child's extended family**
27 **members and adult relatives to provide family structure and support for the Indian child and**
28 **the Indian child's parents;**

29 **(e) Offering and employing culturally appropriate family preservation strategies and fa-**
30 **cilitating the use of remedial and rehabilitative services provided by the Indian child's tribe;**

31 **(f) Taking steps to keep the Indian child and the Indian child's siblings together whenever**
32 **possible;**

33 **(g) Supporting regular visits with the Indian child's parent or Indian custodian in the**
34 **most natural setting possible, as well as trial home visits during any period of removal,**
35 **consistent with the need to ensure the health, safety and welfare of the Indian child;**

36 **(h) Identifying community resources, including housing, financial assistance, employment**
37 **training, transportation, mental health, health care, substance abuse prevention and treat-**
38 **ment, parent training, transportation and peer support services and actively assisting the**
39 **Indian child's parents or, when appropriate, the Indian child's extended family members, in**
40 **utilizing and accessing those resources;**

41 **(i) Monitoring progress and participation of the Indian child's parents, Indian custodian**
42 **or extended family members in the services as described in paragraphs (b), (c), (e) and (h)**
43 **of this subsection;**

44 **(j) Considering alternative options to address the needs of the Indian child's parents and,**
45 **where appropriate, the Indian child's extended family members, if the services as described**

1 in paragraphs (b), (c), (e) and (h) of this subsection are not available;

2 (k) Providing post-reunification services and monitoring for the duration of juvenile
3 court's jurisdiction; and

4 (L) Any other efforts that are appropriate to the Indian child's circumstances.

5 **SECTION 19. Right to appear.** (1) Notwithstanding ORS 9.160 and 9.320, a tribe that is a
6 party to a proceeding under ORS 419B.875 (1)(a)(H) may be represented by any individual,
7 regardless of whether the individual is licensed to practice law.

8 (2) An attorney who is not barred from practicing law in this state may appear in any
9 proceeding involving an Indian child without associating with local counsel if the attorney
10 establishes to the satisfaction of the Oregon State Bar that:

11 (a) The attorney will appear in a court in this state for the limited purpose of partic-
12 ipating in a proceeding under ORS chapter 419B subject to the provisions of sections 1 to 23
13 of this 2020 special session Act;

14 (b) The attorney represents an Indian child's parent, Indian custodian or tribe; and

15 (c) The Indian child's tribe has affirmed the Indian child's membership or eligibility for
16 membership under tribal law.

17 (3) Notwithstanding ORS 419B.875 (1)(a)(H), an Indian custodian or tribe may notify the
18 court, orally on the record or in writing, that the Indian custodian or tribe withdraws as a
19 party to the proceeding.

20 **SECTION 20. Right to counsel.** (1) If there is reason to know that a child in a proceeding
21 under ORS chapter 419B is an Indian child:

22 (a) The court shall appoint counsel to represent the Indian child.

23 (b) If the Indian child's parent or Indian custodian requests counsel to represent the
24 parent or Indian custodian but is without sufficient financial means to employ suitable
25 counsel possessing skills and experience commensurate with the nature of the petition and
26 the complexity of the case, the court shall appoint suitable counsel to represent the Indian
27 child's parent or Indian custodian if the parent or Indian custodian is determined to be fi-
28 nancially eligible under the policies, procedures, standards and guidelines of the Public De-
29 fense Services Commission.

30 (2) Upon presentation of the order of appointment under this section by the attorney for
31 the Indian child, any agency, hospital, school organization, division or department of the
32 state, doctor, nurse or other health care provider, psychologist, psychiatrist, police depart-
33 ment or mental health clinic shall permit the attorney for the Indian child to inspect and
34 copy any records of the Indian child involved in the case, without the consent of the Indian
35 child or the Indian child's parent or Indian custodian. This subsection does not apply to re-
36 cords of a police agency relating to an ongoing investigation prior to bringing charges.

37 **SECTION 21. Right to examine documents.** In any proceeding under ORS chapter 419B
38 when there is reason to know that the child is an Indian child, each party has the right to
39 timely examine all reports or other documents held by the Department of Human Services
40 that are not otherwise subject to a discovery exception under ORS 419B.881 or precluded
41 under state or federal law.

42 **SECTION 22. Improper placements or terminations of parental rights involving Indian**
43 **children.** (1) A petition to invalidate the placement of an Indian child, the guardianship of
44 an Indian child or the termination of parental rights involving an Indian child may be filed
45 in any court of competent jurisdiction by:

1 (a) An Indian child who is or was under the jurisdiction of the juvenile court under ORS
2 chapter 419B;

3 (b) The Indian child's parent or Indian custodian from whose custody such child was re-
4 moved; or

5 (c) The Indian child's tribe.

6 (2)(a) The court shall invalidate the placement of an Indian child, the guardianship of an
7 Indian child or the termination of parental rights involving an Indian child if the court de-
8 termines that any provision of sections 12, 13, 16 (2), (3)(a) or (b), (5)(a), 20 (1) or 21 of this
9 2020 special session Act, ORS 418.312 or, where required, section 17 (2), 18 or 23 of this 2020
10 special session Act has been violated.

11 (b) The proceeding that led to the violation must be vacated and, if the proceeding led
12 to the removal or placement of the Indian child, the court shall order the child immediately
13 returned to the Indian child's parent or Indian custodian, and any issues determined must
14 be relitigated.

15 (3)(a) If any party to a proceeding under ORS chapter 419B involving an Indian child as-
16 serts or the court has reason to believe that the Indian child may have been improperly re-
17 tained following a visit or temporary relinquishment of custody or improperly removed, the
18 court shall expeditiously determine whether the Indian child was improperly retained or im-
19 properly removed.

20 (b) If the court finds that the Indian child was improperly retained or improperly re-
21 moved, the court shall terminate the proceeding and order the Department of Human Ser-
22 vices to immediately return the Indian child to the Indian child's parent or Indian custodian,
23 unless the court determines by clear and convincing evidence that doing so would subject the
24 Indian child to substantial and immediate danger or a threat of substantial and immediate
25 danger.

26
27 (Preferred Placement)

28
29 **SECTION 23. Placement preferences.** (1) If there is reason to know that a child is an
30 Indian child and the child is in need of placement or continuation in substitute care, as de-
31 fined in ORS 419A.004, except as provided in subsection (4) of this section the child must be
32 placed in the least restrictive setting that:

33 (a) Most closely approximates a family, taking into consideration sibling attachment;

34 (b) Allows the Indian child's special needs, if any, to be met;

35 (c) Is in reasonable proximity to the Indian child's home, extended family or siblings; and

36 (d)(A) Is in accordance with the order of preference established by the Indian child's
37 tribe; or

38 (B) If the Indian child's tribe has not established placement preferences, is in accordance
39 with the following order of preference:

40 (i) A member of the Indian child's extended family;

41 (ii) A foster home licensed, approved or specified by the Indian child's tribe;

42 (iii) A foster home licensed or approved by a licensing authority in this state and in which
43 one or more of the licensed or approved foster parents is an Indian; or

44 (iv) An institution for children that has a program suitable to meet the Indian child's
45 needs and is approved by an Indian tribe or operated by an Indian organization.

1 **(2) If the juvenile court finds that an Indian child is in need of a guardianship pursuant**
2 **to ORS 419B.365 or 419B.366, except as provided in subsection (4) of this section, the Indian**
3 **child shall be placed:**

4 **(a) In accordance with the order of preference established by the Indian child's tribe; or**

5 **(b) If the Indian child's tribe has not established guardianship placement preferences,**
6 **according to the following order of preference:**

7 **(A) With a member of the Indian child's extended family;**

8 **(B) With other members of the Indian child's tribe; or**

9 **(C) With other Indian families.**

10 **(3) If any party asserts or the court has reason to believe that the Indian child may have**
11 **been placed contrary to the placement preferences of subsection (1) or (2) of this section, the**
12 **court shall make a determination regarding the placement under section 22 of this 2020**
13 **special session Act.**

14 **(4)(a) A party may move the court for authority to make a placement contrary to the**
15 **placement preferences of subsection (1) or (2) of this section. The motion must detail the**
16 **reasons the party asserts that good cause exists for placement contrary to the placement**
17 **preferences established by subsection (1) or (2) of this section.**

18 **(b) Upon the filing of an objection to a motion under this subsection, the juvenile court**
19 **shall fix the time for hearing on the objections.**

20 **(c) If the juvenile court determines that the moving party has established, by clear and**
21 **convincing evidence, that there is good cause to depart from the placement preferences un-**
22 **der this section, the court may authorize placement in an alternative placement.**

23 **(d) The court's determination under paragraph (c) of this subsection:**

24 **(A) Must be in writing and be based on:**

25 **(i) The preferences of the Indian child;**

26 **(ii) The presence of a sibling attachment that cannot be maintained through placement**
27 **consistent with the placement preferences established by subsection (1) or (2) of this section;**

28 **(iii) Any extraordinary physical, mental or emotional needs of the Indian child that re-**
29 **quire specialized treatment services if, despite active efforts, those services are unavailable**
30 **in the community where families who meet the placement preferences under subsection (1)**
31 **or (2) of this section reside; or**

32 **(iv) Whether, despite a diligent search, a placement meeting the placement preferences**
33 **under this section is unavailable, as determined by the prevailing social and cultural stan-**
34 **dards of the Indian community in which the Indian child's parent or extended family resides**
35 **or with which the Indian child's parent or extended family members maintain social and**
36 **cultural ties.**

37 **(B) May be informed by but not determined by the placement request of a parent of the**
38 **Indian child, if the parent has reviewed the placement options, if any, that comply with the**
39 **placement preferences under this section.**

40 **(C) May not be based on:**

41 **(i) The socioeconomic conditions of the Indian child's tribe;**

42 **(ii) Any perception of the tribal or United States Bureau of Indian Affairs social services**
43 **or judicial systems;**

44 **(iii) The distance between a placement meeting the placement preferences under this**
45 **section that is located on or near a reservation and the Indian child's parent; or**

1 (iv) The ordinary bonding or attachment between the Indian child and a nonpreferred
2 placement arising from time spent in the nonpreferred placement.

4 **INDIAN CHILD WELFARE**
5 **IN EXISTING OREGON JUVENILE CODE**
6 **(Policy)**
7

8 **SECTION 24.** ORS 418.627 is amended to read:

9 418.627. [(1) *The Legislative Assembly finds that in the Indian Child Welfare Act, Public Law*
10 *95-608, the United States Congress recognized the special legal status of Indian tribes and their mem-*
11 *bers. This section implements the federal policy of protecting Indian cultures by insuring the placement*
12 *of Indian children within Indian families or communities, and that as a consequence, the State of*
13 *Oregon should take the actions provided in subsections (2) to (4) of this section.*]

14 [(2)] (1) A person providing a foster home to an American Indian child shall be eligible for
15 payments under ORS 418.625 to 418.645 regardless of the relationship by blood or marriage that the
16 person has to the child where the child's placement in the foster home is pursuant to the Indian
17 Child Welfare Act (25 U.S.C. 1901 et seq.).

18 [(3)] (2) Certification of a foster home described in subsection [(2)] (1) of this section shall be
19 pursuant to standards set out in an agreement between the Department of Human Services and the
20 tribe of which the child is a member or, if there is no such agreement, certification shall be pursuant
21 to standards adopted by a federally recognized Indian tribe.

22 [(4)] (3) If subsection [(2) or (3)] (1) or (2) of this section is found to be unconstitutional for any
23 reason, then the entire section shall be null and void.

24 **SECTION 25.** ORS 419B.090 is amended to read:

25 419B.090. (1) The juvenile court is a court of record and exercises jurisdiction as a court of
26 general and equitable jurisdiction and not as a court of limited or inferior jurisdiction. The juvenile
27 court is called "The _____ Court of _____ County, Juvenile Department."

28 (2)(a) It is the policy of the State of Oregon to recognize that children are individuals who have
29 legal rights. Among those rights are the right to:

30 (A) Permanency with a safe family;

31 (B) Freedom from physical, sexual or emotional abuse or exploitation; and

32 (C) Freedom from substantial neglect of basic needs.

33 (b) Parents and guardians have a duty to afford their children the rights listed in paragraph (a)
34 of this subsection. Parents and guardians have a duty to remove any impediment to their ability to
35 perform parental duties that afford these rights to their children. When a parent or guardian fails
36 to fulfill these duties, the juvenile court may determine that it is in the best interests of the child
37 to remove the child from the parent or guardian either temporarily or permanently.

38 (c) The provisions of this chapter shall be liberally construed to the end that a child coming
39 within the jurisdiction of the court may receive such care, guidance, treatment and control as will
40 lead to the child's welfare and the protection of the community.

41 (3) It is the policy of the State of Oregon to safeguard and promote each child's right to safety,
42 stability and well-being and to safeguard and promote each child's relationships with parents, sib-
43 lings, grandparents, other relatives and adults with whom a child develops healthy emotional at-
44 tachments.

45 (4) It is the policy of the State of Oregon to guard the liberty interest of parents protected by

1 the Fourteenth Amendment to the United States Constitution and to protect the rights and interests
2 of children, as provided in subsection (2) of this section. The provisions of this chapter shall be
3 construed and applied in compliance with federal constitutional limitations on state action estab-
4 lished by the United States Supreme Court with respect to interference with the rights of parents
5 to direct the upbringing of their children, including, but not limited to, the right to:

- 6 (a) Guide the secular and religious education of their children;
- 7 (b) Make health care decisions for their children; and
- 8 (c) Discipline their children.

9 (5) It is the policy of the State of Oregon, in those cases not described as extreme conduct under
10 ORS 419B.502, to offer appropriate reunification services to parents and guardians to allow them the
11 opportunity to adjust their circumstances, conduct or conditions to make it possible for the child to
12 safely return home within a reasonable time. The state shall provide to parents and guardians with
13 disabilities opportunities to benefit from or participate in reunification services that are equal to
14 those extended to individuals without disabilities. The state shall provide aids, benefits and services
15 different from those provided to parents and guardians without disabilities, when necessary to en-
16 sure that parents and guardians with disabilities are provided with an equal opportunity under this
17 subsection. Although there is a strong preference that children live in their own homes with their
18 own families, the state recognizes that it is not always possible or in the best interests of the child
19 or the public for children who have been abused or neglected to be reunited with their parents or
20 guardians. In those cases, the State of Oregon has the obligation to create or provide an alternative,
21 safe and permanent home for the child.

22 *[(6) The State of Oregon recognizes the value of the Indian Child Welfare Act and hereby incor-*
23 *porates the policies of that Act.]*

24 **(6) It is the policy of the State of Oregon, in a case involving an Indian child, to safeguard**
25 **and promote the Indian child's connections with the Indian child's family, culture and tribe**
26 **in accordance with the policies regarding Indian children in dependency proceedings under**
27 **section 1 of this 2020 special session Act.**

29 **(Definitions)**

30
31 **SECTION 26.** ORS 419A.004 is amended to read:

32 419A.004. As used in this chapter and ORS chapters 419B and 419C, unless the context requires
33 otherwise:

34 (1) "Age-appropriate or developmentally appropriate activities" means:

35 (a) Activities or items that are generally accepted as suitable for children of the same chrono-
36 logical age or level of maturity or that are determined to be developmentally appropriate for a child,
37 based on the development of cognitive, emotional, physical and behavioral capacities that are typical
38 for an age or age group; and

39 (b) In the case of a specific child, activities or items that are suitable for the child based on the
40 developmental stages attained by the child with respect to the cognitive, emotional, physical and

42 (2) "Another planned permanent living arrangement" means an out-of-home placement for a ward
43 16 years of age or older that is consistent with the case plan and in the best interests of the ward
44 other than placement:

45 (a) By adoption;

- 1 (b) With a legal guardian; or
2 (c) With a fit and willing relative.
- 3 (3) "CASA Volunteer Program" means a program that is approved or sanctioned by a juvenile
4 court, has received accreditation from the National CASA Association and has entered into a con-
5 tract with the Oregon Department of Administrative Services under ORS 184.492 to recruit, train
6 and supervise volunteers to serve as court appointed special advocates.
- 7 (4) "Child care center" means a residential facility for wards or youth offenders that is licensed,
8 certified or otherwise authorized as a child-caring agency as that term is defined in ORS 418.205.
- 9 (5) "Community service" has the meaning given that term in ORS 137.126.
- 10 (6) "Conflict of interest" means a person appointed to a local citizen review board who has a
11 personal or pecuniary interest in a case being reviewed by that board.
- 12 (7) "Counselor" means a juvenile department counselor or a county juvenile probation officer.
- 13 (8) "Court" means the juvenile court.
- 14 (9) "Court appointed special advocate" means a person in a CASA Volunteer Program who is
15 appointed by the court to act as a court appointed special advocate pursuant to ORS 419B.112.
- 16 (10) "Court facility" has the meaning given that term in ORS 166.360.
- 17 (11) "Current caretaker" means a foster parent:
- 18 (a) Who is currently caring for a ward who is in the legal custody of the Department of Human
19 Services and who has a permanency plan or concurrent permanent plan of adoption; and
- 20 (b) Who has cared for the ward, or at least one sibling of the ward, for at least 12 cumulative
21 months or for one-half of the ward's or sibling's life where the ward or sibling is younger than two
22 years of age, calculated cumulatively.
- 23 (12) "Department" means the Department of Human Services.

39 substitute care in the legal custody of the Department of Human Services.

40 **SECTION 59.** ORS 419B.452 is amended to read:

41 419B.452. Except when a child or ward has been surrendered for adoption or the parents' rights
42 have been terminated, the court shall send a copy of the report required by ORS 419B.440 to the
43 parents and shall notify the parents either that a hearing will be held or that the parents may re-
44 quest a hearing at which time they may ask for modifications in the care, treatment and supervision
45 of the child or ward. If the court finds that informing the parents of the identity and location of the

1 foster parents of the child or ward is not in the best interest of the child or ward, the court may
 2 order such information deleted from the report before sending the report to the parents. If **there**
 3 **is reason to know, as described in section 15 of this 2020 special session Act, that** an Indian
 4 child is involved, the court shall send a copy of the report to the Indian child's tribe as required
 5 by the notice requirements [*of the Indian Child Welfare Act*] **under section 16 of this 2020 special**
 6 **session Act.**

7 **SECTION 60.** ORS 419B.923 is amended to read:

8 419B.923. (1) Except as otherwise provided in this section, on motion and such notice and
 9 hearing as the court may direct, the court may modify or set aside any order or judgment made by
 10 it. Reasons for modifying or setting aside an order or judgment include, but are not limited to:

11 (a) Clerical mistakes in judgments, orders or other parts of the record and errors in the order
 12 or judgment arising from oversight or omission. These mistakes and errors may be corrected by the
 13 court at any time on its own motion or on the motion of a party and after notice as the court orders
 14 to all parties who have appeared. During the pendency of an appeal, an order or judgment may be
 15 corrected as provided in subsection (7) of this section.

16 (b) Excusable neglect.

17 (c) Newly discovered evidence that by due diligence could not have been discovered in time to
 18 present it at the hearing from which the order or judgment issued.

19 (2) A motion to modify or set aside an order or judgment or request a new hearing must be
 20 accompanied by an affidavit that states with reasonable particularity the facts and legal basis for
 21 the motion.

22 (3) A motion to modify or set aside an order or judgment must be made within a reasonable time
 23 except no order or judgment pursuant to ORS 419B.527 may be set aside or modified during the
 24 pendency of a proceeding for the adoption of the ward, nor after a petition for adoption has been
 25 granted.

26 (4) Except as provided in subsection (6) of this section, notice and a hearing as provided in ORS
 27 419B.195, 419B.198, 419B.201, 419B.205, 419B.208, 419B.310, 419B.325 and 419B.893 must be provided
 28 in any case when the effect of modifying or setting aside the order or judgment will or may be to
 29 deprive a parent of the legal custody of the child or ward, to place the child or ward in an institu-
 30 tion or agency or to transfer the child or ward from one institution or agency to another. The pro-
 31 visions of this subsection do not apply to a parent whose rights have been terminated under ORS
 32 419B.500 to 419B.524 or whose child has been permanently committed by order or judgment of the
 33 court unless an appeal from the order or judgment is pending.

34 (5) When **there is reason to know, as described in section 15 of this 2020 special session**
 35 **Act, that** an Indian child is involved, notice must be provided as required under [*the Indian Child*
 36 *Welfare Act*] **section 16 of this 2020 special session Act.**

37 (6) Except when the child or ward is an Indian child, notice and a hearing are not required when
 38 the effect of modifying or setting aside the order or judgment will be to transfer the child or ward
 39 from one foster home to another.

40 (7) A motion under subsection (1) of this section may be filed with and decided by the trial court
 41 during the time an appeal from a judgment is pending before an appellate court. The moving party
 42 shall serve a copy of the motion on the appellate court. The moving party shall file a copy of the
 43 trial court's order or judgment in the appellate court within seven days of the date of the trial court
 44 order or judgment. Any necessary modification of the appeal required by the court order or judg-
 45 ment must be pursuant to rule of the appellate court.

1 (8) This section does not limit the inherent power of a court to modify an order or judgment
2 within a reasonable time or the power of a court to set aside an order or judgment for fraud upon
3 the court.

7 **SECTION 61. Reports.** No later than September 15 of every even-numbered year, the
8 Department of Human Services and the Judicial Department shall report to the interim
9 committees of the Legislative Assembly relating to children regarding:

10 (1) The number of Indian children involved in dependency proceedings during the prior
11 two-year period.

12 (2) The average duration Indian children were in protective custody.

13 (3) The ratio of Indian children to non-Indian children in protective custody.

14 (4) Which tribes the Indian children in protective custody were members of or of which
15 they were eligible for membership.

16 (5) The number of Indian children in foster care who are in each of the placement pref-
17 erence categories described in section 23 of this 2020 special session Act and the number of
18 those placements that have Indian parents in the home.

19 (6) The number of Indian children placed in adoptive homes in each of the placement
20 preference categories described in section 23 of this 2020 special session Act and the number
21 of those placements that have Indian parents in the home.

22 (7) The number of available placements and common barriers to recruitment and re-
23 tention of appropriate placements.

24 (8) The number of times the court determined that good cause existed to deviate from
25 the statutory placement preferences under section 23 of this 2020 special session Act.

26 (9) The number of cases that were transferred to tribal court under section 14 of this
27 2020 special session Act.

28 (10) The number of times the court found good cause to decline to transfer jurisdiction
29 of a case to tribal court upon request and the most common reasons the court found good
30 cause to decline a transfer petition.

31 (11) The efforts the Department of Human Services and the Judicial Department have
32 taken to ensure compliance with the provisions of sections 1 to 23 of this 2020 special session
33 Act and the amendments to statutes by sections 24 to 60 of this 2020 special session Act.

34 **SECTION 62. First report due.** The report under section 61 of this 2020 special session
35 Act is first due no later than September 15, 2022.

36 **SECTION 63. Full faith and credit.** The juvenile court shall give full faith and credit to
37 the public acts, records and judicial proceedings of an Indian tribe applicable to an Indian
38 child custody proceeding.

39 **SECTION 64. Conflict of laws.** If any provision of sections 1 to 23 of this 2020 special
40 session Act or the amendments to statutes by sections 24 to 60 of this 2020 special session
41 Act is found to contravene the Indian Child Welfare Act (25 U.S.C. 1901 et seq.), it shall not
42 serve to render inoperative any remaining provisions of sections 1 to 23 of this 2020 special
43 session Act or the amendments to statutes by sections 24 to 60 of this 2020 special session
44 Act that may be held not to conflict with the Indian Child Welfare Act.

45 **SECTION 65. Rules.** The Department of Human Services and the Judicial Department

1 may adopt rules to implement sections 1 to 23 of this 2020 special session Act.

2 **SECTION 66. Captions.** The unit and section captions used in this 2020 special session
3 Act are provided only for the convenience of the reader and do not become part of the stat-
4 utory law of this state or express any legislative intent in the enactment of this 2020 special
5 session Act.
