**PROPOSED AMENDMENTS TO
SENATE BILL 1601**

1 On page 13 of the printed bill, after line 11, insert:

3 **“MORATORIUM ON CERTAIN TRAFFIC OFFENSES**

5 **“SECTION 20. Section 21 of this 2020 special session Act is added to**
6 **and made a part of the Oregon Vehicle Code.**

7 **“SECTION 21. (1) As used in this section, ‘document or credential’**
8 **includes but is not limited to documents or credentials issued or ac-**
9 **cepted by the Department of Transportation such as vehicle registra-**
10 **tion, registration stickers, driving privileges, declaration of weight,**
11 **disabled person parking permits, trip permits, driver licenses and**
12 **driver permits.**

13 **“(2) Notwithstanding any other provision of law, a police officer**
14 **may not issue a citation for a traffic offense based upon a document**
15 **or credential that expired or a document that was not submitted to the**
16 **department during the period beginning on March 1, 2020 and ending**
17 **on December 31, 2020. This subsection applies to the following offenses:**

18 **“(a) Unlawful parking in a space reserved for persons with disabili-**
19 **ties under ORS 811.615. This paragraph applies only to individuals who**
20 **displayed a disabled person parking permit, issued by this state or**
21 **another jurisdiction, at the time of the offense but the permit expired**

1 **during the period described in subsection (2) of this section.**

2 **“(b) Operating a vehicle without driving privileges under ORS**
3 **807.010.**

4 **“(c) Failure to carry a license or to present a license to a police**
5 **officer under ORS 807.570.**

6 **“(d) Failure to register a vehicle under ORS 803.300.**

7 **“(e) Failure to pay the appropriate registration fee under ORS**
8 **803.315.**

9 **“(f) Permitting unlawful operation of an unregistered vehicle under**
10 **ORS 803.320.**

11 **“(g) Purchase and use of an out-of-state registered vehicle by a**
12 **resident under ORS 803.325.**

13 **“(h) Failure to surrender out-of-state registration under ORS**
14 **803.380.**

15 **“(i) Failure to submit a declaration of weight under ORS 803.440.**

16 **“(j) Failure to renew vehicle registration under ORS 803.455.**

17 **“(k) Improper display of validating stickers under ORS 803.560.**

18 **“(L) Failure of a person to hold a trip permit when required under**
19 **ORS 803.600 (10).**

20 **“(3) If a police officer issues a citation in violation of subsection (2)**
21 **of this section, the court shall dismiss the charge.”.**

22 In line 15, delete “20” and insert “22”.

23 In line 21, delete “21” and insert “23”.
