SUMMARY

Provides that during statutorily declared emergency Governor may authorize Director of Department of Revenue to disclose certain information set forth in tax report or return to any state agency if director determines that administration of any federal or state law or program, including, but not limited to, administration of unemployment insurance laws and programs by Employment Department, requires disclosure to enable agency to verify identity or income level of any person for purposes related to emergency or any consequences of emergency.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to emergency disclosure by the Department of Revenue of certain
3 tax information to state agencies; amending ORS 401.175; and declaring
4 an emergency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 401.175 is amended to read:

7 401.175. During the existence of an emergency, the Governor may:

8 (1) Assume complete control of all emergency operations in the area
9 specified in a proclamation of a state of emergency issued under ORS 401.165,
10 direct all rescue and salvage work and do all things deemed advisable and
11 necessary to alleviate the immediate conditions.

12 (2) Assume control of all police and law enforcement activities in such
13 area, including the activities of all local police and peace officers.

14 (3) Close all roads and highways in such area to traffic or by order of the
15 Governor limit the travel on such roads to such extent as the Governor
16 deems necessary and expedient.

1 (4) Designate persons to coordinate the work of public and private relief
2 agencies operating in such area and exclude from such area any person or
3 agency refusing to cooperate with and work under such coordinator or to
4 cooperate with other agencies engaged in emergency work.

5 (5) Require the aid and assistance of any state or other public or quasi-
6 public agencies in the performance of duties and work attendant upon the
7 emergency conditions in such area.

8 **(6) Authorize the Director of the Department of Revenue to disclose**
9 **and give access to information described in ORS 314.835 to any agency**
10 **of the State of Oregon if the director determines that the adminis-**
11 **tration of any federal or state law or program requires the disclosure**
12 **of the information to enable the agency to verify the identity or in-**
13 **come level of any person for purposes related to the emergency or any**
14 **consequences of the emergency. The information that may be disclosed**
15 **under this subsection shall be limited to information that is necessary**
16 **to verify a person's identity or income level. An agency that receives**
17 **information from the director under this subsection shall maintain the**
18 **confidentiality of the information during and after the state of emer-**
19 **gency.**

20 **SECTION 2. This 2020 second special session Act being necessary for**
21 **the immediate preservation of the public peace, health and safety, an**
22 **emergency is declared to exist, and this 2020 second special session Act**
23 **takes effect on its passage.**
